VOTED, That in view of the indebtedness of the General Conference, and the fact that its receipts are inadequate to meet its current expenses, we request that the expenses of members of the Executive Committee connected with local institutions or organizations be met by these respective organizations. It was understood that this recommendation included I.H.Evans, Frederick Griggs, J.H.Kellogg, S.H.Lane, David Paulson, H.F.Rand, A.J.Read, and E.A.Sutherland.

VOTED, On individual motions, to grant credentials to the following persons: W.A.Spicer, H.E.Osborne, E.R.Palmer, and H.M.Mitchell, Further-

VOTED, On motion of Elder Evans, that we invite Elder Uriah Smith to attend the Conference as an accredited delegate, requesting the Review and Herald Publishing Company to pay his expenses.

EDITORS OF BULLETIN:

Careful consideration was given to the editorial staff of the Daily Bulletin, and it was-

WOTED, On motion of Elder Evans, that Elders W.A.Spicer, M.C.Wilcox, and C.P.Bollman act as editors of the Daily Bulletin. Further--

VOTED, That we invite Adeliade B.Cooper to arrange her work in order to attend the General Conference, and to act as an assistant editor.

3. That all up-to-date saleable books, pamphlets and tracts in good condition which may be in stock at the Burban Branch December 31, 1903 be taken over by the South African Union Conference Depository at publishers' rates.

EDUCATIONAL DEPARTMENT.

It was stated by the Chair that the organization of the educational department was the work to be considered, together with the arrangements for the educational council.

L.A. Hoopes spoke as to the need of giving the department a thoroughly representative character, so that no one school should be a General Conference School more than another. The department has work to do in systematizing and unifying methods, though leaving opportunity for diversity. It should be a department for the study of principles, and should help in the matter of taxt books. Other councils than the general summer coulcil might be held in the Unions, so that as far as possible responsibility might be distributed. The recommendation passed at Conference regarding the work of the secretary of the department, and its organ need consideration.

The Chair mentioned various matters of organization of the department and its work to be considered.

E.A. Sutherland thought the province of the Committee should be advisory, and that it should not be centralized. There is need of concert of action, and to reach this, the Committee should bring together the leaders in work, and study plans.

Dr. Paulson thought the medical school would like to cooperate in studying the educational problems referred to.

A.T. Jones suggested that one of the most important things in the whole problem is for the teachers to devote themselves to the study of the things necessary to their work. The teachers in Colleges need to come into the institute to learn how to use the Bible in their work, and how to use the text books prepared. At this juncture Dr. J.H. Kellogg joined the Committee, and made a statement regarding the somewhat strained relations which had existed between the workers in the medical missionary and evangelical departments. He desired, which but compromising or surrendering any principles or convictions for which he had stood, to have peace established, together with concert in the work. He was followed by Brethren Prescott, Daniells, and most other persons pr esent. The Spirit of God witnessed to the conciliatory move, and all rejoiced that friendly and fratermal feeling was established.

Word having been received that some **Cal**ifornia workers did not receive their full wage regularly, Brethren Jones, Conradi, and Knox were appointed to look into the method of sending the California appropriation for workers in England.

AUSTRALIAN ACCOUNT ADJUSTED.

Brother G.A. Irwin presented the following recommendation: --

Whereas, Some years ago the General Conference Association received \$500 from Mrs. Wessels, of South Africa, to be used in the erection of church buildings in Australia, and

Whereas, This money has never beed paid over to the Australian field, but has been used in ways not authorized by the doner; therefore the Australasian Union Conference would respectfully request that this matter be re-adjusted, believing that the blessing of the Lord will attend such action on on the part of the General Conference Association; and to make this action as easy as possible, will accept in full settlement of this claim an order on the Echo Publishing Company for 250 pounds, and an order on the New Zealand Tract Society for 250 pounds. These orders to be credited to the respective organizations as part payment of their long standing accounts, the Australiasian Union Conference to take all responsibility of collecting the amounts in Australiasia. Brother W.H. Edwards, formerly treasurer of the General Conference Association, can verify the statements made herein.

The recommendation was adopted.

BRITISH MATTERS.

,

Dr. Waggoner was present to speak of matters in England, especially of the general meetings in South England, and of help for the meeting, and also for the dedication of the Caterham Sanitarium. He had hoped Elder Daniells might be there, or that otherwise Elder A.T. Jones might attend.

The English school had hoped that American assistance might be given it. By the sale of Christ's Object Lessons they have gathered nearly 2,000 pounds, which remains in the bank. They have hoped America might help them to an equal amount. The school has been doing good work, even with the lack of facilities in rented quarters.

The circulation of "The Present Truth" has left a deficit Last year 500 pounds. This kept about 80 workers in the field. The office has felt it could not carry this indefinitely. Then a change was made and the Conferences and mission fields were to take the deficit. But no provision has been hade for the additional burden upon the field. Some provision is asked for.

Dr. A.B. Olsen spoke also of the circulation of "The Present Truth," and of his personal knowledge of the circumstances and consecration of the agents circulating the paper. The deficit can not be donsidered a loss.

In Leicester an opening has developed for treatment rooms. One gentleman interested offers a property, formerly a Sanitorium, as treatment rooms, rent-free, for 5 years, with privilege of renewing for another 5 years. The institution cost \$15,000. They need \$1,000 for equipping the place, and the fare of two nurses.

J.E. White then desired the Committee to consider the propriety of allowing him wages from the general fund, inasmuch as the colored work in the South is a legacy of the whole denomination. He had received but \$\$7 per week, last year, rated at half wage. He had paid stenographic and office help for the Southern Missionary Society to more than this. He suggested that the General Conference make up the \$\$7 on last year.

Elder George I Butler spoke of the fruitfulness of J.E. White's labors in the South. He thought Brother White had been taking a genercus, helpful course and favored allowing his salary to come upon the general funds.

Brother A.G. Daniells suggested that it would be more in harmony with the general policy if Brother J.E. White drew his wage from the Union Conference. That the Southern Union should place him on the payroll, and include the amount in their call for appropriations.

This matter was considered referred to the Finance Committee.

NEW YORK CITY.

During the discussion of the estimated, H.W. Cottrell introduced the needs of the New York Oity work. Elder S.N. Haskell spoke of the vast field in Greater New York, in which all nationalities are gathered. It is the money center of the world. There will be large funds yet coming in from men of means. He therefore urged that the work should be represented there properly in all its branches. Between fifty and sixty people embraced the truth during the sixteen months in New York City, during which time the Lord had sent the means necessary. Treatment rooms have been opened in a rented house in Brooklyn, and is paying its way. Openings present themselves and practical experiences in their work during the last two years have shown that New York City is indeed ripe for work.

He appealed for a headquarters, a head to the work, and a steong committee in New York, so that shape and direction could be given to the . work.

It was voted to insert \$1,000 in the estimates to help in the Atlantic Union deficit on account of its effort to help Greater New york.

The following recommendations were presented by the Committee on Finance:--

JULY COLLECTION FOR AUSTRALIA.

Recommended, That a general collection be taken for Australia the first Sabbath in July.

MISSION FUNDS.

Whereas, The General Conference must secure this money from month to month or our laborers will suffer; therefore, --

We recommend:

1. That every Seventh-day Adventist church be urged to systematically take up the ten-cent-a-week plan, and **faith**fully see that each church pays an average of ten cents a week per capita.

2. That each Conference be requested to pay the entire second Conference tithe into the treasury of the General Conference for mi ssion work.

3. That special donations for missions be taken up at all large gatherings.

4. That we request all our Union and State Conference papers to open their columns to the General Conference for working up the funds for mission work.

Whereas, The custom is now established of paying our workers monthly; and,--

monthly; and,---Whereas, The General Conference will be compelled to make remittances from month to month to the various fields; therefore,---

Resolved:

1. That all donations of tithes and offerings to the mission work be sent to the Union Sonference treasurers monthly.

2. That each Union Conference is hereby urged to instruct its treasurer to use all diligence in collecting all funds, whether special or otherwise, and forward the same monthly to the treasury of the General Conference.

3. That all Conference s supporting workers in mission fields are requested to send the remittances for such support monthly to the General Conference treasury.

APPROPRIATIONS NOT OBLIGATIONS.

In the discussion it was agreed that our appropriations should

not be considered as obligations, as the Committee can only send as contributions come in.

Voted, That the estimate be considered as calls upon the people in behalf of the fields, rather than appropriations or obligations. BRITISH SCHOOL.

Voted, That \$10,000 be placed on the list of calls to be raised, if possible, for the British School.

BATTLE CREEK COLLEGE PROPERTY.

Opportunity was given for the consideration of matters connected will with the old Battle Creek College property, which the General Conference had advised the Training School Association to deed to the General Conference Association, and which had been the subject of conferences between the various parties interested.

The following plan for the conduct of the affairs of the old Battle Creek College property was then presented by P.T. Magan:--

1. That the title to the property remain in the International Medical Missionary Training School Association until all the obligations now standing against the Association shall have been liquidated.

2. That the creditors of the International Medical Missionary Training School Association who have not as yet received promissory notes covering the amounts due them, shall receive the same immediately; that the Review & Herald Publishing Co., shall receive an interest bearing note for the amount due said company, payable January 1, 1904, and that the S.D.A. Central Educational Association shall receive a note or notes for the amount of equity due said company, said note or notes, however, to be non-interest bearing.

3. That the International Medical Missionary Training School Association shall proceed immediately to give the International Medical Missionary and Benevolent Association a written instrument of contract and lease for the Battle Creek property, the lease to be for the term of twenty-eight years, or, if so desired until the property has been paid for as herein stipulated.

4. That the Benevolent Association shall raise a sum sufficient to pay the purchase price of the property by means of the Missionary Acre and other plans, devised, or to be devised in the future.

5. The Benevolent Association is to pay all taxes, assessments and expense of repairs to keep the buildings in a reasonably good condition.

6. That the Benevolent Association is to pay to the Training School Company an amount equal to the interest which the Training School has to pay, as stipulated in the contract.

7. That the Benevolent Association insure the property for \$40,000, said insurance to be made payable to Training School as its interest may appear.

8. When Benevolent Association has paid for property it shall receive a deed in fee simple for the property to be used for the American Medical Missionary College, and the Training of Medical Missionary Workers, and its other purposes.

9. In case of fire loss, such a teduction shall be made in the purchase price as shall relieve the Benevolent Association from loss after taking the insurance into account, the said reduction to be borne by the unpaid equity.

Moved, That we approve of the Training School Association entering into the arrangement proposed, if on investigation the Training School Association assents to the terms of the contract and lease, as outlined.

The motion was seconded.

E.A. Sutherland asked that some general understanding should be secured regarding the missionary acre fund, so that there might be cooperation in all the field.

A.G. Daniells referred to the importance of providing for the notes out, so that people should not in any way be disappointed by failure to receive their interest when due.

S.H. Lane expressed it as his mind that it would be better to have the property remain in the hands of the Training School Association rather than to have it deeded to the General Conference Association.

George I. Butler favored leaving the matter with the Training School Association, until the indebtedhess is paid, as frequent changes have a tendency to unsettle the minds of the people.

P.T. Magan said that the Benevolent Association had named A.T. Jones, S.H. Lane, P.T. Magan as a committee to see to the working up of the acrefunds. The essential thing to success in this was hearty cooperation in the field.

In accordance with this recommendation we further recommend that J.E. Tenney, M. Bessis De Graw, C.C. Lewis, Elmer L. Eggleston, B.E. Huffman, E.W. Catlin, and H.A. Washburn, be added to the committee.

REPORT OF FINANCE COMMITTEE.

That an appeal from the 1st. Washington church be referred to a committee of H.W. Cottrell, I.H. Evans, and A.G. Daniells for such favorable action as the committee may be able to divise.

OBJECT LESSONS.

That the burden of completing the Object Lesson Campaign be referred to the Union Conferences, who alone can do the work.

AUSTRALASIAN APPROPRIATION.

That the \$5000 appropriation for Australasia be arranged by giving the Australasian Union credid on Mission Board account against Echo Publishing Co., and New Zealand Tract Ecciety.

J.E. WHITE'S CLAIM ON SCANDINAVIA.

That the \$150 asked by J.E. White from the Scandinavian field on account of the plates on "Coming King" be granted from the general funds, inasmuch as the Christiania publishing work is itself in need of assistance.

The report was adopted.

HEADQUARTERS NEAR NEW YORK.

Voted, That we favor locating the headquarters of the General Conference in the Vicinity of New York City.

SANIMARIUM BOND ISSUE.

At this junctureDrs. Kellogg, Stewart, Thomason came in, and Dr. Kellogg suggested that a number of questions needed to be considered by members of the Medical Board and the General Conference Committee.

Sr. White had stated that the Sanitarium should be helped, but that our people should not invest in the honds. The publication of the talk concerning bonds in the Bubletin has made the matter known in the field. But people are effected differently. Some have withdrawn bonds, but others send in for them, saying they believe in them. The only embarrassment the Sanitarium felt was in respect of the course they should take regarding this application for bonds. Should they issue bonds to those calling for them, inasmuch as a recent Testimony has said there is unsafety in the bonds.

Elder Butler said that his understanting of what Sister White said was that our people having great work on their hands ought not to tie up their means in the nonds, so that it would not be available. He understood that the monds would ordinarily the up the investment for twenty years. We believe the end is at hand, and should keep this in mind in the use of means which are called for in aggressive work.

If all went well, the investment in bonds might be safe for the world. But if hard times come, or if Dr. Kellbgg should pass away, what effect would it have on the situation? As for worldly people, they will do what they like, and invest as the y like.

Dr. Kellogg stated that what they wanted was to know what attitude in view of the testimony lately received, should be taken in the matter of the bonds. While the money is not due for twenty years, the bonds

28

are negotiable. Thus those investing in the bonds would have their money safe and could be approached for help for missions, etc., at any time, and the Sanitarium could easily pay the money redeeming the bonds. He felt that it was not necessary to forecast flifficulty in case of his death, as the workers are developing to take the work. As to hard times, the Battle Creek Sanitarium has never been affected by such times. The testimony says there is unsafety and a snare in the bonds. If the k bonds are unsafe, they are unsafe for anybody. If there is a snare in them, it is a snare for anybody.

G.I. Butler expressed it as his mind that inasmuch as Sister White has said she had nothing to say as to worldly investors, he did not think the Testimony was intended to have a beating on that side. He also referred to the word "snare," as used in Matther 24-, as immedimentions suggesting that the word might indicate a danger of joining in with the world in making investments that would prove a snare in view of the soon coming of the end.

The Chairman suggested the appointment of a committee to consider the matter. He understood that the idea as the council last November was that the nonds were not for our own people, but to be sold to people of the world. He believed more was involved than the legal of commercial side of the matter. It was our attitude toward God and the truth and work, and he saw omens for good in the present situation.

Brother A.T. Jones stated that it was his understanding as the November Council that the bonds were to be sold generally to outside investors.

COMMITTEE TO ADVISE ON BONDS.

Voted, That a committee of three be selected who shall take the matter under advisement, and make report.

A.T. Jones, G.A. Irwin, W.T. Knox were named.

SANITARIUM BONDS.

.

The committee appointed to report on the question of the Sanitarium bonds brought in its recommendation. W.T. Knox had been anked has obliged to go to his western appointments, but had met with the committee.

A.T. Jones reported that the Committee had agreed about as follows: --

That taking the Sanitarium situation in itself, it would have been the Lord's mind that it should not have been built so large in Battle Creek, but that now that it is built, it should be helped.

That it was the idea in the November council that the bonds should be negotiated outside of our people. The bonds have now been issued, and the instruction has comethat our own people should not take them, as was understood in the council.

Now that the bonds are issued, to attempt to recall them would be confusing. Under the circumstances it seems best to let matters proceed, saying no word against the delivery of the bonds to outside people.

On our side, we, in the laght of the testimonies, are to strive

for that concert of action a nd seek the way that will be shown by which to help the Sanitarium, and so working we shall be able to find whatever danger may be in the bonds. When memomenatum found we shall be qualified to guard against it. By taking this course we shall escape whenever the snare is sprung, that it is stated make is in the bonds. By taking the right course the Lord can show where the snare is.

Thus we shall be helping the Sanitarium out of every difficulty, and onto the foundation on which the Lord designs that it shall stand so that all the people may be clear in helping it.

Dr. Kellogg suggested that this was the outline of the report: we have been instructed that the new building is larger than it should have been, but having been built, it should be helped.

Bonds have been issued, and now are to be allowed to be sold. The bonds have been looked into, and as a commercial matter have been found not out of harmony with ordinary commercial paper. The bonds should not be sold to our own people, as they should hold themselves in readiness to place their money otherwise.

As regards the snare referred to we are to hold ourselves in readiness to guard against it.

G.A. Irwin, the other memner of the Committee of three present, said he understood the one point the committee was to consider was whether the Sanitarium should be advised to supply the bonds to would be purchasers, or should withdraw them, and attempt to gather in those already sold. He thought we should take the Testimony and sit down together and shouly it, rather than to take any vote to interpret a testimony.

H.W. Cottrell said he would regret if by some vote at to interpretation we ourselves were ensmared. He would not want to interpret the Testimony.

A.G. Daniells daid he thought, so far as he could understand, the Testimonymme covered these points: --

1. Danger is pointed out, a warning note sounded.

2. Assurance is offered that the danger can be met, because the Lord will institute ways and means by which the Sanitarium can be helped.

3. That it will be averted when food has supreme control.

None could foretell what calamities might come if we should separate from him. Much could happen that would throw the whole thing into wreckage, so it would prove a snare to our people if they had invested their mans. So the Lord must have control. He felt thankful that this is the spirit and the attitude to-day. When we decide to rebuild with certain limitations he felt great interest. Trouble had come in since. But how he felt assurance of better conditions. We have gone contrary to Ged's council. We have sinned. Our remedy lies in humbhy management assurance must humbling ourselves and

acknowledging our sins, and so our work may be under the control of t the God of Heaven.

Dr. Kellogg expressed himself as in accord with the spirit of the remarks.

While some ask explanations about bonds, where one is questioning, half a dozen are asking for bonds.

ORGANIZATION OF THE MEDICAL WORK IN ENGLAND.

Dr. Kellogg suggested that the General Conference Committee and Medical Missionary Board should appoint a committee to consider articles of incorporation for the Health Association in Britain.

He felt that the articles as prepared in Great Bristain placed the control of the work in the hands of those who have not been educated or trained in the work.

Voted, That a committee of three be appointed to act with a similar committee from the Medical Board, to make such suggestions as may be thought advisable regarding the articles of association.

Brethren G.A. Irwin, L.R. Conradi, A.G. Daniells were named.

GOOD HEALTH FOR JULY.

Dr. Kellogg suggested that through the General Conference and Tract Society machinery, there might be a special effort made to extend the circulation of the GOOD HEALTH. They were planning on a special Sanitarium dedicatory number, giving a history of the institution and branches, and a statement of principles.

Voted, That effort should be made to encourage the circulation of the special July number of the GOOD HEALTH.

MISSIONARY ACRE FUND.

.Dr. Kellogg presented a resolution passed in the Training School Association as monimum follows:

Elder Daniells presented a communication from Elder M.H.Brown, secretary of the California Conference, in which the California Conference proposed a plan for making certain provisions for DR. M.G.Kellogg and family. The proposition was in substance, that a small home of about ten acres be purchased and fitted with necessary equipment for Dr. Kellogg, at a cost of about \$1,275, and that this cost be borne equally by the General Conference, the International Medical Missionary and Benevolent Association, and the California Conference.

Voted, That the General Conference join with the California Conference and the International Medical Missionary and Benevolent Association in the purchase of a small property for Dr. M.H.Kellogg, and that the obligations of the General Conference in this purchase by onethird the investment, to a limit of \$425.

The California Conference, through its Secretary, Elder Brown, had also communicated with the General Conference relative to the traveling expenses of Miss Howard from California to France.

Voted, That the Mission Board advance as a loan to Brother fauterau, of France, the amount necessary to pay the traveling expenses of liss Howard to that country from California, and that the final settletent of these traveling expenses by left between Brother Gauterau and the French-Latin Mission field.

Elder Daniells read a lengthy communication from the managing ward of the Pacific Press, in which the Pacific Press Board declined to accept the proposition previously made by the General Conference to the effect that the Pacific Press Publishing Company turn over to the Review and Herald, or to its successor for the management of the publishing business in the Bast, all the assets of the New York Branch of the Pacific Press as a donation.

In reply the managing board offered to sell its New York business to the Review and Herald, or to its successor, at the last inventory value, which was approximately \$26,000, and proposed to donate in stock at the above-mentioned value, \$1,000 for each \$5,000 which the General Conference or the Review and Herald might raise in cash donations for this enterprise from the people; the amount of the gift, however, to be limited to \$5,000.

The officers of the General Conference were unable to give favorable consideration to this proposition.

The treasurer, Elder I.H.Evans, read a letter from Brother S.C.Stickney, of the Pacific Press, in response to an invitation which had been sent to Brother Stickney to connect with the treasury department of the General Conference as bookkeeper. Brother Stickney gave various reasons why he must decline to accept the position. He is pleasantly connected with the Pacific Press, and engaged in a work with which he has . become familiar during twenty-three years of experience, and he would not care to separate from that work. Moreover, his present work enables him to lead a very active life outside of the office, and he would prefer to continue that work rather than take up desk work again.

The treasurer was advised to make definite arrangements for securing the services of Brother D.K.Nicola, of College View, Nebr., and advised that he be notified at once of the decision.

The presidents of conferences in the Atlantic, Lake, Northern, and Canadian Union Conferences had been invited, not only because their help will be valuable in the consideration of the important questions to come before the Committee, but because the committees of the conferences in these unions are the constituency of the newly organized Review and Herald Fublishing Company, and it was desired that as many of the constituency as preasonable might meet to consider the plans and shape the policy of the new Association.

After reading a Testimony addressed to brethren in responsible positions, a schedule of questions to come before the (Council was submitted on printed slips, as follows:---

Topics for the Council, Oct. 2-21, 1903, Washington, D. C.

T. The Approaching Union Conference Sesons.— When and where shall they be held? How shall they be conducted so as to secure the argest results possible? What general help hall be furnished each? What can be done to perfect the organization of each? 2. Work With "Christ's Object Lessons."— Shall this work now be dropped? Shall it be left to drift? Shall the plans for conducting this work be reorganized? If so; what general arrangement can be made that will give promise of yood returns?

3. The Week of Prayer. Preparation of readings. What can be done to secure a general observance and larger results? Shall the old plans be followed?

4. Home Missionary Work.— Should not a great forward movement, or winter missionary campaign, be set on foot at an early date this fall? If so, what shall be the general plan? (c) To largely increase our staff of regular canvassers?

(d) To enlist the rank and file of our people in America in an earnest and continuous effort to place our papers and tracts in the hands of all their neighbors? What special literature should be prepared for such a missionary effort, and who should be selected to prepare it?

5. Finances. What can be done during the coming winter to raise sufficient means to meet the appropriations voted by the Committee last spring in the general council at Battle Creek, for both the evangelical work and the establishment and equipment of institutions?

Furthermore, what can be done to dispose of the General Conference overdraft of thirty-four thousand dollars, the accumulation of deficits covering a number of years? And still further, what steps should be taken to close out the assets and liabilities of the General Conference Association? These assets and liabilities are about even, and amount to two-hundred thousand dollars. Instead of the General Conference Association being able to render the cause valuable service, it is in its present condition really a burden. Can not its affairs be wound up, and a new and better arrangement be made?

6. Camp-Meetings. Do they pay as now conducted? How can they be made more profitable to the cause? What steps can now be taken. of gathering and teaching and reviving our people?

7. Washington Enterprises.— When shall definite steps be taken to develop the work in Washington in harmony with the instruction from the spirit of prophecy?

(a) Shall vigorous efforts be made this winter to preach the third angel's message in the city of Washington, and to carry on a strong Biblereading aud house-visitation work? UNION CONFERENCE SESSIONS:

After prayer the topic of Union Conference sessions was taken up. Union presidents spoke as to the time and the nature of the meetings.

C.W.Flaiz, of the Worthern Union, stated that their first choice for time would be the last of February's second choice, the first of March. They proposed calling in all their laborers.

WASHINGTON WORK:

The topic, Washington work, was then up as the subject of the hour,

A.G. Daniells outlined the general instruction given by the Spirit of Prophecy leading to the selection of the Washington location. The conditions required that the following advantages should be secured:

(1) Rural surroundings. (2) The printing business was to be located so that the Washington imprint could legitimately appear on the literature. (3) The arrangements were to be such that in close proximity to the publishing headquarters there should be a sanitarium and a school. (4) There was to be land sufficient to provide out-of-door work for school and sanitarium. (5) The advantages of a healthful site were to be secured.

The locating committee examined all parts of the listrict and found Takoma Fark the location best fulfilling the specifications.

Brother Daniell's stated that it was not the idea that the General Conference should have and operate the printing house, the school, the school canitarium. The General Conference must hold itself in equal relations with all our denominational schools, printing offices, and sanitariums, helping all alike, although in starting the work in Washington, the General Conference must necessarily take special interest in festering the enterprise. Therefore, some plan of organization must be devised for handling these enterprises.

W.W.Prescott called at ontion to the fact that the instruction was that the institutions here were not to be detached, but allied interests, so that in case the printing plant should have to be removed, the facilities might be made use of by sanitarium or school.

It is also a part of the instruction that everything is to begin shall and grow, We are not to make an effort to attract attention by any display or large expenditure.

On this basis, the basis of a great work with humble facilities, we can hope to begin at once to execute the plans. We may trust God's power to make the truth itself the prominent thing, and not the outward display or the large facilities.

PUBLIC EPEORY IN WASHINGTON:

Plans for a special comparing this winter in Washington were discussed, including the idea of meetings in public halls, Wible work, and distribution of literature.

TREATMENT ROOMS IN WASHINGTON:

W.W.Prescott expressed himself as heartily in favor of Opening treatment rooms in the city at onco.

After devotions, the conference proceeded to take up topic 5 in the schedule of business, A.G. Daniells asking counsel concerning the General Conference deficit, now \$34,000, the amount having been reduced about \$7,000 during the last year.

It was folt generally that the matter could be dealt with by calls in appropriations, 410,000 for this purpose having been listed in the appropriations voted last spring.

I.H.Evans stated that he fult that some general plan should be formed to meet the General Conference Association obligations and wipe out the entire General Conference deficit. The suggested a dollar donation is a possible plan, calling for a dollar peryear until the indebted ess was baid.

R.A. Underwood favored dealing with the matter with one great fund for the general work, setting aside twenty per cent of the fund for the debt, and gauging the appressive work accordingly.

R.C.Porter thought that the soccial fund suggested by Brother Evans should not be denominated a dollar collection, but a one to five dollar domation.

H.W.Cottrell stated his belief that if mother annual offering were established, it would militate against the one already operating. He favored getting the Union Conferences that have a surplus to help; and to make up the balance by calls in the general appropriations.

I.H.Evans hardly felt that it should be called an annual offering, but let it be) understood that this fund washeeded, and let people give when they were inclined, callishing receipts in the REVIEW, perhaps. W.J.Stone favored the plan proposed by R.A.Underwood, the raising of a general fund.

C.W.Flaiz felt that we were in danger of fearing too much to call directly for money for indebtedness. He reviewed the efforts by which State conferences had been generally freed from debt, some by raising a special side fund on account of indebtedness. Elders Thompson, Thurston, and Flaiz emphasized the fact that better work could be done in Canada by a Canadian than by a citizen of the United States, and that religious liberty literature used should bear a Canadian imprint, and should be adapted. to the situation in that country.

SUNDAY LAW AGITATION:

E.T. Russell said the Mational Reformers were making an active campaign in the Central Union Conference, and that there was need of new ligerature for the United States as well as for Canada. R.C.Porter stated that a vigorous effort was being made to secure complete Sunday closing of the World's Fair in St.Louis.

Dr. Paulson and Allen Moon spoke of the Labor Unions as a new and ang dangerous factor in the situation.

L.F.Starr said that in Iowa during the last winter, religious liberty conventions had been held with excellent effect.

MISSION FINANCE:

I.H.Hvans asked permission to speak of mission finance and the working up of general funds. He much desired to see in each State Conference a man especially appointed as a financial agent, to work in the interests of general funds. He wished also that in Union Conferences there might be a Union financial agent, working to the same end.

It was stated by W.T.Bland that the Finance Committee were considering such a plan, and would make report,

The Chair stated his convictions that great results would come to the work to have a thoroughly organized system for gathering funds. Our people, reckoning by general statistics, save vast sums by refraining from the use of harmful luxuries, apwards of two millions a year by on liquor and tobacco alone. Our people are able, if touched by the call of need, to give far more largely. Now, in these critical times, a great movement for the consecration of means to the cause of God should bring in large sums.

W.J.Stone urged that systematic effort should be made to get our people to pay a full tithe. He suggested special literature on the tithe question.

J.W.Watt reported that Vermont had found good results from the use of printed slips, with a few texts on tithe-paying, for circulation among the brethren.

R.A.Undorwood urged the Bible plan of tithes and offerings as the basis of finance, and favored the strongthening of the link between the head office and the field.

E.T.Russell arged the importance of the ten-cent-a-week plan, which would bring in \$312,000 per year for missions, if practized. He related some experiences showing how a trial of the plan had increased the offerings.

Allen Moon said that he had found that those who had taken hold of this work had the most spiritual life of any. It had been a great means of revival, and would further be such.

P.T. Marin referred to the origin of the plan and to the importance of setting all our people to work. He believed that a systematic effort should be made the country over, beginning about the middle of Movember, to o rganize the forces for. a campaign to finish the work this fall and winter. In regard to another book needed to go with the campaign, he felt that the book "Education" should be the one. He felt that the schools should join cornectly in the campaign.

L.A.Hoopes spoke also of the book "Education" as a work that should be widely sirculated.

Before vote was taken, A.T.Jones stated objections to the report in that he viewed it as opening the way for one man to rule within a given territory. He saw in the arrangement a patterning after the United States Government, which is headed toward Reme, and is to make an image to the beast.

A. C. Daniells explained that the idea-of the Committee was simply to provide for carrying on the mission work in the territory named, associating the people living in the district with the whole ceneral conference Committee in the selection of a local board for working the territory as a mission field. The institutional interests contaring here were to have a constituency and a management altegether apart from this working arrangement for evangelistic effort. Brethren Lane, Prescott, Cottrell, Underwood, and Porter spoke to the question.

FEPORT OF COMMITTEE ON HOME WORK:

We recommend,

(a) That we indorse the creation of the international Publishing Association according to the plan adopted, and herewith submitted, as follows: —

1. That a publishing association be incorporated which shall be organized as a Trustee Association, which shall be a non-stock and non-dividend paying association, to carry on this work (among the Germans, Swedes, Danes, and Norwegians in America).

2. That the name of this association be the International Publishing Association.

3. That the work of this Association be the printing, publishing, purchasing, and sale of religious, health, and educational literature throughout the United States in the German ,Danish, Norwegian, Swedish, and other foreign languages, and also to print in the English for Union College and the Gentral Union Conference, and to provide facilities for slass room work in general printing instruction in connection with Union College, and that after the present cylinder press ,owned by the College; is paid for, that it and all other equipment owned in the printing department of the College be turned over to the International Publishing Association. 4. That the business of the Association be gov-

erned by a board of seven trustees.

5. That there be a committee of seventeen counselors, not less than three to be selected from each of the different nationalities; namely, Geeman Swedish, Danish, Norweglan, and English, and these to meet once or twice a year with the trustees for the discussion of general plans.

6. That hereafter the trustees and counselors be elected annually by the following body of electors : The Executive Committees of the Gencral Conference, the Central, the Northern and the Southwestern Union Conferences. And in as much as the main purpose of this association is to purchase, print, and pullish literature in foreign tongues, the majority of the trustees should be elected from the foreign nationalities represented in the same.

7. That the officers of the three union conferences, in the Mississippi Valley, the German and Scandinavian laborers throughout the United States, and the influential breaken everywhere, be encouraged to raise funds for the erection of a modest, but foomy factory, for the purchase of a good book printing press, and other necessary facilities, and also for the purchase from the Review and Herald of a portion of its stock of German and Scandinavian books.

8. That the General Conference shall consider the advisability of establishing in New York City a general book store and importing and shipping agency which shall carry a full line of German and Scandinavian and other translated books for distribution in the Eastern States, and which shall act as our Eastern agents for the importation of books printed in Europe, and for the distribution of books printed in College View.

9. That the preliminary steps for the incorporation of this association be committed to the following persons, whom we have selected to act as the first Board of Trustees, namely, E. T. Russell, A. Swedborg, T. Valentiner, C. A. Thorp, F. H. Westphal, T. G. Johnson, and J. Sutherland.

The Advisory Committee of seventeen counselors are N. P. Nelson, L. Johnson, H. Shultz, S. F. Svensson, Fred Johnson, J. J. Graf, C. H. Hermann, S. Martensen, H. R. Johnson, H. H. Hall, L. A. Hoopes, G. F. Haffner, E. G. Olsen, C. A. Burman, J. G. Walker, and Jno Wallenkampf.
