VOTED, That we approve of C.A.Russell's attending Elementary Teachers' Institutes in the Atlantic Union, October 4 to 15.

VOTED, That F.C.Gilbert be authorized to make a trip to the Lake, Central and Pacific Unions, in the interests of the Jewish Department.

MRS. BERTHA PEAKE--PERMANENT RETURN:

VOTED, That in harmony with the request of the Inter-American Division, we approve of the permanent return of Mrs. Bertha Peake from Jamaica.

NELS ANDERSON AND FAMILY TO SCANDINAVIA:

SOUTHEASTERN CALIFORNIA-ARIZONA
CONFERENCE-- PER CENT OF TITHE:

R.E.STEWART--PERMANENT RETURN:

VOTED, That the return of R.E.Stewart from Cuba be changed from the furlough to the permanent return basis, inasmuch as Brother Stewart's condition of health does not warrant his continuing in service in a mission field.

VICTOR CAMPBELL--ACTION RESCINDED:

A letter was read from J.W.MacNeil, president of the Potomac Conference and of the Shenandoah Valley Academy Board, with reference to the call for Victor Campbell, of the Academy, to connect with the school in Costa Rica, Central America. Three teachers have already been called from the Academy to other schools this year, the principal is just recovering from a long illness, and they have a heavy building program on. They therefore feel it would be a serious matter for them to release Brother Campbell. It was

VOTED, That in view of the conditions at Shenandoah Valley Academy, as outlined in the letter from J.W.MacNeil, we rescind the action asking for the release of Victor Campbell to connect with the school in Costa Rica.

WORKERS IN ETHIOPIA:

Information was received that E.D. Dick, Secretary of
 the Northern European Division, is at the present time visiting
 our missions in Uganda and Kenya, and plans on going into
 Ethiopia before returning to Europe, possibly some time in Oc-
 tober. Feeling that it would be a great help to the workers
 in Ethiopia if they could have his counsel now in the present
 emergency, it was

VOTED, To send the following cable to E.D. Dick, at
 Nakuru, Kenya Colony, East Africa:

"Request you rearrange itinerary going Addis Ababa
 immediately for counsel. Suggest airplane. We directing mat-
 ters from Washington. American government repeats request
 missionaries leave. Have cabled Ethiopia authorizing women
 and children to leave if considered necessary. Approve
 Sorenson suggestion missionaries especially doctors stay as
 long as considered safe. Cable your movements and also after
 visit." (Signed) Committee.

It was also

VOTED, To cable M.J. Sorenson, at Addis Ababa, as
 follows:

"Reassured your cable and Review article indicating
 waiting developments. Cabling Mission Secretary Dick change
 plans go Ethiopia immediately for counsel."

VOTED, That we approve of the following appointments and itineraries for General Conference workers:

Meade MacGuire, after a period of rest following the Autumn Council, to spend some time, possibly two months, in work in the Pacific Union.

F.L.Peterson to accede to the request of the Lake Union and the Michigan Conference for his services for a few weeks, in connection with the Detroit colored church, as soon as he can arrange to go.

L.E.Christman to visit churches in Mobile, Montgomery and Birmingham, Alabama, on his way home from the Pacific Coast and to the Northern and Southern New England Conferences, September 28 to October 5.

E.E.Franklin to a meeting of book and Bible house men and field missionary secretaries at College View, Nebraska, October 14 to 17.

C.A.Russell to attend elementary teachers' institutes as follows: Columbia Union, October 18 to 20; Southern Union, October 21 to 24; North Pacific Union, November 10 to 20; and Pacific Union, two weeks the latter part of November and first of December.

W.D. KIESER--TEXICO:

W.D. Kieser, field missionary secretary of the Cuba Mission, finds it necessary to leave Cuba on account of the health of his little boy, who has been ordered by the doctors to a high, dry climate, and the Southwestern Union learning of this has placed a call for Brother Kieser for Spanish evangelistic work in the Texico Conference. It was

VOTED, That we approve of the permanent return of W.D. Kieser from Cuba, the Inter-American Division having concurred in his return, and that we pass on to him the call to connect with the Texico Conference for Spanish evangelistic work.

A.H. FIELD--RELEASED FROM RETURNING TO SOUTH AMERICA:

VOTED, That in view of the condition of his health, we release A.H. Field from returning to South America.

G.B. YOUNGBERG--BRITISH NORTH BORNEO:

Consideration was given to the call from the Far Eastern Division for G.B. Youngberg to return to the Malayan Union, to fill their call for a teacher for the school among the Dusuhs of British North Borneo. Brother Youngberg is desirous of accepting this call, though it means leaving three

of his children in school in America, and he feels it will be necessary also for his wife and the three younger children to remain here another year. While this is not an ideal arrangement, yet in view of Brother Youngberg's fourteen years of service in Malaysia, part of the time in Borneo, his knowledge of the language, and his desire to respond to the call, together with the fact that even though he were to take all the family the older children would necessarily have to be sent away to school, it was

VOTED, That we authorize the return of G.B.Youngberg to the Malayan Union, subject to favorable medical report, placing him under appointment as teacher in the school for the Dusuns of British North Borneo.

P.J.GAEDE--COSTA RICA SCHOOL:

VOTED, To invite P.J.Gaede, of Shafter, California, to connect with the Inter-American Division, for the principalship of the training school at San Jose, Costa Rica.

HAROLD VORHEES--INDIA:

VOTED, To request the Columbia Union and the New Jersey Conference to release Harold Vorhees to connect with the Southern Asia Division as field missionary secretary.

MINISTERIAL INTERNESHIPS:

A number of applications for Ministerial Interneships were referred by the Interneship Committee to the General Conference Committee, the applicants in each case being past 30 years of age.
