L.H.Christian, occupying the chair, was sorry to announce that Elder McElhany, who had contracted the influenza while filling appointments on the Pacific Coast, was not well enough to be with us. The Secretary was asked to convey to Elder McElhany the sympathy of the Committee, and their hopes for his speedy recovery.

After referring to present world conditions, Elder Christian in opening the meeting read the promise in Psa.76:10: "Surely the wrath of man shall praise thee; the remainder of wrath shalt thou restrain." Also the call in Isa. 60:1,2, to "Arise, shine; for thy light is come, and the glory of the Lord is risen upon thee. For behold the darkness shall cover the earth, and gross darkness the people; but the Lord shall arise upon thee, and His glory shall be seen upon thee."

The following quotation from Special Testimonies was also read:

"God's workers today constitute the connecting link between the former workers, the church of history, and the church that is to be called out from the world and prepared to meet their Lord. The tide of spiritual life is to flow through the appointed channels, as in the history of the past. From age to age the light which God has for the world has been imparted to the church militant, and God is continuing to impart precious light. All who receive the light are to diffuse it to those who sit in darkness. All the excellencies that have come through the belief of the truth from past ages to the present time, are to be treated with the utmost respect."

"Truly," said Elder Christian, "we should make present conditions and the searching for light, and the willingness to think of spiritual and eternal things on the part of many in the. world today, count for the advancement of the advent movement."

PRINCIPLES OF PROTESTANTISM AND SEPARATION OF CHURCH AND STATE:

Information was given by H.H.Votaw and W.G.Turner relative to a plan being developed by certain religious leaders in Washington, in which we have been asked to join, for educating the people in the United States in the true principles of Protestantism, and concerning the principle of the separation of church and state.

Suggestion was made that our own people need to be better informed concerning the prophecies relating to the Papacy, and concerning the increasing spread and encroachments of Catholicism in the United States, both in religious circles and in govern ment affairs, and that it might be well if some special attention were given to this subject at the camp meetings this summer.

VOTED, That a committee of five be appointed by the Chair, to give study to this question, and make recommendation

as to how we may cooperate with these religious leaders in the educational campaign which they propose, and also as to ways and means of enlightening our own people on this matter.

OBJECTIVES AND SPIRIT OF OUR CAMP MEETINGS:

VOTED, That the Chair appoint a committee of seven to give study to this question, and bring in recommendations.

GENERAL CONFERENCE COMMITTEE

April 9, 1940, 2 P.M.

The Chairman, W.G.Turner, read from page 173 of the book "Education," and pages 753 and 754 of Volume V of the Testimonies from which we take the following excerpts:

"In the annals of human history the growth of nations, the rise and fall of empires, appear as dependent on the will and prowess of man. The shaping of events seems, to a great degree, to be determined by his power, ambition, or caprice. But in the word of God the curtain is drawn aside, and we behold, behind, above, and through all the play and counter-play of human interests and power and passions, the agencies of the allmerciful One, silently, patiently working out the counsels of His own will."

"We permit ourselves to feel altogether too much care, trouble, perplexity in the Lord's work. Finite men are not left to carry the burdens of responsibility. We need to trust in God, believe in Him, and go forward. The tireless vigilance of the heavenly messengers, and their unceasing employment in their ministry in connection with the beings of earth, show us how God's hand is guiding the wheel within a wheel."

F.Griggs and J.J.Nethery led in prayer.

E.D.Dick conveyed to the delegates an expression of appreciation from J.L.McElhany for the message of good wishes sent him by action taken in the morning meeting.

SPIRIT OF PROPHECY READING PROGRAM:

The Promotion Committee on the Spirit of Prophecy Reading Program for 1940 had made recommendation to the General Conference Committee that the volumes for the 1941 Reading Program be selected at the Spring Meeting. Although certain questions were raised concerning the wisdom of the continuance of this plan, yet it was felt by many that the plan had met with a welcome reception in the field and is of benefit to our membership generally.

VOTED, That the Spirit of Prophecy Reading Program be continued during 1941, and that a committee of five, appointed by the Chair, be asked to submit suggestive volumes for reading during 1941.

STATEMENT ON RELATIONSHIP TO LABOR UNIONS:

The "Statement Concerning the Relationship of Seventhday Adventists to Labor Unions" which had been adopted in the meeting of February 29, was distributed. E.D.Dick reported on contacts recently made with leading labor union officials. Inasmuch as this Statement had already been sent to union and local conference presidents in North America opportunity was given for an expression as to its reception in the field. Various suggestions were made, and it was generally felt that such a statement would be very helpful in the future.

VOTED, To await the reaction of the labor leaders who have been approached on this item, and then give study to revising the Statement, with a view to printing it in leaflet form for distribution to our leaders.

MEDICAL COUNCIL:

It is desired by the Medical Department secretaries and by medical workers that a Medical Council be held in the near future, where problems of mutual interest may be discussed. It may be advisable to postpone the meeting of Nursing Administrators called for May 19-21, and hold it in connection with the Council.

VOTED, That Dr. H.M.Walton, L.H.Christian, E.D.Dick, Miss Kathryn Jensen, and the union conference presidents who have medical institutions in their territories, constitute a committee to give study to the holding of a Medical Council, and the time and place of such a meeting.

Adjourned at 5:30 P.M., with the closing prayer by W.B. Ochs.

ADDITIONAL MEMBERS PRESENT:

C.S.Longacre.

"Nearer, My God to Thee," was sung to open the devotional service, which, conducted by Elder Spicer, occupied the first thirty minutes of the morning session.

Elder Spicer's message was one of faith and confidence in the certainty of the soon appearing of the Lord Jesus, and of admonition to faithfulness in the work committed to us, of preparing a people to meet the Lord. We have never before seen such things as we see today, and the events that are taking place in the world with such suddenness are but signs that the coming of the Lord is hastening on. That is the event we are looking "For unto for, and upon which we must keep our eyes fixed. those that look for Him shall He appear again the second time without sin unto salvation." "Great pains should be taken," we are told in the Spirit of prophecy, "to keep this subject before the people. The solemn fact is to be kept not only be -. fore the people of the world, but before our own churches, that the day of the Lord will come suddenly, unexpectedly." And, "Let no one feel that he is secure from the danger of being Again quoting, from "Prophets and Kings," "While surprised. all the world is plunged in darkness, there will be light in every dwelling of the saints. They will catch the first light of His second appearing." One of the most important things we have to do, said Elder Spicer, is to keep the light of the hope of the coming of Jesus burning brightly in the homes and hearts of Seventh-day Adventists, and to do that we as workers must be prepared and ready ourselves.

Elders Wilcox, Kern and Dick led in a season of prayer, especially remembering our work and workers in the war-torn fields of Europe.

Taking up the business of the forenoon, the first item was the appointment of a committee on Special Days and Offerings, and it was

VOTED, That the Chair appoint a committee to bring in recommendations regarding the Calendar of Special Days, Offerings, and Campaigns for 1941.

SPANISH SCHOOL:

Attention was called to the fact that tentative plans for the establishment of a school for the training of Spanish workers have been before us for quite a long time, but that these plans have mever been finalized. H.A.Morrison and H.D.Casebeer told of the very great meed for such a school, and of the advisability of its being located where those who come for training will be in their own natural environment. H.T.Elliott reported concerning funds which the Bureau of Home Missions is prepared to allot to the establishment of the school.

VOTED, That a committee be appointed by the Chair, to give study to the matter, and make definite recommendation concerning the establishment of a Spanish training school.

SUSTENTATION FUND SURPLUS:

The following recommendation, introduced by the Treasurer was adopted:

WHEREAS, The Sustentation Fund is a fund that is held in trust for our conferences and institutions in North America, to be used in assisting sick and aged workers, and the needy widows and children of deceased laborers; and

WHEREAS, There has been accumulated over a period of years a larger surplus in this fund than seems necessary, and the percentages now being paid to the fund by our conferences and institutions appear to be sufficient to meet the present disbursements to beneficiaries; and

WHEREAS, It appears consistent that since any reduction of the present surplus should benefit the organizations which have helped to create it; therefore

We recommend, That in order to adjust the present surplus of the Sustentation Fund, we refund to each conference, publishing house, book and Bible house, sanitarium, college and academy in North America, a sum equivalent to the amount paid to or due to the Sustentation Fund for the months of January, February and March, 1939, it being understood that should any of the organizations named be owing the Sustentation Fund, the amount refunded shall apply on such indebtedness.

BOOKS FOR 1941 MISSIONS EXTENSION CAMPAIGN:

VOTED, That the Chair appoint a committee of seven to give consideration to, and report concerning the books to be used in the 1941 Missions Extension Campaign.

VICE-PRESIDENT FOR NORTH AMERICA:

The committee that was appointed to nominate a Vice-President for the North American Division, submitted the following recommendation, which was adopted:

Your committee appointed to make provision for the leader ship of the work in North America recommends that W.G.Turner be appointed as Vice-President for the North American Division, to serve in the interim between now and the next General Conference Session.

REVISION OF CURRICULUM OF SECONDARY SCHOOLS:

H.A.Morrison, secretary of the Department of Education, reported that the committee appointed by the 1937 Autumn Council, on revision of the curriculum of our elementary schools, has completed its work, and the Department is now desirous that a revision of the secondary curriculum shall be undertaken. This work should be assigned to a representative committee of nine or ten members, who would meet and study the problem and make assignments, and then meet once or twice again during the two years that it would probably take to complete the work.

VOTED, To refer to the Minority Committee the appointment of a committee on revision of the curriculum of our secondary schools.

BIBLE TEACHING IN OUR SECONDARY SCHOOLS:

W.H.Teesdale outlined a plan which the Department of Education hopes may lead to the strengthening and unifying of the Bible teaching in our secondary schools, in which field in some of the schools the same methods are being used that were followed years ago, whereas other teachers are following new methods of teaching the same truths. It is felt that something should be done towards revising plans and methods before there is a wide diversity of practice on the part of our teachers.

VOTED, That we approve of the suggestion by the Department of Education, looking toward the strengthening and unifying of the Bible teaching in our secondary schools; that it be left with the Minority Committee and the Department of Education to work out the plan in detail; and that we ask the union and local conferences and institutions concerned to cooperate in the plan.

Adjourned at 12 o'clock noon, with the closing prayer by E.H.Oswald.

After the opening song, the Chairman read from "Testimonies to Ministers," page 49, a part of the excerpt reading as follows: "The church, enfeebled and defective, needing to be reproved, warned and counseled, is the only object upon earth upon which Christ bestows His supreme regard."

CHURCH HYMNAL:

Report was made by I.H.Evans concerning the selection of hymns for the new church hymnal, announcing that this work has now been completed. It is necessary to secure permission for copyright on two hundred of the 660 hymns to be used in the book. It will doubtless take some months to obtain this permission. The Review and Herald Publishing Association has in hand sufficient stock of "Christ in Song" to meet the demand for twelve to fourteen weeks. Suggestion was made that in case of need for further copies of "Christ in Song," after the supply is exhausted, prior to the completion of the printing of the new hymnal, rebound copies of "Christ in Song" could be used to supply the need.

VOTED, To authorize the discontinuance of the publication of "Christ in Song," with the understanding that the Review and Herald Publishing Association make such provision as is necessary to meet the demand for these books; and that we authorize the publication of the new song book as the denominational hymnal.

AUTUMN COUNCIL GENERAL CONFERENCE SESSION TIME OF UNION CONFERENCE SESSIONS:

Attention was called to items on the Agenda referring to the Autumn Council, General Conference Session, and time of Union Sessions, and it was

VOTED, To refer these items to a committee as follows: L H Christian, E D Dick, W E Nelson, H T Elliott, W G Turner, and the North American union presidents, with J.L.McElhany.

Adjourned at 3:25 P.M., to give opportunity for subcommittees to meet.

FOUR HUNDRED SEVENTY-FIRST MEETING

GENERAL CONFERENCE COMMITTEE

April 11, 1940, 8:30 A.M.

"In a Little While We're Going Home" was sung to open the meeting.

F.M.Wilcox, who led in the devotional service, referred to the admonition of Moses to Israel just before he was taken away, that they should remember the Lord who had led them during the forty years in the wilderness, and how in a very short time they forgot this admonition and departed from God. The people served the Lord all the days of Joshua. But Joshua died, and a new generation arose, which knew not the Lord, nor the things that he had done for Israel. They forgot the faith of their fathers. This experience was repeated again and again in the history of Israel. Repeatedly the Lord called them back, and repeatedly they wandered away. The apostolic church went through the same experience, for the Lord said to the church of Ephesus, "Nevertheless, I have somewhat against thee, because thou hast left thy first love. And all through the centuries every religious movement that has arisen has fallen away from the fundamentals that formed the basis of their existence. Elder Wilcox then spoke of the lowering of certain standards among us, of departure from the simplicity that characterized the early work of this message, and of our need of guarding against these influences The messenger of the Lord has said, "We have nothing to fear for the future, except as we shall forget the way the Lord has led us, and His teaching in our past history." Surely we must not forget. And we should by consistency in our own lives, encourage those who come into the church to remain true and faithful to the principles and standards of the message.

The devotional service closed with a season of prayer.

ATTENDANCE AT FORTHCOMING AUTUMN COUNCIL:

The first item of business was a report from the committee to whom items were referred relative to the next Autumn Council, the General Conference Session, and the Union Conference Sessions. The report of this committee was adopted as follows:

At a meeting of the Minority Committee of the General Conference held March 4, action was taken inviting the presidents of all overseas divisions insofar as may be possible to attend the forthcoming Autumn Council. It was also agreed that the question of the time of holding the next General Conference Session be referred to the Autumn Council, when representatives from these overseas divisions could be present to give counsel on this matter.

April 11, 1940

In view of the possibility of holding the General Conference Session in the spring of 1941, and the desirability, therefore, of not having a large attendance from North America at the Autumn Council preceding the Session,

We recommend, That the attendance at the Autumn Council be limited to the following:

> Members of the General Conference Committee. Presidents of local conferences. Union conference secretary-treasurers and auditors. Union Negro secretaries. Presidents of junior and senior colleges. Leading editors from each of the publishing houses.

GENERAL CONFERENCE SESSION:

Since it is necessary to make reservation for auditoriums and other accommodations suitable for large gatherings well in advance, and since the holding of the General Conference Session in 1941 will not be decided until the forthcoming Autumn Council, which will be too late to secure suitable services,

We recommend, That the Minority Committee in counsel with the union conferences be authorized to make early tentative reservations for an auditorium and other accommodations as may be needed for the holding of the General Conference Session in 1941.

TIME OF UNION SESSIONS:

Since the final decision on the time of the General Conference Session has been referred to the Autumn Council, and inasmuch as the time for the holding of the union sessions is related to the time of the holding of the General Conference Session,

We recommend, That the time of the holding of such sessions be referred to the forthcoming Autumn Council for decision.

MISSIONS EXTENSION CAMPAIGN LITERATURE:

The following report from the committee appointed on Missions Extension Campaign literature for 1941 was adopted:

We recommend, 1. That, in harmony with the suggestion of the recent Nashville Home Missionary Council, for the 1941 Missions Extension effort we favor the plan of having two 25cent, 96-page books for this campaign, and that the entire North American Division unite in the use of the same two books.

2. That one of the books deal with present-day world conditions in the light of Bible prophecy with special emphasis being placed on the Christian's hope, -- the second coming of Christ, and that the other be a book that would make a special appeal to theyouth.

3. That the publishing houses in the North American field work on the basis of an exchange of plates in the production of these books as provided for in the Publishing Department recommendation.

4. That the Brookfield Branch of the Pacific Press be requested to provide two books in a number of the leading foreign languages for use in the 1941 Missions Extension campaign.

MEDICAL COUNCIL:

The committee on the question of calling a Medical Council submitted a report, which was adopted as follows:

We recommend, 1. That the meeting of directors of schools of nursing previously approved to have been held in Takoma Park following a meeting of national nursing associations in Philadelphia, be now canceled.

2. That approval be given for the holding of a Medical Convention in Boulder, Colorado, November 29 to December 4, inclusive. Delegates to this convention will be the personnel of the General Conference Medical Department, such General Conference officers as may be able to be present, the chairmen of the sanitarium boards of management, the medical directors, business managers, directors of the school of nursing and nursing service, and the sanitarium chaplains.

3. The purpose of this convention shall be to study objectives and purposes of sanitarium work, to seek for greater uniformity of practice, to elevate standards of service, to improve morale, and to study varied problems of common interest, including matters of organization, and to further study matters pertaining to nursing education, especially ways and means of more fully preparing nurses to meet denominational standards.

OBJECTIVES AND SPIRIT OF OUR CAMP MEETINGS:

The committee on Objectives and Spirit of our Camp Meetings submitted a report, which was amended and adopted as follows:

Divine counsel has been given as to the objective of our camp meetings, and in detail has outlined methods that will meet the approval of the Spirit of God. Facing the 1940 camp

meeting season, we may well consider this admonition: "Tremendous issues are before us, yea, and right upon us. Let our prayers ascend to God that the four angels may still hold the four winds, that they may not blow to injure or destroy until the last warning has been given to the world. Then let us work in harmony with our prayers. Let nothing lessen the force of the truth for this time. . . Our message is a life-and-death message, and we must let it appear as it is, the great power of God. We are to present it in all its telling force. Then the Lord will make it effectual. It is our privilege to expect large things, even the demonstration of the Spirit of God. This is the power that will convict and convert the scul."--"Testimonies," Vol. VI, p.61.

Your committee spent much time in constructive discussion of the camp meeting program, and respectfully submits the following recommendations as a general guide in the development of plans for the 1940 camp meetings:

1. In the opportunity that the annual camp meeting provides of meeting with so many of our people, and in facing the seriousness of the hour and the need of all for individual heart searching and consecration, we would stress the thought that the camp should provide for every opportunity wherein the spirit of revival shall be emphasized, that all attending may be refreshed and uplifted in the things of God.

2. As the work has grown, the camp meeting program has cutgrown the old-time simplicity, and too often is so congested as to allow little or no time for personal work and quiet meditation. "Do not immediately follow one discourse with another, but let a period of rest intervene, that the truth may be fastened in the mind, and that opportunity for meditation and prayer may be given for both ministers and people."--"Testimonies," Vol. VI, p.56.

3. As far as possible there should be greater continuity of the work of those who bear the burdens of preaching at our camp meetings. Some special lines of work may require but one presentation before the worker passes on to other meetings, but those who are called to carry the heaviest part of instructing the people should, as far as possible, remain throughout the period of the camp meeting in order to have ample time to ascertain their spiritual needs, and do effective work to meet such need.

4. Opportunity should be provided for prayer and personal work. Where such arrangement can be made, district the camp, assigning certain tents, or rooms, to one or more workers whose duty it shall be to minister to the spiritual needs of old and young. Time and place should also be provided where individuals may counsel with ministers, Bible workers or other workers, or have special prayer.

5. Attendance at camp meeting can be greatly increased by community visitation work by selected workers from among the campers. "At some of cur camp meetings, strong companies of workers have been organized to go cut into the city and its suburbs to distribute literature and invite people to the meetings." --"Testimonies," Vol. VI, p. 36.

6. One benefit accruing from our camp meetings is the opportunity afforded our people to secure our literature. We therefore recommend that there be at least one good "book sale," but that we discourage a growing tendency to make each general service an occasion for selling a book or pamphlet. Nor do we believe it is good promotion to decorate the preaching pavilion constantly with a variety of posters or placards advertising our good books and periodicals.

7. With rare exceptions, the evening services should be devoted to the presentation of evangelistic topics. Where pictures are to be shown, let such be presented for twenty or thirty minutes <u>before</u> the time of the evening preaching service, using what would otherwise be the song-service time.

8. Throughout the years our people have gone to camp meeting prepared to respond to an appeal for liberal gifts to foreign missions. This old-time spirit of interest in our worldwide work should be carefully nurtured during the camp meeting, and on one, or both Sabbaths of the meeting, an offering for missions should be taken; care being exercised that the appeal for the offering shall be made in such a way as not to spoil the spiritual influence of the meeting.

9. Camp meeting music should be a vital phase of the spiritual work of the meeting. Therefore we suggest that a responsible committee, answerable to the conference committee, clothed with authority, be asked to direct in the appointment of musicians and singers, and to pass on the merits of all special musical contributions to the service programs; and further, that we encourage more congregational singing.

CREDENTIALS TO THOSE ENGAGED IN PRIVATE BUSINESS:

A committee that was appointed on a question concerning credentials, submitted the following recommendation, which was adopted:

In response to the question raised by the field relative to men once ordained, but who have left full-time evangelistic ministry to enter private professional work or business, and as to whether such should be granted credentials for assisting in local church work as elders or otherwise, we are of the opinion that the Working Policy of the General Conference makes no provision for the granting of credentials to such individuals, as they are not under or subject to the direction of any denominational body. Therefore

PRIMCIPLES OF PROTESTANTISM

AND SEPARATION OF CHURCH AND STATE:

The committee appointed to draft a statement on Principles of Protestantism and Separation of Church and State, submitted a Statement, and recommendations, which were adopted as follows:

We recommend, 1. That in view of world developments that point to the soon-fulfillment of Revelation 13, the accompanying Statement, "The Impending Conflict and Our Responsibility," which seeks to arouse our people to a clearer realization of the impending crisis and our responsibilities in relation to this crisis, be sent to all our churches in North America.

2. That we ask the Religious Liberty Department of the General Conference to foster the preparation of a special, inexpensive piece of literature dealing with this crisis, and that

our ministry and people be encouraged to give this a circulation of not less than two million copies.

3. That our ministers and others be invited to send in to the Religious Liberty Department any significant newspaper clippings or magazine articles they find that throw light on the fulfillment of Revelation 13, and that in turn the best of this material be made available to our whole ministry.

4. That our ministry be encouraged to give special attention to the prophecy of Revelation 13 in their preaching to c our own people, in their evangelistic efforts, and at the coming camp meetings. Further, we suggest to the editors of our journals that they capitalize the present opportunity, to enlighten both our own people and the world on this subject.

5. That so far as it is possible to do so, without compromising our principles, we respond favorably to the invitation of certain Protestant leaders to cooperate with them in an educational movement in behalf of the Protestant principle of the separation of church and state.

THE IMPENDING CONFLICT AND OUR RESPONSIBILITY

On every side fast fulfilling prophecy meets our eyes. Wars and rumors of wars rivet our attention. Calamities by land and nea and other startling signs become increasingly the topic of our conversation. All these omens of the end are intended of God to arouse us by their very magnitude and spectacular nature. But thile we are gazing, spellbound, at these tremendous happenings, we should remember that other signs, equally significant, are being fulfilled also, and that there is danger that we may fail to sense their import because of the stealthy way in which they have been creeping upon us. We think particularly of the events that have been shaping themselves for the fulfillment of the prophecy of Revelation 13.

If there is one prophecy above another that ought to stir us, it is the inspired forecast concerning the healing of the "deadly wound" and the making of an image to the beast. Revelation 13 describes the last conflict between good and evil in this world, a conflict in which we shall be called upon to play a most solemn part. And because we believe that this proohecy does portray the very last events we have always considered that any evidence of its soon-fulfillment is equally an evidence that the end of all things is nigh at hand.

Recent developments provide vivid proof that the day of the complete fulfillment of this prophecy is very near. For example, the collapse of liberty with resulting civil and religious persecution; the growing power of the Papacy; the widespread apostasy in Protestantism coupled with an almost complete loss of conviction concerning the principles of Protestantism; and, lastly, the sending of an ambassadorial representative by the President of the United States to the Vatican.

If we are to be able to stand in the impending crisis we must be developing the kind of faith and the kind of character that will enable us to choose prison and persecution, if need be, rather than to deny our faith. There is need also, that all of us become more diligent students of prophecy. We must be able to discern rightly the signs of the times if we are to be protected from the almost overmastering delusions of Satan that will finally take the world captive. Likewise, we need to refresh our minds on the basic principles that distinguish Protestantism and concerning the history of its providential beginnings.

We need to sense with new force that if we intend, under God, to accomplish our task of completing the unfinished Reformation we must put new energy and fervor into our endeavors. As bearers of the third angel's message we are to warn men against worshipping the beast and his image. If ever these words had meaning and timeliness it is today. We have a message on religious liberty for the world. When could we expect to find the time more ripe for the preaching of that message?

There is nothing in our view of fulfilling prophecy that permits us to sit in resigned piety awaiting the storm. While we should always be resigned to the will of God, we should never be resigned to the will of Satan; and it is the display of Satan' scheming that is revealed in a very special way in the thirteenth chapter of Revelation. Declares the servant of the Lord:

"Let none sit in calm expectation of the evil, comforting themselves with the belief that this work must go on because prophecy has foretold it, and that the Lord will shelter His people. We are not doing the will of God if we sit in quietude, doing nothing to preserve liberty of conscience."--"Testimonies, Vol. 5, page 714.

"While the Protestant world is by her attitude making concessions to Rome; let us arouse to comprehend the situation, and view the contest before us in its true bearings. Let the watchmen now lift up their voice, and give the message which is present truth for this time. Let us show the people where we are in prophetic history, and seek to arouse the spirit of true Protestantism, awaking the world to a sense of the value of the priv ileges of religious liberty so long enjoyed."--Id. Page 716.

There should be a concerted endeavor on the part of the membership in all our churches to carry out this inspired instruction. But with all our earnestness and vigor in proclaiming the truth on Revelation 13, there should be coupled good sense and prudence. We should not forget that we are dealing with a prophecy not yet completely fulfilled, and we must eschew the alluring temptation to fill in details of future developments that are not clearly revealed in the prophecy. We must never substitute our imagination for divine revelation, for thereby we only weaken our cause and subject it to possible ridicule. We need not depart from the simple outline of the prophecy and the evident facts of current history in order to preach a stirring and convicting message to the world.

Furthermore, we need to be on our guard lest in our preaching of Revelation 13 we appear to be political agitators. The servant of the Lord warns us "not to say or do anything that would necessarily close up our way."--"Gospel Workers," p. 390.

The critical happenings of our day and the signs of the impending conflict call upon all of us to greater holiness in our own lives and greater activity in proclaiming the message God has given to us. Should we not adopt as our own the words of our Lord: "I must work the works of Him that sent me, while it is day: the night cometh, when no man can work"? John 9:4.

FOUR HUNDRED SEVENTY-SECOND MEETING

GENERAL CONFERENCE COMMITTEE

April 11, 1940, 4:15 P.M.

"Wholly Thine" was sung as the meeting opened. W.K.Ising left in prayer.

SPANISH SCHOOL:

The committee appointed to give study to the question of special training for Spanish young people, submitted a report, which being amended, was adopted as follows:

In harmony with previous actions of the General Conference Committee authorizing establishment of a Spanish training school,

We recommend, 1. That it be located in a Spanish environment, in the Southwestern area of the United States.

2. That it be owned and operated by the Pacific and Southwestern Union Conferences.

3. That the constituency of the school be composed of five members selected by the Pacific Union Conference Committee, five members selected by the Southwestern Union Conference Committee, two members selected by the Central Union Conference Committee, and of any other members of these three above-named union conference committees and of any member of the General Conference Committee who may be present at any meeting of the constituency.

4. That the managing board of this mission training school, when and if organized, consist of three members of the Pacific Union Conference Committee, three members of the Southwestern Union Conference Committee, the Secretary of the Bureau of Home Missions, the Secretary of the Spanish Department of the Bureau, the Secretary of the Department of Education of the General Conference, and the President of the North American Division.

5. That the first meeting of the proposed constituency be called May 6, 194C, at El Paso, Texas.

6. That the General Conference Treasurer, the President of the North American Division, the Secretary of the Bureau of Home Missions, the Secretary of the Spanish Department of the Bureau, and the Secretary of the Department of Education of the General Conference, be authorized to join the constituency in this meeting, W.G.Turner serving as temporary chairman.

MISSIONARY VOLUNTEER EVANGELISTIC CONGRESS:

The following recommendation was presented from the Missionary Volunteer Secretaries' Council, held just prior to this Spring Meeting:

WHEREAS, "Time is short. Workers for Christ are needed everywhere. There should be one hundred earnest, faithful laborers in home and foreign fields where now there is one. The highways and byways are yet unworked. . . The Lord calls upon our youth to labor as canvassers and evangelists, to do house-tohouse work in places that have not yet heard the truth"; and

WHEREAS, Similar gatherings of Christian youth in other parts of the world field have demonstrated their value to inspire and to unite advent youth in Christian service; therefore,

We recommend, That the General Conference Committee give consideration to the matter of arranging for a North American Evangelistic Youth's Conference which would bring together a selected and delegated body of representative Missionary Volunteers for instruction and inspiration, with the purpose of sending them back to their respective churches imbued with the spirit of personal devotion and evangelism; the time, place, and arrangements for such an Evangelistic Youth's Conference to be studied by a representative committee appointed by the General Conference Committee.

VOTED, That the above recommendation be referred to the General Conference Committee, for report at the Autumn Council.

LITERATURE AND METHODS IN HARVEST INGATHERING:

Attention was directed to the difficulties experienced in certain unions with reference to expressions used in literature prepared for promotion purposes in the Harvest Ingathering Campaign, which some feel do not give a correct impression. It was stated that at times funds are solicited ostensibly for welfare work whereas in actuality they^{ar}fised for mission work.Following a discussion as to the purpose and propriety of the methods now used for Harvest Ingathering, it was

VOTED, That this item of Literature and Methods in Harvest Ingathering be referred to the Minority Committee for further study.

T.H.OKOHIRA--RESOLUTION:

The Secretary made mention of the word that had been received some time ago of the death of Elder T.H.Okohira, in Tokyo, on the 7th of December. Elder Okohira was one of our pioneer missionaries to Japan. As a young man he had come to the United States with a business career in view. Here, however,

he found the truth and returned later to take the message to the people of his own country, where for forty-three years he labored earnestly and successfully for the upbuilding of the church.

RESOLVED, That we record our appreciation of the devoted, Christian life and the faithful and fruitful service of Brother T.H.Okohira in the Japanese field, and hereby extend to the sorrowing relatives and friends who mourn his loss our deepest sympathy.

TIME OF SURVEY OF COLLEGE OF MEDICAL EVANGELISTS:

W.E.Nelson as chairman of the commission appointed to survey the College of Medical Evangelists reported it is planned to hold the survey at an early date, and that the definite time would be announced as soon as possible to the members of the Survey Commission.

MEDICAL CADET CORPS COUNCIL:

It is desired to call a meeting of the Medical Cadet Corps Council while the delegates from the field are in. Inasmuch as J.L.McElhany, the chairman, is unable to call the Council together at this time, suggestion was made that a temporary chairman be appointed.

VOTED, That E.D.Dick be appointed as chairman temporarly with the understanding that a meeting of the Medical Cadet Corps Council be called.

SPIRIT OF PROPHECY READING PROGRAM VOLUMES FOR 1941:

The committee appointed to recommend volumes for the 1941 Spirit of Prophecy Reading Program presented the following recommendation, which was adopted:

We recommend, That the Spirit of Prophecy Reading Program volumes for 1941 be "Patriarchs and Prophets," and "Messages to Young People."

RECREATION FOR YOUNG PEOPLE IN BASEMENT OF CHURCH:

Request for counsel has come from the field as to the propriety of using the basement of a church for recreational purposes for young people. Questions have been raised also as to the holding of meetings for progressive class work in basement rooms of our churches. Certain churches have refused to grant our young people this privilege. As the question involves the spirituality of our young people, it is one that deserves careful study.

VOTED, To request the Minority Committee to give study to the question of recreation for young people in the basement of our churches, and to appoint a committee to bring in a report to the Officers' Meeting preceding the Autumn Council.

ELLEN G. WHITE PUBLICATIONS:

In view of limited time, the reading of the report on the work of the Ellen G.White Publications was waived, with the understanding that a mimeographed copy of the report would be later placed in the hands of the delegates. Noteworthy among the facts given are the following:

During the year 1939 the preparation of two new manuscripts has been completed, ---"Counsels on Stewardship," and "Counsels to Editors." Work is progressing on a history of health reform. A number of Mrs. E.G.White's books have been translated and printed in foreign countries. Over five thousand copies of the larger books have been sold by colporteurs. Fortyone thousand books have been placed in the homes of our people as compared with twenty-two thousand the preceding year. From ten to twenty per cent of our members have joined in the Spirit of Prophecy Reading Program, the plan having been adopted in nearly all the world divisions. A representative of the office has visited several of our schools in an intensive Spirit of Prophecy program, and the response has been gratifying. The work of the office has been carried on within the budget for the year.
