MILITARY POSTS--SALE OF ALCOHOLIC BEVERAGES:

Inasmuch as it is reported that an order was issued on September 4, 1953 by Major General William E. Bergin, Adjutant General, authorizing the sale of alcoholic beverages on United States military posts, it was

VOTED, That the following statement of protest be forwarded to the Secretary of Defense of the Government of the United States:

The Seventh-day Adventist Church has through the years derived considerable assurance from the provisions of the Federal law of February 2, 1901 (Title 10, United States Code, Section 1350) which provides that

"The sale of or dealing in beer, wine, or any intoxicating liquors by any person in any post exchange or canteen or army transport or upon any premises used for military purposes by the United States, is prohibited. The Secretary of War is directed to carry the provisions of this section into full force and effect."

It is our firm conviction that this is a wise measure, and that its enforcement has done much to safeguard the character and morals of those in the armed forces, and to keep before the world the ideals of dignity and sobriety which are indispensable to the nation's greatness.

September 10, 1953

It is with disappointment, dismay, and alarm, therefore, that we learn of the order issued September 4, 1953, by Major General Wm. E. Bergin, Adjutant General, authorizing the sale of alcoholic beverages on military posts. This we believe constitutes a flagrant and open violation of Federal law, is against the expressed mandate of the people of the United States and if tolerated will contribute substantially to the success of those iniquitous forces of disorder, immorality, lawlessness and corruption against which it is the solemn duty of every conscientious citizen most earnestly to contend.

The General Conference Executive Committee of Seventh-day Adventists hereby registers its vigorous protest against the implementation of General Bergin's order, and calls respectfully upon the Secretary of Defense to take prompt and adequate measures to see that the Federal law of 1901 covering the sale of alcoholic liquors to service personnel is maintained "in full force and effect."

SEMINARY EXTENSION COURSE--INTER-AMERICA:

VOTED, That in response to the request of the Inter-American Division we authorize the Theological Seminary to conduct an extension course in Inter-America during the summer quarter of 1954.

DANIEL WALTHER--VISIT INTER-AMERICA:

VOTED, That Daniel Walther be authorized to visit Inter-America during the time of the Theological Seminary winter quarter, December, 1953 to February, 1954, where he will meet appointments in the French-speaking areas of the West Indies.

ARMY LIQUOR SALES--PROTEST:

VOTED, To continue our protests against the September 4 order of Adjutant General Bergin authorizing liquor sales on army posts, adopting the following means:

1. A letter to the President of the United States, as follows:

"The Executive Committee of the General Conference of Seventh-day Adventists respectfully and earnestly protests against the sale of alcoholic beverages on Army posts. The recent order of the Adjutant General authorizing the practice has shocked and dismayed us. We join with thousands of our fellow citizens in the conviction that such a measure if allowed to stand will prove positively detrimental to the true interests of the nation and will seriously affect the prestige of our military forces both at home and abroad.

"We submit the following as strong reasons for our protest, and are persuaded that by bringing them to your attention you will be moved as Chief

Executive to safeguard the people against an unwarranted violation of their expressed will as well as of those orderly processes of government upon which we rely for our liberty, safety and security.

- "1. The order of September 4 by Major General William E. Bergin, Adjutant General, is in direct violation of the Federal law of 1901 (Title 10, US Code, Section 1350) prohibiting the sale of intoxicating liquors upon any premises used for military purposes by the United States.
- "2. The order is contrary to the intention of Congress as revealed in the Congressional Record of April 13, 1951.
- "3. The order is promulgated during the recess of Congress and so far as we can determine is in total disregard of the wishes of the legislative branch of the government.
- "4. Construction of liquor bars and sales counters is being rushed in order for them to be open for business December 1, before Congress convenes. Any opposition from the Congress will therefore be confronted by the fact that the sale of liquor is actually in effect, thus greatly hampering any proper legislative treatment of the question.
- "5. The order will in practice, we believe, provide no protection against the consumption of liquor by minors but will place the Army of the United States in the position of subjecting them while on the premises of the government they serve, to the influence and temptation of the liquor habit.
- "6. The order puts the government further in business, a situation which we understand is contrary to the avowed aims of the administration.

"Our committee therefore, Mr. President, with every assurance of sincere regard and loyalty, without being unmindful of the problems which constantly press upon the Chief Executive for attention, but deeply convinced that this of which we speak is one which closely affects the efficiency of our armed forces, the welfare of our citizens and the future of our country, is constrained to lay it before you in the confident hope that it will receive your early and decisive attention.

"Most respectfully,"

- 2. A telegram to the Chairmen of the House and Senate Armed Services Committees, as follows: SEVENTH-DAY ADVENTISTS PROTEST ADJUTANT GENERAL'S SEPTEMBER 4, 1953, ORDER PERMITTING LIQUOR SALES ON ARMY POSTS. THIS VIOLATES FEDERAL LAW. IT IS CONTRARY TO CONGRESSIONAL INTENTION AS REVEALED IN UMT DEBATE OF APRIL 13, 1951 AND IS AN OUTRAGE OF SAFEGUARDS PARENTS RIGHT-FULLY EXPECT FOR THEIR SONS AND DAUGHTERS IN SERVICE.
- 3. Telegrams to representatives, senators and governors selected by the American Temperance Society as likely to be helpful, the messages to be substantially as follows: REPORTS COMING INTO OUR OFFICE INDICATE RISING STORM OF PROTEST AGAINST ADJUTANT GENERAL WILLIAM E BERGIN'S ORDER OF SEPTEMBER FOUR PERMITTING SALE OF ALCOHOLIC BEVERAGES ON ARMY POSTS. EARNESTLY REQUEST YOU USE YOUR INFLUENCE IN PREVENTING THE EXECUTION OF THIS ORDER.

- 4. Letters from the officers to the Missouri Conference since Missouri is the home state of Dewey Short, chairman of the House Armed Services Committee, and the Southern New England Conference, Massachusetts being the home state of Leverett Saltonstall, chairman of the Senate Armed Services Committee, urging the conferences to issue a public statement, to ask church leaders to mention the matter at a Sabbath service, and to encourage our constituency to wire or write Representative Short and Senator Saltonstall in protest. Detailed information and instruction will be supplied the field by the Temperance office.
- 5. Letters from the officers to the union conference presidents, with detailed information, urging them to give publicity in pulpit and press to the protest of the church.
- 6. A statement to be released to the press answering the charge that we are being used by the retail liquor interests.
- 7. A message to Dr. John A. Hannah, Assistant Secretary of Defense for Manpower, who released a statement to the press asserting that retail liquor dealers had been "using" church groups and organizations to oppose the authorization of liquor sales on military posts.

VOTED, That Dr. and Mrs. John W. Schnepper, already under deferred appointment for overseas service, be invited to connect with the Manila Sanitarium, he for surgical work and she as an enesthetist.

STANLEY L WILKINSON--PENANG MISSION HOSPITAL:

VOTED, To invite Dr. Stanley L. Wilkinson of Midwest, W yoming, to connect with the Far Eastern Division and the Penang Mission Hospital for the practice of internal medicine.

D J DUNNETT--CARIBBEAN TRAINING COLLEGE:

REFUGEES--ASSISTANCE:

The Refugee Relief Act of 1953 provides for visas to be granted by the United States for certain classes of individuals now living as refugees in Germany, Italy, Greece, and the Orient to enter this country to establish their homes. Among these persons are a number of Seventh-day Adventists.

VOTED, That plans be laid to assist up to three hundred such families to find refuge in the United States, referring to the Budget Committee the provision of funds for the necessary financial assistance.

DAPHNE E BROWN--SPONSORSHIP:

VOTED, On request of the Inter-American Division, that we grant the sponsorship required by the Government for Miss Daphne E. Brown to enter the United States on a student visa.

ROBERT W LINK--LONDON EVANGELISTIC EFFORT:

Link to the Northern European Division for a period of three or four months to serve as singing evangelist in the London effort which is to open October 15, 1953.
