The Chairman, Theodore Carcích, read Matthew 6: 34. He said that he understands this scripture to teach that we are to follow Christ day by day, one day at a time. God supplies strength for just one day at a time. God does not bestow help for tomorrow. "Give us this day our daily bread." He read also Proverbs 30: 8 and Exodus 16: 4. When the people of Israel gathered too much manna and tried to save it for tomorrow, the record says it bred worms and stank. Likewise, hoarding in our day is taken care of by moths and rust. Regarding strength, wealth, counsel, work, enough is granted just for today, and we should use such today. There is today's strength for today's work; today's grace for today's victories; today's balm for today's sorrow; today's counsel for today's problems.

A quotation from page 313 of <u>Desire of Ages</u> was read which states that "God does not bestow help for tomorrow. He does not give His children all the directions for their life journey at once, lest they should become confused. He tells them just as much as they can remember and perform. The strength and wisdom imparted are for the present emergency." Elder Carcich closed with the admonition that we do not cross our bridges before we come to them. Let us not imagine disaster and defeat for the future. It is ours to live victoriously today. It is ours to solve the problems of today, and for that God promises help and strength.

R. S. Watts, Chairman, called attention to an experience that came to the Kings of Israel and Judah, as recorded in 1 Kings 22, an experience from which we can draw a lesson or two. Jehoshaphat was the King of Judah; and Ahab was the King of Israel. Jehoshaphat and Ahab had a council together. They agreed to join forces and enter into a war against the King of Syria. One of the cities of Israel, a City of Refuge, had been taken by the King of Syria. They were anxious to reclaim Ramoth-Gilead. Jehoshaphat, being a truer man of God, a truer King, suggested they call in a prophet. Ahab called in four hundred men, not prophets of Baal. Jehoshaphat heard their decision, saying "Go up; for the Lord shall deliver it into the hand of the king." It seemed to him there was too much uniformity. He rather suspected they were trying to please the King and be on the popular side.

Jehoshaphat inquired of Ahab as to whether there was some one else to whom they could turn. Ahab did refer to Micaiah, but he said "I hate him; for he doth not prophesy good concerning me, but evil." This caused Jehoshaphat to think a little more seriously that he ought to call in this man. So they called him in. He was being conditioned before he came in before the kings. Micaiah said "As the Lord liveth, what the Lord saith unto me, that will I speak." We cannot help but admire this, a true man of God. Nothing could intimidate him. The only thing that could influence him was a message from God. He was not going to be influenced by the flattery or bribery from the King. His characteristics are true and noble ones, which ought to be exemplified in the lives of all of us. He was not afraid to stand up and be counted when the time came. We face great problems among our believers, and sometimes among workers—those who have a spirit of conformity. As we face the difficult problems, let us remember the experience of this prophet who stood alone, and whose prophecy was fulfilled. He was unafraid in spite of the prophets that were prophesying contrary to him. We should be men of courage and faith today.

Portions of Isaiah 58, from the Revised Standard Version of the Bible, were read by R. S. Watts, Chairman. This is a chapter that the Servant of the Lord has repeatedly told us we ought to read and study. It points out the practical aspects of true godliness. Judah as a nation outwardly professed to follow the Lord, but inwardly the people were far from God. Here you find an incongruous attempt of people who tried to serve God and mammon at the same time. They wanted all the world had to offer, and to enjoy heaven, too. They desired the privilege of obedience, but were loath to assume its responsibilities.

Elder Watts read a quotation from page 42 of Welfare Ministry in which it states that true religion "consists not in systems, creeds, or rites, but in the performance of loving deeds, in bringing the greatest good to others, in genuine goodness. ... Unless there is practical self-sacrifice for the good of others, in the family circle, in the neighborhood, in the church, and wherever we may be, then whatever our profession we are not Christians." There are many avenues whereby Seventh-day Adventists can demonstrate what they can do for the good of others. The Farm Journal for September, 1964, contains an article by Dick Seim entitled "Meatless Days--They're Here and They're Not Bad." This reports a "taste panel" of editors who "chewed samples of 'beef,' 'chicken,' and 'ham, "and their reactions were mostly favorable. These samples were described as "meatlike foods derived from soybeans." This article points out potential human food growing on every acre of beans.
