A. J. HABIBI, M.D. PLANS 66/40

VOTED, To recommend to the Iran Section that A. J. Habibi, M.D. return to Iran while he awaits the results of the medical examinations taken at the A. U. B., and if he finds it necessary to take further study for future examinations, that he do so in Tehran; if he is successful in the examinations taken and is accepted in the U. S. for an internship, that he leave from his home country--Iran.

PURCHASE OF 1966 SABBATH SCHOOL DEPARTMENT FILM 66/41 <u>VOTED</u>, To authorize the Sabbath School Department to purchase the 1966 General Conference Sabbath School film.

KERAK RENT CEILING 66/42 VOTED, To raise the rent ceiling in Kerak, Jordan to 35 per cent on recommendation of the Jordan Section Committee.

COLPORTEUR
COLLECTION PLAN
66/43

VOTED, To authorize D. L. Chappell to inform the local Sections that the Colporteur Collection Plan is proving successful and that it is highly recommended by the Division. If they wish to implement this plan they should contact Elder Chappell so that he can help them to put it into action and follow it up. Fields desiring to use this plan should submit their request to the Middle East Division.

AUTOMOBILE POLICY REVIEW 66/44 VOTED, To recommend that an amount up to 50 per cent of the customs duty on a new small (1300) Volkswagen, in the country where purchased, be paid to a worker who has been authorized an automobile, to help him with the additional expenses involved in purchasing an automobile, this to be granted once within a 5-year period and to be effective January 1, 1966.

MEDICAL EXPENSE POLICY 66/45

VOTED, To recommend that when a person desires to purchase contact lenses instead of regular glasses, the medical assistance be paid on the amount that regular glasses would cost as the examining physician would prescribe. Glasses, as a rule, should not be changed oftener than every two years.

UTILITY ALLOWANCE POLICY 66/46

VOTED, To recommend that married workers shall pay the equivalent of the first LL 147.50 of their total utility bills including fuel, gas, electricity, and water, the balance to be shared by the employing organization and the worker on a 75/25 per cent basis. The worker would pay the smaller amount.

Single workers living alone or sharing an apartment with another worker, will pay the equivalent of the first LL 115.00 of their total utility bills, the balance to be shared by the employing organization and the worker on a 75/25 per cent basis, the worker paying the smaller amount.

The worker must submit receipted bills when claiming the utility allowance. Bills may be submitted as of June 30 and December 31 each year.

Single workers living with their families may receive a utility allowance equivalent to LL 5.00 per month. No receipts required.

This policy is to be effective as of January 1, 1966 where the field is capable of handling such expense.

VACATION POLICY 66/55

<u>VOTED</u>, To approve the following revision of the Vacation Policy:

All regular full-time Seventh-day Adventist workers who are in denominational employ may be granted a vacation of 14 consecutive days each year on salary, as arranged for by the officers and approved by the controlling committees or boards. All travel and other expenses involved are considered to be personal. In principle, it is understood that vacations are granted after completion of one year of denominational service. These arrangements should be made in the first quarter of the year.

Workers shall take vacations during the calendar year with the exception that one week (7 days) of vacation time may be carried over to the succeeding year on prior approval of the controlling committee or board.

An additional one-week (7 days) vacation may be allowed workers who have put in 15 years or more of continuous full-time denominational service. It is understood that in no case will a vacation exceed 28 consecutive days in one year.

In the case of a worker who has not had continuous service it is required that he have a total service of one year additional to the 15 for each year that he has been out of denominational employ in order to qualify for the three-week (21 days) vacation in harmony with the principle followed in reckoning the period for sustentation eligibility.

In transferring workers, the vacation should be considered in working out the settlement between the two organizations or institutions involved. Otherwise, the organization employing the worker at the time the vacation is taken will be responsible.

Workers desiring to take their vacation outside the Division territory should have the approval of the Division Committee, except Benghazi workers visiting Greece.

Part-time workers, who work half time or more, will be given an annual vacation in proportion to the time they have worked.

Exceptions

In some areas climatic conditions prevail that are adverse to the health and well being of the worker. Often it is necessary to travel long distances in order to reach an area of moderate climate. In view of these facts, certain exceptions to the Vacation Policy are granted. The following are the exceptions to the Vacation Policy:

Non-Libyans working in Benghazi will receive an additional one-week (7 days) vacation every second year with a transportation allowance equal to 50 per cent of the round-trip tourist air fare to their home within the Middle East.

Workers in Aden, Iraq, Khuzistan, Kuwait, and Sudan will receive a basic vacation of three weeks (21 days) per year. Those who are working outside their home country will receive an additional one-week (7 days) vacation every second year with a transportation allowance equal to 50 per cent of the round-trip tourist air fare to their home within the Middle East.

Workers living in one of the above areas who are entitled to a three-week (21 days) vacation because of having 15 or more years of service shall be entitled to add one week (7 days) to the length of vacation stated for their particular field, but four weeks (28 days) shall be the maximum length of vacation under the application of any provision of this policy including the carry-over of 7 days from the previous year.

The transportation allowance is for the worker and his dependent family. It is paid for travel that is actually undertaken. It is not accumulative, and is forfeited if not used during the calendar year in which the vacation is due. If the worker prefers to take the trip to his homeland every four years instead of every two years, the transportation allowance will be increased to 100 per cent. It is understood that the 7 days additional vacation time allowed in the policy is for travel time to be taken in connection with the worker's visit to his homeland.

Educational Workers

Regular full-time educational workers shall be entitled to the same vacation privileges as any other regular full-time worker. The principal of the school shall be responsible to provide work assignments for educational workers under his/her direction on days during the school year when classes do not meet, but which have not been designated among the eight holidays approved by the controlling committee. The summer program of such workers, if they are employed in schools which do not offer summer classes, shall be under the direction of the controlling committee.

The Vacation Policy shall be reviewed each year at the time of the annual meeting of the Middle East Division Committee

REQUEST FOR STUDY

VOTED, To authorize Anees Haddad to attend Andrews University to work on his Master's degree in Sociology as soon as it can be worked out with the University. Elder Haddad is a delegate to the General Conference session and he will begin his study program following the session and under the provisions of the Policy for Advanced Study by Workers of the Middle East Division.

LOTFY ABADIR SERVICE RECORD 66/65 <u>VOTED</u>, To concur with the entries on Lotfy Abadir's service record as recorded, that he has a total of 9 years service through 1965.

WORKER IN-SERVICE POLICY ALENDMENT 66/66 VOTED, To insert the following in the Worker In-Service Training Policy, on page 101, Section 8, paragraph a, of the Middle East Division Working Policy:

"When a worker takes advantage of this policy and completes his study program the sending organization has priority for his services; and that he follow the guidance and counsel of his controlling committee."

INCOME TAX POLICY 66/67

VOTED, That in countries where the worker is required to pay income tax, if funds are available and the budget is adequate, the employing organization be allowed to share this income tax expense up to a maximum of 75 per cent, upon the clearance of this request by the Division Committee.

ADVANCED STUDY BY WORKERS OF MIDDLE EAST DIVISION 66/68

VOTED, To adopt the following policy for Advanced Study by Workers of the Middle East Division. This will replace the former policy for Advanced Study by Workers of Middle East College (Action 64/128).

- 1. Candidates for graduate study from the territory of the Middle East Division shall be recommended to the Middle East Division Committee by the worker's controlling committee or board.
- 2. The worker from any organization who has been approved by the Middle East Division Committee to benefit from the provisions of this policy shall enter into a written agreement covering the terms of leave, which shall include the following:
 - a. Date leave of absence begins.
- b. Agreement of worker to return for work to his former field of labor.
- c. Agreement upon a course of study with the understanding that no changes shall be made unless authorized by the controlling committee or board and approved by the Division Committee. The worker shall further agree to instruct the institution in which he is studying to furnish the secretary of the Middle East Division a report of his grades at the completion of each term.
- d. In case a worker receives grades that make it impossible for him to be granted the Master of Arts degree in the allotted time, he agrees to abide by any decision of his controlling committee or board, including returning to the Middle East Division immediately.
 - e. Financial arrangements.
- 3. Leave shall be limited to a period of time sufficient for the worker to receive the Master of Arts degree, not to exceed two semesters and two summers.
- 4. This plan shall be applied only for study in a Seventh-day Adventist college or university except when the course of study approved by the controlling committee or board is not offered in a denominational institution.
- 5. Before leaving his homeland (or place of labor) the worker shall have been accepted in a school and for a course of study, both of which have been approved by the controlling committee or board.

Acvanced Study Policy -- Continued

- 6. The following financial provisions shall apply:
- a. The Middle East Division shall pay round-trip travel expense for the worker, his wife, and dependent children, from place of labor to the destination authorized by the Division. Travel shall be by economy class air transportation. (Travel expenses shall include tickets, documentation, immunications, incidental travel expense, travel accident and personal effects floater insurance, handling charges on hand baggage.)
- b. The sending organization shall pay the following expenses:
- (1) A living allowance of up to 75 per cent of the maximum ordained minister's salary rate in the country where studying beginning the date of departure from Division territory until date of return.
 - (2) Rent as may be arranged (for a single worker, not to exceed \$65.00 per month)
 - (3) Tuition for authorized course of study.
 - (4) Registration, library, and graduation fees.
 - (5) Medical allowance.
- (6) An allowance of 25 per cent of the tuition for children in a Seventh-day Adventist church school outside of the Division.
- c. The worker shall be responsible for the cost of textbooks.
- d. The sending organization may pay the expense of tuition for a course of study for the wife if recommended by the controlling committee or board and approved by the Division Committee.
- 3. When the worker returns to the Middle East Division he shall be granted a freight allowance on goods actually shipped of 1,000 pounds to port of entry (500 pounds for a single worker), this to include cost of packing and insurance but not customs duties.
- 7. The entire sum expended shall be advanced on the worker's personal account and shall be amortized at a rate of 20 per cent for each corresponding and equal period of service. For example, the worker shall subsequently serve the organization five months for each month of leave of absence for graduate study. In case a call is placed for the beneficiary before the allowance for leave of absence is amortized, the amount uncared for shall be assumed by the calling organization, or in the event of appointment outside his home Division, by the calling Division.

Advanced Study Policy -- Continued

8. At the time when a worker who has been on study leave returns to his field of labor, the controlling committee or board and the worker shall come to a written and itemized understanding regarding the total amount to be amortized.

Agreement for Beneficiary of Advanced Study Policy

Whereas I, (name), have accepted leave of absence from the Middle East Division under the provisions of the Policy for Advanced Study for Workers of the Middle East Division, I willingly agree:

- 1. That I will return to the Middle East Division for duty in my former field of labor as shall be assigned by the controlling committee or board.
- 2. That, after the graduation exercises in which I shall receive my Master's degree, I will return to my former field of labor within a period of time as shall be designated by the controlling committee or board.
- 3. That I will study only at (name of college or university) as authorized by the controlling committee or board unless I am directed by the committee to attend another university or college.
- 4. That I will study in the field of (name of field of study) and I will not change my course of study unless authorized to do so by the controlling committee or board. I will instruct the registrar's office to furnish a copy of my grades at the close of each term to the secretary of the Middle East Division.
- 5. That in case I shall receive grades that make it impossible for me to be granted a Master of Arts degree in the allotted time, I agree to abide by any decision of the controlling committee or board, including returning to the Middle East Division immediately.
- 6. That the entire sum of money expended for my graduate study and leave of absence, including transportation, tuition, living allowance, and other expenses, shall be advanced on my personal account and I understand that the controlling committee or board will amortize this amount at a rate of 20 per cent for each period of service in the organization equal to the period of time that I shall spend in graduate study under the policy.
- 7. That during this leave of absence for graduate study I will be responsible to the controlling committee or board in the same way as during the time of my regular employment in the organization.

Advanced Study Policy -- Continued

I have read the attached policy and I understand and accept the privileges, obligations, and limitations stated therein as binding upon myself, although such may not be specifically mentioned in this agreement. Further, I understand that my leave of absence begins
