For some time I have felt that the work in the Ohio Conference was in a measure crippled, due to the fact that we do not have as many ordained ministers as we ought to have in a Conference like this, and so it has been my motive in the past to try to educate workers up to that point where they would be set apart to the gospel ministry, by giving them as much of an all-round training as was in my power. On coming to this camp-meeting, and in studying the matter over it seemed to me there were some six or seven men, who had been out in the gospel ministry for various lengths of time, who ought to be set apart and ordained to that work. In the reading of this report you will see that I was not alone in my conviction, but that the whole committee was of the same mind, and so a number will be presented to secretary.
