### NEW YORK CONFERENCE PROCEEDINGS.

THE second meeting of the thirty-fifth annual session of the New York Conference held at Oswego Falls, N. Y., convened Sept. 11, 1896, at 5 p. M. President A. E. Place occupied the chair. Hymn 1257 was sung, and the roll call showed representatives from twenty-eight churches. Prayer was then offered by Elder S. B. Whitney. The minutes of the last meeting were read and approved. On call of Chair Elder J. W. Raymond presented the church at Elmira, with a membership of sixteen. After some remarks by Elder Raymond the church was received by the Conference. On motion the reading of the minutes of the last session was waived.

Your Committee on Resolutions would respectfully submit the following :-

1. Whereas, It is necessary to have a family with each tent company to provide a home for the laborers and thus to contribute to the influence and efficiency of the work; therefore,—

*Resolved*, That the travelling expenses of minister's wives and such other help as the Conference shall deem it advisable and necessary to ask to connect with tent work, be met by the Conference.

2. *Resolved*, That we recognize the Christian Help Work now being introduced among us as a people, as an important part of true missionary work, and we request our church elders to interest themselves in this kind of work and that they enlist all the members of their churches to engage with them in this work.
