# Principles of Division

At the joint session of the three conferences north of the Tehachapi Mountains held in Oakland February 4 to 8, called for the purpose of considering the question of a readjusting of conference lines, and again at the meeting of the Southern California Conference held in Los Angeles February 18 to 22. the question of the general policy that should govern us in our conference work, especially touching the matter of the proper size of conferences for the most advantageous work along spiritual and economic lines, received careful study.

The California Conference with a membership of 2826 and the Southern California Conference with a membership of 3773 were much the largest local conferences in the world. In the 1913 statistical report there are sixtyseven conferences listed in the North American Division Conference with an average membership of 1056. In the European Divison Conference there are thirty-four local conferences with an average membership of 634. In the Australasian Union Conference there are six local conferences with an anverage membership of 777.

It would hardly be fair to say that a

conference in the North American Division with a membership of 1056 was regarded as the proper size for the best work, since many of the sixty-seven conferences in this field represent whole states with large populations and a very small membership. It was thought that these could be worked to better advantage as separate fields on account of the topography of the country or the long distances the laborers would be required to travel if united with an adjoining conference. The same field could be worked to better advantage, in many instances, with a larger constituency and larger tithe. The same is true in Europe and Australia. However, it will be observed that the California and Southern California Conferences were very much larger than the average conference in any of these fields.

One of the favorite figures used by the Saviour to represent the work of the gospel minister is that of "shepherd." This is also applied to the office of a local elder. In writing to the elders of the churches at Ephesus, Paul said, "Take heed therefore unto yourselves, and to all the flock, over the which the Holy Ghost hath made you overseers, to feed the church of God, which He hath purchased with His own blood." Acts 20:28. Juses said of Himself, "I am the good shepherd." John 10:11. And Peter in writing to the elders said. "Feed the flock of God which is among you, taking the oversight thereof, not by constraint, but willingly; not for filthy lucre, but of a ready mind; neither as being lords over God's heritage, but being ensamples to the flock. And when the chief Shepherd shall appear, ye shall receive a crown of glory that fadeth not away." 1 Peter 5:2-4.

The president of a conference is the shepherd over all the churches in his

territory. He has the chief responsibility for their care. While all the ordained ministers in the conference are also shepherds, their chief responsibity, as we have understood it as a people, is along the line of evangelism. We have not as other denominations stationed ministers over churches to act as pastors save in a few exceptional cases, and these were for the chief purpose of leading the church in the work evangelism. The local church elders are expected to do the work of the pastors, looking after the interests of their separate flocks.

If this is the correct principle, it must be very evident that in order to attend properly to the interest of the churches in the conference, the president must not have too large a parish over which to preside. He should frequently visit all the churches in his conference, thus keeping in constant touch with the interests of each church. He should guard them as the good shepherd against the encroachment of wolves, and should also have some time to teach them how to labor for the advancement of the kingdom.

Besides this, he should have some time during each year in which to labor directly in evangelistic work, otherwise he will soon lose touch with the field work, and will not be as efficient in leading his force of field laborers as a president should be.

Years ago it was thought that the best way to farm in the Western coun-. try was in very large farms. But in more recent years it has been demonstrated that intensive farming is much more profitable both to the individual and to the state. This is just as true in working the Lord's vineyard as it is in material things.

Quite generally it is found to be true that the spirituality in the smaller churches is deeper than it is in the

large city churches. If the spirituality of the members is kept up in a large church, it requires very much more of an effort to accomplish this task than it does in the smaller churches. It seems to be quite generally the conviction of such laborers as are called to continually attend camp-meetings that in the smaller camp-meetings much more can be accomplished proportionately in lifting power, than in the larger camp-meetings. We believe these general principles may be safely applied in our conference work; and while a conference president can occupy his time to much better advantage in looking after the interests of a conference that is sufficiently large to employ a good force of workers, and to be selfsustaining, better results will follow his efforts where he is not expected to look after too large a conference.

After carefully studying this question at our meeting in Oakland, the brethren were convinced that it would be well to divide the California Conference, making two conferences out of it. This was done, leaving twenty churches and a membership of 1620 in the California Conference south of the bay and west of the Coast Range of mountains, with a tithe based on last year's figures of \$32,051. Another conference was organized north of the bay and west of the mountains to the Oregon line, called the Northwestern California Conference, with twenty-one churches, 1261 members, and \$20,758 tithe.

During the meeting in Los Angeles, the Southern California Conference was divided, leaving thirty churches, 2163 members and \$40,728 tithe in the present Southern California Conference, and a new conference was organized, including San Bernardino, Riverside, Orange, San Diego, and Imperial Counties, with twenty-seven churches, 1645 members and \$35,379 tithe. Elder B. E. Beddoe was elected president of the Southern California Conference, and Elder W. F. Martin of the Southeastern California Conference.

We confidently hope that the divisions made will work for the better interests of the cause, and it is generally believed that every department will receive a stimulous that it did not have before. We bespeak the prayers of the people for the advancement of the work. E. E. ANDROSS. 0-

# The Oakland Joint Conference

The joint gathering which was declared to be the forty-fourth annual session of the California Conference, the sixth annual session of the Northern California Conference, and the fourth annual meeting of the Central California Conference of Seventh-day Adventists, convened at Oakland, Cal., February 4 to 9, 1915.

There were 243 delegates reported at the meeting as follows:

Besides the regular delegates, a large number of our brethren and sisters from the near-by churches, and many from more distant churches, were in attendance.

Ten conference meetings were held, the first being called at 10 A.M. Thursday, February 4.

Three newly organized churches were accepted into the Central California Conference-Clovis, Fresno County, with a membership of twenty-one; Shafter, Kern County, with eighteen members; and Rolinda, in Fresno County, twenty-three members.

Practically all of the business of the three conferences was done in joint meeting, the committees being made representative in their nature, and largely working together.

The item of business which made the joint session desirable was the readjustment of the conference boundary lines. After careful study, it was decided to divide the California Conference, making the territory north of San Francisco Bay into a new Northwestern California Conference. Some other adjustments of territory were also made among the fields.

# Central California President's Address

To present this annual report to the delegates of the Central California Conference in the presence of the delegates of the California and Northern California Conferences in special session, is an honor accorded me of which I feel unworthy. This is the fourth annual meeting of this conference. It is just four years this month since it was organized. Our conference year having commenced

April 1, this report will be confined principally to the nine months ending December 31, 1914. If we compare the present with the past, the degree of progress made is encouraging. If we compare the progress of the past year with our desire to see the work speedily finished, what has been done seems very small.

For the progress which we see, though it does not equal the desire of our hearts, we ascribe all glory to God. And, while we honor God for the blessing which has rested upon the work, we cannot forget the part our laborers have acted during the year just closed. They have toiled faithfully, spending their strength and giving their best to the cause they love more than life. As I have witnessed the sacrifice of these toilers in His service, and have seen their devotion to the cause in the face of sickness, my heart has been bound to them by a love stronger than death. One day these men and women, who are laying themselves a living sacrifice on the altar, will receive a reward comparable only to the goodness and mercy of God.

#### **Evangelistic Work**

During the year six ordained ministers, three licensed ministers, and six missionary licentiates have been in the regular employ of the conference, making a total of fifteen laborers. This does not include four others who have been in conference employ temporarily.

Series of meetings have been held at the following places: Bakersfield, Barstow, Clovis, Fresno, Lemoore, Lindsay and Rolinda.

As a result of the season's work we are glad to report that 155 persons have been baptized, and forty-seven others have either joined the church on profession of faith, or were, at the close of the year ready for baptism. The present membership of the conference is 1341.

Churches have been organized as follows: Clovis, with a membership of twenty-one; Shafter with a membership of eighteen; and Rolinda with a membership of twenty-three.

At Chowchilla a very neat little building has been erected. The believers at Rolinda and Clovis have laid plans for buildings. In each case the erection of a building seemed imperative, so we trust our brethern in other parts of the field will not think we have not been endeavoring to conform to the action of the Pacific Union Conference recommending that all local church enter-

prises, during the time of the raising of the \$150,000 fund, be held in abeyance as far as consistent with the progress of the cause.

Last fall Elder A. S. Booth was invited to come to the conference to work with us in evangelical meetings to be held at Bakersfield and Fresno, our two largest cities. The latter part of September Elders Booth and E. H. Adams with a company of faithful workers began work in Bakersfield. From the first the attendance was good. Forty have begun keeping the Sabbath. Most of these have been baptized.

Early in January of this year Elder Booth, in company with Elder N. P. Neilsen, began a series of meetings in the Fresno church. There were 400 people in attendance the first evening. The following Saturday and Sunday evenings the attendance was about 800. Brethren who have been in Fresno since the church was erected about twentyfive years ago tell us that the attendance is the largest since the building was dedicated.

Since our last annual conference, the following workers have come to our field to labor: Elder A. S. Booth, Sisters Ada L. Bond and Gertrude Patterson. In the meetings now being held at Fresno, Prof. J. W. Beardslee, Sisters J. W. Jackson and Lora Dart are temporarily in the employ of the conference.

Last October death claimed our beloved brother, Elder Adam George Schlotthauer. Elder Schlotthauer had not been in active conference work for some time on account of failing health and financial affairs. He was laid to rest November 1, 1914, at Vasalia, Cal. His labors are done, but his works do follow him. Our sympathy is with dear Sister Schlotthauer and others who are bereaved by our brother's decease.

#### Finance

With the coming of events that indicate the nearness of the end, has come greater faithfulness on the part of our people in the payment of tithes and offerings. Tithes for the nine months ending December 31, 1914, amounted to \$16,798.28. This is a gain of \$1466.05 over the same period of the preceding year. Or, by figuring on the full year, we find the tithes of 1914 exceed that of 1913 by \$2066.90.

Our offerings to foreign missions for 1914 were \$9487.50. This is a gain of \$2184.86 over 1913. The delegates will see by this that the total increase of tithes and offerings over the previous year is \$4201.76, a gain of  $16\frac{1}{2}$  per cent. While we have rejoiced to see this increase, yet we are very sorry to report that in spite of this we have still failed to reach our goal of 20 cents a week per member. The average is a little more than 16 cents per member. We hoped it might be 20.

Another interesting item appears in the treasurer's report. After 36 per cent of the tithe had been sent to the union and North American Division Conferences, and another 3 per cent had been appropriated to the cause outside our conference, and after meeting the expense of the three extra laborers for the Bakersfield meeting, yet we found that God had so blessed us that the balance at the close of the year appeared on the right side of the ledger.

A beginning has been made by the members of the conference in assisting in the raising of the \$150,000 needed for the educational work in the Pacific Union Conference. Elder G. W. Reaser, in company with a representative of the conference, has visited most of the churches of the conference. To date \$14,586 has been subscribed by members of the conference toward this fund.

Our departmental representatives have furnished me with brief reports to be incorporated into this report.

# Departmental Reports

MISSIONARY DEPARTMENT During the year 1914, there has developed in some of our churches a spirit of earnestness in missionary work, and as a result these churches have grown in strength spiritually as well as in number. We know of individuals who have set their goal at at least one soul and they have not been disappointed. Wonderful results have been reported to us from so small an act as the handing out of a tract or of lending a book. It is the old-time missionary zeal coming into the church, and we are hoping that with it will return the old-fashioned missionary meetings.

We are coming to realize that more can be done with the 10-cent magazines even in a conference where there are no large cities.

We feel encouraged in this work, and are determined to push forward with greater effort. G. A. WHEELER,

Many other experiences might be related which show the value of house-tohouse work with our literature.

Field Missionary Agent. Young People's

We are grateful to the Father of all that we are able to report that our young people are giving heed to the call of Isaiah 60:1, "Arise, shine." That our young people are becoming real home missionaries is shown in their report of 430 missionary visits and 969 hours of Christian help work. Thousands of homes have been entered in our conference the past year by the work of our volunteers, having distributed 13,653 papers, 2633 books and 17,853 tracts.

We are thankful indeed for the work accomplished through the medium of our reading course. Fifty-two have received certificates the past year. As our young people read the experiences of those who have given their lives to the work in foreign fields, their interest in these fields increases, also their donations, as is shown by their offering of \$1093.56. Twenty-two Standard of Attainment certificates were issued during the past nine months.

We are very grateful to our heavenly Father that we have been able to reach our 1914 goal, and with His continued blessing we feel hopeful for a greater work for Him in 1915. We firmly believe the success of our denomination lies in keeping close to the Word, keeping close to our young people and keeping close to the work of the young people for the world.

#### EDUCATIONAL DEPARTMENT

The educational work in our conference has been one of advancement. We have at present twelve schools, fourteen teachers employed, and 225 pupils enrolled.

The Lord has said, "Where there are six children, a church school should be established." Our church at Lindsay having just that number, started their school September 14. The little light kindled at that time has shown with such brightness that they now have fifteen coming from homes of various denominations.

The new company just settled at Chowchilla recognized the importance of the educational work, and started their school of eighteen in a corner of a private dwelling, earnestly praying and working for a better location. An acre of ground and a nice new building now stands as a monument to our Father's answer to the pleading of His children.

God has not only blessed the Lemoore church with a new school building, but has rewarded the faithful work of the teacher in the conversion of every pupil in the school.

Throughout the schools junior missionary societies have been organized. Under the direction of the teacher, the children are obtaining an experience that is fitting them for usefulness in a broader field. The faithful ones have labored with their unconverted schoolmates, and as a result twelve were baptized the past month. In many of our schools successful work along lines of manual training is carried on, the proceeds being given to missions.

God will reward the faithful effort of our churches in providing Christian schools for their children, and through this medium we expect to see a greater work for both the home and foreign fields. LIDA ACKLEY,

#### Edu. Sec. SABBATH-SCHOOL

The Sabbath-school work in this conference during the nine months ending December 31,1914, has been most encouraging. The work was ably directed during the second and third quarters by Miss Lida Ackley, but because of heavy work in other departments, she was released from this department. During the last quarter the work has been directed by the missionary secretary of the conference.

We now have thirty-two schools with a membership of 1264. Our total contributions to missions during the nine months was \$5,143.80. Of this amount \$867.04 were thirteenth sabbath-offerings.

I do not have statistics at hand to determine the number of conversions and baptisms during the entire time, but during the last quarter of the year, thirty members of the Sabbath-school were converted and baptized.

The interest in this branch of the work is shown in the increased demand for Sabbath-school supplies.

The home department of the Sabbath-school is now receiving much attention, and results are already appearing. G. A. WHEELER,

## **Resolutions Adopted**

1. For the blessing of God manifest in His manifold providences; for the preservation of our land from the visitation of calamity and our people from pestilence; for the great and multitudinous common blessings of life, all of which are blood-bought; for the privilege of living and laboring in a land of peace; for the spiritual blessings He has granted us in response to our labor for Him; for the many tokens of the near coming of our King—

We, the delegates of these northern California conferences in joint meeting assembled, hereby express our heartfelt and united thanksgiving, and reconsecrate ourselves and our all to our Redeemer and to the finishing of the work.

Whereas, The responsibility laid upon this people of proclaiming the last heaven-sent message to all peoples of the earth demands a continuous and unfailing system of financial support for our world-wide missionary operations; and,

Whereas, The plan inaugurated by our General Conference, known as the 20-cent-a-week fund, is proving in a most encouraging and satisfactory manner to meet the needs of the cause in the line indicated; therefore,

2. Resolved, That the four conferences assembled in joint session give their full endorsement to this system of providing funds for our missionary enterprises, and that we pledge ourselves to faithful and ceaseless effort to make the plan a complete success; and further, that the plan may be made wholly successful, we request that our union conference and local conference committees outline practical and tested methods whereby the desired average of 20 cents per week per member may be maintained by all of our churches, companies and scattered believers.

Whereas, One of the most important enterprises pertaining to the welfare of the cause of God in the Pacific Union Conference at the present time is the completion of the raising of the \$150,000 educational fund; and,

Whereas, Since the inauguration of the plan it has been decided that this fund may have the full benefit of the surplus of the 20-cent-a-week fund raised in the entire Pacific Union Conference during the period that the securing of subscriptions is in progress, which surplus gives us a total of some \$14,000 for the year 1914 to apply on the \$150,000 fund, and a splendid prospect of approximately \$25,000 from the surplus of the 20-cent-a-week fund for the full current year; therefore (for all of the reasons set forth),

3. We Recommend, That this conference approve the extension of the time limit originally fixed for the securing of subscriptions for the entire fund to the thirty-first day of December, 1915, and we earnestly request all of our people in the four conferences represented who have thus far subscribed to concur in this action.

Whereas, The raising of the \$150,000 educational fund is a matter of paramount importance to the prosperity of the cause in our union conference; and,

Whereas, The greatness of the task, if the desired result is attained, demands that all other enterprises pertaining to the cause requiring the expenditure of money collected from our people, such as institutional, church and school buildings, be held in abeyance until the raising of this fund is completed; therefore,

4. We Recommend and earnestly entreat all of our institutions and churches to defer the solicitation of funds for the erection of buildings, unless it is certain that the work of the Lord will suffer loss thereby, until the raising of this fund is completed.

5. Resolved, That we recommend and urge the conference committees of the various conferences to study and practise the most rigid economy consistent with the greatest efficiency and advancement of the work.

6. Resolved, That we recommend as far as practicable either one person carry the work of a department in two conferences, or that two departments be carried by one person in a conference.

7. Resolved, That we recommend to our various conference committees in the planning of evangelistic work in our cities to labor to secure the best, the strongest, and most complete organization for fruitful results, in which our younger ministers shall receive proper education as successful soul-winners.

Whereas, The North American Division Conference recommends the closing of all conference books at the close of the calendar year; and,

Whereas, It is desirable that at our annual conference business meetings we should have as large an attendance as possible of our able and experienced brethren who can usually better attend at that season than in the busy summer time; and,

Whereas, It is greatly desirable that in our camp-meetings we should have the spiritual help our conference officials could give unimpeded by business and committee meetings inevitably incident to our annual conferences; therefore,

8. Resolved, That we recommend our several conference committees consider

with favor the plan of holding our annual conference during the winter months following the close of the year.

Whereas, Much labor, expense and many details of legal responsibility are entailed upon the local conference officials in the union by a multiplicity of legal corporations, created for the holding of church and conference property; and,

Whereas, These difficulties would largely be eliminated by proceeding as do other denominations in this respect; namely, by having simply one holding corporation for such property in the union conference, or at least in each state in the union; therefore,

9. Resolved, That we request the executive officers of the Pacific Union Conference to make thorough legal investigation of this matter, and as early as consistent, submit to the local conferences in this union a plan to simplify the holding of all church and conference real property, and while this report is pending that the new conference formed hold in abeyance the question of creating a new corporation.

10. We Recommend, That the new conference just organized be called the Northwestern California Conference.

11. In the matter of the division of the California Conference,

Resolved, (a) That the division of surplus and assets between the two conferences be made on a pro rata membership basis January 1, 1915. (b) That the California Conference treasurv and departmental work be carried on from the Oakland office until April 1, 1915. (c) That the tithe from the churches in each section of the field from January 1, 1915, go to the treasurer in which the church is located. (d) That the operating expenses in the territory in question from January 1 to March 31, 1915, be divided between the two conferences on a pro rata membership basis. (e) That for the present at least the camp-meeting outfit be used conjointly between the two coast conferences.

12. Resolved, That we hereby express our thanks to the California Conference and the Oakland church for the courtesy, kindness, hospitality and good cheer extended to the delegates of this conference.

13. Resolved, That we extend to the newspapers about the bay our hearty thanks for their courtesy and liberality in the publication of reports of our sessions. 14. Resolved, That we hereby express to the Oakland Y. M. C. A. our appreciation and thanks for the many courtesies shown our delegates.

# Constitution of the Northwestern California Conference S. D. A. ARTICLE I-NAME

This organization shall be known as the Northwestern California Conference of Seventh-day Adventists.

#### ARTICLE II-OBJECT

The object of this organization shall be to extend the work of the everlasting gospel of Jesus Christ in its threefold setting throughout the world.

#### ARTICLE III-TERRITORY

The territory of this conference shall consist of the following counties in the State of California:

Solano, Marin, Napa, Sonoma, Lake, Mendocino, Trinity, Humboldt, and Del Norte.

#### ARTICLE IV-MEMBERSHIP

This conference shall be composed of such churches as are or may be organized in any part of its territory, under the direction of its executive committee, said churches having been accepted by vote of the conference in session.

#### ARTICLE V-REPRESENTATION

SECTION 1.—The voters of this conference shall be the duly accredited delegates from the local churches, members of the executive committee, all regularly ordained ministers holding credentials from the conference, and such representatives of the Pacific Union, North American Division, and General conferences of Seventh-day Adventists as may be present at any meeting.

SECTION 2.—Each local church shall be entitled to one delegate in the sessions of this conference, without regard to numbers, and one additional delegate for every fifteen church-members, or major fraction thereof.

SECTION 3.—Unorganized companies of Sabbath-keepers shall be represented by the delegates at large.

SECTION 4.—The delegates present at any regular or specially called meeting shall constitute a quorum for the transaction of business.

#### ARTICLE VI-OFFICERS

The officers of this conference shall be a president, a secretary, a treasurer, an auditor, and an executive committee, of seven members, including the president, all of whom shall be elected at each annual meeting.

#### ARTICLE VII-MEETINGS

SECTION 1.—Meetings of this conference shall be held annually at such time and place in the territory of this conference as the executive committee shall determine and designate, for the purpose of electing the officers of the conference, and to transact such other business as may properly come before the conference. Notice of such annual meeting shall be published at least three weeks prior to such meetings, in the PACIFIC UNION RECORDER.

SECTION 2.—The executive committee may call extra sessions, as occasions may require, by a like notice, and the transaction of such sessions shall be equally valid with the regular sessions. ARTICLE VIII—CORPORATION, TRUS-

#### TEES, DEPARTMENTS, AGENTS,

#### Committees

SECTION 1.—This conference may authorize the creation of corporations necessary for the execution of its business or the operation of its institutions, and may at each regular session elect or appoint the boards of management of such institutions and enterprises as are or may be operated by this organization, with the acts governing the same.

SECTION 2.—This conference shall maintain such departments as may be provided by the conference in regular session, and employ such committees, agents, ministers, missionaries, and make such distribution of labor, as may be necessary to carry on its work effectually.

#### ARTICLE IX-LABORERS

Credentials and licenses shall be granted by the conference at its regular sessions to all its approved laborers, and during the interval between sessions, when deemed necessary, by the executive committee.

#### ARTICLE X-BY-LAWS

The voters of this conference may make by-laws and amend or repeal them at any session thereof, and the scope of such by-laws may embrace all subjects not inconsistent with the constitution.

#### ARTICLE XI-AMENDMENTS

This constitution may be amended by a two-thirds vote of the delegates present and voting in any session, provided that if it be proposed to amend the constitution at a special session, notice of the proposed amendment shall be given in the call for such special session.

#### **Bv-laws**

## ARTICLE I-PRESIDENT

It shall be the duty of the president to preside at all meetings of the conference, to report annually the condition of the work, and to make such recommendations as may seem best in the judgment of himself and the executive committee, and to attend to all the duties that usually pertain to this office.

#### ARTICLE II-SECRETARY

It shall be the duty of the secretary to keep a record of the proceedings of each session of the conference; to give immediate notice to officers and committees, trustees and agents, of all votes pertaining to their respective duties; to have charge of the records; to collect from the churches in the territory such financial and statistical reports as may be required, and forward copies of the same as may be directed; and to conduct the general correspondence of the conference.

#### ARTICLE III-TREASURER

SECTION 1.—It shall be the duty of the treasurer to receive all moneys belonging to the conference, keep a detailed and accurate account of the same, and disburse them under the direction of the president, also to make a full report thereof at each annual session of the conference, and at such other times as may be required by the president or executive committee.

SECTION 2.—It shall be the duty of the treasurer to forward monthly all trust funds to their proper destination through the Pacific Union Conference.

#### ARTICLE IV-AUDITOR

The conference shall elect an auditor to examine thoroughly, at least once a year, all accounts of the conference and its several departments, and to report the same to the conference annually.

#### ARTICLE V—THE EXECUTIVE COMMITTEE

SECTION 1.—The executive committee shall have full administrative power during the intervals between sessions of the conference, and shall exercise a general watch-care over all matters pertaining to the work of the conference; and shall fill, for the current term, any vacancies that may occur in its membership, or in the boards, committees, or agents which are appointed or selected by the conference. It shall direct the movements of the employees of the conference, and pay them for labor, at regular intervals from the funds of the conference.

SECTION 2.—The executive committee shall appoint annually such department secretaries and committees as shall be provided for from time to time by the conference in session.

#### ARTICLE VI-AUDITING COMMITTEE

The executive committee shall appoint a sufficient number of brethren from year to year to exceed their own number by one, and who shall not have been in the employ of the conference during any part of the preceding year. These, together with the executive committee, shall constitute an auditing committee to examine and settle all accounts which are presented to the conference at the close of each conference year.

#### ARTICLE VII-FUNDS

The funds of this conference shall consist of the tithes paid by the churches and individuals in the conference, donations for special purposes, and such other funds as it is proper to use for conference work.

ARTICLE VIII—LABORERS SECTION 1.—It shall be the duty of laborers in the employ of this conference to make a written report of their labors performed from month to month during the year, together with such receipts and expenditures as are required by the conference, and to send the same at the close of the month to the conference secretary.

 $\overline{7}$ 

SECTION 2.—This conference shall not regularly employ any worker, and pay him from the tithe, unless he is himself a tithe-payer.

SECTION 3.—Those who may feel it duty to exercise their gift in preaching, colporteur, or Bible work in a public way should express their wish to the conference or its executive committee.

#### ARTICLE IX-CHURCHES

SECTION 1.—Each church of this conference shall render faithful support to the conference work by the prompt payment of its membership tithe, and such other funds as may be set apart for that purpose.

SECTION 2.—Each church, through its clerk, shall make a written report every quarter to the conference secretary of its standing, its additions and losses, the amount of its tithe, and the number of members of its Sabbathschool and young people's societies, and such other information as may be called for.

SECTION 3.—Any church or isolated brethren desiring labor in their vicinity should make request for the same to the conference or its executive committee.

# SOUTHERN CALIFORNIA CONFERENCE SESSION

The fifteenth annual session of the Southern California Conference of Seventh-Day Adventists met in Los Angeles, Cal., February 18 to 23, 1915. Most of the meetings were held in the hall adjoining the conference office at 417 West Fifth Street.

Besides thirty-two ministers and other workers who were delegates at large, 139 regularly elected representatives and alternates from the churches answered to the roll call. The following churches were represented:

Anaheim, Beaumont, Boyle Heights, .Brawley, Burbank, Carr Street, Centralia, Colton, Corona, Eastside, Edendale, Escondido (English), Escondido (German), Fernando, Florence Avenue, Furlong, Garden Grove, Glendale, Glendora, Graham, Hemet, Hinkley, Holtville, Imperial, Inglewood, Loma Linda, Long Beach, Los Angeles (German), Mexican, Norwalk, Orange, Paradise Valley, Pasadena, Pomona, Redlands, Rivera, Riverside, San Bernardino, San Diego, San Pedro, Santa Ana, Santa Monica, Sawtelle, Southside, University Heights (San Diego), Vermont Avenue, Watts.

Only seven churches in the conference reported no representatives at the meeting. They were El Centro, El Cajon, Gardena, La Mesa, Ontario, San Pasqual and Santa Barbara.

One new church, the Berean, organized by Elder L. C. Sheafe, was admitted to the conference with thirty members.

The statistics presented showed that at the close of 1914 there were fifty-four churches in the Southern California Conference with a total membership of 3773. During the last six months of 1914, 138 were baptized in this field, and there had been paid into the treasury in tithes, \$38,037.33. Twenty-seven church schools were in operation, employing thirty-six teach-

ers, and having an enrolment of about 700 pupils. An increase of \$885.16 in retail sales of publications was reported for the year 1914 over 1913, giving a total of \$34,415.88. On December 31, 1914, there were sixtyone Sabbath schools in the conference with a membership of 3542; and the offerings for the last six months of the year were \$8,149.25, of which amount \$1852.48 was thirteenth Sabbath donations.

The main topic which came before this meeting for consideration was the division of the territory into two conferences. The field lying around Los Angeles is still to bear the name of the Southern California Conference, and comprises the counties of San Luis Obispo (formerly belonging to Central California Conference, and accepted at this time into Southern California jurisdiction) Santa Barbara, Ventura, Los Angeles, and that portion of Kern County lying south of the Tehachapi mountains.

The other section was named the Southeastern California Conference, and included the counties of San Bernardino, Riverside, Orange, San Diego and Imperial.



# Resolutions Adopted in Los Angeles

Whereas, Under the guidance of a kind Providence, the various departments of our work are making remarkable progress under stress of an unprecedented world crisis, therefore

1. Resolved, That we express our heartfelt gratitude to God for His wonderful protection and care.

Whereas, Miss Violet R. Bell, who has served so long and faithfully in the conference office, has been called home on account of the sudden death of her father;

2. Resolved, That we extend to Miss Bell and all members of her family our heartfelt sorrow and sympathy in their bereavement.

Whereas, The Central California Conference has requested the Southern California Conference to take into its boundaries the county of San Luis Obispo; therefore,

3. Resolved, That we accept this responsibility.

Whereas, It seems advisable to unify the medical work throughout the Pacific Union Conference; therefore,

4. We hereby empower the Pacific Union Conference committee to nominate all boards and officers of the Sanitarium Association of Seventh-Day Adventists of Southern California now operating the Glendale and Paradise Valley Sanitariums.

5. We Recommend: (a) That the Pacific Union College Association of St. Helena, California, be changed by the union cenference into general Pacific Union Educational Association holding the college, the academies and the other conference schools in the union.

(b) That when such corporation is in position to take over the ownership of San Fernando Academy, the Southern California Association of Seventh-Day Adventists of Los Angeles, Cal., transfer the resources and liabilities of the academy to said Educational Association.

(c) That a board of seven persons be appointed for the local management for San Fernardo Academy, said board to carry out the plans and decisions made for the school by the Pacific Union Educational Association. This board of the academy shall have both union and local representatives, the majority of which shall be from the local field.

(d) That this school still stand as an academy drawing the academic students of the Southern California territory and the students of the eleventh and twelfth grades from Arizona as planned for at the Oakland union conference March 10 to 22, 1914.

(e) That the academy affiliate with the other union conference schools as to courses of study, calendar, text books and school regulations.

6. We Recommend: That the church property now owned by the Southern California Association be transferred to the Pacific Union Conference Association when it is legally organized to hold property.

7. We Recommend for the consideration of the conference the question of the division of the Southern California territory into two conferences, the division line to be the county lines between Kern and Los Angeles Counties on the west and San Bernardino and Orange Counties on the east.

8. We Recommend: (a) That the territory comprised of Los Angeles, Santa Barbara, San Luis Obispo, and that portion of Kern County lying south and east of the Tehachapi Mountains continue the name of the Southern California Conference of Seventh-Day Adventists.

(b) That the territory comprised of San Bernardino, Riverside, Orange, San Diego and Imperial Counties be known as the Southeastern California Conference of Seventh-Day Adventists.

(c) That the division of tithe and donations be made from January 1, 1915, each conference to receive the amounts paid in by the churches in its territory.

(d) That the operating expense from January 1, 1915, to March 31, 1915, be shared by the two conferences on a pro rata membership basis as reported December 31, 1914.

(e) That the surplus and assets reported December 31, 1914, be divided between the two conferences on a pro rata membership basis.

(f) That as far as practicable either one person carry the work of a department in two conferences, or that two departments be carried by one person in a conference.

9. We Recommend: That the two incoming conference committees consider carefully the following suggestions:

(a) That the portion yet remaining of the lease at 417 West Fifth St., Los Angeles, and now assumed by the Southern California Conference to be divided as follows:

(1) The Southern California Conference to estimate a reasonable rental per month. The total amount of this rate for the remaining period from January 1, 1915, to be deducted from the amount of the lease and the remainder divided between the conferences on a pro rata membership basis.

....(2) The amount to be assumed by the Southeastern California. Conference to be taken out of its portion of the assets, so that this extra expense shall not appear each year in its operating amount.

(b) That for the present the tract society work for both conferences be operated from the central office of the Southern California Conference.

(c) The plan of holding the annual conference sessions during the winter months and closing the conference books December 31 of each year.

Whereas, The plan inaugurated by the General Conference known as the 20-cent-a-week fund is meeting in a most encouraging and satisfactory manner the need of the cause; therefore,

10. Resolved, That these conferences pledge themselves to faithful and ceaseless effort to make the plan a complete success, and we request the local conference committee to outline practical plans that will encourage each church and company to average at least 20 cents per week per member throughout the entire year.

Whereas, Since the inauguration of the \$150,000 fund plan, it has been decided that this fund may have the full benefit of the surplus of the 20cent-a-week fund raised in the entire Pacific Union Conference which surplus gives us a total of some \$14,000 for 1914, and a splendid prospect of approximately \$25,000 for the 20-centa-week fund for the full year 1915; therefore,

11. We Recommend, That these conferences favor the extension of the time limit originally fixed for the securing of subscriptions for the \$150,000 fund from November 30, 1915, to the thirty-first day of December, 1915, and we earnestly request all people in our conference who have thus far subscribed to concur in this action.

Whereas, The bill now pending in Congress to close the mails against matter that opposes certain religious teaching is a menace to liberty of speech and freedom of the press; and,

Whereas, Such legislation would tend to the establishment of religion by law contrary to the principles and constitution of our government; therefore,

12. Resolved, That this conference petition Congress in behalf of liberty against the passage of this bill or any similar measure, and that a committee of three be appointed to draft a message expressing the sense of this conference.

Whereas. The Lord has called into existance medical institutions within our boundaries to assist in carrying the everlasting gospel to perishing souls: and.

Whereas, Loma Linda is a General Conference institution, and it is planned that Glendale and Paradise Valley shall become union conference institutions: therefore,

13. Resolved, That we extend to them a hearty invitation to cooperate with our conferences in their efforts to evangelize our large cities; and furthermore we pledge to them a continuance of our support.

Whereas, The North American Division Conference has arranged for holding an educational and young people's council meeting at Pacific Union College, June 4, 1915, and this to be followed by a one week's convention for the instruction of teachers and young people's officers in the local conferences of our union; we therefore.

14. Recommend: That these conferences arrange for the educational superintendent, young people's secretary and the principal of Fernando Academy to attend the council and convention.

(b) That these conferences arrange as far as practicable for our academy and church school teachers to attend the convention and the summer school that follows.

(c) That the churches of these conferences having young people's societies, be encouraged to send the leader and secretary of the society to the convention.

15. Resolved, That we hereby express our sincere and hearty thanks to the members of our churches in and around Los Angeles who have so hospitably opened their homes to visiting delegates and to the manager of the Vegeterian Cafeteria for the courtesies extended them.

16. Resolved. That we hereby extend hearty thanks to the newspapers of Los Angeles and vicinity for their courtesies in publishing full accounts of our conference sessions, and further,

17. Resolved, That the secretary of the Southern California Conference hereby be instructed to send a copy of this resolution to the managing editors of these papers.

# Constitution of the Southern California Conference S. D. A. as Amended February 22, 1915

ARTICLE I-NAME

This conference shall be known as the Southern California Conference of Seventh-Day Adventists.

#### ARTICLE II-TERRITORY

The territory of this conference shall embrace all that portion of California known as the counties of San Luis Obispo, Santa Barbara, Ventura, Los Angeles and that part of Kern County lying south and east of the Tehachapi Mountains.

#### ARTICLE III-OBJECTS

The objects of this organization are to constitute a representative body of said people in the above named territory, and to secure a systematic and united effort to disseminate the light of the everlasting gospel.

ARTICLE IV-MEMBERSHIP

The membership of this conference shall embrace the members in good standing in all the churches of the Seventh-Day Adventists in the above described territory.

#### ARTICLE V-MEETINGS

One session of this conference shall be held each year for the transaction of business, and for the election of officers, the time and place of this meeting to be determined by the executive committee. Notice of the same shall be published at least two weeks prior to the holding of such meeting, in one or more of the denominational papers in general circulation in said conference.

ARTICLE VI

#### REPRESENTATION

The members of the conference executive committee, the ordained ministers in the employ of the conference, the secretary and treasurer, the superintendent of church schools, the president, medical superintendent and business manager of each denominational institution in the territory of the Southern California Conference, and any representative present from the General, North American Division, or the Pacific Union Conference, shall be delegates at large, while each church shall be entitled to one delegate for the organization and one additional delegate for each twenty members or major fraction thereof.

# ARTICLE VII-QUORUM

A majority of the delegates enrolled at any session shall constitute a quorum for the transaction of business.

#### ARTICLE VIII—OFFICERS

SECTION 1-The officers of the conference shall be a president, secretary, treasurer and an executive committee of seven members, including the president:

SECTION 2-The auditor of the Pacific Union Conference shall be the auditor of this conference.

SECTION 3-The conference shall elect a managing board for each unincorporated institution of the conference, and shall nominate a board of managers, trustees or directors for such conference institutions as shall be provided for in their articles of incorporation or by-laws.

SECTION 4-The executive committee, together with any one of the local boards, shall constitute a counsel of advice and appeal on any question relating to the institution under the management of the local board, and may be called at the request of any two members of either committee.

SECTION 5-The duties of the president, secretary, treasurer and the auditor shall be such as usually pertain to such offices.

SECTION 6-It shall be the duty of the executive committee: (a) To take the general supervision of all labor of the conference; (b) To appoint such departmental committees, secretaries, and other officers, agents and employees as the needs of the cause may require from time to time; (c) To appoint eight persons who have not been in the employ of the conference during any part of the preceding year who together with it shall constitute an auditing committee to examine and settle at the end of each year all accounts of laborers; (d) To fill all vacancies which may occur in the offices in the interim between the sessions of the conference; (e) To remove any employee of the conference when it shall seem necessary to do so.

SECTION 7-It shall be the duty of the managing board of each institution to take full charge of the finances of the work of the institution over which it is placed.

# ARTICLE IX-FUNDS

SECTION 1-The funds of this conference shall consist of tithes and offerings.

SECTION 2-It shall be the duty of each church through its proper

officers to receive, collect, and monthly to transmit these funds; and likewise to receive, collect, and monthly to transmit to the conference all trust funds for denominational enterprises outside the conference territory.

SECTION 3-The tithe shall be disbursed by the treasurer under the directions of the conference president.

ARTICLE X DUTY OF CHURCHES

SECTION 1-It shall be the duty of each church through its clerk to

make a written report every quarter to the conference secretary of its standing, its additions and losses, and the amount of its tithes.

SECTION 2-When any church or scattered brethren desire labor in their vicinity their call should be made to the executive committee.

ARTICLE XI-LABORERS

SECTION 1-Credentials and licenses shall be granted by the conference at its regular annual session to all its approved laborers, and during the interval between the sessions, by the executive committee.

SECTION 2-It shall be the duty of all laborers in the conference to send a report to the secretary of the conference of the labor performed during the month together with all receipts and expenditures.

ARTICLE XII-AMENDMENTS

This constitution may be amended at any regular meeting of the conference, by a two-third vote of the members present, provided that such amendment shall not conflict with the constitution of the Pacific Union Conference.

# Constitution of the Southeastern California Conference S. D. A.

The constitution of the Southeastern California Conference is identical with that of the Southern California Conference with these exceptions:

ARTICLE I-NAME

This conference shall be known as the Southeastern California Conference of Seventh-Day Adventists.

ARTICLE II-TERRITORY .. The territory of this conference shall embrace all that portion of California known as the counties of San Bernardino, Riverside, Orange, San Diego and Imperial.

ARTICLE VI

The words Southeastern California Conference to be substituted for the words"SouthernCaliforniaConference."

Auditor's Statement

TO THE DELEGATES OF THE SOUTHERN CALIFORNIA CONFER-ENCE:

In examining the accounts of the Southern California Conference, no complete inventories of tent, camp equipment and furniture were found which had been recorded during several years past, previous to the one taken for the statements December 31, 1914. In closing the books for the past few years, a percentage for wear and tear has been written off the face of the account. In applying the totals of the physical inventories this year, an abnormal reduction is shown in the accounts affected. The difference between the ledger accounts depreciated for the six-month period on the percentage of former years and the actual inventory values is over \$2,000, which provides for more than the loss shown by the revenue statement.

The inventory records used in making up the tract society report were those of January 31, 1915, instead of December 31, 1914, but it is reckoned that the values on the two dates were practically even.

The cash was found to agree with the amount called for by the records, and the books have been kept in a very satisfactory manner. We believe that the revenue accounts and financial statements presented under date of December 31, 1914, show the standing of the Southern California Conference and Tract Society as disclosed by its books and records CLAUDE CONARD, account. The annual corporation meeting of the Arizona Conference will be held in Phoenix Tuesday, April 6.

The Pacific Union Conference committee is in session at Mountain View this week planning for the summer's camp-meetings and other work in the conferences this year.

During the last six months of 1914, there were 138 baptisms in the Southern California Conference, and 131 united with the church on former baptism, making 269 new members. Eleven tent and hall efforts have been held since June 30, 1914.

Anyone knowing the whereabouts of Mr. and Mrs. Loy, of this faith, would confer a favor upon Mrs. M. P. N. Franklin (General Delivery, Los Angeles, Cal.) by writing her to this effect. They came to California some time ago.

A medical convention is to be held March 19 to 23 in connection with the annual constituency meeting of the College of Medical Evangelists at Loma Linda, Cal. Dr. H. W. Miller, Elder I. H. Evans and other general men are expected to be present.

The annual meeting of the Pacific Press Publishing Association was held at Mountain View on Monday of this week, March 8. An unusually large number of prominent laborers were present, owing to the bookmen's and secretaries' convention also in progress at the Pacific Press this week. Extended reports will be given later.

Brother J. J. Ireland, for many years secretary-treasurer and auditor of the Pacific Union Conference, is spending a few weeks on the coast. While here he is checking the books at the Pacific Press and the union conference office, and will attend the Loma' Linda annual meeting, March 24. Brother Ireland is now auditor for the General and North American Division Conferences.

Elder Andross spent a day or so last week at Lodi, also attended a board meeting at Pacific Union College early this week, and is now in attendance at the Mountain View convention and Pacific Union Conference committee meetings.

The bookmen's and tract society secretaries' convention for the entire Western and Middle West territory is in session at Mountain View this week. There are present union and state canvassing men and tract society secretaries from nearly every conference in the territory, as well as many of the union and local conference presidents. It is anticipated that this gathering will give a great impetus to our literature work throughout the entire field.

Elder and Mrs. H. W. Cottrell arrived at the St. Helena Sanitarium from Portland Tuesday of last week; where they spent a few days before going on to Mountain View to attend the bookmen's convention and annual meeting of the Pacific Press Publishing Association. For a number of years Elder Cottrell was president of the Pacific Union Conference, and he and his good wife always receive a hearty welcome in this field. At the present, Elder Cottrell is president of the Western Oregon Conference.

The reports that have just come from Washington, D. C., show that for the month of January, 1915, the Pacific Union Conference came the farthest behind of any union conference in the North American Division in the 20-cent-a-week contributions. Of the \$8450.31 required to show even, there was received only \$3348 .-58. a shortage of \$5,101.73. However no remittances whatever were included from Northern California and Utah. Arizona stood \$28.87 over her quota for the month. Of the entire \$59080.85 that should have been paid in the North America Division Conference, \$37,710.92 came in during January, leaving the field \$21,369.91 behind the quota. Is your church one that is helping to raise this load, or is it assisting in drawing down the average? Are you a lifter or a leaner?
