## MEDICAL ASSOCIATION AND GUADALAJARA:

The committee appointed to bring in recommendations on the Medical Missionary Association affairs and the Battle Creek College property, reported as follows:==

"Your committee appointed to bring in recommendations regarding the affairs of the International Medical Missionary and Benevolent Association, would most respectfully submit the following:--

"Meereas, Some who have loaned money to the International Medical Missionary and Benevolent Association are suffering because of their inability to secure said money or the interest thereon; and,

"Whereas, It seems unjust that these creditors who loaned their money in good faith should thus suffer when they are not in the least responsible for this condition of affairs, we would therefore recommend the following: --

"(a) That the advice of the General Conference Committee given at College View, Nebr.k under date of September 15-25,1904, and the advice of the General Conference Committee given at Takoma Park, January 24-27, 1905, copies of which are hereto attached, be adhered to,

"(b) That a committee of three be appointed by the General Conference Committee to negotiate with the Boards of Trustees of the Michigan Sanitarium and Benevolent Association, and the International Medical Missionary and Benevolent Association, and endeavor to secure from them a proper adjustment of the Guadalajara Sanitarium affairs.

"(c) That we request our various institutions which may have received benefits from the investments of the International Medical Missionary and Benevolent Association's funds, to assume the responsibility as far as possible, of reimbursing the Receiver of said corporation for any funds that have been expended in the establishment of these institutions."

## BATTLE CREEK COLLEGE PROPERTY:

"Concerning the management, direction, and disposition of the Battle Creek College property, your committee would most pespectfully submit the following:-- "1. That a special committee of three be appointed by the General Conference Committee to negotiate with the Michigan Sani tarium and Benevolent Association, and the American Medical Mis=` sionary College. in regard to the purchase of said property.

"2. That said property be sold to the Michigan Sanitarium and Benevolent Association, on satisfactory security, at the price of \$45,225 plus any additional expense or outlay to which the General Conference has been on this property.

"3. That if a proper and satisfactory sale cannot be effected with the Michigan Sanitarium and Benevolent Association or with the American Missionary College, that we request the International Medical Missionary Training School Association to execute to the General Conference a sufficient warranty deed to secure this property to the General Conference Corporation of the Seventh-day Adventists.

"4. That the taxes be at once paid to secure the Corporation against further loss.

\*5. That the Michigan Sanitarium and Benevolent Association be offered the rent of said property at the rate of \$300.00 per month, the Michigan Sanitarium and Benevolent Association to make all necessary repairs, and keep the buildings in good condition, said General Conference Corporation to carry the insurance, and pay the taxes,

"6. That if the Michigan Sanitarium and Benevolent Association, or the American Medical Missionary College decline to rent said property, that said property be then placed on the market and sold to the best possible advantage."

By vote these two reports were adopted, and it was agreed to present them to the meeting of conference presidents at 7:30 this date.

(2) That Allen Moon, of Indianapolis, Ind., and I.H.Evans, of Takoma Park, Washington, D.C., are hereby constituted a committee to negotiate with the respective railroads to secure a lower rating on tents for the accommodation of our people.

## A.F. BARRENGER & WM. HUTCHINSON:

A.F.Ballenger appeared before the Committee and said he still believed as he did before the hearing on his views before the brethren during the Conference. He asked for a committee to be appointed to study with him quietly. He could not fight the Testimonies, but would wait quietly, seeing what God had for him. He could not fight this people. Anything he might publish would be a prayer for light rather than antagonism to our people. He planned to retire to a little farm in Virginia to wait. Wm. Hutchinson stated that he still believed the views presented by Brother Ballenger. He feil it impossible to change. Now he could only say that he must surrender as to what he should do, and leave it to the brethren to decide. He would abide such decision.

The chairman reviewed the history of some experiences of men who have gone out from us in the past, and begged that, with the decided Testimony that had been given in this special matter, the brethren consider the possibility that they may be mistaken, and mot take a course to bring trouble and disaster upon themselves.

Brother Weber, of Germany, asked counsel as to his course, inasmuch as it had been suggested that he remain in America.

A food bakery is desired in Argentine.

They request funds for carrying stock of Portuguese and Spanish books.

WOTED, That W.H.Thurston, J.W.Westphal, and L.R.Conradi be a committee to draw up a resolution re Brazilian responsibility for Portuguese publications, and that Brother Westphal be allowed to gather money for book fund for South America.

# CANADA:

W.H.THURSTON was given time to speak of Canadian problems,

They have \$610 deficit on past appropriations to June 1, 1905, and they owe this amount on book stock to the Review and Herald \$500 was needed for Knowlton Sanitarium,

A French worker and wife could be employed in Quebec at \$300 a year, earning balance of support from sales,

Elder Guthrie asks asvice about raising balance of money for Maritime school -- \$1000 more needed. He raised about \$900 in Missouri and Iowa.

WOTED, That we appropriate \$300 for the French worker for Quebec, this amount, with receipts from literature and otherwise, to cover a year's malabor.

WOTED, That we send \$500 already appropriated for Knowlton Sanitarium at our earliest opportunity.

Recommended, That the Vice-President, Secretary, and Treasurer try to get some workers for Canada, stirring and active, from stated offering workers,

Suggested, To let debts owing Review and Herald wait and bring about reorganization of book business, so that it will be self-supporting.

Suggested, That Elder Guthrie is free to work for school funds as in the past.

PHILIPPINES, DR. ROSS:

G.A. Irwin reported for the committee on the Philippines, recommending that Dr. Ross be sent to the Philippines and \$500 advanced to start the work, he to pay back the \$500 when work is started, the central Union to take half this expenditure, according to their offic, through E.T.Russell.

4. That we regard it essential that he shall leave off pushing his private book business so far as any public labor is concerned if he hopes to work satisfactorily in regular conference work.

## GREAT BRITAIN:

W. C. Sisley presented matters re Great Britain.

The various enterprises, publishing, food factory, and sanitarium work are earning money. The publishing branch ought to be able to earn \$5,000 a year, and help in other branches. The field is approaching self-support.

There is a desire to remove the food factory to the country, also the school. They need a place of their own for their publishing house. All the arguments as to getting out of the crowded cities that apply in America apply equally in England. They ask counsel as to what they should do. They are paying rent on school, food factory, and printing office, a rent equivalent to 4% on \$50,000.

They have in mind a property eight miles out of London, where they might locate school, food factory, and printing office.

WOTED, That W.C.Sisley, A.G.Daniells, and W.C.White be a committee to confer with Sister White about the general proposition to move the British enterprises into the country.

## Belief Bureau;

The following statement and plan were presented by the Relief Burgau as a basis for the operation of the work:--

"I. That 'Ministry of Healing" is a gift to the Seventhday Adventists people, as represented in conferencest to be sold in behalf of their sanit ariums and medical missionary enterprises.

"2. That the control of the enterprise rests with the wnion conference committees, in harmony with the plans of the author and the Relief Bureau.

"3. That the institutions to be benefitted by this gift, are those sanitariums which are organized, and operated in harmony with their union conference plans, and are in harmony with the light regarding this work received through the spirit of prophecy (and are recommended by the author).

"4. That special plans may be made to met special conditions, with the approval of the Relief Bureau and the author.

"5. That a special prospectus be provided for each union conference.

"6. That all publishing houses made a full report monthly to the secretary of the Relief Bureau, of books printed, books sold to each state, and number in stock, and that they make a full settlement quarterly for all books distributed.

"7. That tract societies settle monthly for all books purchased, and that they be advised to sell books to the people for cash.

"8. That the publishers hold all funds subject to orders of the Relief Bureau.

"9. That the Relief Bureau secure full information on the standing of the C.O.L.work in behalf of the schools, and 'Story of Joseph ' work in behalf of colored schools in the South, and that definite plans for the vigorous prosecution of both enterprises be perfected as soon as possible and presented to the General Conference Committee for approval."

It was adopted.

"2. That we encourage the friends of the Huntsville school to raise a fund of five thousand dollars, for the enlargement of the buildings and the improvement of facilities of the school.

"3. That we encourage the Nashville church to purchase the Baptist meeting-house now offered to them for five thousand dollars, and that calls be issued in the Review, Watchman, and Signs for gifts to assist in payment of the same.

"4. That we ask G.A. Irwin and Dr. J.E. Froom to join our brethren in the South in arranging plans for the Nashville Sanitarium work, and that when these plans are developed, we assist in securing the means that will be required.

"5. That our brethren of the Cumberland Conference be encouraged to place the Graysville Sanitarium in good working order.

"6. That our brethren throughout the Southern Union Conference be encouraged to unite in putting the Atlantis Sanitarium in good working condition.

"7. That the managers of the Southern Publishing Association be encouraged --

(a) To study the plan so successfully followed in England, Europe, and Australa sia, by which a small constituency place a large number of papers in their field; and to put the Watchman upon an efficient paying basis.

(b) To enter judiciously into the publication of books for the magnificient book field assigned them.

(c) That friends of the cause be encouraged to load money to the Southern Publishing Association, with which that Association may take up current obligations.

## SOUTHERN MISSIONARY SOCIETY:

The committee appointed to make recommendations regarding flivision of funds for the South, and the more exact designation of funds, made a report, which was adopted as follows:--

"We recommend, --

"1. That in consideration of the probability that numerous small sums given by our people to the Southern work, and intended for the mission schools of the Southern Missionary Society, have been assigned to other uses in the South, through failure to properly specify the intent, that \$800 be appropriated from the general fund to the Southern Missionary Society.

"2. That an earnest effort be made to inform our people everywhere about the names and natire of the various enterprises in the South needing help, so that they may give understandingly, and that our librarians and secretaries be instructed to secure and transmit exact information regarding the gifts passing through their hands.

"3. That in the interest of the fullest confidence and cooperation, we advise the Executive Board of the Southern Missionary Society, --

> "(a) To concentrate the energies of the Society upon the establishment and maintenance of colored mission schools, and upon helping to build meeting houses for colored congregations in the Southern Union Conference,

> "(b) That the Society employ as secretaryk treasurer, and corresponding cherk, such person or persons as are favorably known by our conference officers,

"(c) That the Society be so reorganized that its annual meetings may be held in Nashville, in conjunction with the annual meeting of the Southern Publishing Association, at which time full reports of the working of the Society, and complete financial statements be submitted for consideration and publication."

VOTED, That a committee of three be appointed on the program for the midsummer offering.

Named: W.A. Spicer, I.H. Evans, G. B. Thompson.

(h) The business manager shall have authority to employ any assistants or agents needed.

WOTED, That under the circumstances we assent to the return of Brother and Sister Burgess to India, and ask the India Mission Committee to cooperate with them in establishing their new effort.

I.H.EVANS TO SOUTH AMERICA:

The committee on I.H.Evans' visit to South America advised that he go direct to Colon from New York, visiting Ecuador and Peru on the way to Chile, where the first general meeting would be held in February (it was considered inadvisable to call the new workers from Ecuador and Peru to the Chile meeting), thence to the Union meeting in Argentina, and on to the Brazil meeting, planning to reach home about June 30.

WOTED, That the general outline for the visit to South America be approved.

EUROPEAN MINUTES:

The Chairman presented the following minutes of the General Conference Committee meetings in Europe, which were discussed. No action was taken in the matters referred to the Committee on this side:--

Friedensau, July 25, 1905.

PRESENT:

A.G.Daniells (Chairman), L.R.Conradi, J.W.Westphal, H.F. Schuberth, W.H.Wakeham, D.P.Gaede, J.T.Boettcher, and by invitation H. Hartkop and G. Dail.

Prayer by H.F.Schuberth.

The President stated that the General Conference provides that any five members of the Committee, wherever they may be together, are a quorum for work in harmony with the general plans of the General Conference.

### P. CHRISTENSEN TO ARGENTINA:

Brother Westphal stated that a Scandinavian brother in Argentina felt very anxious to have an effort made for the Scandinawians in that country. He had therefore offered 1,000 kroner toward providing for his traveling expenses, would give him a house to live in for the immediate future, and would perhaps do more, if a minister could be sent there. He had written this offer to the Danish Conference Committee, and it was known in Denmark that Brother F. Christensen, of that conference, was the brother called for. He is willing to go. However, in view of the lack of knowledge with reference to the actual needs of Argentina in this direction, Brother Westphal would hardly feel free, without first consulting with his Committee, to suggest that Brother Christensen be called to that field. It was therefore, ==

**WOTED,** That the question of P. Christensen's going to Argentina be referred to the South American Union Committee, for their investigation and recommendation to the Mission Board,

### BOOKKEEPER TO BRAZIL:

Brother Westphal further spoke, asking if it would be possible to secure a German business man and bookkpeper for the office in Ric. Brother Pages' name was mentioned as a possible candidate for such a position, as he is a man who had had a good deal of experience in this department of work. He is also a good churcher elder, and has a live Christian experience.

VOTED, That the question of securing a suitable bookkeeper for the Ric office be referred to Brethren Conradi and Westphal, who will counsel with Brother Pages, and report to the Mission Board

PAGES TO BRAZIL:

At Friedensau, the matter of Brother Fages' going to Brazil had received favorable consideration, and after Brethren Conradi and Westphal had talked with Brother Pages, they felt clear to recommend that he go, as he and his family are willing to accept the call. It is understood that the Brazilian mission, through the appropriation received from the Mission Board, will meet the transportation expenses of the family, which consists of Brother A. Pages, his wife, and their fifteen-year-old daughter. Brother Pages will take charge of the office, and Brother A. B. Stauffer, who is now working in the depository at Rio, will enter the field.

VOTED, That we recommend Brother A. Pages, of Hamburg, to take charge of the Rio office, in Brazil.

SCHWANTES TO PORTUGAL:

In this connection, Brother Conradi stated our need of another man in Spain, as Brother Robinson and wife may not remain, being quite fully in harmony with the doctrines of Brother Ballenger. Brother Rentfro is just beginning in Portugal, and would rather labor in Spain, so it is suggested that he might be transferred to that country, and that Brother E. Schwantes, who is an ordained minister, and speaks Fortuguese, Spanish, and some English (he is about 45 years of age, and no one but his wife meuld meed accompany him) could fit nicely into the Portuguese work. This would relieve the payroll where Brother Schwantes now labors (Brazil) and would give us at once a worker who could labor among the Fortuguese.

VOTED, That we recommend the Brazilian Mission Committee to take under favorable consideration the removal of Elder E. Schwantes to Portugal, to help in that field.

King's Heath, Birmingham, August 10.

PRESENT:

L.R.Conradi (Chairman), W.C.Sisley, E.E.Andross, H.E. Salisbury; by invitation, G. Dail.

Prayer by H. R. Salisbury.

Elder Conradi took up the larger part of the evening in stating his plan fot the coming six months, also giving some of the details of his work since the series of summer meetings began. He desires not only to help the work in Great Britain, but that the British brethren render him help; therefore, his desire to have this short interview with the members present.

The Chairman referred to the mharmonious meeting in Denmark-the best for many years. Although sorry that it had been impossible for Brother F.A.Hansen to be present in Scandinavia, and therefore the necessity of asking that the Scandinavian Union meeting be cancelled, yet he rejoices that things in Skodsborg (where they need a new building), and in Frydenstrand, which has been purchased by the Danish Conference, are in such good condition. Upon our going to Sweden, we found the way open for a good meeting Erother Olsen had gone on a day or two ahead, and there was an excellent spirit at Grythytehed, when we arrived. It did not seem advisable to make any material change in the administration, but there were two laborers freed for Finland, so that Sweden for 1906 will be able to get on without any appropriations from American money, and still pay a tithe to the Unioni thus all the Scandinavian Conferences fall into line in this respect. In Norway, where we also had a good meeting, there was still some misunderstanding between the brethren before we arrived; but matters seemed to be arranged before our leaving. Brother Olsen did not go to Norway, but returned to London, to prepare for his trip to Australia.

Returning to the South, the Chairman had visited the German-Swiss Conference at Wadaenswd1, where there was a good attendance and spirit. Later, he had visited the Latin Union meeting at Gland. Here our new sanitarium is nearing completion; one difficulty seems to have been with the water supply, but we hope this may soon be overcome.

From Gland, we attended the German Union meeting at Friedensau, where between seven and eight hindred were on the grounds, and where, as at Gland, all the rooms of the sanitarium are full. There is a good prospect before our health food work. The new laundry is complete. In ice-house is to be erected, and another dwelling. The Russian field has been divided into still other parts: The South Russian Conference had a large strip cut off, to form the South Russian Mission, composed of the Don and Crimea territory, to be in charge of Brother D. Isaac; while the Caucasus and Volga will be known as the East Russian Conference. Brother O. Wildgrube is to take charge of the Middle Russian formfermance. Mission. The Russians, in the organized fields, where the German predominates, will be included in the field membership, and not be separated as heretofore. We are to apply to the Rusto Publish the gospel. After attending the meetings in Great Britain, the Chairman is to visit France, Gland, Hamburg, Holland, Rhenish Prussia, and early in October, go to Vasa, Finland, where the meeting in that field is to be. Then follow the North Russian meeting, at Petersburg, the East Russian Conference, the visit to Tiflis, the South Russian, and the Middle Russian meetings. Brother Ising, the German secretary, will go to Russia with him. The mid-winter meetings in Germany being the latter part of December, and last until the middle latter part of January or the first of February. Erother Wakeham will visit Asia Minor and Palestine, and meet Brother Conradi in Constantinopde in December.

Another matter we ought to keep in mind, is the circulation of "Ministry of Healing,"

### M.A.ALTMAN'S CASE:

The question of the true status of affairs with reference to the return of Brother M.A. Altman from South Africa to Great Britain was considered. The matter received thorough discussion. He haver had felt Africa to be his field; he returned because of a temporary scarcity on the funds of the conference treasury there; and because, after having placed the matter before the General Conference, and felt that he ought to be present at the British meeting, he had returned at his own expense. He had sold his furniture to enable him to come back, and although he did not ask for compensation, yet he desired to make a clear statement to the brethren of how he looked at the matter. He also knew there was a strong desire on the part of the brethren in Cape Colony to retain him there, after he had returned from the field in which he had been laboring, but he had not felt free to romain in Africa at all. This meeting wasthen adjourned, and a session of the British Union was called, which voted to return him L 25 toward the expense he had incurred in reaching Great Britain-about half the amount it had cost him to return.

## JOSEPH BOOTH'S CASE:

This brother had not been satisfied with the arrangements that had been made to close our contract with him. He had thought it would be very pleasing to him to have the doings of the General Conference in his case passed upon by a committee of twelve Englishmen, and so, at the suggestion of Brother Salisbury, such a committee was arranged for, consisting of Brethren Bartlett, Davis, Jessop, Partridge, Nicholson, Thomas, Spencer, Richardson, Hussey, Morris, Burt, and Barhard,

On assembling, with the members of the General Conference and British Union Committees present, the Committee of Twelve chose Brother H.R.Salisbury as chairman, and Brother Bartleet, secretary.

Brother Booth was then given ample opportunity to state his views of his connection with the General Conference of Seventhday Adventists, that the Committee might themselves form a correct and unbiased opinion as to the merits of the case, and the treatment he had been accorded. After he had finished, his remarks, Brother Daniells made a clear statement of the matter, as the General Conference views it, and his remarks were briefly supplemented by Brother W.S.Hyatt. The Committee of Twelve were then dismissed from the tent for a short time, and Brother Bartlett was chosen their chairman. Mach man was given an opportunity to express his mind, and then the following report was drawn up and unanimously adopted as their view of the matter:---

That Brother Booth has been dealt with in a liberal and indulgent manner; that the General Conference Committee has done more than it was really justified in doing in contracting with the him on the last occasion; that Brother Booth's connection with the cause does not appear to have been profitable thereto; and that any new arrangement would not be likely to result more favorably. The brethren most sincerely wish Brother Booth success in any work to which God has called him.

On behalf of Twelve,

Brother Booth expressed his satisfaction on hearing the decision, and promised to abide by it.

W. ROBINSON'S CASE:

The first question introduced was that of Brother W. Robinson and wife, of Spain, who feel that Brother Ballenger's ideas with reference to the sanctuary are right. The case is a grave one, n and we feel anxious to continue them as workers in Spain, if possible. It was-- VOTED, That the President of the General European Conference be asked to carefully correspond with Brother and Sister W. Robinson, doing everything he can to enlighten and instruct them, and to win them over to the truth; but that if, after due time for consideration and reflection has been given them, they do not see their way clear to change their views in harmony with those held by our people, they they be retired from our mission in Spain, and returned to Great Britain.

#### BOND BROTHERS RETURN:

After considering the correspondence that has recently passed between the Bond brothers and the Mission Board, especially Frank Bond, it was thought that it would be well to ask for the services of both brothers, in case California would feel free to assure them their support. It is understood that they pay their return passage to Spain. It was-

VOTED, That we recommend to the Latin Union Committee the advisability of favorably acting upon the return of the Bond brothers, providing the California Conference would support them both in the Spanish field; and the two brothers would be willing to work under the direction of the Latin Union Committee, and be rated as the other laborers are audited in that field.

### B. HOUSE SUGGESTED FOR EGYPT:

A ketter was referred to, written by Brother Wakeham, and asking that a good young minister or licentiate beselected for Egypt, to come and learn the language and master the situation, so that it would heave Brother Wakeham more free to assist in looking after the Oriental Mission. It was thought that B. House, of Ohio, might be a man who would fit into the work nicely, and therefore it was-

VOTED, That the Mission Board be asked to furnish a suitable young man for Egypt, and that we would suggest the name of Brother B. House, of Ohio, providing that conference would be willing to send and support him in the field.

In this connection the learning of the Arabic was spoken of as one of the tasks before the young man who should go to Egypt, and it was felt that only in case it were probable that he would succeed at mastering that tongue would it be well to attempt the securing of the services of this young man. Inquiry into his ability to learn languages should be made before he is sent to Egypt.

### ASIA MINOR:

Since Brother J.H.Krum left, last year, there has been a great need of help in Syria and Asia Minor. We ought to have a good man there to assist Brother Baharian. It was--

VOTED, That the Mission Board be asked to supply a suitable minister for Asia Minor.

#### WORK IN NORWAY, H. HANSEN:

The situation in Norway was dwelt upon quite carefully by Brother Conradi, and he stated that there must be a change there, as it seems impossible for the present committee and workers to agree. It was therefore.--

WOTED, That it is our judgment that Brother H. Hansen, of Norway, should be advised to make Denmark his field of labor for a year, and we would ask the Mission Board to counsel with Brother P.A.Hansen, to this end.

#### "MINISTRY OF HEALING":

It wasstated that inasmuch as Sweden has some \$16,000 capital, it would be well for that field to bear the expense of getting ready "Ministry of Healing," instead of expecting it to come from the Hamburg office. It was also stated that Brother E. Arnesen had been chosen to do the Danish translation on that book.

London, August 15, 1905.

#### PRESENT:

Brethren Conradi (Chairman), Daniells, Hyatt, Sisley, Andross, Salisbury, and by invitation, Dail, Frayer by Elder Andross,

### GENERAL EUROPEAN AUDIT:

The first subject of the evening was the audit of the General European workers for the first six months of 1905, showing a net expenditure of \$1,389.36.

#### SKODSBORG ENTERPRISE:

The rest of the time was taken up in discussing propositions presented by Dr. Ottosen in his letter of August 7, to Brother Conradi. After a thorough consideration of the plans presented, concerning the erection of a new building at a cost not to exceed 50,000 kroner, it was-

WOTED, That W.C. Sisley and L.R. Conradi be asked to formulate a motion with reference to the Skodsborg situation,

### BRITISH FINANCES:

Brother Conradi then called attention to the loss in the tithe of the British Union for the first six months of 1905 as compared with the first six months of 1904--about \$125. The shortage comes from Ireland, Scotland, and South England. It is felt that this question should be very carefully looked into by the British Union Committee, lest the income behould not increase as it ought to for the carrent year.

London, August 16, 1905.

PRESENT:

Brethren Conradi (Chairman), Daniells, Sisley, Andross, Salisbury; by invitation, Dail.

The afternoon had been spent considering some British Union matters, and that meeting was informally merged into the Joint Committee.

### SKODSBORG BUILDING:

The subject of the evening was the consideration of the report of the committee appointed to submit recommendations concerning the Skodsborg building question. The following was unanimously adopted:---

Whereas, The patronage of the Skodsborg Sanitarium is such as to demand additional buildings to take the place of those that have hitherto been rented at great expense and serious disadvantage and, farther, as we are already in possession of suitable ground for such buildings; therefore, --

Resolved. That we would favor the immediate erection of a building at a cost not to exceed 50,000 kroner, under the follow-ing conditions:--

1. That the financial affairs of the institution be placed under the most economical management, so that its earnings can be fully used for the erection of this building,

2. That the salaries of the medical staff and all employees be adjusted so as to be in proportion to the salaries paid throughout the General European Conference.

3. That Dr. Ottosen relieve himself of all private business so as to devote himself entirely to the interests of the Skodsborg Sanitarium, thus giving the sanitarium the full benefit of his labors, and making it possible to reduce the present medical staff.

ŧ,

4. That a vigorous effort be made throughout Denmark to sell as large a number as possible of the "Ministry of Healing," and that the proceeds be applied to the building.

5. That we request the Relief Bureau, and the respective conferences in the States, to kindly grant us one-half of the met proceeds of the sale of the Danish-Norwegian books in the United States for this purpose.

6. That, in order to secure funds for immediate use, we suggest that the new building be mortgaged for 21,000 kroner, at a rate not to exceed 4%, and that the Hamburg Seventh-day Adventist As sociation advance 10,000 kroner at 4%, to be returned as fast as it can be collected from the earnings of the institution, and the sale of "Ministry of Healing."

In explanation of these propositions, we would further add that the Skodsborg Sanitarium now has a floating debt of 20,000 kroner, which it would like to dispose of; this, with the 50,000 kroner required for the building, would make 60,000 kr. Up to Muly 31, 1905, the net earnings of the institution for the past seven months had been 11,195 kroner, so they surely ought to reach 18,000 kroner earnings for the full year, 1905; and if the new building is to be ready for use next year, the earnings for 1906 ought to be ht least 20,000 kroner. Then we would expect from the sale of "Ministry of Healing" in America and in Europe, 15,000 kroner. So, taking the 21,000 secured by mortgage, and the 38,000 kroner by the earnings, and the 15,000 from the sale of "Ministry of Healing," we would raise the 70,000 kroner and still have a margin of 4,000 kroner for incidentals.

The floating debt can easily be carried mother year, and the 18,000 kroner earnings, the 21,000 from the mortgage, and the 10,000 from the Hamburg House, would make 49,000 kroner, or nearly enough to erect the proposed building. Then the coming year the floating debt could be covered, and, later on, the money returned to the Hamburg House. If this financial program be carried out, it would not only double the present worth of the Skodsborg Sanitarium, during the next two years, but would increase its earning capacity at least three or four thousand kroner per annum.

Naturally, we would expect the consent of Elder P.A.Hansen would be secured to the above proposition; and we have written him today (August 16), requesting him to wire in case he is favorable, within the next three welks; that we may begin with the erection of the building as early as possible.

Brother Enoch collected \$375 in cash in the West, \$280 available for distribution to general purposes. He suggested this as an aid in building various meeting houses now under way.

He has pledges further from four fields for about \$400 and would be glad to use this toward getting a press so that they can print the Caribbean Watchman, which they believe they dould produce themselves to good advantage. They can hire labor at 24 cents a day, and can print tracts and pemphlets much cheaper than they can purchase.

Four members of the local Caribbean Conference Committee agree to raise \$100 each, and with the \$400 from pledges they could secure a printing outfit.

The question came up as to how this work should be operated to avoid the plan of having funds sent to private individuals to be expended on individual judgment without accounting to a recognized body.

It was agreed that it would be proper for Brother Gilbert to ask the Atlantic Union office to handle the accounts and to make provision so that he will be able to account to the Union for all money received, and expended, thus avoiding giving opportunity for any criticism.

### MEDICAL COLLEGE LOANS:

E lder Irwin presented a request from a brother in Ohio for information as to the advisability of responding to a call for loans or transfer of notes sent out by the Medical College at Battle Creek.

The following action was taken: --

Whereas, At the late session of the General Conference, held at Takoma Park, Washington, D.C., May 11 to 30, 1905, the following preambles and recommendations were unanimously adopted:--

> "Whereas, The growth and extension of our denominational work has become so varied and extensive that it is impossible for the General Conference, either in itself, or through its committee, to familiarize itself with the needs of the cause in every place; therefore, --

We recommend, (a) That the General Conference assume no financial responsibility mateman whatsoever in any institution, corporation, or enterprise planned and started in the various parts of the w rib without a direct action by the General Conference, or by the General Conference Committee.

"(b) That all parties loaning money to such enterprises should satisfy themselves as to "the security" before making such loans."

And further, --

Whereas, In a recent communication addressed to the Vice-President of the General Conference, one of our brethren asked concerning the advisability of loaning money to the American Medical Missionary College, a corporation of Battle Creek, Michigan, or transferring notes held against the General Conference Corporation to said American Medical Missionary College, taking in lieu thereof the note of the American Medical Missionary College; therefore, -- We hereby notify all interested parties. That the General Conference is not in any wise responsible in any way for the management, control, or direction of the American Medical Missionacy College, and that all individuals loaning money to said corporation must look to said American Medical Missionary College for satisfaction therefor, inasmuch as the General Conference Corporation, the General Conference Association, or the General Conference unincorporated are not, and will not be in any wise responsible for any obligations contracted by said American Medical Missionary College.

At an informal meeting held November 10, 1905, Professor W W.Prescott and A G.Daniells were asked to draft a statement setting forth our need of a spiritual awakening in view of the times in which we are living, which could be used in the correspondence sent from this office concerning the week of prayer. The following was presented and adopted:---

The present condition of things in the world at large, in the professed Christian church, and in our own denomination, moves us to make an earnest effort to arouse our people to an appreciation of the solemn significance of our position, and to call upon them to wait earnestly upon the Lord for a quickening of our faith and zeal in this message.

There are troublous times in the world. There is a manifest spirit of unrest among the people of many countries. They do not realize that they are being stirred by a power from beneath in preparation for the final conflict. Recent disclostimes in the financial and political world indicate such a disregard of moral standards and such a weakening of moral character as causes surprise and alarm in the minds of those who do not know that we have come to the perilous times which are to characterize the last days. It seems that men's hearts are already beginning to fail them for fear of the things that are coming.

In the professed Christian church there has been such a spirit of compromise with the wrid, and such a departure from the findamental triths of a Biblical Christianity as show plainly that the prophecies concerning the complete fall of Babylon are no now being fulfilled, and that the call should now be sounded forth to come out of her.

At the same time, we are conscious of the lack of that spiritual life and power which ought to be revealed in our own churches and which ought to accompany the proclemation of the third angel's message as the hope of deliverance from these evil times. We therefore feel impelled to make this appeal to our brethren in official positions; to our brethren in the ministry, and to our brethren and sisters in the churches to take these things to heart, and to seek for a real revival of primitive religion among this people. We need it for the glory of God and his truth. We need it for the sake of those millions to whom this message is to be proclaimed. We need it for the sake of our own souls. We need it in view of the experiences which are just before us. We shall earnestly pray that God will stir the hearts of his people to wait upon him for it.
