SYRIA, JOE DAVID:

Call for Joe David, of Springfield, Ill., a native Syrian, to enter Syria as a self-suporting worker. At this juncture letters were read from Brother David and W H Wakeham on this question.

VOTED, To instruct the officers of the Board to take, up correspondence with Brother and Sister David with reference to their returning to Syria as self-supporting workers at their own expense, the plans to be consummated at such time as said officers think best.

NYASSALAND, MISS E EDIE:

In the course of the consideration of the return of Miss IE Edie to Nyassaland, the imperative need of a strong white worker and his wife to connect with that mission was discussed. It was---

This represents money which came in as donations during the General Conference meeting without being accompanied with any advices; evidently the \$12,03 was included in the \$179,12.

I find receipts, receipted invoices and vouchers for the disbursements, with the exception that in a few cases they are not as complete as they should be; that is, orders for stamps, expenses, etc. have not been properly receipted or approved.

The bank account has been carefully checked and compared with statements rendered by the bank, and after verifying the corrections, I find to be in correct balance with the office accounts, and agree with amount which appears on Trial Balance. The cash balance statement attached represents the Bank balance and the amount of cash on hand December 31, as reported by the chakier, Mr H H Gobban, This has been verified by the amount of cash on hand as appears on daily cash balance of January 17, the date of commencing the audit.

Since the entry of the amount of \$179.12, June 29, the cash has apparently been in balance, with the exception of July 23, when it was discovered that checks # 2081 for \$40,00, issued March 20, and #2378 for \$1,000, issued May 9, both for cash, and no previous record of these transactions more than appeared on the check stubs. In this case the cash was short the amount of \$41.00. The \$40.00 item, as you understand, has been charged to Mr W T Bland who issued the check, the \$1.00 item, I believe, should be charged to the Washington Fund.

In the temporary deposit account it would appear from the records that D C Babcock had been charged with \$20.00 in excess of deposit. Either this or the proper amount of the draft was not credited. I simply refer to this in case any question arises in future.

In checking over the back checks, I find where checks have been institudissued in duplicate according to the information on the stubs, the unipermits original in each case apparently has been destroyed, as I do not find them among the files. As an illustration, check #2515 was issued as duplicate for #2474, amount \$2,227.42. The original acording to letter hasevidently been destroyed, but if it had been properly cancelled and placed among the files it would have avoided any question being raised. I have suggested to your bookkeeper and cashier that in futype all cancelled and spoiled checks be preserved and filed in their order.

I find that the books for the year 1905 have been neatly jept and records filed in good order, the ledger in correct balance, and trial balances being taken at the close of each month, which is verified by the trial balance and statements herewith, and with the exception of the matters poinnted out, the condition of the accounts are favorable.

GENERAL CONFERENCE AND BATTLE CREEK CHURCH:

WW Frescott called attention to the matter of the equity claimed by the General Conference and the Battle Creek church in the property of the Review and Herald in Battle Creek. A full statement was given by I H Evans, explaining the amount originally invested by the Review and Herald, the General Conference, and the Battle Creek church in the building now owned by the Review and Herald. The original cost was about \$11,000. Of this amount \$1,600 was invested by the Battle Creek church, and \$3,500 by the General Conference.

The Battle Creek church has a further claim on \$400 due them from the General Conference as commission for selling a thousand copies of the book "Christ"s Object Lessons."

There being some \$800 due the Review and Herald from the Battle Creek church for heating the tabernacle since the Corporation in Washington took the plant in Battle Creek, it was-

VOTED, That in view of the great expense necessarily incurred by the Review and Herald in removing from Battle Creek in harmony with the advice given this Corporation by the General Conference, and because of the depreciation of the property in Battle Creek because of this removal, we recommend to the officers of the General Conference that the claim for the original investment of \$3,500 be waived.

On motion it was further VOTED that-

Whereas, The General Conference and the Review and Herald Publishing Association moved out of Battle Creek, Michigan, in harmony with the advice and instruction of the General Conference of the Seventh-day Adventists in session assembled at Oakland, California; and,-

Whereas, inxikis The spirit of prophecy instructed the General Conference and the Review & Herald to move their headquarters from Battle Creek, Michigan to some place in the East; and,

Whereas, In this removal the real estate of the Review and Herald located at 267 West Main Street, in the city of Battle Creek Michigan, has greatly depreciated in value; and,-

Whereas, The Seventh-day Adventist church located at Battle Creek, Michigan, holds an equity in the said brick building, known as the Review and Herald office, located at 267 West Main Street, to the amount of \$1800, and has asked the Reveiver of said Seventhday Adventist Publishing Association to settle for the claim; and,-

Whereas, The equity in the said Review and Herald building is not worth its face value, owing to the great depreciation in the market value of the property; and further, -

Whereas, The Seventh-day Adventist church of Battle Creek, Mich igan, is owing said Review & Herald Publishing Association on heat for the tabernacle between \$700 and \$800; and,-

Whereas, The said Battle Creek church of the Seventh-day Adventists also asks that \$400 be allowed them as commission on the sale of "Object Lessons;" and,---

Whereas, The General Conference of the Seventh-day Adventists having an equity in said west building in Battle Creek, Michigan, to the amount of over \$4000, but has donated the same to the Review and Herald because of the heavy expense to which it has been in this removal; therefore,-

We petition the Seventh-day Adventist church of Battle Creek, Michigan,-

1. To balance its account with the Review and Herald Fublishing Association of Washington, DC., waiving its claim of \$1800 against said Receiver of the Seventy-day Adventist Publishing association, and receiving credits on the books of the Review and Herald Fublishing Association to the amount of the book account standing against said Seventh-day Adventist church for h heating said tabernacle.

2. That the claim of \$400 as commission for the selling of "Christ"s Object Lessons" shall also be waived in this adjustment of accounts, andthat the above items be considered settled, and a receipt passed to the Receiver of the Seventh-day Adventist Publishing Association for the amount of \$1,800.

SUPPORT OF DEPENDENT WORKERS:

The committee appointed to make recommendations concerning the support of aged and feeble workers, or their families, submitted the following:--

Vereas, There is an increasing number of workers who have given their lives unselfishly to the cause of God, who are unable from various causes to continue their arduous labors in the cause; and \rightarrow

Whereas, Oftentimes a laborer falls at his post of duty leaving his wife and children without means of support; and,---

Whereas, The tithe is the Lord*s for the support of the gospel ministry; therefore .---

We recommend .---

1. That we urge upon every State Conference, Union Conference, and Mission Field both the duty and the privilege of supporting faithful dependent workers and their families who are unable to support themselves because of sickness, declining years, or death.

2. That we advise that workers be supported, as far as practicable, by the Conference of Mission Field where their labors cease, or by the Conference where the principal part of their work has been performed.

3. That this support be given cheerfully as unto the Lord, and that all embarrassment of having to ask or petition for the same be removed by the respective Conferences and Mission Fields placing these workers upon their regular pay-rolls, and remitting to them as to workers who are actively engaged in service.

4. That we urge our General Conference men to request State and Union Conferences not to endeavor to shift the responsibility of supporting these workers, but to show a warm heading layalty to dependent ministers and their families, and to make arrangements for their support where they have done their work and where they may be located.

The report was accepted by considering each item separately.

DENOMINATIONAL INSTITUTIONS:

The committee appointed to make recommendations concerning the policy which the Meneral Conference advises to be followedc in the organization, holding, and operating of denominational institutions throughout the country, submitted the following report:--

Whereas The General Conference Committee have been requested to give information concerning the policy they recommend in the holding of institutional property, which is bukit up and maintained by the donations and sympathetic cooperation of the people, therefore --

We recommend ---

1. That we recognize the principle that the people who build up and support an enterprise should own and direct the control and management of said property.

2. That future corporations for holding property be organized on a membership basis.

3. That the membership of such institutions be not placed upon a monetary basis, but be so arranged as to make the constituency represent the field from which the support is to come.

4. That all institutions or enterprises built up by the contributions and fostered by the patrongge and sympathy of the denomination, shall have their property held by a corporation who semembership is representative of the people, and whose Charter and By-laws are subject to change by the membership only, and secures the property to the denomination.

After carefully considering each item the report was unanimously adopted.

WOTED, That we approve of the plans of the B⁰ard in arranging for J P Anderson to go to China, and encourage him to go on as soon as the plans are comp leted.

I H Evans made a statement concerning the present state of the Samoan Sanitarium property, and the relation of Dr.Braucht to the same.

VOTED, That it be the policy of the Board to pay a reasonable fee for a language teacher when missionaries are sent to a field in wwich a difficult language must be mastered in order to do efficient work.

AFRICA:

VOTED, To refer Africa's request for a doctor to the committee named to supply medical help for India.

VOTED, To invite Brother Geo. Istael of South Lancaster, Mass., to go to South Africa, to connect with the printing and publishing work in that country.

We recommend that plans be entered into by our union and local conference executives that will place this work of the Signs before all our camp-meetings and other general gatherings, and that this general work be followed by placing it in detail before all our churches and isolated Sabbath-keepers,

MEDICAL DEPARTMENTY

A G Daniells mentioned the growth of our medical work during the last five years, stating that thirty-six sanitariums and treatment establishments had been added to the list during that time.

Dr W A Beorge, the chairman of the Medical Department, spoke of his attitude toward this work, and of his desire to stand true to principle.

Dr J E Froem, the secretary of the Department, presented a report to the Council, showing the present status of the work of the Medical Department, and making some recommendations to the Council which were considered and acted upon later.

3. That we request Dr J E Froom to correspond with A J Harris and W E Caldwell, with reference to further perfecting their professional education with a year in a medial school.

The committee appointed to consider medical missionary help for the East made the following report, which was unanimously adopted:

We recommend that Dr and Mrs D C Ross, of Keene, Texas, arrange to proceed to Manila according to the plan proposed by the last General Conference; and we suggest further the advisability of their first spending two or three months at the Sanitarium in C⁰llege View, Nebr.

YASHVILLE SANITARIUCI

The following petition in behalf of the Nashville Sanitarium was presented --

"To the General Conference Committee: --

"Our Nashville Sanitarium is very hard pressed for money with which to meet current obligations, amounting to \$1,500, which are very pressing. Our Board has already promised to satisfy L C Heminger for money advanced us on the purchase of our land, to the amount of \$2,000, out of the first money raised on the appropriation to our Nashville Sanitarium.

"Our Southern Finance Committee has promised that Graysville shall have \$1,500 from the first funds raised on the Southern Fund, with which to meet demands for the Graysville Sanitarium work.

"We ask you to help us in ourpresent need by advancing to us the sum of \$1,500 the same to be taken from the first money raised for us, after the above two items are met. To this we fully agree.

VOTED. To authorize the officers of the General Conference Cruoration to make a loan of \$1,500 in response to this request, the same to be returned as suggested.

In order to encourage the union conference medical chairman to devote part of their time to the general interests of the medical missionary work in their territory, we suggest the advisability of each union conference bearing a part of the expense of providing a medial assistant for ite medical chairman.

MEDICAL CREDENTIALS:

VOTED, To grant ministerial credentials to S Mortenson, L H Christian, G F Haffner, and O E Reinke, laborers in the General Conference employ.

The secretary was instructed to cprrespond with California and Michigan, where M G Kellogg and A C Bourdeau respectively are located, with reference to their receiving credentials from said conferences.

UNION CONFERENCE LINES:

The Committee appointed to consider the rearrangement of the territory belonging to the Central, Northern, and Lake Union Conferences, submitted the following report:--

1. That Canada, beginning at the eastern line of Manitoba and extending to the pacific Coast, be embraced inwhat is known as the West Candáan Mission Field.

2. That a suitable superintendent be subscied to direct the work in this field.

3. That this field be under the general direction of the General Conference.

4. That the Wisconsin Conference, now belonging to the Lake Union Conference, be transferred to the Northern Union Conference, providing such transfer receives the approbation of the said Wisconsin Conference, and the Lake Union Conference, to which it now belongs. In case such recommendation is ratified by said conferences, the recommendation to take effect January 1, 1907.

It is understood that this transfer is not to disturb the present educational relations and financial obligations of said conferences toward the Berrien Springs school.

Considerable discussion followed the various items, in which a number of the members of the Council participated. It was

VOTED, That in view of the fact that there was not unanimity of sentiment prevailing in reference to the report, it be laid on the table.

FURTHER VOTED, To invite the Central Union Conference to pay annually \$1500, and the Lake Union Conference to pay annually \$1000, into the Werthern Union Conference for the development of the work in the Worthwest Territory of Canada.

FINA NCES:

The financial committee appointed to bring in recommendations concerning the various enterprises that have been discussed in the council submitted the following report: G A Irwin, A G Daniells, F T Magan, A 0 Tait and others spoke at some length, pointing out the fact that \$50,000 would not be a sufficient sum to finish the buildings necessary for carrying ont the work in Washington as outlined by the spirit of prophec

VOIED, That the report be amended so as to read \$150,000 instead of \$100,000.

With this an endment the report was adopted.

ONE HUNDRED THOUSAND DOLLAR FUND:

Whereas, The Southern Union Conference has petitioned the General Conference Committee to assist it in raising the sum of \$40,000 for the development of its institutional work in the South; and,-

Whereas, The spirit of prop hecy has repeatedly instructe this denomination to assist the South in opening up irs work in many of its large cities; and further .-

Whereas, The work at Washington, D C., is still i n need of additional help to complete the buildings which have already been started, and to place them in a condition where they can command the respe ct of the public in this important center; therefore, -

We recommend,

1. That a fund of One Hundred Tⁿousand Dollars be raised for the work in the South, and to complete the work in Washington, D C.

That the first \$50,000 received from this fund 2. shall be donated to the work in the South.

That the funds shall be sent to the treasurer of 3. the General Conference, at Takoma Park, Washington, D C.

That our church paper, the Review and Herlad, the Watchman, the Signs of the Times, and the foreign papers in the United States, ppen their columns for suitable articles from various persons agitaging the raising of these funds, and that a list of these donations br printed in the Review and Herald.

That the president of the General Conference open 5. up the campaign for this fund by publishing an article in the Review and Herald and other papers, accompanied by the recommendations of the General Conference Committee favoring the raising of the fund.

That the editors of these papers are invited 6. to make frequent favorable mention of this fund.

That in our efforts to raise this fund we earnestly 7. solicit the sympathetic co-operation of our union and state conferences, and of our people everywhere,

The matter of the territorial division of the German work was considered. G A Irwin suggested that there should be a clear understanding of the matter, that there be no confusion in the placing of German workers in the various fields, or in dealing with any other question which pertains to this line of work. GF Haffner and AG Daniells spoke on the subject. It was urged that these questions should be handled on the same general plan pursued in the various union conferences in their relation to one another.

FOREIGN DEPARTMENT:

The Foreign Department presented a recommendation that a general collection for the International Fublication Association be taken the first Sabbath in November, 1906. It was unanimously

VOTED, That this collection be taken.

FUBLISHING DEFARTMENT:

A communication was laid before the Council from the officers of the Relief Bureau, containing a number of suggestions, and it was--

WOTED, That a publishers convention be held in the United States, as suggested, at such time and place as devibe decided later.

VOTED, That the matter of publishing Spanish books and literature be pushed from the Facific Press, and that they secure such assistance from Professor G W Caviness as may be necessary in doing this work.

VOTED, That we fully approve of the plan of continuing the great missionary campaign inaugurated, on the same general plan as last year,

WOTED. That we recommend that each union conference where the "Christ's Object Lessons" work is not yet finished take steps for the early completion of this work.

WOTED, That from the information and data we have on hand, we are unable to suggest a better plan for the handling of the funds accruing from the sale of "Ministry of Healing" than the one mecently adopted by the Relief Bureau.

VOTED, That in view of the fact that Iowa, Kansas, Nebrasks and Missouri have sanitariums on which there are debts, we approve of the suggestion of the Relief Committee that these conferences be relieved from appropriating a portion of the funds accruing from the sale of "Ministry of Healing" to the Boulder Sanitarium.

WOTED, That union conferences be advised to appoint a relief committee for the energetic prosecution of the sale of the book "Ministry of Healing" within their territory, and by such other means as may be necessary take steps for the successful prosecution of this relief enterprise. The following recommendations were presented by the treasurer of the General Conference and adopted:

RESOLVED, --

DOLLAR FUND:

That we open a fund known as the Dollar Fund.

That we endeavor to persuade our people to each devote one dollar per year to this fund, the same to be used in liquidating the present obligations of the General Conference and other imperative demands made upon it.

BRITISH SCHOOL:

That the \$10,000 called for with which to assist in establishing a much needed school for Great Britaain be raised by our union conference presidence in soliciting liberal donations from those who are best able to give.

That articles be frequently printed in all our papers setting the needs of the school before our people.

COLORED WORK:

That we appropriate 5% of the October donation for 1905 and 1906 to the development of the work among the colored people of Washington, D C. the same to be expe ded under the direction of the District Executive Committee.

MARITIME SCHOOL:

That matter of re dering help for the school in the Maritime Conference was presented by Wm Guthrie. The present capacity of the school is filled, and it is necessary to make some additions. About \$1,600 is needed in order to make the school a success.

VOTED, That \$2000 be added to the call for the school in England, and that this additional \$2000 be used when raised for the Maritime School.

Adjourned sine die.

VOTED, That we recommend to the D¹ strict Committee that they extend their evangelical work to the city of Baltimore, cooperating with the Chesapeake Conference to the extent of supporting, for a time, one laborer in that city, thus assisting in building up the work in that important center.

L F SVENSSON TO SWEDEN:

VOTED, That we recommend L F Svensson, of Colorado, who is planning to visit Sweden, to the favorable consideration of the European and Scandanavian Union Conferences, and request that Elders L R Conradi and P A Hanson do all they can to make his visit as beneficial as possible to the work there; and if his work proves to be satisfactory that they render him such financial help as is necessary, th e General Conference to consider favorably the matter of sharing in the payment of his salary which he is visiting in that country.

Dear Brethren and Sisters in Christ: --

We regret that circumstances have prevented us from submitting an earlier reply to your communication addressed to the General Conference the 26th of February, last. When your letter came to the office, the President and Vice-President were on the Pacific Geast, and did not return until the first of April. Immediately on their return, the General Conference spring council convened in Takema Park. This lasted two weeks, and created such a large amount of extra work to be attended to by the officers of the Gommittee, that they have found it impossible to reply at an earlier date.

In order that all may have a clear understanding of the questions to be considered, we herewith submit the entire letter addressed to us: --

Washington, D.C.,

February 26,1906.

THE GENERAL CONFERENCE OF SEVENTH-DAY ADVENTISTS,

Takoma Park, D.C.,

Dear Brethren: ---

"We believe that the third angel's message is of God, that it is for all the people, and that it is to be given in this generation.

"We desire to give the whole message in our day, and generation; but we find ourselves handicapped in that we have no schools, hespitals, or sanitariums under our control, or, to thebest of our knowledge, for our use.

"And, as there is no relief in sight along the line of hospital, school, or sanitarium facilities (judging from the dectrine of expediency by which the Seventh-day Adventist churches in this city were separated on racial grounds), The People's Seventh-day Adventist church, 10th and V Sts., N.W., in convention assembled, hereby requests to be informed, specifically and unequivocally, whether its members are privileged to accept the services and benefits of the schools, hospitals, and sanitariums, either or all of them, now under the control of or operated by the General Conference of the Seventh-day Adventist churches, located at Takoma Park, D.C., or by May District, state, or local cenference subordinate thereto or in ecclesiastical fellowship therewith, or by any person or persons acting under or deriving or pessessing power or authority from either or all of the directing, centrolling, or supervisory bedies hereinhefere mentioned, known and sometimes called or spoken of as Weneral, District, State, or legal Conferences.

"If so, please state the name and locality of such hospital or sanitarium whose doors are opened for the treatment of the ailments of the members of this church, or of such schools where the children and youth of this church may be educated along God's appointed lines.

"The urgent and immediate needs of The People's S.D.A. church along the lines of medical and educational facilities not only demanded this communication, but demand immediate relief; therefore, an early reply will be highly appreciated.

"Sheald a specific reply relative to the points herein set forth be deemed not expedient at this time, it is suggested that this downch be granted the privilege of using its tithes and offerings for the purpose of creating such facilities as its work may demand from time to time.

"A written enswer on or before the 15th of March, 1906, is respectfully requested.

This letter has been given careful consideration by the General Conference Committee. We realize that the subject with which it deals is a delicate one, and we wish to counsel with you in candor and fairness, as Christian brethren, regarding it. While your letter makes inquiry regarding educational

and medical missionary training advantages, we understand that

the race question is the real question at issue. In regard to this matter, we wish to state that Seventh-day Adventists have never attempted by any official action to define or settle what is commonly known as the color-line question. As they have endeavored to carry forward their work in behalf of the colored people during the last twenty-five years, they have met with many difficulties. At times it has been suggested that resolutions be passed in conference sessions, defining by official legislation the position of the demomination; but this has never been done. The testimenies have given explicit instruction that this should not be done. They say: "Such action is not called for. Let not man take the place of Ged, but stand in awe, and let God work upon human hearts, both white and black, in his own way. He will adjust all these perplexing questions. We need not prescribe a definite plan of working. Leave an opportunity for God to do something."

Thus every conference committee, church Board, and minister is left free to adjust the perplexities of this difficult problem according to the circumstances and the necessities of the case in different localities. No one is hampered nor bound by any regulations passed by the General, Union, or local Conferences.

It scarcely seems necessary for us to declare in words that Seventh-day Adventists believe that all the blessings of the gospel are for all mem alike, regardless of caste or color. The great efforts and the continual sacrifice this demomination has made and is still making to proclaim the everlasting gospel to every nation, kindred, tongue, and people, spake more elequently than could any formal statements we might make. And, believing as

we do that the gospel is for all men, and working as we are to carry it to all, how utterly inconsistent and foolish it would be for us to take a position toward any class of people for whom we are making such earnest efforts, that would deprive them of any of the advantages and blessings of the gospel!

No true Seventh-day Adventist can cherish in his heart any feeling of hostility or prejudice against any human being because of his nationality, race, color, or station in life. The benefits and blessings of the gospel are for all mankind. Salvation is to be denied to none.

But because this is so, it does not follow that in the work of salvation no wisdom or tact is to be shown in order to reach men's hearts, and save their souls; nor does it mean that no attention whatever is to be paid to circumstances and conditions as they exist in the world. Both the labors of Ghrist and his instruction to his disciples teach us that the greatest wisdom and care shall be exercised in approaching men, and women in error and superstition, in our efforts to draw them into the hight of the gespel.

Seventh-day Adventists are a separate and distinct people from all other religious bodies and organizations of every kind. They have a definite and peculiar message to proclaim that no other organized body of people professes to be giving. They have an aim, a purpose, and a policy of their own in harmony with the character of their message and work. They do not believe that socialism, civic referm, and modern humanitarianism are the vital questions for them to deal with. They do not believe that it is their special work to agitate the question of the special and rights as far as consistent and just when by doing so they can remove prejudice from people in error, and thus bring then to the knowledge of the truth.

Fourth. That whenever and wherever this principle of self-sacrifice for the good of others calls for the separation of the races in school and durch associations, it should be carried out voluntarily in a cheerful, Christian spirit.

Fifth. That where this is done, suitable provision should be made to instruct and encourage the believers of all classes, and to strengthen and develop the work and workers among them. The General Conference Committee are aware that in the past they have come far short of doing all that they have earnestly desired to do in this respect. Our white people in some sections, our German and Scandinavian brethren in America, and our colored people in some places, feel that they are not receiving the help they require in order to do their part of the work justice. We know that there is occasion for their feeling thus. But, when we have done the best we can, we find ourselves umable to provide all the help required as promptly as it is needed.

Sixth. That provision should be made in or near the District of Columbia to give our young colored people educational training to fit them for Christian missionaries in both home and foreign fields. This training should be broad and varied enough to prepare them for the monistry, Bible work, canvassing, school teaching, and nursing.

Seventh. We recognize the fact that the financial and teaching help required for such a work must be provided very lar-

equality of the races.

The supreme question before Seventh-day Adventists is that of proclaiming to all men the everlasting gespel as set forth in the great three-fold message of Revelation 14: 6-14. This is the highest and best service they can render to rich or poor, white or black. This is God's message and work in the world for this generation. This message will impart to those who receive it all that is best, all that is needed, and all that is to be desired. Eveny other consideration should be subordinated to that of making this message known to anxious, suffering, lest humanity,

The people, either white or colored, who have this message and the exalted privilege of giving their lives to its promulgation have no occasion to worry or war over questions of politics, speiel positions, and many other individual rights and privileges. We may well esteem it a privilegete set all such questions aside, if by so doing we can the more effectually impart this message to men. Jesus, and many illustrious Bible charact ers, such as Messes and Paul, furnish examples worthy of imitation in this respect. Jesus made himself of no reputation. Moses voluntarily surrendered the throne of Rgypt to identify himself with his oppressed and down-trodden race. Paul reputational that the world counts dearp and became all things to all men that he might save some.

We accept what the Bible and the Testimonies teach regarding the brotherhood of men and the Fatherhood of God. We also accept the counsels of these writings that in our work we must be as wise as scrpents and as harmless as doyes. We believe that the fellowing cautions given by the Spirit of prophecy

are of great value in the consideration of the question with which we are dealing, and that they should be carefully heeded: --

"As far as possible, everything that will stir up the race prejudice of the white people should be avoided."

"There is danger that if the color-line question is agitated before the people shall hear from the Bible the reasons of our faith, the minds of many will be closed against the truth. do We must all we possibly can to get the truth before the people. We de not want to close the avenues whereby we may gain access to people of every class.

We have no time to get into contention over the color line. What kind of a line could human beings make? They might lay many plans, which would be laid aside as impracticable to be worked out by the church. I have but one testimony to bear: Receive the Hely Spirit before you submit your plans for dealing with the color line. I can not see how, until then, any plans that you devise can be a success. When you receive the truth as it is in Jesus, you will find that the color line has adjusted itself. There will be a wonderful revival of gespel medical missionary work. The workers will all the time be receiving fresh, new ideas. The great work before us all, as Christians, is to extend Ohrist's Mingdom as rapidly as possible, 'in accordance with the divine commission."

"Not a word should be spoken to create prejudice, for if by any careless or impulsive speech to the colored people in regard to the whites any prejudice is created in their minds against the whites, or in the minds of the whites against them, the spirit of the enemy will work in the children of dischedience. Thus an epposition will be aroused which will hinder the work of the message, and will endanger the lives of the workers and of believers."

"We have no right to do anything that will obstruct the light which is shining from heaven; yet by a wrong course of action we may imperil the work, and close the door which God has opened for the entrance of the truth."

"Make no masterly effort to break down the prejudices of the Southern people, but just live and talk the love of Jesus Christ."

"The breaking down of distinctions between the white and the colored races unfits the blacks to work for their own class, and exerts a wrong influence upon the whites."

"Those who think that the precautions given are unnecessary should heed the warnings the Lord has sent. If you/would have a part in the work in the South, my bräthren, you must hide self in Christ, walking humbly and circumspectly before God."

In view of these considerations we venture to submit the following statements with the hope that they will meet with your hearty approval and thus prove a basis of union and cooperation in our work: --

First. There should not exist in the hearts of men, especially Christians, and more especially Seventh-day Adventists, prejudice against any ofour fellow-men because of nationality, race, or color.

Second. That the same earnest efforts should be made for the salvation of all classes alike.

Third. That all Seventh-day Adventists of all nationalities and races, should subordinate their personal privileges gely by the demoninant at large, for the believers in Washington are not ablete do all of this themselves. Knowing this, the General Conference Committee are anxious to do all they can to assist in securing these advantages.

Eighth. The educational and medical institutions lately established by the S.D.A. denomination in Washington are not under direct management of the General Conference, but are owned by legal corporations whose interests are managed by boards of trustees. It is not within the province of the General Conference or its officers, therefore, to decide upon the details in the management of these institutions. The Boards in Sharge of these have not, so far as we are aware, considered the question raised in your communications. If we have young colored people in the District of Golumbia who desire the educational advantages afforded by these institutions, we would advise that a committee be appointed by this church to confer with the respective boards mentioned, regarding the matter. After careful consideration, should it be deemed unwise, on account of existing circumstances, for theme to receive this training and education in these institu tions, we have other schools and sanit ariums in this country in which they can obtain the training and education desired, until facilities can be provided for this purpose here at Washington. Among these institutions are South Lancaster Academy, Emmanuel Missionary College, Union College, Bethel Academy, Walla Walla College, Fernando College, Melrose Sanitarium, College View Sanitarium, Boulder-Colorado Sanitarium, and Loma Linda Sanitarium. We may mention Huntsyille, Ala., also, where most carnest efforts are new being made to give our colored young people a practical educe

tion.

Ninth. In replying to your communication, we might have referred you to the respective Boards of management of the Washington Training College and Sanitarium for information regarding entrance requirements, etc., in few words just as we refer other inquirers who write us concerning other institutions; but we have desired to confer with you in a brotherly spirit relative to this vexed question, and set before you principles which should govern us in dealing with this matter. This we have done the best we have known how, and we trust you will receive our efforts in the spirit in which they are made.

In conclusion, we suggest that you now appoint a capable committee from your number, in which you will have confidence, to confer with the Ristrict Committee and the General Conference officers regarding the question of educating the colored young people of the District of Columbia for missionary work.

GRPHANS' HOME, MISSOURI:

A G Daniells read a communication from E T Russell concerning an orphanage located at Mountain Grove, Mo. Elder Russell stated that the orphanage at the present time was under the management of our denomination and operating in sympathy with our work. He said they had some thirteen orphans, for whom they are caring, and that they have placed a goodly number in respectable Christian homes; that Brother and Sister Ames had been faithful in their work and had made earnest efforts to succeed.

Elder Russell asked that the General Conference Committee appropriate \$2,000 out of the April donations to orphanages for the maintenance and help of the Mountain Grove (Missouri) Orphanage, or that the Central Union Conference be allowed to retain the April donations for orphans in its territory, to be used in the support of the Mountain Grove Orphanage.

After careful consideration, the Committee felt that it was not warranted in making such a large appropriation to the small enterprise at Mountain Grove, Mo., but finally-- AGREED that the Central Union Conference sould be authorized to retain from its donations for orphanz \$1,500, to be used as the proper committee may direct in the maintenance and building up of the work at Mountain Grove. Mo.

J O CORLISS REIMBURSED;

The Chairman read a letter from H W Cottrell concerning the arrangements discussed by the Chairman, while on the Facific Coast, and the Facific Union and California Conference Committees, relative to the appropriation by the General Conference of \$1,500 to J O Corliss, from a donation of \$3,000 which the Facific Union and California Conferences were to make to the General Conference; this \$1,500 being understood to cover Elder Corliss' return passage from Australia in about 1898, including the expense which he claims he was under in preparing for a two years' sail with Captain Norman in 1899. It was-

AGREED that the Treasurer should carry out these arrangements on receipt of the money from the Facific Union and California Conferences,

NASHVILLE SANITARIUM:

It was unanimously agreed by the members of the Committee present that the Treasurer of the General Conference should send to the Southern Union Conference on June 1, the sum of \$13,500, the same to assist the Nashville Sanitarium Association in paying for the property which they have recently purchased for the Nashville Sanitarium site.

It was understood, however, that the mortgage on the Rinallis Springs property, held by Brother Heminger, of Bowling Green, Ky., should be transferred to the Nashville Samitarium property recently purchased, providing suitable arrangements could be made, and that \$10,000 of the money thus remitted to the Nashville Samitarium Association should be promptly returned to the General Conference Treasurer.

This led to a lengthy discussion of the situation in most of the foreign fields, and the unanimous sentiment prevailed that the pay of our workers in foreign fields was inadequate for their proper maintenance in many places, and all the members present expressed themselves as being desirous of seeing the wages increased.

Elder Irwin recited some instances that had come under his observation in the Oriental work, where great poverty was indicated by the manner of life, and the table set by the workers in these fields.

The reports from China and Japan, and other fields were then taken up, and a rate fixed for the workers, with instructions that the treasurer should write to the various fields, suggesting the rates made by the Committee, and giving leeway for any changes that were necessary for local conditions.

JAFAN, LOSS OF \$50:

F W Field reported at length the loss of \$50 that occurred in transmission from the hands of Brother Burden to himself. Brother Field stated that he did not feel that Brother Burden ought to lose the money, as he could ill afford to do so; much that the party who brought the money was wholly unable to make a reimbursement for what was lost, and if the Mission Board did not think it proper to assume the same, or was unfriendly to this idea, that he would bear the loss himself, as he was the best paid laborer in the field.

WOTED, That the \$50 mentioned by Brother Field in his communication be charged to the expense account of the Japanese Mission, and the same be borne by the Mission Board.

W C HANKINS' RATE:

The Chairman stated that Iowa volunteered to increase the rate of W C Hankins from \$10 per week to \$12, the Mission Board to audit his account and bill the same to them.

PRIVILEGE OF COUNSEL.

The President madea few remarks concerning the privilege of having the advice of his brethren at least once or twice annually especially in view of some of the perplexing questions that are sprung on him as he goes from field to field.

QUESTIONS TO BE CONSIDERED:

Among the subjects demanding attention at this time are: The meeting of the General Conference Committee in Europe next year; Union meetings in Europe; the Scandinavian field; the call for Prof. Salisbury to return to the states; the Orient; and the appropriations for 1907.

COMMITTEE SESSION IN EUROPE 1907.

Eld. Conradi referred to the advantages to be gained by the veit of the American brethren next year. Not only are such in terchanges of labor good for the brethren who will be present from other parts of the world -- it will also do our Union men in Europe good, to get out of their field for a time, and to visit shout in Europe, that they, too, may keep in touch and sympathy with the 'rapidly developing work, that God is conducting in other Unions. The suggestion to have such a gathering next year jests with our hearty approval.

The best plan would be for the visiting brethren to go from place to place, having sessions of the Committee right on the ground and spending enough time to become fully acquainted with the situation in the field. Should the brethren from America come too early, it would be unpleasant for them; but they could hardly be away from their large compnectings. The possibility of Mid. Daniells attending the Morrison centennial in China in May was referred to. It seems that this would be impracticable, if we were to have him with us here in Europe. Were the Centennial to b in February as at first supposed, it would make his attendance there and in Europe more easily possible. In view of the circumstances, it was MOVED by Brother Spicer, and VOTED That we invite Eld. Daniells to ignore the Morrison Centennial in planning his visit to China. VOTED

That we suggest to the American Brethren the months of April and May, 1907 as the best time for their visit to the British Scandinaviam German and Latin Unions, and that while sessions of the Committee be held in each of these places, the final meeting take place in Gland.

WINTER MEETINGS IN BRITAAIN.

This matter was mentioned, and while nodefinite action was thought necessary, it was the general consensus of opinion that, in view of the success of the local conference last year, it would be well to repeat them this coming season, and again have the British Union Conference next Summer.

SKODSBORG BUILDING.

Eld. Conradi made a brief but clear statement of the circumstances making it necessary to delay the erection of the new building at Skodsborg no longer. Although Dr. Ottosen has not seen his way clear to devote all his time to the ineterests of the Skodsborg Sanitarium, still, he has resigned his position as President of the Philanthropic Society and it is now proposed by the constituents of that society to turn over the Skodsborg Sanitarium to the Scandimavian Union Conference at the Society's meeting next winter. The Doctor remains in our employ as Medical Superintendent of the Skodsborg Sanitarium, while P A. Hansen is Chairman of the Philanthropic Board, and is giving his attention to the erection of a new building which certainly is much needed, for the Sanitarium has recently ween deprived of some of the rented villas it formerly occupied.

VOT ID:

That in view of the changed circumstances at Skodsborg Sanitarium, we sanction the decision recently taken by the brethren at Cepenhagen to erect and equip a new building at Skodsborg, costing about 70,000 Kroner.

PROPERTY IN ENGLAND:

At this juncture Brother Sisley called attention to the necessity of early action on an option he had just received for 94 acres of fine agricultural land 25 miles north of London, near good railway and postal facilities; although there is only one building erected atv a cost of L 700 and probably worth about bound or L-400, yet the option of L 4000 on the place is not thought to be exherbitant at all. As the least expires August 13, if we think favorably of the matter it should be given definite attention soon. As the people are getting somewhat restles it is thought we must give attention to this question with the ide of determining it definitely, before the close of this British Union meeting. The food factory must be changed are long, and the school should get into the country too.

MONEY TO PREDERINGLAVE.

VOTED: That Brother Sisley be request to pay at ence the remaining \$700,00 due the Danish Conference on the Frydenstrand Property taken over from the General Conference Ass*n.

WISH PUHLISHING HOUSE MATTERS:

A review of the work of the Helsingfors House was given by Hd. Conradi, touching especially Brother A. Boettcher's connection with it since 1901 when he was sent there to become manager in the place of Brother Sandberg. Brother Boettcher did real well for about four years, but them there was noticed a lack in his being able tofurnish financial statements and reports as he had formerly done, on time, and it seems that in general he acted a little independent in the investment of means, and there seems to have a little misunderstanding arisen between him and the Mission Superintendent. The health food business which Brother B. begen assumed quite large proportions, so that it took a good deal of his time, and as he needed capital for that, he invested some of the Publishing House money. That business, on the advice of the Seandinevian Union Committee, has been sold for 6,000 FM. cach so that we have at least sustained no loss from it. Just before leaving for Finland, from Sweden at the time of the Swedish meeting. Brother Andersen asked for, and sectored a written statement of the principles that govern out Continental Publishing Committees and morthy after his return to Finland, Brother B resignation, giving as a reason, failing health. He says he has no feelings over the matter and thinks after a year's change he may be able to return to the work. He effers us all the help heand Mrs. Boetcher can render in getting a new man worked in.

Before heldewes, it would be well for Brother Boettcher's books to be audited. The most available man for this purpose seem of to be E. Lind. It was therefore

VOTID:

That Brother Emil Lind be invited to go to Helingfors, and audit Brother Boettcher's books, and that he try to work in some one to take Brother Boettcher's place.

SCANDINAVIAN SCHOOL

Brother Hansen desired to ask if we had any advice to offer with reference to the reestablishment of the Scandinavian School, which will take the form of a g four month's Bible Course under the charge of Ekd. O. A. Johnson, assisted by a lady Danish and a lady Swedish teacher at Nyhyttan, this winter. It is felt that the committee would be in better condition to advise after this four month's experiment has been made at our meetings in Scandin avia next Spring. But in this question of education in Scandin avia, the brethren feel the deepest interest and synpathy and hope the Bible School is the beginning of a movement that will end in training workers for the field.

MONEY PLEDGED TO SKODSBORG.

Eld. Hansen called attention to a pledge made when the brethren were in Europe in 1902, in which the America n Brethren agreed to raise two kroners for each kroner collected in Demmark, and to send this money over here quickly. However, until the present, this promise has been unfulfilled. Eld. Spicer remembers something about this matter, but states that after the committee returned to the states, they found themselvesright in the midst of a crisis, and that accounts for their not having been able to answer the call. It was suggested that the matter be further investigated.

CALL FOR PROF. SALISBURY TO AMERICA?

As to the call for Prof. Salisbury to be released from Great Britain for the work of Educational Secretary in America, the brethren freely expressed their opinion, pro and con. They do not feel to lightly regard the requests and needs of our friends in the states, for they have always shown us such consideration we would be glad to see our way clear to relase Brother Salisbury. The question was laid on the table, pending fur ther action.

THE ORIENTAL OR LEVANT MISSION.

Eld. Conradi presented the needs of the Levant. Egypt at present is in a critical condition owing to the presence of Segesser's literature, some of which has been trans lated by Brother Ouzounian into Armenian for circulation among our own people there.

In Turkey Dr. George is doing a good work in the Medical Mission, but does not have the necessary time fof evangelical work. He rather feels that he ought to have a gentleman nurse to assist him. Brother Baharian and the four native workers have a great deal of trouble, some of which might possibly have been avoided, had not Brother Baharian thought it necessary to inaugura ate such a religious liberty campaign, setting before the Turkish government what its duty is. Imprisonment and persecution are the lot of our workers there. In Syria we have Brother and Sister Gregorius at Jerusale and Brother Zarub at Beruit, and Sr. Mueller, who will begin operating in Haifa this fall, after her furlough to Germany is over. While Syria and Turkey both need help very badly, yet Egypt should be supplied as soon as possible. In this connection the Committee considered brie fly the names suggested by the American brethren, Brn. Campbell, Sheppler, and Nethery.

ABYSSINIA

2 The work in that country was mentioned. The Scandinavian Union is now collecting funds for opening a mission to that land. One young man is already in sight as a possible worker, and the names of Brother and Sister Jensen were also mentioned in this connection. It was met with such favor in the Committee that it was

That Brethren Conradi and Hansen be a committee to confer with Brother and Sister Jensen, as to how they would geel about going to Abyssinia.

CALL FOR SKODSBORG.

The minutes had been examined, and it was seen that the brethren at Sjodsborg had been promised 10,000 in 1902 toward a power house and food facilities. but there was also another call nade in February, 1903, by the General Conference Committee in session at Skodsborg, for \$1,800.00 toward the new building they were thinking of erecting, and it had been stated at that time that the changes in the food factory, and power house, were, for the time being, unnecessary.

The Committee feels very highly pleased with the manner in which the Scandinavian field has lifted its indebtedness. in view of the present circumstances in both the American and Scandinavian fields, the brethren feel that it would be wise to remind the American Committee of our desire expressed in February, 1903, of course having no objection whatever, if they should want to keep in mind their pledge of 1902.

It was therefore

VOTED:

That we call the attention of the American brethren to the promise they made at Skodsborg in 1902, and ask if they could not see their way clear to favor Skodsborg with a donation of \$2,000. as the Scandinavian Philanthropic Society has long ago raised its quota of the money originally specified, and it is now going forward with the erection of the building.

The new Skodsborg building is to be paid for by money on hand at Skodsborg, and by money put into it by local brethren, and by money raised by a self canceling mortgage on the building to be erected. Of course the indebtedness of the Skodsborg Sanitarium will be somewhat increased by this plan.

BROTHER JENSEN'S CASE.

Although Brother Jensen is willing to go to Abyssinia, yet the question of citizenship papers is one that may cause some trouble. Born in Schleswic-Holstein, he went to Denmark when 17. and left for America at 23. He took out his first citizen's papers there, but as at that time the no-citizen doctrine was preached, he came to E gland without having completed his application for American Citizenship. He would have to remain in England more than a year to get papers here; he might get the in nenmark, but he would have to serve two and a half years in the army. He could get no german papers without a great deal of trou-He could get no papers in America unless he returned there ble. to live again. This is a matter that must be settled before he can seriously be considered for Abyssinia. In case he can get his papers in time, it would be well for him to spend one season in Scandinavia, getting acquainted with the brethren and the work there, before going as their missionary to Abyssinia.

PASSPORTS.

This dicsusion brought up the matter of providing Passports for our American brethren before they leave the states for the Continental and Asiatic of African mission fields.

VOTED:

That we advise the mission Board to instruct all missionaries coming into European territory from the states to provide themselves with passports before leaving.

Of course in such countries as England, where a passport is in no way needed, it would not be a necessity. But for the Continent, and all countries that require it, a passport should be provided.

BROTHER SALISBURY TO AMERICA?

The question of the possibility of our releasing Brother Salisbury was again introduced. The brethren know of no one here who could take his place. It might do nicely if Prof. Griggs were to come in his place, but all feel that we are right now in the transition period for the school and there are some elements in the British field which make it quite necessary for most careful action lest an unpleasnt crisis be preciptated here. We believe that the American brethren are as anxious that nothing be done to in any way cripple the cause in Great Britain as we are; but of course they may not quite so fully appreciate our situation. It seems to us that it would be really better to have the man who is expected to take Prof. Salisb ry's place suggested to us, and agreed upon, and sent to this field that he might work with Prof. Salisbury for a time, sharing the re sponsibilities of managing the school, before a change is permanently made.

VOTED

That although we recognize the needs of the American field for the servixes of Prof. Salisbury as Educational Sec'ty. and pledge ourselves to do our best to release him as soon as possible for that work, still, we express it as our earnest conviction that, as we are right in the transition period of our educational and union work, it would be wiser to leave the return of Prof. Salisbury too the states, an open question for a year or so, and that we ask the hearty co-operation of the American brethren in supplying us the proper man for the place.

BROTHER CAMPBELL TO SYRIA.

A letter from Brother Campbell expressed his willingness to come to Syria, and asked if there would be any objections to the coming of his sister -- a lady twenty-one years of age. who has had four years successful school work in our church schools. Were it proposed for her to come as a housekeeper and companion, to the family, that would not concern us; but if her desire is to enter the missionary work, we would not object, and would suggest a salary of about \$4.00 a week. The salary of Brother Campbeel is suggested at \$12.00 a week. It is expected that after he gets thorougholy acquainted with his local field, he will be asked to take charge of the Levant Union, in case he develops into a man suited for such responsibility. For the first ye year or so he will have all that he can do getting hisbearings, and mastering the situation in Syria.

NETHERY TO EGYPT.

It is thought that this brother would find it necessary to locate in Cairo, as living there is so expensive; his wage was **expected** suggested at \$11.00 a week.

SHEPPLER TO TURKEY.

It was thought that Brother Sheppler who will go to Turkey should receive \$10.00 per week. The time and also the manner of sailing as well as the destination of the brethren for Egypt and Turkey, were left for Brn. Cohradi, and Spicer to arrange.

SCANDINAVIAN AFFAIRS. "

As Brother P. A. Hansen had not been in at the time the vote was taken requesting \$2000.00 for Skodsborg, he wanted to say just a word before leaving London enroute for Denmark. He wished the brethren to appreciate that while the Lord had been good to them, yet they would be pleased to be remembered in their financial problems in Scandinavia. Skodsborg had not received much money. Such were the bookings in regard to Christiania, that while the American brethren thought they had put that house on its feet, it had actually received 39,000 kroner less than they had though t to send from the States; the indebtedness of the whole field with its institutions today is about 400,000 kroner, although they have paid off 80,000 kroner the last few years.

Brother Spicer assured Brother Hansen that America will not forget Scandinavia; they believe in Skodsborg, and in the ultimate success of our work in the Scandinavian Union.

Brother Hansen spike feelingly over the lack of proper educational strength in Scandinavia -- for years this has been one of their great draw backs. Brother Spicer assured us that if some onecould be found in the states for that work, they would be glad to recommend the help needed Meanwhile, let Scandinavia be of good cheer, and do the best possible under the circumstances to develop their own resources.

INFORMAL MEETING OF COMMITTEE

August 15, 1906.

JENSEN'S CASE.

It is found that Brother Jensen would have to remain here full five years before taking out citizen's papers, or until October, 1907. It would cost him only \$25.00 It is thought it would be wiser for him to return to the states, if he could get the citizen's papers enough sooner, to enable him to get off t Abyssinia next summer.

VOTED that in case it requires three months to secure his citizen's papers in the statesm we would favor Brother Tensen's returning to America about the middle of October; but if it will require longer, we favor seeking the advice of the Mission Board about it, and unless there are some specia. advantages of his going there, he be counselled to remain in Great Britain.

It was stated that he might be able to do a good deal of good among the Scandinavian brethren in America for the Abyssinian Mission, if it were found best for him to return to America.

GENERAL EUROPEAN AUDIT.

The six-months audit of the General European CConference was passed upon, allowing 25 6-7 weeks to the president and secretary respectively at the old rate; traveling expenses to the former, \$265.00, to the latter, \$77.95; I. T. S. 29.22; General Expense, \$21.14; Loss on Exchange, \$10.26, making a total of \$1192.20 for the six months. The income from the British Union for two quarters, and the rest of Europe for the first quarter is \$1,016.76.

VOTED:

That hereafter the General European Conference workers receive no credit on the Treasurer's books until they have their accounts auditted.

ORGANIZATION OF A MISSION BOARD FOR EUROPE.

Quite a little time was taken in the dicsusion of the best way to manage the missions we are now planning for Africa. To attempt to manage them as union fields, and at thesame time as a General European, would give confusion. The question also of the disposition of the surplus funds on hand from 1905 was considered in this connection. In view of the coming of the brethren from America in the spring of 1907, a provisionary Mission Board was chosen, consisting of L.R. Conradi, Chairman, E. E. Andross, W. C. Sisley, and HE R. Salisbury, and G. Dail.

This committee will take the supervision of the Mission until there is opportunity for futher counsel with the American brethrenne when they visit Europe next April and May.

SURPLUS OF L(1905.

VOTED, That the Treasurer be instructed to turn over to a Mission Account the surplus of about \$800.00 From the General European Treasury last year.

This will be a fund from which deficits can be partially

covered after the audits of the missions show how they will be getting on financially. It will not be turned over to any local Unikn, but will be at the disposition of the General European Committee.

BRO. CARCASCALLEN TO B. E. AFRICA.

Brother A. A. Carscallen, who had been spoken of for B. E. Africa, to accompany Brother Enns and Brother Peter Nyamb was present, and expressed his willingness to go. He was enxiou that he might be able to assure the young lady to whom he is engaged that in the evnt of her coming down later, she would not be expected to come that long distance alone. It was stated to him that some one else would surely be going down there to re-in force the mission staff within a year or so, and son he could assure the sister's father and mother that she would not be asked to go that distance alone. It was also plainly stated that it would be expected the sister understand that going to Africa means she is to go as a missionary -- to place her all in God's hands, to give up home, and friends, for good or ill and to dedicate herself to that work.

LOCATION OF THE EAST AFRICAN MISSION.

As to the location, the Chairman said that is a matter that will have to be determined when the brethren arrive on the groubd, and have had a talk with the Commissioner General on the subject. We would seek to get into virgin soil as near to good transportation as possible, secure as favorable climate as we can, but still should keep in mind that we should not have the people too far removed from us. It was suggested that Brother Carscallen finish up his work in England and take boat from London to Hamburg, so that he might be there a few days before the other brothren sail (Sept. 1) He would go with them to German East Africa, stay a short time, and then with Brothet Enns, go on over to British E. Africa, either by land, across the railway, or return to the coast, and go from there up the rai way. We think it would be well eventually for them to have carpenter, shoe making, and blacksmithing outfits, but would recommend that for the beginning, they take only such things as are most necessary, ordering the others later. Some time was spent in talking with him, as to other details and then the meeting adjourned.

G. Dail sec'ty.

In informal discussion later in the day, it was decided that Brother Carscallen be granted L 140 with which to meet the expenses of the outfit he will take with him and paying for his journey. Such things as he may need that can be gotten cheap er in England that in Germany he will secure before leaving for the continent, while the rest will be purchased in Hamburg. It is understood that the British Union supply as much as it can from its British E. Africa Fund, and that the rest be made up by the General European.

THE WORLD-WIDE SURVEY:

The chairman proceeded to give a survey of the world-wide field. About a thousand people, workers and families, are spread through the whole world, trusting, Under God, to the home churches to stand by them, in supporting and extending their work. Last year \$375,000 was raised by this people in all the world for distinctively missionary purposes, while counting the entire tithe for support of all the work, the amount devoted by the denomination to evangelical work was over a million.

The amount required to support foreign and home mission work, and General Conference administrative work is about \$1,000 a day the year round.

The growth of the practice among conferences of sharing the tithe with mission fields is giving a basis for steady growth of mission income.

The Sabbath-schools are now supplying \$1,000 a Sabbath for missions.

The policy to be maintained must preserve this steady and increasing flow of means in order to support the missionary advance On the other hand, the general policy must conserve the home interests and conference enterprises in order that the base of supplies may continually be strengthened.

Various fields formerly calling for help are now selfsupporting and furnishing strength in means and men for other fields, as the Australian, German and Scandinavian Unions.

In speaking of the needs of facilities in mission fields, the chairman called upon I H Evans to speak of the lack of facilities under which he found the laborers working in the West Indies. Enterprises calling for special help are the printing plant in Trinidad and a school establishment in Jamaica. The chairman spoke of calls from the Canadian Northwest and other fields. He further called attention to State conference enterprises-pressing upon the home workers--which must be taken inte consideration in making general calls.

Schools and sanitariums have been so greatly increased that many local conferences are struggling with heavy burdens.

He stated that this review of the facts was not at all to sound a timid note, or to suggest that the work is too great for this people to accomplish, but merely to secure a view of the entire situation so that our plans may be laid with due consideration for all phases of the work.

FACIFIC PRESS SITUATION:

HW Cottrell presented the stuation and needs of the Pacific Press, on which the call for \$50,000 is based. After the fire, the auditor worked out a statement, showing that with all properities and assets, the Press was \$13,000 worse off than nothing, fin a cially. It was planned to make the new plant severely plain in every particular, and no larger than needed for our own work.

Many brethren joined in discussing the financial needs and the work of our publishing houses--how best to help them, and the policy and plans that are to be adopted in operating them.

Much was said as to the responsibility of the whole people to keep our offices busy by circulating the literature. It is when the presses are idle through lack of densitid for literature that the offices must lose or do outside work.

A SUGGESTION TO HOLD TO 5150.000:

W.W.Frescott expressed the conviction that if there was any way to avoid making such heavy calls for help for home enterprises. It should be sought off and said that for his own part he would feel releaved if the Review and Herald could possibly pull theough without calling for help.

Others spoke to the suggestion, and the chairman said that he had felt ready in his own mind, though he could not speak for the school Board, to consider whether the publishing and school work in Washington could not withoudraw from the present call, and allow it to stand at the \$150,000 originally planned for before the Facific Fress fire.

To complete the school enterprise would require help later, but for some time it could operate in the buildings already erected.

WASHINGTON TRAINING COLLEGE;

A G Daniells took up the situation and needs of the school in Washington, first reviewing the manner in which the General Conference was removed to Washington, by instruction of the spirit of prophecy. With the developments of the last three years, every day makes more plain the wisdom and foresight of the instruction, which at the time came as a surprise to members of the Committee.

The greatest need of the school is the increase the number of students. It could take in double the number and would then be self-supporting. Many spoke to the question of the place of the school in the denomination and the importance of aiming at advance work, preparing ministers and other laborers for field service.

SOUTHERN WOR K:

G I Butler presented the Southern field and its needs. The population of the Southern Union is 16,000,000. The Sabbath-keepers in the Southern conferences number only about one-twentieth of the total in the United States, while the population is one-fifth that of the United States.

This sowing of the field may be accounted for only by the fact that it is a "hard field," the "hardest field," as the Festi-monies have said. The difficulties on the race question are great and perplexing. Ever since the emancipation proclamation the Testimonies have been speaking of our duty to the South. By request of the speaker, J.S. Washburn read various extracts from the spirit of prophecy, urging help to be given to the South as the most needy and most neglected field. Notwithstanding difficulties, the speaker thought that, in proportion to the effort, the South could show as high a percentage of growth in recent years as the northern conferences. Workers are of good courage. An encouraging report from Brother Bollman of the Southern Missionary Society's work was read. Effort has been made to secure a colored minister to lead the colored work in each conference. The Southern Missionary Society is now managed as a department of the Southern Union.

An intermission of a few minutes was taken, and after singing "Jesus Lover of my Soul," Elder Butler resumed his presentation Four sanitariums have been started, a small one at Hildebran, N.C. (which wasburned and has never been rebuilt), one at Graysville, at Altanta, and at Nashville. These three sanitariums already under way need assistance for completing their plants. The Nashville Sanitarium has a beautiful location, with ten acres of land. The building requires refitting and additions. Fatients began to come in before they were prepared to take any one, and the prospect for patronage is good. Including land purchase and buildings, it is planned that the entire cost will be \$25,000.

Further Testimonies were read specially emphasizing the importance of sanitarium work in Nashville,

The chairman, G.A.Irwin, called attention to the fact that the sanitarium institutions are not stock companies, but organized on the denominational basis, and steps are being taken to put the publishing house on the same basis.

This school has run in debt to the Union treasury to the extent of over \$4000, but it is the only colored training school we have in this country, and with the burden laid upon us by the Testimonies to train colored workers, we dare not give the school up. The farm and buildings are in better condition than ever before. The school needs as strong a men to lead it as can be found in the denomination.

The Nashville Publishing House had hoped to work its own vay out of indebtedness, but it is really in need of financial help to meet obligations and keep at work producing the literature.

HASKELL HOME COLLECTIONS:

A G Daniells presented for counsel a letter from the secretary of the Haskell Home, asking what may be expected in the future in the way of support for this institution, and the Old People's Home.

In the discussion, it was developed that these institutions had been transferred from the International Association 50 that there could be no denominational direction of their interests. It was generally expressed that while all desired to care for our orphans and aged, and it was assured that the denomination stood ready to do so, the homes for such work should be under denominational direction and influence. It was

VOTED, That this matter be referred to the Finance Committee for consideration and report.

A G Daniells mentioned the fact that a committee had been appointed at the constituency meeting of the Battle Creek Sanitarium to investigate the doings in connection with that medical center, As it appeared that the majority of the investigating committee were men who would be investigating their own acts or those of their associates, it was certainly not a committee from which to expect any satisfactory investigations.

It was evident that all the time the influences in Battle Creek are working to somehow get a foothold among our people. All should keep the people informed and instructed, so that none may be deceived, R A Underwood urged that such information as that contained in the statement of the Receiver of the Medical Association, and other facts be placed before our people.

Brethren Moon, Jayne, Haughey, and White spoke of these influences, both as to the need of supplying information, and the need of wise caution in dealing with the matter.

ONE HUNDFED AND FIFTY THOUSAND DOLLAR FUND:

WOTED, That the presidents of the conferences present be appointed a committee to formulate a plan for raising the \$150,000 flund, with Wm. Covert as chairman, and that they be requested to meet at 8 A.M., October 2, to consider the plan.

CNE HUNDRED AND FIFTY THOUSAND DOLLAR FUND REFORT OF COMMITTEE:

The report of the committee of conference presidents was presented, and after discussion and amendment was ananimously adopted as follows:--

In harmony with the action taken to raise \$150,000 to prosecure various enterprises, we recommend, --

1. That to accomplish this work the General Committee immediately establish an active agency at headquarters to disseminate information to forward the raising of this amount, with such auxiliary agencies in other publishing centers as the Committee may deem advisable. 2. That each union conference provide a man to directly engage in this work.

3. That each union and local conference be free to adopt such measures as in their judgment are best suited to their localities.

4. That as conference presidents we pledge ourselves to do all in our power to complete the raising of this fund as soon as practicable.

5. That the publishers of the Review and Herald be requested to publish the donations by conferences, and in aggregate only.

In the discussion and amendment of the report, many brethren called attention to the practical and detail outworking of the recommendations.

W C White emphasized the work that the auxiliary committees could do in publishing centers, such as Nashville, Mountain View, and College View, including giving attention to use of periodicals in foreign languages.

E R Palmer reminded the Council of the experience in raising the \$100,000 fund, when there came a slow and heavy movement as the fund reached about \$65,000. Then as the conference presidents came forward and entered the campaign directly, the fund was quickly made up,

We Covert stated that it was the suggestion in the committee of presidents that the plan of appointing a union man to give special attention to raising funds for this work might be a perpetual plan for working in behalf of funds until the Lord comes,

W C white and others encorsed thiss uggestion.

I H Evans desired that the appointment of a man in each union or local conference to give special attention to the raising of the fund should in no wise lead any to let the work rest with that man. All must go at it, every president and every man.

JE Jayne emphasized the word "complete" in the recommendation in which the presidents pledged themselves to do their atmost to complete the fund as soon as practicable. The sentiment prevalled in the committee that this was only an addition to the regular funds, and that all mission offerings, etc., should be hept going without decreasing. A G Haughey hoped this plan of organizing for united effort could be made permanent so that when some special work is needed all that will be necessary will be to let it be known, and the plan and machinery will be operating to accomplish the task.

Other brethren spoke to the same effect, and the chairman expressed gratitude at the determined and courageous view all took of the situ ation. He argued only that along with the plan of decentralizing and distributing administrative responsibility, there should be also distribution of responsibility in the matter of mising large funds of a general character.

The Council was resolved into a praise and testimony settice, in which the members realized the blessing of the Lord, as they spoke of their courage and confidence in the triumphing of the work.

We recommend --- //

1. That reply be made to the effect that in view of the present well known conditions, it is not deemed expedient that any further special appeal be made to the denomination for collection to provide for the maintenance of these institutions.

2. That the officers of the General Conference be instructed to enter into negotiations with the management of the Haskell Home and of the James White Memorial Home on the basis that the offer be made that the denomination will take charge of, and provide for the maintenance of any orphans now in the institution coming from Seventh-day Adventist families; and take charge of and provide for the maintenance of any aged people belonging to the denomination now in the James White Memorial Home who are dependent upon that institution for their support, not having placed in the hands of the management any funds or property providing for the same, and who may desire to go el sewhere.

3. That each union conference make provision for the care of orphans and aged people within its borders, and that in the future the general call be made for a collection for orphans and aged people as heretofore, and that each union conference be permitted to retain whatever amount is raised within its territory. 4. That a committee composed of the Vice-President of the General Conference and one representative from each Union Conference be appointed to consider and recommend plans for the establishment and multiintenance of the homes for orphans and aged people, or to make other provision for their care as may be deemed advisable.

5. That from October 1 forward any institution or fund directly benefitted by the call for \$150,000 should report and be charged with, on its appropriation, any donations made for the specific purpose mentioned in the division of these funds.

VOTED, That the chair appoint the union members of the committee on orphanages provided for in this report.

ON FOREIGN WORK:

The Committee on Foreigh Work made a report, which was adopted as follows: --

We recommend, --

1. That Elder HF Graf, of Brazil, be counseled to return to the United States, after twelve years of labor in the tropics, in harmony with his own request and the consent of the South American brethren.

2. That, in reply to a suggestion from a camidate, we counsel the General Conference Committee to adhere to the established practice of issuing credentials to its laborers in unorganized mission fields, and that such laborers should not receive their credentials from home conferences.

3. That we ask the Japan Mission Committee to arrange with Dr. Myrtle Lockwood to take the work in the Japanese sanitarium which has been carried by Dr. Remnine Rumme Ferrine, and that the Joint salary of herself and husband be \$25 per week, with the understanding that the sanitariums interest, will do their utmost to be self-supporting on this basis.

4. That a lady nurse be sent to Japan, to connect with the sanitarium at Kobe,

5. That we counsel the brethren in China that the matter of theorganizing their field be left until the visit of the representative from the General Conference.

Such calls have been made by South Africa, India, China, and Japan.

There was free discussion of the growing importance of the work in other lands, and of the need of giving more and more attention to it.

No definite action was taken in the matter of appointing representatives to make these visits now called for,

WOTED, That it is our opinion that inasmuch as the Facific Fress has received insurance on its stock burned, and an appropriation of \$20,000 from the \$150,000 fund, these items should be considered as covering the loss on "Ministry of Healing."

FOOD ENTERFRISE:

The committee on the health food matter appointed during the Council made a report, which was adopted as follows: --

<u>Whereas</u>, The changes taking place in our medical work suggest the mecessity of our providing some facilities for the manufacture of health foods in the eastern and southern States; therefore,--

Resolved, ---

1. That a committee of five persons be appointed, to be known as the General Food Committee, whose duty it shall be to study the needs of the fields, and top plan regarding the manufacture, distribution, and sale of health foods along such li nes as promise to be most beneficial to our sanitariums, restaurants, health food stores, and to our people and the public generally.

VOTED, That the committee on health foods be as follows: I H Evans, W A Wilcox, W M Lee, V H Cook, L A Hansen.

The further report was adopted as follows: --

2. That the Food Committee unite with the sanitariums managers and the Executive Committee of the Atlantic Union Conference in the study of plans for the organization of this work in the Atlantic Union Conference.

3. That the Food Committee unite with the Executive Committee of the Southern Union Conference in the study of plans for organization, and also in the consideration of an opportunity to secure at least than half of its original cost a large food plant at Edgefield, Tenn.

VOIED, That the chairman of the Food Committee be requested to open correspondence at once with the St. Helena Food Company, with reference to arranging for H H Haines to come East to assist in the development of the food business.

C D ACMOODY:

WOTED, That Brother C.D.McMoody, under appointment to Rutkey, be ordained before his departure.

Various doctors were considered and it was left for personal Interviews by Brethren Conradi and Daniells in the West before selection.

VOTED, That we recommend Dr C A Hansen to make Wyoming his field of labor, if satisfactory arrangements can be made with the Central Union Conference.

DR C W HEALD TO WISCONSIN:

WOTED, That we recommend Dr C W Heald to the Madison Sanitarium Board, to act as assistant to the physician in chief.

SHANISH TRANSLATING:

VOTED, That we request the Fublishing Department to arrange for the closing of Frofessor Caviness' work on Spanish literature at the Pacific Fress as soon as possible.

RELIEF BUREAU: V

E R Falmer asked counsel regarding the work for "Ministry of Healing."

It was agreed that, while the General Conference Committee had not basis of legal ownership on which to stand, the treasurer should enter a protest, in behalf of fair dealing toward the creditors who put money into the Mexican Sanitarium Corporation, and that members of the local Mexican corporation, which had been allowed to lapse, ought to take any steps possible in Mexico to safeguard the interests of creditors.

WASHINGTON SANITARIUM:

VOTED, That inasmuch as the trustees of the Washington Sanitarium Association have petitioned the General Conference to advance specific loans for which they offer the Association notes, that we authorize the treasurer to advance to the Association not to exceed \$10,000, the same to be replaced from the \$50,000 to come in for the enterprise from the \$150,000 now being raised.

VOTED, That Dr Ruble be authorized to correspond with Miss Fitzgerald, with a view to securing her as an assistent in both medical and educational departments, at the rate of \$12 per week.

DEPARTMENT WORK:

WOTED, That the gifts from the Central Union in last April's collection should be alloted to the Missouri orphanage institution. That those from the Southern Union be alloted to the South for orphanage work. And that all the balance of the collection, representing the gifts of six unions, be sent to the Haskell Home.

DR GREAVES:

It has been formerly decided to assist Dr Greaves in his post-graduate work, in order that he may qualify for service in the West Indies or British Guiana under British diploma. A letter from him stated that his expenses would be \$8 per week through the college term. In discussing the matter, Dr Ruble thought that sum represented the requirements for fees, and living expenses on an economical basis. It was---

WOTED, That we advance to Dr Greaves the money necessary to help him through Rush Medical College, in order that he may qualify for service in British fields, the help rendered not to exceed \$8 per week; and that his note be taken for the amounts paid, remittances to be made to him in \$50 or \$100 payments for convenience in covering the amount by note.

ONTARIO SCHOOL AND "OBJECT LESSONS":

Ontario, through Brother W H Thurston, presented a request that the Board extend the time on its appropriation of "Object Lessons" to be sold by the Canadian brethren for the benefit of the Lorne Park Academy in Ontario. It was---

WOTED, That Ontario be informed that the Mission Board will continue to supply "Object Lessons" to the full number formerly agreed upon, on condition that those who take the books promptly turn over the full price in cash to the school fund, inasmuch as it would not be deemed advisable to appropriate these books, to be left on depository shelves or to remain unsold in the homes of the people.

JAMAICA, FROFESSOR HUGHES:

It was felt that a distinction should be made in making up these lists, so that any one taking up the year book for information would be able to tell which enterprises were under denominational direction and which were privately owned or managed. It was therefore---

WOTED, That the year book group enterprises under denominational direction in one list, printing full details regarding boards and Of management and faculties; and that following this, enterprises under private direction should be listed together under the statement that such institutions are owned or managed by private individuals, and are not under conference supervision.

AFFOINTMENTS DECLINED:

The secretary stated that information had been received to the effect that the following persons have not considered it possible to accept appointment to the fields named at this time:---

B L House, to Jamaica; S D Hartwell, to the West Indian treashership; and S J Quantock, to the China secretaryship.

A letter was read from H H Hall, invited to act as field secretary of the Fublication Department, stating that inasmuch as the had determined to devote his life to the business and selling ends of the denominational publishing work, he could not feel free to accept the appointment.

It was folt by the Committee that this decision should be accepted without urging reconsideration.

HEPORT OF PUBLISHERS' CONVENTION:

WOTED, That the secretary be authorized to mail to the leading workers in foreign fields who read English & copy of the report of the recent publishers " convention.

ELLIS ISLAND:

A request from the president of the Greater New York Conference regarding the importance of a representative of this denomination having access to Ellis Island for work among the immigrants was presented, and it was---

Resolved, That we request the immigration authorities to grant us the favor of allowing a representative of our denomination access to Ellis Island, for work among foreign-speaking immigrantion from Europe landing in the port of New York; and further, that we mame Lewis Zecchetto as this representative, for whose character and uprightness we vouch, and as a man having command of most oc the languages of Southern Europe.

It was agreed that two brethren should call on the Immigration Commissioner in Washington with reference to this matter.

CHINESE IN NEW YORK:

A request was made by the New York Conference for help in setting a Chinese brother in New York City to work among the Chinese

It was agreed to notify New York of the desire of the Committee to provide such help as may be necessary, and that the secretary should correspond with C H Edwards to learn what part New York could bear, and what financial responsibility the General Conference would have to assume.

PROFESSOR MILLER AND SOUTH AFRICA:

Letters were presented from Brother Van Kirk, principal of the Graysville school, and from Brother W C Moffett, of Ohio, showing that the latter had decided not to respond to their call to take Professor Miller's place in Graysville, and on this account the Graysville school Board felt that they must withdraw further consideration of the release of Professor Miller for the time being, and that in the interests of their school they must ask Professor Miller to settle down to the finishing of the school year.

WOTED, That we accept the decision of the Graysville school, and failing other help, that we ask counsel from South Africa as to whether we shall continue Professor Miller's appointment to the Claremont Union College, securing his release at the close of the school year next May.

KNOWLTON SANITARIUM:

A request was presented from W H Thurston that the General Conference pay the transportation of the physician whom the medical department is endeavoring to secure for the Knowlton Sanitarium.

VOTED, That the Knowlton Sanitarium be informed that the General Conference will pay the transportation of whateger physician may be secured to take charge of the Quebec Sanitarium.

IR INGERSOLL'S FURLOUGH:

Inasmuch as Dr Menkel is on his way to India to relieve Dr Ingersoll and wife, it was-

VOTED, That the grant Dr R S Ingersoll and Dr Dlive Ingersoll a year's furlough in America, after eight years in India, with the understanding that they will be under furlough pay of the Mission Board, at the united rate of \$15 or more according to the need, while recuperating and taking post-graduate study, or under pay of institutions with which they may be connected while on furlough.

C A HANSEN:

A letter was read from Elder C A Hansen, of Bombay, saying that since his attack of the measles he had been very much broken up, and owing to affection of the heart he was not able to go to the hills for relief. He had been advised by local physicians to leave the country at the first opportunity.

It was hoped by the Committee that by shifts and changes he might yet find it possible to continue in India, but it was-

WOTED, That Elder C A Hansen, of Bumbay, be authorized to return to the United States, providing in the judgment of the India Mission Committee his return is advisable on account of failing health.

WEST AFRICA:

A request was presented from Elder D C Babcock for a canvasser to work along the West Coast of Africa with our literature. He hoped some West Indian worker might be found.

VOTED, That we invite the West Indian Union Conference to select a good canvasser for the West Coast of Africa, a single man preferably, and one whose gifts would enable him to work from the canvassing into evangelistic work as the field develops.

MRS M M QUANTOCK:

WOTED, That Mrs M M Quantock's furlough be counted for the full year 1905, inasmuch as that time was spent in the recovery of her health, after seventeen years of foreign service.

HUNTSVILLE, DONATION:

WOTED, That in response to a request from the Huntsville school, we donate to them a copy of the missionary map of the world at \$3,60, and also a 75 cent missionary map, with missions marked.

HERU, T D ROBISON:

A letter was read from the president of the Southern California Conference, reporting that Brother Robison, who went down to join Elder Perry, with the idea of doing self-supporting teaching work, had found it impracticable to secure sufficient work in that line to be self-supporting. Southern California is interested in the young man, and ready to help in the matter.

WOTED, That the secretary write to Elder Perry and to the South American Union Conference, suggesting that if teaching work does not seem to develop, this brother be set at the colporter work, with such financial assistance from appropriations as may be necessary; and that he be encouraged to study the Spanish and develop into the work in that field, if he gives promise of making a substantial worker.

A B STAUFFER, BRAZAL:

A letter was presented from A B Stauffer, of Brazil, telling of his need of further capital in order to develop his missionary farming plan in the Brazilian territory. He desired help in the way of interesting some of our brethren with capital in his enterprise.

It was felt by the Committee that it is not practicable for the officers to attempt to secure funds for Brother Stauffer, but it was agreed to print his letters as an ordinary report in the Review, so that if there were any brethren interested in missionary farming who felt led to communicate with Brother Stauffer the way would be open for them to do so.

I D RICHARDSON, INDIA:

A letter was read from I D Richardson, stating that he and his wife were ready to go to India, providing they could locate at the first at Ostacamund. It was-

VOTED, That the secretary correspond with India regarding this matter, and in the meantime notify Brother Richardson that while the way is not absolutely closed, the situation requires very careful consideration, inasmuch as morkers going out to India ought to be strong and able to live wherever the work may demand hel help.

DOCTORS FOR JAPAN:

A letter was read from Dr Lockwood, saying that he and his wife would regret to postpone their departure for China later than next autumn, and greatly desiring the help to arrive in April.

VOTED, That the secretary and Dr Ruble give special attention to securing help for Kobe, to relieve Dr Lockwood for China.

VOTED, That we unite with the District of Bolumbia Committee in requesting the Ohio Conference to release Elder B L House to make the District of Solumbia his field of labor, providing Elder House feels free to accept this invitation.

FUBLISHING DEPARTMENT:

Whereas. The officers and members of the General Conference Committee located at our headquarters find it very difficult, if not quite impossible, to keep in touch with the affairs of the Fublishing Department and to cooperate, as they believe the work demands, with the officers of the Department while the latter are located so far away from the headquarters; and, --

Whereas, Brother H H Hall does not deem it best to locate in the Bast and give his entire time to the field work of the Department, as requested by the General Conference Committee in its recent council held in Washington; therefore, --

We advise, That the office of the Fublishing Department be located at the General Conference headquarters, and that the Secretary, E B Falmer, be requested to move to Washington to carry on the work of the Department, providing his health will permit.

ONE HUNDRED AND FORTY-FIRST MEETING

CENERAL CONFERENCE COMMITTEE

January 5,19 07

PRESENT:

A G Daniells, I H Evans, Dr W A Ruble, K C Russell, W A Spicer, T E Bowen.

Frayer by Dr Ruble.

ACCOUNTS:

The treasurer requested action in the matter of several items relating to the closing up of the accounts for the year.

WO TED. That the treasurer be instructed to transfer to the General Conference Corporation the furniture listed in the accounts of the General Conference unincorporated, so that all property holdings may be filed with the legal corporation.

VOTED, That we frequest the Southern Union Conference in the future to include in their appropriations called for from the General Conference the salary of Elder J S Washburn, and that he receive his salary henceforth through the Southern Union treasury.

VOTED, That the salaries of workers in the Religious Liberty Department be closed into the accounts of that Department.

WOTED, That A G Daniells, W A Spicer, H E Rogers, and H H Cobban be a committee to set an inventory valuation upon the furnishings of the General Conference office.

RST AFRICA:

T Kwamina, a colored brother of Jamaica, who had worked in West Africa, with the Baptists some years, was present and reported himself in harmony with us and desirous of returning to Africa as a worker. At the close of his interview, a recess was taken to 2 F.M.

Upon reassimulting, the question of Brother Kwamina's request was taken up, and it was---

VOTED, That A G Daniells, W A Spicer, and K C Russell act as a committee to examine Brother T Kwamina as to his experience, and fitness for the work in Africa, and that in case the committee are satisfied as to his qualifications, he be furnished transportation to Sierra Leone, and advised to work with Elder Babcock as may seem best.

DR MYRTLE LOCKWOOD:

Dr S A Lockwood, of Japan, had reported the necessity of his wife's retaining to this country to receive special medical care not able to be secured in Japan. As the case was an urgent one, they felt it not safe to await any action of the Board. He asked that her fare be allowed in case reports from physicians on this side indicated that their action was the only proper one. Medical certificates had been sent the Board, advising that her return to this country was a medical necessity, and that she would require considerable care in the Loma Linda Sanitarium in order to be able to return for duty.

WOTED, That we allow the transportation of Dr Myrtle Lockwood from Japan to this country, and that her return passage to Japan or China be allowed when she shall be able to return.

CHINESE WORKER IN NEW YORK:

A request was presented from C H Edwards, of the Greater New York Conference, that the Mission Board make provision for setting a Chinese worker of good experience at work among the many thousands of Chinese in New York City.

WOTED, That the Mission Board appropriate \$10 per week to the Greater New York Conference toward the maintenance of a worker for the Chinese.

MRS S J OLJEY: INDIA:

A request eas presented from Dr R S Ingersoll that Sister S J Olney be allowed her return fare from India. She had paid her own fare to India, and spent eight years in the field, mostly in institutional work. She is now returning to remain in this country, and has little means of her own.

WOILED, That we allow the transportation of Sister S J Olney from India to her home in this country.

H G MIKKONEN:

Brother Vasenius, a medical student from Finland, had introduced to members of the Board Brother H G Mikkonen, a minister from Finland who accepted the truth in California. He was in Washington on his way back to Finland, being called to work there by those in charge of our Finnish work. It seemed desirable that he should spend a few months in special Bible study at the Training College, and it was felt that he should be helped to do this from the special educational fund accruing from the royalty on foreign books.

WOTED, That we request the Washington Training College Board to provide for the accommodation of Brother H G Mikkonen at as reasonable rates as possible, the expense to be paid for much out of the foreign educational fund.

SFRING MEETINGS IN EUROPE:

The Committee had fixed the date of the first meeting of the visiting members of the Committee in England as April 16. It was felt that by putting the date a few days later, a little more margin would be allowed in reaching Great Britain, and that five days would be sufficient for the British meeting. It was, therefore---

VOTED, That the date of the beginning of the British meeting be changed from April 16 to April 18, thus enabling any who are pressed for time to sail from New York Wednesday, April 10, with the prospect of reaching the London meeting April 18.

J O MILLER, NEW BRUNSWICK:

A letter was read from Elder J O Miller, of Ohio, whom the Maritime Conference had invited to New Brunswick. It seemed difficult for him to decide whether he should go, and the general opinion of the Committee was that it might be better for some younger worker to be selected for that field.

VOTED, That under the circumstances we advise Elder J O Miller not to make the transfer of his family to New Brunswick unless he is clear in the conviction of duty, and that we suggest to the Maritime field that they endeavor to find some other laborer to supply their need.

THE SPECIAL SIGNS:

The managers of the Signs of the Times asked counsel as to the best time for issuing their special missions number,

WOTED, That we suggest to the Signs of the Times that their missionary special be issued as a mid-summer number.

Meeting adjourned.

G KEOUGH TO SYRIA:

VOTED, That Brother George Keough of the Training College in London, be invited to make Syria his field of labor, going there at the close of the college session in May, 1907.

VISITING EGYPT:

WOTED, That either Brother G B Thompson or Brother G A Irwin stop in Egypt when coming to the council at Gland in May, in order to help Brother Nethery in the difficulty that has come to that field through the erroneous ideas of Brother Ouzounian.
