It was understood that the Lake Union would be glad to have Brother Thurber unite with them in the work on his arrival. It was therefore—

VOTED, That we recommend Professor R B Thurber to the Division Conference for work in this country wherever it may be possible to arrange on his arrival.

## C U B A:

The resignation of A N Allen as superintendent of the Cuban Mission was presented.

While appreciating the good work Elder Allen has done in Cuba, the Committee agreed with his decision that it would be better for a new appointment to be made for the superintendency there.

VOTED, That the resignation of  $\Lambda$  N Allen as superintendent of the Cuban Mission be accepted.

VOTED, That A N Allen be requested to remain in Cuba, to engage in evangelistic work.

# J E BOND--CUBA:

VOTED, That we ask the North American Division to secure the release of Elder J E Bond, of Arizona, provided it is possible for him to accept the call to the superintendency of the Cuba Mission.

### CUBAN ADVISORY COMMITTEE:

VOTED, That the Advisory Committee of the Cuban Mission be constituted as follows: The superintendent, the secretary, the general agent, the school principal, and A N Allen, J E Anderson, H C Goodrich, and A E Doering.

### CANVASSERS FOR CUBA:

In response to counsel regarding the securing of canvassers from some of the schools for vacation scholarship canvassing in Cuba, it was--

VOTED, That we notify the Cuban Mission that they must meet all bills for transportation of canvassers, and that their plans must be shaped accordingly.

# FORREST WASHBURN--CUBA:

The Cuban Mission having reported that Brother Forrest Washburn, of Philadelphia, was desirous of canvassing in Cuba, it was—

VOTED, That we agree to pay the transportation of Brother Forrest Washburn to Cuba, the same to be an addition to the Cuban Mission budget.

### SALVADOR:

A letter from J L Brown, superintendent of Salvador, reported that a worker formerly with the Baptists, and before that an ex-bishop of the Roman church, had accepted the truth, and was thoroughly in earnest and apparently well established in it. Brother Brown appealed that he be authorized to engage the brother to assist him in the work.

In studying the budget for Salvador, it was seen that there were some calls agreed to that might be postponed, and it was--

VOTED, That the Salvador Mission be authorized to employ the new brother at a bare living wage while he is getting acquainted with the truth more thoroughly and proving himself in the work, the rate of remuneration to be \$10 per week.

# NURSES FOR PORTO RICO:

On call from Porto Rico, suggesting that further nurses could be utilized, it was--

VOTED, That if the Porto Rico Mission is prepared to pay the transportation of the nurses out of their budget, and to meet their support, the Committee will agree to find the nurses

## HAITI:

A F Prieger, of Haiti, made request for permission to employ a young Haiten who is just finishing his school work at Huntsville this year.

VOTED, That the Haitien Mission be authorized to employ the young man from Huntsville, provided the budget as voted at the autumn council will allow them to do so.

# SECRETARY TO THE WEST INDIES:

VOTED, That the secretary of the Committee be advised to join the West Indian Union Conference Committee in their council meetings in February, on the Canal Zone, visiting other portions of the West Indian field while abroad.

### C P MARTIN:

G W Caviness, superintendent of the Mexico Mission, recommended that Brother C P Martin, of the Mexico Mission, be allowed \$10 per week audit for 1915, and that his rate be set at \$14 for 1916, so that his time can be given more fully to evangelistic work.

VOTED, That the rates be fixed accordingly, with the understanding that the Mexican budget as voted at the autumn council will be made to cover this item for 1916.

# E W SNYDER:

A letter was received from Elder E W Snyder, enclosing medical certificates, certifying that neither he nor Sister Snyder were in phusical condition to accept the call to Southern Medico. Brother Snyder requested that he be allowed to change his occupation for a time, so as to secure the rest and out of door life recommended. After something over twenty years of work in the Spanish fields he felt the need of this.

VOTED, That Elder E W Snyder be released from the call to Mexico, and that under the circumstances we ask that he be placed on the Sustentation Fund for one year, at a rate of \$10 per week.

## G F ENOCH:

The treasurer asked counsel regarding the furlough rate of Elder G F Enoch during the last year.

Inasmuch as Brother Enoch had been subject to call here and there in camp meeting work and other work since his return to this country, it was--

VOTED, To authorize the treasurer to credit G F Enoch with the difference between his furlough allowance as formerly voted, and the regular wage.

Having already one daughter for years in China, Mrs. A.C.Selmon, and hoping that their son would continue likewise in the field, they were emboldened to make this request.

VOTED, That the treasury department be authorized to grant the request of the parents of R D Loveland.

# J E BOND:

A letter was presented from Elder J E Bond, expressing his willingness to accept the call to Cuba, but stating circumstances which appeared to the Committee sufficient to warrant further search for the Cuba superintendent before pressing the matter of Brother Bond's acceptance.

VOTED, That we rescind the invitation to Elder J E Bond to make Cuba his field of labor, on account of the difficulty that would be experienced just now in arranging his family affairs.

### F G LANE, CUBA:

VOTED, That we ask the North American Division to secure the release of Elder F G Lane, of Southern New England, and that we invite Elder Lene to take the superintendency of the Cuba Mission.

## V D HAWLEY:

VOTED, That we advise V D Hawley, retiring secretary and treasurer of the Cuban Mission, that we are agreeable to his returning early in February, in order to take advantage of an opportunity for out of door work in Dakota to build up his health, and that we ask the Cuban Mission to make temporary provision for the office work until the new secretary, S E Kellman, arrives.

### J J IREEAND:

VOTED, That we ask the treasurer to arrange for J J Ireland to visit Cuba on his return journey from Colon, to audit the books of the Cuban Mission.

# DR E F OTIS:

A letter was received from the Drs Otis, in Santo Domingo, asking counsel as to where they might locate to the best advantage to help in the work, in case of their removal from Santo Domingo.

VoteD, That we recommend to the Drs Otis that if they consider it a proper location they take up work in San Juan, Porto Rico, we on our part assuring them of our hearty sympathy and cooperation, thanking them for wishing to make their work count to the utmost in forwarding the missionary cause in the Spanish fields.

### R G SCHAFFNER:

A communication was read from F A Stahl, of the Inca Union Mission, telling of the interests round Lake Titicaca, and urging more foreign workers to occupy the Indian field now that religious liberty has come. The people expect us to enlarge our work.

VOTED, That we withdraw the appropriation for a second worker in Guatemala, in favor of South America, and that we invite R G Schaffner, of the Washington Missionary College, to go to South America, this action being taken with the Inca Union Mission in mind, though leaving the assignment of Brother Schaffner to the South American Division.

### BRITISH GUIANA:

VOTED, That the North American Division officers be asked to endeavor to secure a minister for British Guiana while in attendance at the union conference sessions.

### REVIEW FILES FOR EUROPE:

A letter was received from Guy Dail, of the European Division, telling of their earnest efforts to make up as nearly as possible a complete file of the REVIEW. Inasmuch as the General Conference has two files and a partial third one, it was-

VOTED, To authorize the treasury to supply Europe with such numbers of the incomplete REVIEW AND HERALD file as may be required.

## HAITI:

In view of the difficulty of getting transportation between Panama and Haiti, it was-

VOTED, That we ask the Haitien Mission to indefinitely postpone its meeting until arrangements can be made for the secretary to visit the field at the time of the meeting.

## NORTH HONDURAS CAMP MEETING:

A letter was received from Elder Isaac Baker, superintendent of the North Honduras Mission, asking counsel# regarding his camp meeting this year. Last year Elder Town was present able to assist in the Spanish. Without Spanish help it seems to him impossible to conduct a camp meeting in Honduras the coming season.

VOTED, That we advise Honduras to allow the camp meeting to go over this year, and that we ask Elder J B Stuyvesant and wife, of Guatemala, to respond to the call, if Honduras desires their services for a short series of local meetings.

# SUSIE BROWN, SALVADOR:

VoteD, That the treasury be authorized to advance the transportation of Miss Susie Brown, nurse, sister of John L Brown, of Salvador, provided Brother Brown thinks she should join

him, with the understanding that she will refund the transportation from her earnings.

### TWENTY-CENT-A-WEEK FUND:

The brethren in the Lake Union feel that this action, as it now stands, will greatly embarrass them in the work of paying their debt and raising the Twenty-cent-a-week Fund, and that it will necessitate their inaugurating some other plan for

creating a fund to liquidate their indebtedness. Fears were expressed that if the action of the Loma Linda council prevails, it will result in destroying the Twenty-cent-a-week plan.

VOTED, That a committee of five be appointed by the chair, to give the question study and report. The following persons were appointed as said committee: A G Daniells, I H Evans, W T Knox, Chas Thompson, L H Christian.

Recess was taken to 4:30 P M.

On reassembling, prayer was offered by W T Knox.

The committee appointed to make recommendation with reference to the future plan of the Twenty-cent-a-week Fund presented their report as follows:--

Whereas, The recommendations concerning the Twenty-cent-a-week Fund, adopted at Loma Linda, seem to be difficult to carry out, and indications seem to point out that the mission funds will not be increased by the plan, while some of the union conferences feel they will have to raise a special fund to apply on their indebtedness; and,--

Whereas, The General Conference needs additional funds for its extended work in the needy mission field; therefore,--

Resolved, 1. That we rescind the Loma Linda action concerning the Twenty-cent-a-week Fund.

- 2. That during 1916 we work on the plan of 1915.
- 3. That beginning with 1917 we send to the General Conference seventeen cents instead of fifteen cents. All above this to be returned to the union on the same basis as 1915.
- 4. That we increase the donations to the General Conference one cent a year thereafter till the General Conference is receiving twenty cents a week for missions, and the remainder of the offerings from any union to be returned as in plan of 1915.

The time was given to Elder R F Cottrell, to report upon his work in behalf of China in this country, and to present matters of business.

# ASIATIC EDITORIAL BUREAU:

Elder Cottrell made a plea for some one to act as central editorial helper in China, some one who would be able to work out matter and manuscripts for publications, and receive manuscripts from different divisions of the Eastern field, so that whatever is done in one place would be available for all the fields without duplication of effort.

No action was taken by the Committee, the matter being left for discussion by the Asiatic Division Committee.

## O B KUHN--HUNAN SUPERINTENDENCY:

Elder R F Cottrell reported that he had been unable to ascertain with any definiteness as to when Dr Landis would be able to reach China, and asked the Committee to make some suggestion regarding the superintendency of Hunan, the post for which Dr Landis had been suggested.

VOTED, That we recommend 0 B Kuhn, formerly designated as medical evangelist for Honan, for the superintendency of Hunan; and that we request Brother and Sister Kuhn to plan their work so as to sail with the July party for China.

## MANUSCRIPT FOR CHINESE BOOK:

Brethren W C White and R F Cottrell spoke of work which had been done in preparation of manuscript for a small book, something after the order of "Coming King," partly original matter prepared by Elder Cottrell, and partly adaptation. The question had been raised as to remuneration for this time spent, whether it should be by royalty or otherwise.

Inasmuch as the Committee has been working with the general understanding that there would be no royalty on books issued in the Oriental languages, it was--

VOTED, That the treasurer be authorized to make up to Elder R F Cottrell the difference between his regular wage and the furlough allowance while in this country, in view of the fact that Elder Cottrell has been engaged fully in the work even while taking his furlough.

### LENA MEAD--SINGAPORE®

A letter from Elder R C Porter presented the matter of Miss Lena Mead, a church school teacher of California, who is desired to assist in the school work in Singapore, and who had reported to him her readiness to go.

VOTED, That we request the North American Division to allow its Educational Department to negotiate with the proper parties for the release of Miss Lena Mead, and that we invite her to go to Singapore, to engage in school work.

### TEACHERS FOR PADANG AND BATTAKLAND:

On further request from Elder Porter, it was--

VOTED, That we endeavor to secure a teacher for Padang, and a teacher for Battakland, and that we request the North American Division to allow the Educational Department to investigate candidates for recommendation to these posts.

## H G PATCHETT--SOUTH AFRICA:

The Educational Department Secretary, F Griggs, recommended Prof H G Patchett, of Beechwood Academy, Indiana, for the preceptorship of the South African training school.

Owing to the difficulty in these war times of visiting his people, and to the present uncertainty of safe transportation through the submarine zone on the European side, it was--

VOTED, That we recommend Professor Patchett to take advantage of the offer of tent work this wummer in the Indiana Conference, holding himself in readiness to go forward to the field in the autumn.

# S A NAGEL'S RETURN TO CHINA:

VOTED, That we recommend S A Nagel, on furlough from China, to plan to return with the autumn party, provided the health of himself and Sister Nagel is found satisfactory.

## MISSES SHRYOCK AND SHOFF:

VOTED, That we recommend Miss M Belle Shryock, on furlough from India, and Miss Vera Shoff, of Oregon, under appointment to India, to plan to sail this autumn for the India mission field.

## C F LOWRY--BURMA:

Elder Cottrell presented the name of C F Lowry for appointment to the Asiatic Division, having had him in mind for China. He reported that he had talked with the Tennessee brethren, and with the North American Division brethren, and that while none wished to spare him, he understood the way was open to extend an invitation to Brother Lowry.

VOTED, That we ask the North American Division to open the way for negotiations with Elder C F Lowry, of Tennessee, with a view to his going to the Asiatic Division, to take the superintendency of the work in Burma.

### MANUSCRIPT FOR FOREIGN BOOKS:

Brother W C White presented manuscripts which had been prepared by the helpers at Elmshaven, being abridgements of some of Sister White's works, prepared with a view to translation into the Oriental languages. He wished to know what would be the method of handling these manuscripts. It was--

VOTED, That we ask the Publishing Department of the General Conference to take charge of the manuscripts prepared by W C White, and to study their use in Oriental and non-European languages; and that we ask that steps be taken by the Department for the appointment of a literary sub-committee to promote the production of books in foreign tongues.

VOTED, That we supply transportation from New Zealand to such point on the Pacific Coast as may be selected, provided it seems wise for Brother J A Chaney to return to this country, with the understanding that the General Conference Committee can take no responsibility as to placing him in conference work on this side, although standing ready heartily to cooperate with him in any way possible in the matter.

# A C GILBERT--SOUTH AFRICA:

A cable message having been received from South Africa, asking for reply as to the prospects of securing a president for the Cape Conference, it was-

VOTED, That we ask the North American Division to ascertain by telegraph if Elder A C Gilbert, president of the Saskatchewan Conference, Canada, would be available to accept the presidency of the Cape Conference, South Africa.

# SOUTH AFRICAN PHYSICIAN:

Consideration was given to the call from South Africa for a physician to take charge of the Cape Sanitarium, and to give his time to conference health and temperance work.

VOTED, That we ask Elder Daniells to correspond with Australia regarding the possibility of securing a man from that field, with British qualifications, and that in the meantime we watch for any other avenue of relief for our brethren in South Africa.

## CALL FOR THREE COUPLES FROM SOUTH AFRICA:

Attention was given to the action of the South African Union Conference Committee calling for at least two couples for the native mission stations, preferably a third couple, all of these being needed immediately in order to enable the South African brethren to man their fields.

The urgency of the call was recognized, but it was felt that it would hardly be possible before the latter months of the year to determine whether the treasury could safely assume further responsibility for expansion in the fields. It was therefore—

VOTED, That we regognize the urgency of the call from South Africa for additional workers for the mission stations, but that we return answer that it will be necessary to wait until t the last months of the year in order to ascertain whether the treasury will be able to increase the South African appropriation.

# J V WILLSON'S RETIREMENT:

Letter was received from Brother J V Willson, for many years engaged in the service in South Africa. He reported that he and his wife, with increasing age and weakening of forces, felt that they would have to retire from the regular work.

VOTED, That we express to Brother and Sister J V Willson our appreciation of the years of faithful service they have rendered this cause in South Africa, and on receipt of information that they feel they must, with advancing years, be relieved of the heavy work which they have been carrying, we recommend the Sustentation Committee to grant a retiring allowance to these workers from the Sustentation Fund, leaving the question of their location to their own judgment and the counsel of the brethren, whether in South Africa or in America.

J R CAMPBELL:

A communication was received from South African Union, asking for advice as to the question of Brother J R Campbell's return to America. Three considerations entered into the matter. Brother Campbell's health has been under pretty heavy strain through fevers while up country, giving himself and others some anxiety. Again, just at this juncture a friend of Brother Campbell's has offered him something over two thousand dollars to enable him to complete his education, and as an additional factor the death of Sister Campbell's mother leaves a situation where she feels that she is needed sorely at home for a time.

Taking all these factors into consideration, with the probability that Brother Campbell would possibly soon have to take a fuflough to build up his health, it was felt by the Committee that the proffer of funds by his friend should be taken advantage of, thus relieving mission funds of the necessity of bearing the expense of his furlough time. It was therefore—

VOTED, That we counsel the South African Union that we will approve the granting of a furlough to Brother J R Campbell, if thought wise by the committee, and that the expense of his transportation to Galifornia will be considered an extra to be added to the South African appropriations.

Adjourned.

VOTED, That we release Elder C S Prout from the call to China, on account of Sister Prout's health.

## ALBERT MUNSON--PADANG:

VOTED, That we withdraw the call for a teacher for the Padang school, allowing Albert Munson, the teacher already under appointment, to return to Malaysia, answering this call from the Padang school.

## BOOKMAN--INDIA AND MALAYSIA:

VOTED, That we ask the North American Division to allow the Publishing Department to make recommendation regarding field missionary secretaries to take charge of the book work in India and in Malaysia.

## H O SWARTOUT--CHINA:

A letter was received from Elder R F Cottrell, reporting that he had interviewed Prof H O Swartout, of Mount Vernon, and also the management of the College, with reference to the calling of Professor Swartout and wife to China for school work. He reported that Professor Swartout had volunteered for that field.

VOTED, That we ask the North American Division to negotiate for the release of Professor Swartout, and that we invite him to make China his field of labor.

# REQUEST TO AUSTRALASIA:

Discussing the pressure of need in the Asiatic Division, and the necessity to safeguard the treasury department in taking on additional obligations, it was suggested that possibly the Australasian Union might from its surplus be able to extend some help in the Far Eastern field during this initial time of reorganization, when effort is being made to thoroughly establish the headquarters in the various fields of the new Division.

VOTED, That we ask the Australasian Union to set apart from their surplus \$10,000 as a special appropriation for the Asiatic Division, with the understanding that the Australasian

Union shall be released from response to a variety of minor calls such as the Philippine tent fund, etc.

## TAGALOG WORKER:

Through Elder R C Porter the request was presented from Elder L V Finster, making urgent plea for a man to be sent out either to take charge of the entire Philippine work, so that Elder Finster might take charge of the rapidly growing Tagalog work on the island of Luzon, or a man to take charge of this latter work. Elder Porter asked for the consideration of the latter proposition.

VOTED, That in view of the urgent need of help at this point, we ask the North American Division to provide a man to look after the Tagalog work on Luzon, so that Elder Finster's hands may be free for the general superintendence of the field.

## G F ENOCH--INDIA:

Elder R C Porter presented a request from G F Enoch that he be allowed to return to the India field on the conclusion of his present work in this country.

VOTED, That Elder G F Enoch be recommended to return to India when his present work is completed.

### LEO K CHANG:

A communication from Elder Porter reported negotiations with the brethren in Korea regarding the return to that field of Brother Leo K Chang, graduating from Union College.

In view of the fact that a little time is necessary to carry on negotiations regarding the question of Brother Chang's return to Korea, it was--

VOTED, That we ask the North American Division to endeavor to find a place for Brother Chang, where he can engage in English work in this country, in connection with some conference tent effort, so as to gain an experience in the evangelistic field, giving time for the Asiatic Division to take up the question of the possibility of utilizing his services later in the mission field.

Recess was taken to 1:15 P.M.

On reassembling, prayer was offered by A G Daniells.

### BRAZIL TRAINING SCHOOL:

Communications were presented from W W Prescott and O Montgomery, making call for a strong school man to take charge of the new training school which is being established by the Brazilian Union Conference. They urged very earnestly the importance of giving this school strong leadership, so that it may accomplish for Brazil the work that is being done by the River Plate school for the Spanish-speaking portion of South America.

After thorough discussion of the proposition, it was---

VOTED, To ask the North American Division to arrange, if possible, for the release of Professor Gordon Andrews, of Union College, and that he be invited to take charge of the Brazilian training school.

## VACCINATION:

Attention was given to the matter of vaccination, particularly against typhoid, and the Committee was asked to take action regarding its policy.

VOTED, That we require all candidates for missionary appointment to be vaccinated for defense against smallpox, and to take the anti-typhoid vaccination against typhoid fever before proceeding to the fields.

### MRS R B THURBER:

In view of the fact that Mrs R B Thurber, just returned from Burma, is in a very serious condition with sprue, it was-

VOTED, That the General Conference Committee be asked to arrange for special medical care of Mrs Thurber.

VOTED, That we advise J P Anderson to bring his wife to the Washington Sanitarium, to be under Dr Miller care, and we authorize the treasurer's and secretary's departments to make such arrangements as are necessary to aid Brother Anderson in the effort to save Sister Anderson's health for future service

### JOHN HOLDER--WEST CARIBBEAN:

W W Eastman, of the Publishing Department, reported, recommending John Holder, of Ohio, as field missionary secretary for the West Caribbean Conference.

VOTED, That we ask the North American Division to allow its Publishing Department to negotiate for the release of Brother John Holder, and that we invite him to labor in the West Caribbean Conference.

### BROTHER BOWERMAN RELEASED:

Action having been taken, inviting Brother Bowerman and wife, of Loma Linda, to take charge of the treatment rooms in Honolulu, report was received from L M Bowen, of Loma Linda, that Sister Bowerman on account of health and the care of her family did not feel that she could take full charge of work in the treatment rooms. A letter was received from W J Fitzgerald, giving information regarding a Brother Baasch, formerly of India, who has been taking school work in England.

VOTED, That we encourage Brother Baasch to get his further medical missionary training in Great Britain, preparatory to returning to the Asiatic Division, and that we assume ± 30 of his training indebtedness on his departure for the field.

## WALDEMAR EHLERS:

On request of the South American Division, it was--

VOTED, That we ask the European Division to arrange work for Elder Waldemar Ehlers, formerly connected with the Brazil Union, which union has been supporting him in Europe during the last several years while he has been seeking to regain his health.

## R DIETRICH:

On report from the South American Division that R Dietrich, formerly of Germany, has not seemed able to make any progress with the Portuguese language, so essential to his efficiency in the work, it was--

VOTED, That we ask the European Division to are range work for Elder Dietrich in the German field in Europe.

#### INCA UNION SECRETARY:

On request of the South American Division, it was--

VOTED, That we ask the North American Division to endeavor to secure for us a secretary and treasurer for the Inca Union Mission.

#### U BENDER:

A letter from Elder U Bender, appointed as superintendent of the Rhodesian Union Mission, reported that there was good prospect that he would be released from the Montana Conference the first of July. Inasmuch as on his return from the West Indian field several years ago, he went at once to Montana, he felt this time his family should spend a little time in meeting his people and Sister Bender's people.

VOTED, That we authorize Elder U Bender to spend a month or six weeks visiting his people before arranging to proceed to South America.

#### APPEAL FROM MOTHER ANDERSON:

An appeal was presented from Sister Naomi Anderson, the aged mother of Elder W H Anderson, of Rhodesia, asking that her son be allowed a furlough in order that she might have him with her for a little time in her last days.

Inasmuch as the South African Union some time ago recommended a furlough for Brother and Sister Anderson, it was the understanding of the Committee that he would doubtless be taking this furlough about the time of the next General Conference.

It was agreed that the letter from Mother Anderson should be sent on to the South African Union Committee.

# CABLES FROM INDIA:

Cable messages were received from India as follows: One reporting opening in Bombay for treatment rooms and asking for Dr Semmens, with cable as to date of departure; one from Mussocrie, reporting that the Mussocrie school was to be registered under government inspection, asking that a teacher be sent immediately, with cable of qualifications and date of departure.

Inasmuch as the Committee had no information regarding the Bombay situation, and whether equipment had been secured, and whether the brethren expected a physician to do the treatment room work; and in view of the fact that no teacher is under appointment for India, and the Committee has little information regarding what may be involved in changing the status of the school, --

It was agreed to cable India as follows: "Continue school as heretofore. Write Bombay needs."

### MALAY TRANSLATING:

A letter received from Elder R W Munson, enclosing a letter from Elder Detamore with regard to work in Malay translating, was referred to Elder R C Porter.

# MISS LENA MEAD-SINGAPORE:

Information was given that Miss Lena Mead, church school teacher of California, accepted the call which has been extended to her to engage in school work in Singapore.

Word was received from Elder C F McVagh, of the Western Canadian Union, reporting that on account of Sister Gilbert's health, Elder A C Gilbert, president of the Saskatchewan Conference, had felt compelled to decline the call to the presidency of the Cape Conference in South Africa. In the meantime a cable message had been awaiting answer, South Africa asking for report regarding the appointment.

It was agreed that we would cable South Africa: "Cannot report yet."

Recess was taken till afternoon.

#### ACCEPTANCES:

A letter was received from Guy Corder, of Ohio, accepting the call to the book work in South Honduras; also from John Holder, of Ohio, accepting the call to the West Caribbean Conference as leader of the book work.

#### HAITI:

VOTED, That the treasurer be authorized to appropriate \$200 for church and school building enterprises in Haiti.

VOTED, That \$150 be granted to Dr D E Blake, recently landed in Haiti from Panama to take up self-supporting medical missionary work, this amount being a grant in aid, to encourage him in establishing work at Cape Haitien.

# BERGER JOHNSON:

VOTED, That we ask the North American Division and the Pacific Union Conference to release Brother Berger Johnson and that we invite him to make the West Caribbean Conference his field of labor.

# SECRETARY WEST CARIBBEAN:

VOTED, That we ask the North American Division to assist in securing a secretary and treasurer for the West Caribbean Conference.

## E W THURBER--CUBA SCHOOL:

WOTED, That we release W P Barto from appointment to the school work in Cuba, and invite E W Thurber to take on this school work, Elder Thurber having left Mexico for Cuba on account of the political situation.

# W P BARTO--BATTAKLAND:

VOTED, That we invite W P Barto to make the Malaysia Mission his field of labor, with a view to answering the call for a teacher in Battakland, where only teachers are allowed by the government.

### U COCHRAN--CUBA:

VOTED, That we take under consideration the request of Brother U Cochran to be released from the general direction of the book work in Cuba, and that we ask the Publishing Department to search for a proper man to take the work; but that we notify Buba that it is difficult to secure the release of strong leaders within a short time, and that Brother Cochran be urged to carry forward the work strongly until provision can be made.

# JOSE VEIGA:

VOTED, That Jose Veiga, of Cuba, be placed under provisional appointment in the Foreign Seminary Department of the Washington Missionary College for the coming school year.

## TEACHER--CUBA:

VOTED, That the treasurer be authorized to meet the transportation of a teacher to Cuba, to engage in a private school in an American colony where a number of children of our missionaries will be in attendance, and that we request the Educational Department to endeavor to secure the teacher.

# CUBA HEADQUARTERS:

Communication was received from Cuba regarding office headquarters. The present place is considered but temporary in Santo Domingo. Havana was the choice of all, but it was stated that Cuba would require further financial assistance if the office were transferred to the city.

VOTED, That under the present conditions we do not advise the transfer of the headquarters of the Cuba Mission to the city of Havana.

### CARNAHAN SCHOOL:

Elder F G Lane, of Cuba, presented by letter a proposition from Sister Carnahan concerning the school Brother and Sister Carnahan are operating at San Claudio, western Cuba. Some gifts had been made by philanthropic societies, or individual connected with the society for the prevention of cruelty to children, and Sister Carnahan raised the question if some sert of corporation should not be formed, so that their school work, which is private, should be more organically connected with the organized work.

VOTED, That we counsel Brother and Sister Carnahan that under the circumstances we feel it would be better for them to make any provision they may wish by will regarding the disposal of the property placed in their hands, rather than to try to forma corporation of a denominational or semi-denominational character.

# NURSES--PORTO RICO:

VOTED, That we ask the Medical Department to endeavor to secure two nurses for Porto Rico.

## DR ROBERT L STOKES:

Owing to the fact that Dr Stokes, under appointment to work in China, seems too far along inyears to learn the language successfully, and owing to the fact that the Asiatic Division seems not to have funds and facilities for the hospital work which Dr Stokes has had in mind---

VOTED, That we release Dr Robert L Stokes from appointment to China, and that he be recommended to the North American Division for service in connection with exame of our institutions.

Inasmuch as the appropriations-already voted promise to consume the full amount which the General Conference treasury has expectation of receiving, and in view of the fact that this call is felt so urgent by Malaysia, it was--

VOTED, That we request the Review and Herald to appropriate from their reserve fund \$5000 for the work in Bornoe, for the specific purpose of securing a headquarters in that field.

# APPOINTMENT TO FIELDS:

VOTED, That we ask the North American Division to open the way for the following persons to be invited to the fields, and that their release be requested:--

W I Hilliard and wife, nurses of Glendale, to Honan, China, as medical evangelists.

G Avery Davis and wife, of Battle Creek, Mich., to Foochow, China, for training school work.

w P Dayton, of Lodi, California, to Swatow, China, for training school work.

H P Gray, of Idaho, to India, for evangelistic work, with a view to answering the call for a Telugu laborer#

Dallas Kime, of College Place, Wash., to Malaysia.

Miss Gladys Bowen, of South Lancaster, to China, for stenographic work.

#### ALBERT MUNSON:

In view of the renewed call from the Asiatic Division for another evangelist for Java, it was agreed that Albert Munson, who had been counted as the teacher for the Padang school, should be recommended for evangelistic work in Java, having the use of the Malay language.

### M M HARE:

It having been ascertained that Elder M M Hare, appointed to India, cannot obtain passport for India in this war time without considerable delay and difficulty, it was--

VOTED, That we withdraw the appointment to India on account of the passport difficulty, and that we invite Elder M M Hare to go to the Philippine Islands, to take charge of the work in the island of Luzon, provided the Asiatic Division will release appropriations from some unfilled calls made for workers in China.

# W D BURDEN--JAPAN:

. The matter of Brother W D Burden's condition in Japan having been further considered, it was--

VOTED, That we advise a continuance of the allowance formerly made to Brother Burden, pending further counsels regarding his work.

### BURMA HILL STATION:

On information that the India Union Mission did not have sufficient funds in hand, or at least allotted for the purpose, to enable the workers in Burma to accept the government gift of a site for a hill station, it was--

voted, That the treasurer be authorized to correspond with the superintendent of India concerning the matter; and we advise that the Burma workers be given furloughs to the India hill stations when requiring release from the heat of the plains, until arrangements can be made for a proper station in Burma.

# BRAZIL SCHOOL:

Report was received through the Educational Department that the way was not clear for the release of Professor Gordon Andrews to accept the call to the Brazil school, and the Central Union brethren reported, recommending Professor J I Beardsley for this appointment.

VOTED, That we withdraw the invitation for Prof Gordon Andrews to go to Brazil, and that we accept the suggestion of the Central Union, and invite Prof J I Beardsley, Educational Secretary of the Nebraska Conference, to go to Brazil, to take charge of the Brazilian Union training school, requesting the North American Division to arrange for his release.

#### L A HANSEN--A G DANIELLS:

Fider A G Daniells explained his need of assistanc in handling his correspondence while he is absent so much from the office, and in other ways. He made request for the services of Brother L A Hansen for a part of his time.

VOTED, That we ask the North American Division to allow Brother L A Hansen to divide his time with the General Conference, and that we request him to serve as private secretary to Elder A C Daniells, making this latter service his primary work.

# STENOGRAPHERS! WAGES:

A sub-committee on wages of office helpers reported that it was their wonviction that the wage of the stenographic helpers in the General Conference office should be raised in view of the present increased cost of living.

VOTED, That the wage of the stenographic and other subordinate helpers in the general conference office be raised one dollar in each case, making the salary of the least \$7.00 per week, and that of the highest \$12.50.

The Medical Department not having secured a man and wife for the treatment rooms in Honolulu, and the Honolulu brethren having called for Brother Bowerman, of Loma Linda, it was

VOTED, That we send Brother Bowerman to take charge of the Honolulu treatment room work.

VOTED, That the treasurer be authorized to return Brother Barthobomew and his family from Honolulu to this country, and that he be granted three months' furlough pay at \$14 per week, unless within the time he has been able to secure work in this country.

### MRS ELIZABETH WRIGHT--PORTO RICO:

L A Hansen, of the Medical Department, reported regarding his search for nurses for Porto Rico.

VOTED, That on recommendation of the Medical Department, we submit the name of Mrs. Elizabeth Wright, of Michigan, to Porto Rico, for nursing and Bible work.

# SOUTH AFRICAN PRINTING:

Letter was received from the South African Union Committee making request for assistance in securing a cutter, stapler, and other appliances and assistance in strengthening their publishing work. They asked if the Review and Herald might not be able to give assistance at this time.

VOTED, That we pass to the Review and Herald Board the request from South Africa for consideration.

# MISS PANE--JAVA:

Word was received from Elder R C Porter, approving of a proposition submitted by Miss Petra Tunheim, to pay the transportation of a nurse to accompany her to Java, and to be a self-supporting worker in that field.

VOTED, That on recommendation of Miss Petra Tunheim, we invite Miss Pane, of the Loma Linda School of Medical Evangelists, to accompany Miss Tunheim to Java, to engage in self-supporting work as a nurse, Miss Tunheim providing the transportation.

# HARRY MCWHINNY--CHINA:

A letter was received from Elder E E Andross, of the Pacific Union, recommending Brother Harry McWhinny, an evangelist of Southern California who had expressed a willingness to labor in China.

VOTED, That we ask the North American Division and the Pacific Union to release Brother Harry McWhinny, and that we invite him to go to China, with a view to locating in the Hakka work at Wai Chow.

#### J J WESTRUP:

In reply to the propositions submitted by the Committee, Elder R C Porter wrote, consenting to the return of Elder J J Westrup to China, provided his wife is able to accompany him.

VOTED, That we agree with the Asiatic Division in arranging for the return of Elder J J Westrup to labor in China whenever the physical condition of his wife makes it possible for her to return with him to the field.

VOTED, That we ask the North American Division to allow its Educational Department to secure an assistant teacher for the Padang school, Sumatra.

# W A JOHNSON--KOREA:

VOTED, That we ask the North American Division to negotiate to open the way for an invitation to be extended to Elder W A Johnson, of California, to make Korea his field of labor.

# MELVIN MUNSON--MALAYSIA:

Honolulu, where he is assisting Elders McCord and Conway in a public effort. He reported his own convictions as to his health, and it was--

VOTED, That on the strength of Brother Melvin Munson's own convictions regarding his health, and on the strength of the medical certificate supplied by Dr. Klingerman, and the consent of Elder Porter, of the Asiatic Division, we take action recommending Brother Melvin Munson's return to Malaysia, with a view to his engaging in editorial work as originally planned at the time of the autumn council.

VOTED, That we ask the Mexico Mission to allow E R Johnson and wife to take the Cuta institute and school work planned for during the last five months of this year, Brother and Sister Johnson having recently arrived in Cuba from Mexico.

#### S M COBB:

LETTER WAS received from Elder S M Gobb, of Australia, who for two years has been engaged in self-supporting work in Queensland. Under the circumstances of his family, after ten years of service in the Australasian field, Elder Cobb reports that they are convinced they should return to this country, holding himself in readiness either to engage in the work if desired, or to engage in business.

VOTED, That the treasurer be authorized to arrange for the transportation to America of Elder S M Cobb and Mrs Cobb and their daughter.

The location of various workers was pointed out on the map, and the circumstances under which they labored. The war has set the people to serious The importance of the message is more fully realized by our brethren in Russia and the funds have been kept up because they see of how little value is money and how important that God's work be maintained.

## A F HAINES:

A communication was received from the secretary of the West Indian Union Conference, reporting the arrangements made for the temporary conduct of the work of the Watchman Press in Jamaica. Owing to the fact that changes are contemplated in the handling of the publishing work in the West Indian Union, with the possibility of removing the printing work from Jamaica, it was felt by the West Indian Committee that Brother A F Haines should not plan to return to Jamaica on the conclusion of his furlough. It was therefore—

VOTED, That we ask the treasury department to endeavor to secure a position for A F Haines in connection with one of our printing houses which might be in need of his services.

#### C H KESLAKE:

The West Indian Committee reported that in view of the great increase in the cost of paper, and the difficulty in the handling of the output, owing to the disarrangement of transportation, the committee had planned to issue the West Indian Watchman only once in two months; this making it necessary to greatly reduce their staff of workers, the committee requested the General Conference to arrange either for the full support of Elder C H Keslake by appropriations, or for his transfer to work in some other field.

VOTED, That we ask the North American Division to give consideration to the work of Elder C H Keslake, and to endeavor to find a place for him in the North American Division, the General Conference to move him to whatever place may be open for his services.

#### H BAASH:

The secretary reported an interview with Brother H Baash, of London, Brother Baash having formerly been connected with the India Mission, and having a good start in the language of Siam. He has now desired to come to America in order to secure such advantages in medical missionary lines as were afforded by the dispensary work in Washington. He is ready to pay his transportation to this country this coming winter in order to secure these advantages, and is recommended by the brethren in Great Britain, Owing to his being a foreigner of Venezuelan citizenship, he is not able to secure these advantages in Great Britain at this time.

VOTED, That we place Brother H Baash under provisional appointment in the Foreign Seminary Department of the Washington Missionary College for such portion of the school year as he may be able to avail himself of at the conclusion of his business engagement in London, this being with a view to fitting himself for passible future service in Siam when we are able to open that field.

## F E PARRISH--PORTO RICO:

The Educational Department reported the name of F E Parrish, of Michigan, as being a candidate available for school work in Porto Rico. It was stated that all local parties interested had been in touch with this matter, and that the way was open.

VOTED. That we request the North American Division to allow the Educational Department to arrange for F E Parrish, of Michigan, to go to Porto Rico to engage in teaching.

#### DR A W SEMMENS:

A request was presented from Loma Linda that consideration be given to the possibility of the General Conference paying the transportation of Dr A W Semmens and family to New Zealand, to take up a medical practice which would be laid down by the Drs. Kellar, in order that the matter may connect with the work at Loma Linda.

VOTED, That the Committee does not feel free to appropriate for this item of transportation, which would involve the return of Dr Semmens to the Australasian Union to engage in private practice.

## REPORT ON GREAT BRITAIN:

The secretary was given time to make a report of his visit to Great Britain, to attend the British Union Conference biennial session. The report testified to the good courage of the brethren and sisters in that field, and to the encouraging progress in the work there notwithstanding war conditions.

Recess was taken to 4 P.M.

On resuming at 4 P.M, there were also present I H Evans and G B Thompson.

#### R C WANGERIN:

The treasurer presented correspondence with Brother R C Wangerin, returned from Korea, and now endeavoring to recover from tuberculosis.

VOTED, That R C Wangerin be granted the same allowance for the present as when in Korea, the treasurer to counsel with him regarding his location.

#### ACCOUNTS OF S A OBERG AND ROLAND LOASBY:

VOTED, That the treasurer be authorized to share with the Iowa Conference in meeting the expense at the St Helena Sanitarium of Mrs S A Oberg, who was ill there after her return from Venezuela, the amount of the account being \$180.

VOTED, That the treasurer be authorized to meet the account of Roland Loasby, of India, for operation and care of Mrs Loasby at the Washington Sanitarium, the amount being \$171.51.

#### TENT FOR CUBA:

VOTED, That the treasurer be authorized to secure for Cuba a meeting tent, 40 x 60 feet.

## JOHN W COLE--SOUTH AMERICA:

VOTED, That we invite John W Cole to go to South America, to act as stenographer for the South American Division officers.

## LEO K CHANG--HAWAII:

The Committee had before them correspondence with Brother Leo K Cang, a Korean graduate of Union College, Nebraska. It being understood that the Asiatic Division is considering the matter of his employment in Korea, it was felt by the Committee that something should be done to encourage him into the work while waiting for the decision. It was therefore—

VOTED, That we invite Brother Leo K Chang to engage in the work in the Hawaiian Island Mission, laboring for the Koreans, his salary rate to be ten dollars per week, this action being taken with the understanding that it does not contemplate permanent service in the Hawaiian Islands.

#### MOTHER KIRSTEIN--SOUTH AMERICA:

W W Prescott presented correspondence with Wisconsin regarding the mother of William Kirstein, of Argentine, who has been expecting to go out to South America to join her son. Owing to passport difficulties in war time, her transfer to South America according to arrangement when the son went out, seems difficult.

VOTED, That the treasurer be authorized to grant to the mother of William Kirstein \$2.00 per week for a limited time, to aid in her support while endeavors are made to make arrangements for her to join her son in South America.

#### DR DUNSCOMBE:

A letter was presented from Dr W C Dunscombe, of South Africa, calling in question the advisability of his returning to America. A telegram had been received from Elder E E Andross, stating that Brother R J Bennett, a returned missionary from India, who had recently accepted the truth, was awaiting word from the General Conference as to whether it would be possible for him to attend Pacific Union College this coming school year, the telegram stating that Elder Porter met Brother Bennett while in California, and desired that some provision should be made for him to get acquainted with the truth and our work, with a view of his possible return to India.

VOTED, That the treasurer be authorized to grant an allowance of \$12.00 per week to R J Bennett and family, propvided this will open the way for him to attend college, the allowance not to continue beyond the present school year.

#### C H KESLAKE:

A communication was received from Elder A J Haysmer, of Jamaica, stating that since the action was taken asking for the return of Elder C H Keslake to America matters had been reconsidered and it was felt that if at all possible to provide for his support they should have his services in connection with their printing work during the remainder of this year.

VOTED, That the treasurer be authorized to add to the West Indian appropriation a further \$7.50 per week on account of the salary of C H Keslake for the remainder of 1916.

## J A LELAND:

The Committee had before it a letter from Elder J A Leland, written to N Z Town, speaking of his having under consideration a change from the Texas field, and raising the question as to whether he ought not to be engaged in Spanish work, inasmuch as he has fluent use of the Spanish tongue. Consideration was given to the matter, and it was--

VOTED, That we request the North American Division and the Southwestern Union Conference for permission to take up with Elder J A Leland the practicability of his engaging in work in Mexico for the present, with a view to keeping thim in the Spanish work if the endeavor proves satisfactory, this action being taken with a view that we will endeavor to utilize Elder Leland's services for one year at least, the salary rate being \$16.00 per week.

VOTED, That Mrs H R Salisbury, returned from India, be granted \$5.00 per week as a furlough rate, in addition to an equal amount which she will receive from the Washington Missionary College during the present school year.

VOTED, That \$5.00 per week on account of furlough allowance be paid to Mrs Edith E Bruce, receiving part support from the Washington Missionary College during the school year.

It was agreed that further consideration should be given to the matter of the manager.

The secretary reported that Brother W C Sisley felt that on retiring from more active service, he had thought of Florida as a possible location. It was-

VOTED, That we ask the North American Division to keep in mind the matter of Brother W C Sisley's location on his return to America, and to consider the possibility of utilizing his services in Florida, if that should seem the fielf of his choice.

#### W R WHITE:

# COMMITTEE ON APPROPRIATIONS:

VOTED, That the officers of the two conferences and the union conference presidents be a committee on appropriations for 1917.

#### SPECIAL EXPENSES IN FIELDS:

WHEREAS, The present method of drafting the budgets of the respective mission fields calls for the recording of requests for funds for many unforeseen expenses which may be provided for directly in a more satisfactory manner by the General Conference treasurer; therefore,—

WE RECOMMEND, That, from henceforth, we ask our superintendents of mission fields to include in their annual budgets only the items of regular expenses, leaving all unforeseen expenses and heavy items of transportations of workers to be adjust ed at the time of their contraction.

#### SAFEGUARDING FIELD EMERGENCY FUNDS:

For the establishing and safeguarding of our emergency funds,--

We recommend, l. That we place with our Division treasurers and such Union mission treasurers as may be decided upon special deposits of money to be known as Emergency Funds, which shall be used, not for the local operation of the field, but for special service in the meeting of such unavoidable expenses as may present themselves from time to time.

- 2. Each treasurer of emergency funds is to report from time to time to the General Conférence treasurer full particulars as to why and how these funds are disbursed. When 40% of said money is expended, the detailed report is to be made out and sent with a request to the treasurer of the General Conference for the restoring of the emergency fund to its full or agreed amount.
- 3. All payments from the emergency fund are to be made only with the approval of the local committee in each Division or Union concerned.

#### APPEALS FOR ASSISTANCE:

The treasurer reported that since the outbreak of the war and the interruption of ordinary lines of communication with many parts, appeals for assistance from workers or believers cut off from help sometimes came to the General Conference, seemingly requiring action without consultation with the fields which ordinarily would be consulted. He asked counsel as to how such appeals should be treated.

VOTED, That a committee of three be appointed to consider these items and to make report.

Minutes were read.

#### AUDITING COMMITTEE:

VOTED, That the officers of the General and Division Conferences, the union presidents, and ChH Jones, ER Palmer, AO Tait, LM Bowen, SN Curtiss, DH Kress, RL Pierce, FM Wilcox constitute the Auditing Committee for General Conference accounts.

#### WEST INDIAN PUBLISHING BRANCH:

The question of a branch publishing housem or depository, in the West Indies, for serving the West Indian and North Latin fields, was introduced, and it was--

VOTED, That the matter be referred to the members of the Publishing Department committee, with the addition of W A Spicer, M E Kern, J J Ireland, G B Thompson.

#### BOOK LEADERS:

VOTED, That the calls in the Agenda paper for leaders of the book work in Korea, Inca Union, Salvador, Malaysia, Venezuela, and India be referred to the committee on distribution of labor.

## SABBATH SCHOOL LESSONS ON TITHING:

A request was received from the Kansas Conference that a lesson on tithing be presented each quarter.

The secretary of the Sabbath School Department stated that when an effort had been made to follow this plan, considerable objection had come from the field, owing to the breaking of book study by the introduction of a study which obviously did not fit into the general plan of the quarter. It was stated that the Sabbath School Department was always watching for chances to introduce studies on tithing whenever the subject came naturally into the book study, or whenever topical subjects were under review.

The importance of keeping this matter before the people was unanimously agreed upon, and it was--

VOTED, That we request the Sabbath School Department to continue its plan of giving studies on the obligation of the tithe whenever opportunity offers in the Sabbath School lessons.

## STANDARD OF ATTAINMENT:

After listening to an interesting report by the secretary of the Young People's Department regarding progress in the work for the youth in other lands, it was-

VOTED, That we recommend a uniform plan for the Standard of Attainment, to apply in all countries.

MISS. VOL. DEPT. COMMITTEE:

VOTED, That the following persons be added to the Missionary Volunteer departmental committee, these being in the way of substitutes to fill vacancies, or additions to the committee: F Knight, G H Clark, S L Frost, L L Caviness, Howard Lee, C P Crager

#### FRANCE:

An appeal in behalf of the work in France had been received from Elder J Vuilleumier, of Montreal. The appeal stated that thirty-six years ago France was entered by our work, but that up to the present time, out of eighty-six departments or provinces, only fourteen had been entered. The appeal asked that encouragement be given to the circulation of literature in France by some method that would enable colporteurs to keep the field. Along with this a plan was suggested for producing magazine and tract literature. It was a very earnest appeal, and at its conclusion, it was--

VOTED, That we report to Elder J Vuilleumier that the council listened to his appeal in behalf of France with greatest interest and sympathy, and that we assure him that the matter will be borne in mind when the way opens for opportunity for counsel with the Latin Union regarding the work in Southern Europe.

## WEST INDIAN UNION:

The calls for a superintendent for Venezuela, and for a secretary for the Jamaica Conference were referred to the committee on distribution of labor.

#### NORTH LATIN FIELD:

THE calls for a superintendent for the North Latin field, and for two evangelists for Cuba were referred to the committee on distribution of labor.

#### INDIA UNION MISSION:

The calls for superintendents for Bengal, the Punjab, Central India, and for a lady Bible worker for Bombay were referred to the committee on distribution of labor.

#### D N WALL:

Information was received that Elder D N Wall, of Australia, formerly a German worker in New York City, was engaging in English evangelistic work. The brethren of the German Department in the North American Division felt anxious that Elder Wall

should be able to devote his strength to evangelistic work in the German tongue, and reported their great need in the cities of the East. It was further reported that the Austral Union Conference, South America, was in great need of an evangelist, such a call having been listed on the Agenda paper. It was therefore—

VOTED, That the matter of Elder D N Wall's future work be referred to the committee on distribution of labor, with the suggestion that he might be transferred to the South American Division.

# SOUTH AFRICAN UNION:

The requests of the South African Union for a presitent for the Cape Conference, teacher for the Zulu Mission, and teacher for the Kafir Mission were referred to the committee on distribution of labor.

# W A WALSTON--FURLOUGH:

VOTED, That we grant the recommendation of the South African Union Conference, that Elder W C Walston, and wife, of the Solusi Mission, be granted a furlough, to America, after about twenty years in the South African field.

# W H ANDERSON--FURLOUGH:

Information was given that on account of Sister Anderson's health, Elder W H Anderson, of South Africa, was accompanying her to this country, under action of the South African Union Conference. It was--

VOTED, That after a time spent in visiting his people, we ask the North American Division to consider what arrangements can be made for utilizing the services of Elder W H Anderson while in this country, with the idea that his services should be available for at least a year.

#### SOUTH AMERICAN DIVISION:

VOTED, That the request of the Austral Union Conference for a home missionary secretary be referred to the committee on distribution of labor.

In all these references to the committee on distribution of labor, explanation was given to the council as to the urgency of these calls for workers.

## BRAZIL UNION:

The calls from Brazil were explained by W W Prescott and it was--

VOTED, That we refer to the committee on distribution of labor the calls from the South American Division for Brazil, as follows: Union school principal, Union secretarytreasurer, ministers for Rio Grande, Minas Geraes, Sao Paulo, Santa Catharina, and book leaders for North Brazil and Minas Geraes

### INCA UNION MISSION:

W W Prescott continued presenting the South American Division calls, describing the needs and openings in the Inca Union Mission. The remarkable work among the Indians of Peru was reported. It was--

VOTED, That the Inca Union Mission calls be referred to the committee on distribution of labor as follows: Superintendent for Peru, superintendent for Bolivia, field agent for Bolivia, evangelist for Bolivia, teacher for Indian work in Bolivia, field agent for the Inca Union, and seven workers for the Lake Titicaca Mission (two of whom have already been appointed).

# ST THOMAS HURRICANE:

A cable message was received from Elder E C Widgery, of the Danish West Indies, saying: "Devastating hurricane. Great distress. Church party demolished. Help is needed."

VOTED; That the matter be referred to the treasurer and secretary, to report as to the best means of providing help, some of the union conferences having suggested that they might help.

## WEST INDIAN AND NORTH LATIN PUBLISHING:

The committee appointed to consider the matter of the West Indian and North Latin publishing work presented a report as follows:--

Whereas, There is an urgent need for the consolidation and building up of the book and periodical work in the West Indian Union and Northern Latin American Mission fields; therefore,

- We recommend, l. That the Pacific Press Publishing Association be invited to establish a branch publishing house in the West Indian Union or Northern Latin American Mission field territory at such place as may be decided upon in counsel among the members of the West Indian Union Conference Committee, the Northern Latin American Mission Committee, the Pacific Press Board and the General Conference Committee.
- 2. Chat the Pacific Press Publishing Association take over such portion of the present Watchman Press and Mexican Publishing House equipment as may be agreed upon by the General Conference and the Pacific Press Board, and at such valuation as may be decided upon by the General Conference auditor.
- 3. This publishing branch shall supply literature in all languages to the entire field, and may print or import such English, and foreign periodicals, tracts and books as may be needed in the field.
- 4. That the branch office shall absorb custom duties to each field up to, but not exceeding, 10%; also consular fees and freight charges to society offices, or to agents on railway or steamship lines, provided such shipments weigh 500 lbs. or more; freight, but not consular fees, to be paid on shipments of 100 to 500 lbs.
- 5. That this branch office allow the same discounts to societies, missions, and laborers as are outlined in the Recommendations of the General Conference Publishing Department; and shall also pay one half of the salary and expenses of the union field missionary secretary.
- 6. That the West Indian Union missionary field secretary supervise the book work in the Northern Latin American Mission territory until such time as it shall seem best to appoint a union secretary for that field, the General Conference compensating the West Indian Union for the time he spends in their service.
- 7. That the book work in each conference and mission field be managed and controlled by the local committee with a field secretary in charge.

- That the following be the local advisory board: 8. The branch office manager;; president of the West Indian Union; superintendent of the Northern Latin American Mission; union field missionary secretary; president or superintendent of the local conference or mission in which the office is located, and two other resident members to be selected by the foregoing and approved by the Pacific Press Board.
- That it is understood that the Pacific Press Publishing Association will turn over this branch office to the local field if requested to do so by the General Conference, on such terms as may be agreed upon by the General Conference, the Pacific Press Board and the local fields.

Prof G W Caviness, who was present, expressed his feeling that the press of the Mexico Mission should not be merged into this enterprise, feeling that Mexico, with its fifteen millions needs a printing work there.) It was--

> That the report of the committee be adopted. VOTED.

## LETTER FROM L R CONRADI:

The secretary read a letter from Elder L R Conradi, posted in Switzerland, speaking of matters relating to the work in Europe.

The council adjourned, in order to give the committee on appropriations opportunity to go forward with their work on the budget for 1917.

### ST THOMAS HURRICANE:

The committee appointed to consider the matter of response to the call for help to relieve distress and damage in the Danish West Indies, made a report, suggesting that \$500 be cabled to Elder Widgery, made up as follows: General Conference, \$100; Pacific Union, \$75; North Pacific, \$50; Northern, \$100; Columbia, \$50; Lake, \$75; North American Division, \$50, these amounts being suggested by the various unions.

## THIRTEENTH SABBATH OFFERINGS:

The secretary of the Sabbath School Department presented a report of the results of the Thirteenth Sabbath Offerings as follows:--

Thus, as the secretary of the department said, passing the hat seventeen times has brought \$285,765 to missions.

VOTED, That W T Knox, Mrs L F Plummer, J L Shaw, G B Thompson, W A Spicer be a committee to designate objects for the second, third, and fourth quarters of 1917.

REPORT OF COMMITTEE ON APPROPRIATIONS:

The committee on appropriations brought in the results of their study.

In the committee on appropriations it had been agreed that sixteen cents should be the amount set aside for missions in the Twenty-cent-a-week Fund in 1917; that from the surplus of the Sustentation Fund \$25,000 should be appropriated to missions; and that the treasurer be authorized to reduce his operating capital by \$55,000, adding this amount to the available funds. This still left \$101,000 to be cut from the calls for 1917 presented by the fields. The work of making this cut had been assigned to a small sub-committee.

The report of this sub-committee was presented by the treasurer, showing that reductions of about \$80,000 had been made in the 1917 estimates by deferring various enterprises called for, and reducing the number of workers requested. The suggestion of the sub-committee was that the \$20,000 shortage be made up by appropriating a further \$15,000 from the Sustentation Fund surplus, and asking Australasia to increase its estimated contribution from \$15,000 or more, to full \$20,000.

The council listened to a brief explanation of the manner in which the cut had been applied, giving an idea of various calls which would have to be deferred. At the same time the argange ment proposed listed a good number of additions to the fields, both in men and means, so that the year 1917 would still be a year of advancement.

By formal action it was then--

VOTED, That for 1917 we appropriate for missions sixteen cents per week from the Twenty-cent-a-week Fund.

That the treasurer be authorized to reduce the proposed working capital, or operating fund, by \$55,000, adding this amount to the funds available.

That \$40,000 be appropriated to missions from the Sustentation Fund surplus.

That we ask the Australasian Union to bring their contribution to the Asiatic Division up to an amount of at least \$20,00.

That with these provisions the appropriations be made according to recommendation.

## MISSIONARY APPOINTEES FUND:

Consideration was given the matter of placing students under provisional appointment for the mission fields, with grant of assistance for the final work of preparation. This plan had been used to a considerable extent in the days of the Foreign Mission Seminary, but had been reduced to a minimum more recently. It was--

VOTED, To eliminate the amount of \$4,200 set aside for this appointee fund in the estimates for 1917, with the understanding that this would not cut off a number who were receiving some help from the fund this school year.

# FOSTERING MISSIONARY TRAINING:

VOTED, That a committee of five be appointed to make recommendation regarding plans for fostering missionary aims in the colleges, and to help the colleges in developing missionaries for the fields.

Named: W E Howell, J L Shaw, L H Christian, R A Underwood, E E Andross.

The council adjourned in order to give committees time to go on with their work.

The sixth meeting of the council was called as a joint session with the North American Division at 3:45 P.M., October 16, to receive the report of the joint committee on wage schedule.

## WAGE SCHEDULE:

The report of the committee on wage schedule was presented and adopted as follows, the report being as an amendment to the wage schedule report adopted in dession some years ago.

We recognize the fact that in exceptional cases the requirements of city work may call for the employment on a conference of an evangelist who is expected to take responsibilities and bear burdens of a special nature, in which case the rate of wage might right be equal to that of the president of the conference.

The institution to meet expenses for such post-graduate work, medical fees, and medical literature as may be agreed upon.

This increased rate allowed to medical superintendents and physicians is intended to cover the full amount of salary, thus eliminating the provision made in the previous schedule for the addition of 10%.

We further recommend, -- 1. That when laborers are sent to any field where rents are excessive, proper allowance be made by conferences and institutional Boards.

2. That the introductory paragraph to the wage schedule be amended by adding in the second line after the word "living" the words "under similar conditions," thus making the paragraph read:--

"From the information we have been able to gather. we find that the cost of living under similar conditions for the same standard of personal and household expenditure, is about the same throughout the world. That is to say, in every country, the necessities of life, such as food, clothing, rents, fuel, etc., can be secured at approximately the same cost. The same is true regarding luxuries. This uniformity is no doubt brought about by railway and steamship service, governmental legislation, trades' unions, manufacturers' combinations, and trusts, etc."

- 3. That the General Conference Committee at this session appoint a commission to give study to the question of authoris' remuneration, and payment for articles furnished to our papers, private lessons by teachers, and other supplementary sources of income, as recommended in the wage schedule adopted October 22, 1913, and that this commission make its report as soon as possible.
- 4. That questions relating to the application of the family wage regulation be referred to this commission on author's remuneration.

- 4. Lindsay A Semmens, of California, to India, for mission station work.
- 5. D N Wall, of Australia, to South America, for evangelistic work.
- 6. W D MacLay, president of the Kansas Conference to South Africa, to take the presidency of the Cape Conference.
- 7. W E Baxter, president of the Arkansas Conference, to the superintendency of the Venezuela Mission.

# SPECIAL APPEALS IN WAR TIME:

The committee appointed to make recommendation regarding the handling of appeals for assistance under abnormal conditions made a report, which was adopted as follows:--

Whereas, Appeals come to the General, Division, and Union officers for financial assistance to be rendered in times of emergency from persons who are or have been connected with the work in some other portions of the world; and,—

Whereas, There has been no definite statement rendered as to what our attitude or the attitude of the organization to which the appeal is made, should be in such instances, or the responsibility of the field with which such workers are or have been connected should be when assistance is given; and,—

Whereas, We recognize the justness of the plan that no money should be paid to any person on account of some specific field without an order from the executive officers of the field concerned; therefore.—

We recommend, 1. That the officers of the organization to which the appeal is made should satisfy themselves of the worthiness of the applicant and the urgency of the appeal by as thorough an examination as time and circumstances will permit.

- 2. That when the officers of the field are satisfied of the worthiness of the applicant as to aid requested, they should advance to him the smallest amount necessary to relieve the bare necessities, taking from the person assisted receipts in triplicate for the funds advanced, one receipt to be kept at the office, and the other two receipts to be sent on to the General Conference, with a full statement of all the particulars, besides such other evidences of worthiness as the applicant is able to furnish.
- 3. That when payment has been made to applicants of this class, it becomes a question for adjustment betwen the fields concerned.

Opportunity was given for the Educational Department to make a report on the Ministerial Reading Course outline for the next year.

Further report was made by the Department on the Correspondence School work.

# PORTO RICO SCHOOL:

Elder Wm Steele was present from Porto Rico, and was given opportunity to present the needs of his field. Reporting for the seven years during which he had been connected with the work in Porto Rico, he stated that \$35,000 worth of publications had been put into the field during that time. The mission had been so nearly self-supporting that he thought that in the whole seven years the amount of appropriations would scarcely average \$700 a year. Two millions of people are within the territory of the mission, which includes Santo Domingo. We have three churches, two church buildings, and 130 members.

The budget of appropriations as adopted had cut out the appeal for \$5000 for school headquarters. Brother Steele made an earnest plea for at least half of this amount for their school enterprise, feeling that it was of first importance that the young people embracing the truth and showing missionary zeal and activity should be trained for service.

VOTED, That a committee of five be appointed by the chair to confer with the officers and to suggest if possible means by which the Porto Rico school enterprise might receive assistance.

## FOSTERING MISSIONARY TRAINING:

The committee on developing missionaries made a report, which was adopted as follows:--

Whereas, We recognize the need of acquainting the young people in our schools more fully with our missionary work, and encouraging a still larger number to enter the work at home and in foreign lands,—

We recommend, l. That when possible, the Mission Board place in our various training schools a missionary on furlough, under furlough pay, to spend, if possible, one year in the school promoting missionary work, and perhaps teaching or studying some.

- 2. That the General Conference men closely connected with the Mission Board make more frequent visits to our colleges, spending a week or more in placing foreign mission interests and problems before the students, and giving opportunity for personal consultation to young men and women who are interested.
- That our young people be encouraged to complete their education in our own schools, and to keep their eyes continually on the field, planning to enter immediately some branch of the cause on leaving school.
- 4. That presidents and other laborers in our various conferences in the training school territory keep in close touch with the development of their young men and women in school, with a view to having some definite place to offer them as soon as their course is finished, thus making the field a more active participant with the school in developing new workers.
- 5. That we urge our school men and visiting brethren to keep before the young men in our colleges the sacred and high calling of the ministry, and before the young women that of the Bible work; and further, that definite instruction in both lines be provided in the school in addition to what visiting brethren may contribute.

## BEN HOFFIZ:

A letter from Elder E T Russell having presented the case of Ben Hoffiz, a Syrian who desires to become better acquainted with our work and ultimately to offer himself for work in Syria, it was--

VOTED, That we authorize the treasury to appropriate \$75.00 to assist this Syrian brother in attending Union College, provided the balance of the amount required can be secured otherwise.

### DR D E BLAKE:

A letter was received from Dr D E Blake, of Jamaica, asking assistance to return to this country, he having gone out to Panama in an effort to become a self-supporting helper, and having failed through sickness and otherwise, found it necessary to try to get back to the States, to engage in medical practice, later bringing his family.

Under the circumstances, it was--

VOTED, That the treasurer be authorized to appropriate \$100 to Dr D E Blake, to assist him in returning to the States.

VOTED, That we ask the Porto Rico Mission to release G D Raff, and that we invite Brother Raff to go to Venezuela and the South Caribbean, to lead out in the book work in the South Caribbean Conference.

## J G PETTEY--LAKE TITICACA:

VOTED, That we ask Brother J G Pettey, of Texas, formerly of the Guatemala Mission, to join the Lake Titicaca Mission staff, with the idea of taking the secretary— and treasurership, and the principalship of the teachers' training school.

## J J STRAHLE:

A letter was received from Elder E T Russell, of the South Dakota Conference, saying that the conference, which had released their book leader for the Philippines, would be compelled to take on his successor in February, in order that he might attend the bookman's convention in California. VOTED, That the General Conference assume the support and direction of Brother J J Stranle from about February 1, or the time when the South Dakota Conference must release him from service in order to take on his successor.

A W PETERSON--BRAZIL SCHOOL:

Consideration was given to the call for a principal for the Brazil Union school, and it was--

VOTED, That we invite A W Peterson, of the Keene Academy, to respond to the call for a principal for the Brazil school, asking the North American Division and the Southwestern Union to release him for this purpose, it being understood that he be called to go at the end of the present school year.

## W F FIELD--JAMAICA:

VOTED, That we invite W F Fleld, of North Texas, to take the secretary—and treasurership of the Jamaica Conference, asking the North American Division and the conferences involved to release him for this purpose.

## WEEK OF PRAYER--YOUNG PEOPLE:

The Young People's Department having requested that one reading each Week of Prayer be aimed especially to appear to the young people, it was--

VOTED, That we accept the suggestion and endeavor to work to it in the arrangement of future Week of Prayer programs

## ALBERT MUNSON:

A letter was received from Elder Sandborn, of New Jersey, saying that the New Jersey Conference appreciated the services of Brother Albert Munson, who has been working in New Jersey while awaiting the time for his proceeding to Malaysia. He reported, however, that some difficulty with his feet required attention. It was--

VOTED. That Brother Albert Munson be invited to come to the Dispensary in Washington, if arrangements can be made to this effect, with the idea that while taking treatment for this difficulty he will be getting helpful experience in dispensary work which will help him in the mission field.

## B L MORSE--B E AFRICA:

Word was received from B L Morse, secretary of the British East African missions, reporting his wife's need of a furlough as soon as travel is safe. He had hoped they might have been released in 1915 while their work was tied up on account of the war, in order that he right proceed to his home in America, and then later to his wife's home in England. Now it is his desire that his wife be given furlough, while he wished to remain a little longer, if able to do so. He had written to the British Union Conference to this effect.

It was recognized that the matter was wholly within the decision of the British Union Conference Committee, but in view of the heavy pressure coming upon the mission funds of that committee, it was-

VOTED, That we assure the British Union Conference of our readiness to come to their aid if necessary to enable them to grant sick leave to Mrs Morse, of British East Africa, or to other workers similarly requiring furloughs.

SOUTH AFRICAN MISSIONS AND COLLEGE ENTERPRISE:

Consideration was given to a letter from Elder W B White, bringing request from the recent meeting of the South African Union Committee.

The Committee in the South African Union advised that they believed one training school in a language area is sufficient to train the teachers needed for out-school work. They therefore recommend that for Matabeleland the old Solusi station and farm enterprise be made the training school, and that the

rented farm at Somabula be discontinued, leaving simply a station there, the missionary in charge overseeing the primary school and giving aid to his out-schools, releasing the second missionary to take an out-station, as at Shangami, and in turn to superintend out-schools. The committee by their experience feel that the best results among the natives are attained, not by bringing them onto a mission farm to live, but by bringing the trith to them in their kraals, where the test is really brought as to their faithfulness in living the truth.

On this plan the committee recommended for Mashonaland that Tsungwesi be the training school, and that the Glendale station be conducted as a main out-school station.

The proposition is also madd to endeavor by sale or exchange in the case of the Spionkpp station to get into a more populous part of Zululand in offer to conduct training school work for the Zulus.

In connection with this matter the South African Committee further present their convictions that the European training school at the Cape should be moved into a country location

The South African Committee made request for reply to the following proposition:--

"Would you sanction the South African Union Comference selling the greater part of the Glendale farm, if a fair price can be secured, allowing us to use the proceeds toward the purchase of a farm for our (Union) training school?

"And could we make a shift of the Spionkop farm, possibly located nearer into Zululand, and not get so large a farm, would you allow us to use a portion of the proceeds of this farm in securing the rural location for the training school? We hardly think the Glendale farm would being to us enough to secure a farm in a favorable location for the training school, but should Spionkop be sold and a portion of this land used, we could locate all the farm we need as a training school among the Zulus, and likely add enough to the proceeds of Glendale to get us a good farm for our union training school without indebtedness."

The South African Committee further ask: "If not willing for us to have any portion of the Spionkop farm, would you be willing that we make a transfer of the Glendale farm to a school in the country for the Claremont Union College? Failing this, would the General Conference grant a Thirteenth Sabbath Offering, or such portion as might be needed in securing a school farm for the Union College?"

The General Conference Committee considered these propositions, and the following action was taken:--

VOTED, That we inform the South African Union Committee that the General Conference Committee here has not sufficient information as to the situation to be able to express decided opinion as to the necessity of removing the Union training school from Claremont at this time, and must leave the responsibility of this move to the Union Committee on the ground.

We state further that so far as we understand the matter, the plan of conducting but one farm training school in a language area recommends itself to our judgment, and we accept the first proposition made by the South African Committee, reported in W B White's letter of September 20, agreeing on our part that if in the judgment of the Union Committee it is practicable to dispose of the Glendale property, or the greater part of it, while still not allowing Mashonaland interests to suffer; and if it is practicable to provide proper facilities for the Zululand training school work, and yet leave a margin over the requirements for that enterprise, whatever amount may be saved shall be used as recommended by the Committee in securing land for a country location for the Union Conference training school.

## JOHN BROWN--SALVADOR:

VOTED, That the General Conference Corporation be recommended to make a loan of \$500 to Brother John Brown, superintendent of the Salvador Mission, to enable him to secure a proper home in which to live, Brother Brown to return this amount within a reasonable period of time.

## APPROPRIATION TO YARL SNOW:

A letter was presented by the treasury department from Henry Brown, superintendent of South Honduras, reporting that Brother Karl Snow and wife needed to return to this country, Sister Snow being under the necessity of having a surgical operation in order to live. These workers have been generally self-supporting in the field, having taken over the school work formerly conducted by H A Owen. It was felt that they had by t their efforts in taking over this enterprise saved the name of the denomination from reproach, and had been working loyally and in full harmony with the mission.

VOTED, That we make an appropriation of \$300, to enable Brother and Sister Snow to spend a little time in the States, to secure necessary medical attention.

#### THIRTEENTH SABBATH OFFERINGSL

The sub-committee appointed during the council made a report regarding objects for the Thirteenth Sabbath Offerings, which was adopted as follows:--

VOTED, That in view of the needs of the work in the West Indian Union field, with its four thousand believers, and with new enterprises calling for extra endeavor at this time, we ask the Sabbath School Department to make the needs in the West Indian field the object of the Thirteenth Sabbath Offering for the second quarter of 1917, aiming to reach at least \$21,245, the minimum amount necessary to carry through the work needing to be done this year in the West Indian Union Conference.

VCTED, That in view of requests that have come in from the Malaysian Mission, which includes Singapore, the Straits Settlements, and the East Indies, with their call for expansion and the opening of new fields, we request the Sabbath School Department to call upon the schools for a special offering for Malaysia on the thirteenth Sabbath of the third quarter of 1913, 2 aiming to reach \$23,524; which is the lowest estimate of the requirements of the Malaysian Mission in its work for the year.

Whereas, The Asiatic Division holds within its boundaries half the population of the world, its evangelization calling for our utmost endeavors in every phase of gospel work,--

Resolved, That we ask the Sabbath School Department to rally its forces on the last Sabbath of the year 1917, to achieve, if possible, a Thirteenth Sabbath Offering of \$30,000—the largest yet—for the prosecution of the publishing work in all the Asiatic Division, thus hastening the time when the message filled pages shall be falling over that vast field as the leaves of autumn.

## DR C C LANDIS--CHINA:

A letter was received from Dr C C Landis, stating that he had received instruction from the Asiatic Division to close out his affairs and plan to take his postgraduate work, preparatory to hastening on to China.

VOTED, That this matter be referred to the officers, with power to act.

## BANK DECLARATION:

The following action was taken, making provision for the acting treasurer to conform to the banking requirements:

Resolved, That a savings account be opened with the District National Bank, under the name of General Conference of Seventh-day Adventists, J J Ireland, acting treasurer, and that said Bank is hereby authorized to honor checks on said account signed by the Acting Treasurer.

U M COOKE--SALVADOR:

W W Eastman, assistant secretary of the Publishing Department, reported that negotiations had been concluded for the services of U M Cooke, a bookman of Texas, to engage as leader of the book work in the Republic of Salvador.

VOTED, That this recommendation be accepted, and that Brother U M Cooke be invited to Salvador as leader of the book work.

MEETINGS MISSIONARIES AT SAN FRANCISCO:

Suggestion having come from the Pacific Coast that some definitely understood arrangement should be made for meeting missionaries arriving or department from San Francisco, it was-

VOTED, That we ask the California Conference to allow its secretary and treasurer to act in the capacity of agent in meeting missionaries who may require assistance at the port of San Francisco, the conference to bill us monthly the expense incurred in this service.

Adjourned.

## ECUADOR SUPERINTENDENT:

The South American Division included in their request a call for a superintendent for Ecuador, to be provided by the General Conference. Inasmuch, however, as Ecuador is a very difficult field in which to give a new man experience in Spanish work, it was—

VOTED, That we ask the Austral Union Conference to supply a successor to Elder Knight for the oversight of the work in Ecuador, selecting, if possible, some South American couple who will have the Spanish language to begin with, and a knowledge of South American ways.

# REQUEST FROM LOCAL YOUNG PEOPLE:

A request was presented from representatives of the local young people's society, asking for the use of the General Conference chapel for a time, for the Friday evening meetings of the society. They reported that the vestry of the church was too small for the meetings, while the auditorium was so large that it seemed impossible to conduct really spiritual social meetings such as was desired, particularly at this time before the week of prayer. It was felt that if they could secure the General Conference chapel, much more efficient work could be done in their Friday evening meetings. After considering the request, it was--

VOTED, That we grant the request of the local young people's society for the use for a time of the General Conference Committee meeting room.

#### E C SILSBEE:

Cable was received from South Africa, reporting that Mrs Silsbee could like to come on to America at once, provided Brother E C Silsbee, of Basutoland, was granted a furlough next year. Inasmuch as no provision had been made for a furlough in his case, it was--

VOTED, That we notify South Africa that we do not see how it is possible to grant any additional furloughs for 1917.

#### R J BENNETT:

A telegram was received from the St. Helena Sanitarium, reporting Mrs Bennett, wife of R J Bennett, of Pacific Union College, as needing an operation. A letter had come in also from Brother Bennett, reporting his desire to return to India, where he accepted the truth some time before returning to this country. It seemed evident that the call for an operation was pressing in view of the expectation of appointment to return to India at an early date, and it was therefore—

VOTED, That we telegraph St. Helena that the Mission Board has not made any appointment in this matter, and that no appropriations have been made for opening work in the field to which Brother Bennett wishes to return. Therefore if the operation is contingent on appointment to the field, we would advise deferring the matter.

## R J BENNETT'S RETURN:

A letter was received from Brother R J Bennett, reporting that he felt that it would be better for him to return this winter to India, rather than to spend logger time in school. He was anxious to get back and resume his work in the province of Gugarat.

Inasmuch as this is a matter which it was felt should be considered first by the India Union and the Asiatic Division, provision being made in the appropriations, and inasmuch as the design in assisting Brother Bennett at the Pacific Union College was to allow him to get better acquainted with our work, and the brethren on the Coast to become acquainted with him, It was—

VOTED, That we advise Brother R J Bennett to counsel with the union and local conference workers in California, and to plan to spend a longer time in this country, any call to return to India being subject to arrangement by the Asiatic Division.

## J G PETTEY RELEASED:

A letter was received from J G Pettey, of Texas, stating that he did not see light in accepting the call to Lake Titicaca for school and office work, it being his strong desire not to enter school work.

VOTED, That we release J G Pettey from invitation to the Lake Titicaca Indian work.

### M R PROCTOR RELEASED:

Letter was received from Elder M R Proctor, of El Paso, Texas, in reply to the invitation to evangelistic work in Jamaica. On account of Brother Proctor's statement as to his condition of health, and a particular weakness of his voice in any damp climate, and his feeling that his work was not public platform work, but rather the quieter house to house and pastoral work, it was—

VOTED, That we release Brother M R Proctor from the call to Jamaica.

## R N STUDT--JAMAICA:

VOTED, That we invite Brother R N Studt, of Colorado, at present free from any conference engagement, to go to Jamaica, to engage in evangelistic work.

## CLYDE LOWRY RELEASED:

As the result of exchange of telegrams with Brother Clyde Lowry, making it apparenty that in the care of parents he and his wife had financial responsibilities which they could hardly hope to carry on the salary in Jamaica, it was--

VOTED, That we release Brother Clyde Lowry from the invitation to the secretary- and treasurership in Jamaica.

#### J G PETTEY--JAMAICA:

VOTED, That we ask J G Bettey, of Keene, Texas, to go to Jamaica, to accept the secretary— and treasurership of the conference and tract society.

#### R G SCHAFFNER: .

A letter was received from R G Schafiner, under appointment to go to Lake Titicaca early in the coming year. Brother Schaffner reported that the young lady to whom he is engaged had been ill, and that it did not seem at all advisable to plan for her to go to a mission field at present. He therefore regretfully asked to be released from the appointment.

VOTED, That we release Brother R G Schaffner from appointment to Eake Titicaca at this time, but that we ask him to hold himself in readiness for appointment to some of the mission fields at some future date.

## MRS J P ANDERSON:

A letter was received from Mrs J P Anderson, in Wyoming, reporting favorable progress healthwise, and asking counsel as to returning to China early next year. In view of the fact that she was returned from China with a tropical difficulty that has always proven very stubborn, it was--

VOTED, That we advise Sister J P Anderson to remain in this country at least until next autumn, not returning to China to enter upon the hot season of the tropics.

## M R COON RELEASED:

A letter was received from Mrs M R Coon, wife of Elder Coon, of Western New York, in reply to the invitation that they go to India. She reported Elder Coon in poor health, advised by the doctor to cease all labor for a time. They felt therefore compelled to decline the invitation.

VOTED, That we release Elder M R Coon from invitation to India.

## W F MAYERS--GUATEMALA:

Information was received that Brother C F Innis, colporteur in Guatemala, was returning to Arizona, broken again in health. Guatemala reported that this would leave them with a considerable stock of books on hand.

VOTED, That we invite Brother W F Mayers, formerly of the Mexico Mission, now canvassing along the border States, to go to Guatemala to engage in the canvassing work on his own account, the General Conference agreeing to pay transportation to the field.

## BOOKMEN'S CONVENTION; GUATEMALA:

Brethren J A P Green and H H Hall had written regarding tentative plans for holding a bookmen's convention in Guatemala City in January, about the time of Brother Hall's return from the Caribbean. Inasmuch, however, as we are only just getting bookmen to the Central American fields, and those who have reached the field have not had time to develop local workers as yet, and inasmuch as the winter season is the time for pushing the work in these fields that have had so little attention, it was-

VOTED, That we advise the brethren concerned that the proposed bookmen's convention for Guatemala City be deferred until another season.

#### L J BORROWDALE:

Correspondence was presented from L J Borrowdale and wife, nurses at Melrose, recommended for service. Inasmuch as Brother Borrowdale is of English nationality, it was felt that we should interrview him with reference to possible calls from the African West Coast and other British fields.

VOTED, That we encourage Brother L J Borrowdale and wife to come to rashington for an interview regarding possible future appointment to work in the mission fields.

## J J STRAHLE:

VOTED, That we make a rate of \$13 per week to Brother J J Strahle from the time when South Dakota discontinues his services, thus allowing Brother Strahle to spend the time before departure for the Philippines in securing every advantage for his future work, either on the Pacific Coast following the bookmen's convention, or at Union College.

## E H WILCOX--PERU:

W W Eastman, of the Publishing Department, presented the name of E H Wilcox for the field missionary secretaryship of Phru and the Inca Union Mission. It was understood that arrangements had already been made with the local conferences for the release of Brother Wilcox. It was thereforeVOTED. That we ask the North American Dibision to release to us Brother E H Wilcox, of New Mexico, and that we invite him to go to South America, to take the field missionary secretaryship of the Inca Union Mission and of Peru.

Adjourned.

VOTED, That we release Brother H A Fish from the call to South America, to act as superintendent of the Peruvian Mission.

## L J BORROWDALE--LAKE TITICACA:

Brother and Sister L.J.Borrowdale met with the Committee, having come from Melrose for counsel regarding mission field work. They had decided in favor of accepting the call to the Lake Titicaca Indian Mission, and it was--

VOTED, That Brother and Sister L.J.Borrowdale, nurses of Akron, Ohio, be invited to South Imerica, to engage in work with the Lake Titicaca Indian Mission.

## E L SHELDON RELEASED:

A letter was received from Elder E L Sheldon, of Minnesota, in answer to the invitation to India. On two counts he felt that the way was not open. The Committee felt the reasonableness of the position of Brother Sheldon, and it was-

VOTED, That we release Elder E L Sheldon from appointment to India.

#### LAKE TITICACA SPECIAL APPROPRIATION:

Letter received from Elder E L Maxwell, stated that the explosion of an oil stove in the house where Elder Achenbach, of the Lake Titicaca Mission, was living, had resulted in a fire and a loss of \$600.

VOTED, That the treasury make a special appropriation of \$300 to the Lake Titicaca Mission, to aid in replacing the loss by this accident.

#### HAITI:

In response to recommendation of Elder A F Pieger, of Haiti, the following papers were voted: E A Curdy, ministerial license; Arioste Pean, ministerial license; J B M Abel, missionary credentials.

#### SOUTH HONDURAS:

The following papers were granted to South Honduras, on recommendation of Henry F Brown, superintendent; missionary license to Karl J Snow, Mrs Karl J Snow, Howard E Loftin, Mrs Howard E Loftin, Gilbert Schwerin.

## W W PRESCOTT TO CUBA:

VOTED, That we ask W W Prescott to attend the general meeting in Cuba early in January.

#### CUBAN CANVASSERS:

VOTED, That we appropriate \$150 to Cuba, in order to provide a fund for assisting canvassers who arrive without the Spanish language, recommending that \$50 in each case be granted such workers, to tide them over the initial experience in working into service.

## BAHAMA ISLANDS:

Consideration was given to a letter from Elder J H Smith, recommending the employment of several native workers who are now in training.

VOTED, That we authorize the Bahama Islands Mission to engage two or three native workers in the service when it is felt that they are qualified for work.

# CONFERENCE OF TOREIGN MISSION BCARDS:

VOTED, That the treasury be authorized to make the usual contribution to the expenses of the meeting of the representatives of all the boards of foreign missions in North America, as in former years, the conference being held in Garden City, Long Island.

#### COMPUTING MACHINE--PERU:

VOTED, That we authorize the treasury to provide the Inca Union Mission with a computing machine, in order to assist the treasurer in dealing with accounts where he has a variety of different kinds of money and shifting exchange.

### SOUTH AMERICAN DIVISION BUDGET:

The treasurer reported that no definite budget had been voted the South American Division for 1916. W H Williams the treasurer of the Division, had submitted a budget, calling for \$5,384.

VOTED, That we appropriate \$5,384 for the South American Division for the current year, 1916.

## ELMSHAVEN INDEX FILES:

J J Ireland, of the treasury, reported information that the work on the files of Sister White's manuscripts and paper had been carried well on toward completion, but that in order to complete the work, so that any one could refer easily to any part of the whole mass of material, it would require work estimated to cost about \$210.

VOTED, That the treasury be authorized to arrange for the completion of the work on the index files.

Adjourned.

VOTED, That the Medical Department be authorized to secure, if possible, the services of Brother Robert McCracken and wife, recommended by the St Helena Sanitarium, for mission service, or some other couple for treatment room work in Hilo.

He reported his endeavor to close out his business in such a way as to make his entire medical equipment a girt to the Asiatic Division He requested, however, an advance of \$1000 in order to clear up all his obligations before going East for post graduate work. Against this advance he has accounts for collection of some \$4000, a portion of it being in the form of notes, which he leaves for an attorney to collect.

In view of the Doctor's effort to get away at an early date to China, and the assurance that by his collections he would be able soon to return the \$1000 advanced, it was--

VOTED, That the treasurer be authorized to advance \$1000 to Dr C C Landis, on his personal note.

## C F INMIS:

A letter was presented by the treasurer from Brother C F Innis, returning to Arizona on account of his health after years spent in self-supporting book work abroad.

VOTED, That the treasurer be authorized to allow Brother C F Innis's transportation from Guatemala to Arizona by way of his parents' home in Ohio, and that Brother Innis be allowed to report the time on his trip from Guatemala until he is able to reach Arizona.

On regort from the Sabbath School Department that Central China had failed to supply material for the Thirteenth Sabbath Quarterly for the first quarter of 1917, due now to go to press, it was--

VOTED, That we express anew our appreciation and thankfulness for the great blessing the Thirteenth Sabbath Offering plan has been to our missionary cause, lifting, as it does, such heavy burdens as every thirteenth Sabbath comes round; this expression of thankfulness is preliminary to the request that the Sabbath schools lift yet again, on Sabbath, March 31, 1917, this time in behalf of the South African missions.

#### ARKANBAS:

On receipt of information that the Arkansas Conference was releasing their president, Elder W E Baxter, to respond to the call to Venezuela, and that their conference funds were depleted, it was--

VOTED, That we thank the Arkansas Conference for its generous release of their president, Elder W E Baxter, to respond to the call from Venezuela, and that the General Conference appropriate from \$100 to \$150, as may be required, on the expense of moving a new president to Arkansas.

#### OUTFITTING ALLOWANCE:

The recent appointments to Central and South American fields having impressed upon the Committee the fact that

responding to these calls and having to close out practically all their household effects are asked to make as heavy a sacrifice as any breaking up home to go to the Asiatic fields, it was--

VOTED, That we make the \$150 outfitting rate applicable to the West Indies, Central America and South America, as well as other parts.

## W F HARDT--GUATEMALA:

On request of Elder J B Stuyvesant, superintendent of Guatemala, it was--

VOTED, That missionary credentials be granted to W F Hardt and Mrs W F Hardt, of Guatemala.

# BROTHER KUMALAE, MINISTER'S SUPPORT:

A letter was received from Elder F H Conway, of Hawaii, saying that Brother Kumalae, of Honolulu, desired an ordained minister selected for labor on the island of Maui, Brother Kumalae offering transportation and full support, the worker to be under the direction of the mission as a regular staff laborer.

VOTED, That we request Edder I H Evans, on his forthcoming trip to the Pacific Coast, to endeavor to secure such a young evangelist to respond to this call.

## W H ANDERSON:

VOTED, That we authorize the treasury to continue his regular salary to Elder W H Anderson, of Barotseband, from the time when South Africa ceased paying him, until his arrival at home, and that thereafter he receive the usual furlough rate of \$14 per week until arrangements may be made for him to engage in service.

The assistant secretary of the Publishing Department, W W Eastman, suggested that Brother U M Cooke, who had been secured to lead out in the Salvador book work, be encouraged to attend the southern bookmen's convention in January, before leaving for his field.

VOTED, That we agree to the suggestion that Brother U M Cooke attend the southern bookmen's convention, and authorize him to begin to report his time from January 1, fixing his salary rate as a single man at \$13 per week

#### JOHN OHMAN--ABYSSINIA:

In response to a request from Elder Conradi, correspondence had been opened with Brother John Ohman, the young man formerly with Elder Grundset in the Abyssinian Mission, inasmuch as the two men had been compelled to forsake the mission, leaving only Sister Steiner, the wife of the superintendent.

A letter was received from Brother Ohman, telling of his struggles to secure education and training, and of his disappointment in not being able to take the nurses' course in the West. He said that he would be ready to go back to Abyssinia any time it was felt that he should.

In view of this situation, it was agreed without formal vote that we would ask Brother John Ohman to write to Dr Miller at the Washington Sanitarium, with reference to the suggestion that he come on to Washington, to get what help he can in a short time at the sanitarium and dispensary, paying his way by work; the Committee agreeing to meet his transportation from Minnemota to Washington, in case he feels free to give his time in these ffort to secure whatever instruction may be possible in nursing and dispensary work, with a view to being ready to return to Abyssinia at any time the call may be extended.

VOTED, That we accept with gratitude the gift of the Doctors Morse, of Porto Rico, (approximately \$1000), for the support for one year of a missionary to work among the Indians about Lake Titicaca, Peru; with the understanding that this gift shall be applied on the support of one of the regularly appointed workers to that field, and that the appropriation for extending the native work of this mission shall be increased to the amount of this gift.

## DEPARTMENTAL PUBLISHING:

VOTED, That inasmuch as bills have come from the Review and Herald for certain losses sustained in the publishing of departmental documents and blanks, we request the Review and Herald Board to appoint a committee of three to join a like committee from the General Conference to give this question study, and report at a joint meeting of the Review and Herald Board and the General Conference Committee, for final settlement.
