The matter was discussed at some length, but in view of the fact that Elders Shaw and McElhany are on their way to the Pacific Coast, to attend annual constituency meeting there, at which there will be present quite a number of union conference presidents, as well as other members of the General Conference Committee on the Coast, it was felt that the cable message should be passed on to them, with the conviction of the members here that the matter be referred back to the Far Eastern Division, for consideration in their Division Council soon to be held, the decision of the Far Eastern Division Council to be brought to the Spring Meeting of the General Conference Committee for final action.

VOTED, That G.W.Wells be asked to respond to the invitation to attend a Home Missionary Convention in West Virginia March 29 to 31.

H.S.PRENIER--EMMANUEL MISSIONARY COLLEGE:

VOTED, To pass on to the Central Union and Union College, without recommendation, the call from the Lake Union for H.S.Prenier to connect with Emmanuel Missionary College as Dean of the School of Theology.

L.H.HARTIN--OSHAWA MISSIONARY COLLEGE:

VOTED, To pass on to the Western Canadian Union and the Saskatchewan Conference, without recommendation, the call from the Eastern Canadian Union for Lewis H.Hartin, of Battleford Academy, to connect with the Bible Department of Oshawa Missionary College.

L.E.CHRISTMAN--ITINERARY:
