MEDICAL EXTENSION:

Figures were presented indicating that the medical requests for assistance from the Extension Fund for 1930 are \$50,760.81, and with

salaries and expenses of medical workers in mission fields totaling \$138,758.43, a total of \$189,519.24 is called for in the medical budget of the mission fields for 1930. It was felt that if a plan could be devised whereby the help of our sanitariums could be enlisted in a larger and more definite way in the medical extension program, it would mean not only extension of the medical work in the mission fields, but great blessing to the sanitariums themselves. After considerable discussion it was

VOTED, That the treasurer, the secretaries of the Medical Department and H. H. Hall be a committee to give further study to this question, and to formulate a definite plan for medical extension, to bring to the Autumn Council for consideration.

This Association has but the one object, namely, the preservation to every man, regardless of creed, of those inalienable rights which the founders of the Republic declared had been given by The Association receives associate members, the the Creator. annual membership fee being \$1.00, and the members receive the official Association magazine, "Liberty" and certain tracts, pamphlets, etc. which may be issued from time to time.
