#### SOUTHERN JUNIOR COLLEGE:

The committee appointed in the morning meeting submitted the results of their consideration of the memorial from Southern Junior College in the form of three recommendations, which were adopted as follows:

1. With every expression of appreciation of the growing strength of the Southern Junior College, and with full conviction that the desire to reach senior college status is a worthy aim, we register our sympathy with this aim and desire, and state our belief that ultimately this purpose must be realized, to the advantage of the great Southern field, whose youth must be trained to service in the Southland and in lands abroad.

In view, however, of the fact that any change of college status or the establishment of a new college is a major question affecting our present undertaking through the Association, as well as the matter of the territory of other colleges, and calls for re-distribution of appropriations to our colleges, we feel that this matter should be considered and acted upon by a full Committee in Council.

We therefore recommend, That the memorial be referred to the Autumn Council.

2. That we ask the Educational Department, in harmony with its program being carried on through its Board of Regents to outline a policy and set up standards for the advancing of a junior college or academy to a higher rank, to be submitted for adoption at the Autumn Council.

3. That we counsel our people in the Southeastern and Southern Union Conferences to rally strongly to the patronage and support of our denominational schools, and Southern Junior College in particular, for the finishing of the work in the Southland.

#### OAKWOOD JUNIOR COLLEGE:

Prof. J. A. Tucker, being present, sought counsel of the Committee as to plans for the future of Oakwood Junior College in connection with the arrangements for the establishment of a new school for colored young people. He felt that plans for both schools should be made in the closest cooperation. He asked regarding the solicitation of students, not wishing to interfere with the interests of the proposed new school.

VOTED, That we advise Professor Tucker to go forward with plans for the solicitation of students and the promotion of the interests of Oakwood Junior College this season as heretofore, notwithstanding the fact that we are looking forward to the early establishment of another school for colored youth.

VOTED, further, That we suggest to the committee on the new colored school that at the proper stage they invite Professor Tucker to meet with them, in order that they may study together the relationship of the two schools.

FOREST LAKE ACADEMY:
