#### WORKERS TO PACIFIC UNION:

VOTED, That E.E.Cossentine, returned from Australia, be invited to take the presidency of the Southern California Junior College.

That Leo Thiel, of Oakwood Junior College, connect with the Southern California Junior College.

That C.W. Flaiz, of Oak Park Academy, Iowa, connect with the Loma Linda Academy.

#### J.C. THOMPSON:

VOTED, That in view of unfavorable medical report for Mrs. Thompson, Elder and Mrs. J.C. Thompson be released from the call to the Far East.

VOTED, That J.C. Thompson be invited to connect with the Sabbath School Department as associate secretary.

#### W.W. EASTMAN:

That we renew the invitation to L.H. Stump to connect with the Philippine Junior College.

That we request the Lake Union and the West Lichigan Conference to release P.H. Augustine, to connect with the Far Eastern Division for evangelistic work in the South China Union.

That we request the Southeastern Union and the Carolina Conference to release J.G.MacIntyre, to take the principalship of the Canton intermediate school in the South China Union Mission.

That we renew the invitation to hiss Mary Kisz, of the St. Helena Sanitarium, to connect with the hospital in Japan as nurse and matron.

That we invite Joseph L. Jumins, of San Jose, California, to connect with the Far Eastern Division, as English teacher in the Philippine Junior College.

#### CHUTRAL EUROPEAN DIVISION:

The arrangement made with the Central European Division for 25 per cent of their tithes and mission offerings to come to the General Conference was discussed by J.L. Shaw and L.R.Conradi. Inasmuch as the Central European Division desires a reduction in this percentage, it was--

VOTED, That the chair appoint a committee to give this matter study. Named: J.L.Shaw, C.H.Watson, O. Hontgomery, J.L.HoElhany, E.E.Andross, Dr. H.W.Hiller, F. Griggs, I.H.Evans, A.V.Olson, A.W.Cormack, L.H.Christian, C.B. Haynes, E.R.Palmer, H.F.Schuberth, J.F.Wright.

#### C.H. TATSON--TRANSPORTATION:

VOTED, That the General Conference treasurer be authorized to meet the transportation expense of C.H. Watson, single fare, back to Australia, and then returning to America with his family.

#### GENERAL WORKERS -- SALARY RATES:

VOTED, That the chair appoint a committee to set the salary rates of the following workers: C.H. Watson, I.H. Evans, W.H. Branson, W.I. Smith, H.G. Lucas, C.P. Crager, C.E. Teaks, J.A.P. Green, T.B. Ochs, W.H. Williams, J.F. Wright.

The committee was appointed as follows: J.L. Shaw, C.T.Irwin, H.H.Hall, M.Lukens, W.H.Holden.

#### RULIANIAN SCHOOL:

A.V.Olson of the Southern European Division made a statement concerning the situation confronting the Rumanian school, and it was--

VOTED, That the chair appoint a committee to study the Rumanian school situation.

Named: O.Hontgomery, L.H.Christian, H.E.Kern, A.V.Olson, G.W.Schubert.

#### SOLALA MISSION:

The Inter-American Division made request to be allowed to use the one thousand dollars available from the Extension Fund for treatment rooms in Guatemala City, for medical work in the Solala Mission, Guatemala.

VOTED, That this request be granted.

#### CANADIAN JUNIOR COLLEGE:

S.A. Ruskjer stated the situation confronting them in their union in view of the fire that destroyed most of the buildings of the Canadian Junior College in Lacombe.

VOTED, That this question be referred to the same committee appointed to give study to the Central European Division percentage of funds.

#### MOVING EXPENSES:

VOTED, That the moving expenses of J.H. Williams, V.I.Smith, H.G.Lucas, J.A.P.Green, C.E. Teaks, C.P.Crager and J.F. Wright, and the entertainment of L.C. Hetcalf while assisting with the music during the General Conference, be referred to the committee appointed to set salary rates of certain workers.

# HRS. O.E.SCHNEPPER--MEDICAL EXPENSE:

VOTED, That the treasurer be authorized to meet the expense of medical examination, and one half the bill for medical treatment in the case of Mrs. O.E.Schnepper, formerly of South America.

#### O.T. TUCKER'S SISTER--TRANSPORTATION:

VOTED, That the question of the return transportation of O.W.Tucker's sister-in-law from Jamaica be referred to the Hinority Committee.

#### ABBIE DUNN:

VOTED, That the question of additional financial assistance for Hiss Abbie Dunn, under appointment to China, be referred to the Hinority Committee.

#### NEGRO DEPARTMENT:

During the General Conference session much time was spent by a large committee appointed for the purpose in considering the organization of the Negro work in North America. In response to a request from some of the Negro workers for the organization of Negro conferences, a statement was presented to the Negro representatives in attendance at the General Conference Session. This statement was then referred to the Executive Committee of the General Conference for their consideration, and was by them unanimously adopted as follows:

"Dear Brethren:

"Having given consideration to your request to organize Negro Associations or Conferences within the boundaries of conferences already organized, we now respectfully present to you the conclusions we have reached:

"We wish to assure you that we greatly appreciate the burden you have expressed to us for the more rapid and substantial progress of our cause among the Negro people. We join you in the desire to bring to our movement more of the progressive, substantial men and women of your race.

"But, brethren, we cannot think that the organization you propose is the means necessary for achieving such results.

"On the other hand we are led by our study of the proposal to the conclusion that the organization of recial conferences within the boundaries of conferences already organized would prove disastrous to both organizations.

It is our conviction that the plan is fundamentally wrong:

"First, (a) In the very nature of things it would lead to confusion, conflict and discord.

"(b) It would duplicate machinery which would require the time and talents of men to operate, thus withdrawing them from the aggressive evangelism so greatly needed in this closing hour of time.

"(c) It would add very materially to financial expense in purely administrative affairs. This of course would turn thousands of dollars from missionary to administrative channels.

"(d) There is a growing, deepening conviction that the marvelous openings for evangelism in all directions, and the rapidly growing demands for means in mission field call for reducing instead of increasing administrative expense.

"Second, In reaching our conclusions regarding this matter we have been guided by the views and decisions of our predecessors, and by the counsel given through the spirit of prophecy.

"A quarter of a century ago the request you have brought to us was made by some of our foreign nationals. After careful discussion the plan was abandoned. In its place the departmental plan was adopted and is still adhered to.

"Of the plan to organize separate conferences, the spirit of prophecy gave definite counsel. Here are some of the statements: "The instruction given was that should such separation take place, it would not tend to advance the interests of the work among the various nationalities. It would not lead to the highest spiritual development. Walls would be built up that would have to be removed in the near future.

"'According to the light given me of God, separate organizations, instead of bringing about unity, will create discord.

"'Thrist has hedged in His people from the world, but those who would build up national separation, would do a work for which the Lord Jesus Christ has given no encouragement.

"'Brethren, unify; draw close together, laying aside every human invention, and following closely in the footsteps of Jesus, your great Example.' -- Testimonies, Vol. 9, pp. 195,198.

"It is our sincere conviction, brethren, that there is a better, surer way than more organization by which to reach the hearts of men and women of any race and any class. The treat, true effective secret lies in the enduement with the divine power that Jesus directed His disciples to tarry for and seek before entering upon their work. This they did and when endued they went forth without means, influence or organization to achieve the most marvelous victories among hostile Jews and bitter pagans. Under that spiritual enduement those men were likened to a rider with crown and bow going forth on a white charger conquering and still to conquer!"

This same committee in considering the future conduct of the Megro work, reported as their recommendation that the plan adopted at the Columbus Autumn Council be readopted, with certain amendements. By unanimous action the Executive Committee adopted this amended plan as follows:

# ORGANIZATION OF NEGRO DEPARTMENT:

- 1. a. That the General Conference Committee select one of our representative colored ministers to fill the office of secretary of the Negro Department.
- b. That this secretary locate in Mashington, having his headquarters at the General Conference office.
- c. That in giving general supervision to the colored work throughout North America, he work under the counsel of the General Conference Committee, as do all other General Conference departmental secretaries.

- 2. That the Negro work in the Southeastern, Southern and Southwestern Union Conferences be organized on the following basis:
- a. That the Negro Committee of the union conference be composed as follows: The president of the union conference, the secretary-treasurer of the union, the president of each local conference, the Negro union secretary, the Negro Missionary Volunteer, Educational and Home Missionary secretary, where there is such a secretary, and the Negro evargelist of each local conference; said committee to have full administrative charge of the colored work.
- b. That the Negro Committee of the local conference be composed as follows: The president of the conference, the secretary-treasurer of the conference, the colored evangelist of the conference, and two Negro members to be elected.
- 3. That the Negro work in the other union conferences of North America (aside from the Southeastern, Southern and Southwestern Unions) be organized as follows:
- a. That in each union conference where there are as many as five hundred colored believers a Negro secretary be elected, this secretary to be a member of the union conference committee.
- b. These Negro secretaries to work under the direction of the union conference committees. When laboring in a local conference, they will work under the counsel of the local conference president, just as all other union departmental secretaries do.
- c. The primary responsibility of these secretaries shall be to build up the colored constituencies:
  - (1) By holding evangelistic efforts.
- (2) By assisting other evangelists with their efforts when advisable.
- (3) By helping to train young preachers and workers.
- (4) By helping to foster real soul-winning work in each of the churches and conferences.
- (5) By cooperating in all lines of departmental and church activities.
- d. That in unions where this plan, because of the scattered churches and lack of populous cities, might seem impracticable a representative of the department be appointed, to be ready at the invitation of the union, to help foster the colored work in such unions.

- e. That where the colored constituency in a local conference is sufficiently strong and is represented by a colored minister of experience, we recommend that this minister be a member of the local conference committee.
- 4. The Negro secretaries of all unions in North America, and such other persons as the General Conference may appoint, to form the General Conference Negro Department advisory committee, to counsel over matters pertaining to the colored work.
- 5. That the Negro secretaries of all unions in North America be invited to attend such Autumn Councils as the local conference presidents may be called to attend. Thus they would receive the encouragement to be gained by contact with the leaders of our world-wide work, and would carry back to the colored churches in their fields the appeals on all our activities throughout the field the world around.

VOTED, That the chair appoint a committee to nominate a secretary for the North American Negro Department.

#### PERMANENTLY RETURNED MISSIONARIES:

The question of the premature permanent return of so many of our missionaries had been given study by the Minority Committee, and also by the Missions Round Table at this Conference session. These two bodies having agreed upon the following statement, it was adopted:

- l. We believe that our home conference leaders and doctors, and the Executive Committee of the General Conference have cooperated in guarding against any one going to the mission fields whose medical examination papers have shown heavy physical liabilities or who was otherwise not qualified for mission service. We advise the continuance of the greatest caution along this line.
- 2. Further, we recommend that thorough study be given to the question of closer cooperation between the General Conference Committee and the respective missionary divisions in the matter of educating and influencing missionaries to remain in the field.
- 3. That if sudden illness does not require immediate action, the permanent release of a missionary from a field be first made a matter of consultation with the General Board or Division Committee that appointed him, a rule that was generally observed in former years; and that the decision concerning the permanent return be communicated to the missionary before he leaves the mission field.
- 4. That the General Conference Committee endeavor to make arrangements with our colleges whereby one of the secretaries, or a designated member of the Committee, will spend some definitely arranged time in each college in the North American Division during the year, giving instruction on foreign mission problems, not merely by general lectures to the whole school but in the form of seminar work with a special group. That in this lecture work and in private interviews a special effort be made to keep the high ideals of life-long service before the young people.
- 5. That the gospel idea of service (Matt.20: 25-28) be strongly emphasized in the daily instruction to the students and especially in these seminars, and in the new missionary manual which is to be prepared; that our young people, as well as the missionaries in the field, be encouraged to study the teachings and life of Jesus with the above text in mind, so that they may harbor no feeling of racial super-

iority which would militate against their usefulness in the field and their willingness to serve under all circumstances.

CENTRAL EUROPE: PERCENTAGE OF FUNDS:

The committee appointed to study the percentage of mission offerings and tithe to be given by the Central European Division to the General Conference, reported and their report was adopted as follows:

Whereas, The Central European Division has urgently requested that it be released from that provision of the Darmstadt agreement by which it has been giving 25 per cent of its tithe and mission funds to the General Conference, asking that this percentage be reduced to 10 per cent; and,

whereas, The Central European Division in making this reduest expresses its willingness to undertake to fully support its own work at home and abroad, thus releasing the General Conference from making regular or special appropriations to this division,

We recommend, That, beginning January 1, 1931, the 25 per cent of tithe and mission offerings now being received from the Central European Division under the provisions of the Darmstadt agreement, be reduced to 10 per cent, in compliance with the request made, with the understanding that the Central European Division will undertake to fully provide for all of its own needs, both at home and in its mission territory.

Whereas, The reduction of the payments of the Central European Division to the General Conference from 25 per cent to 10 per cent reduces the funds of the General Conference by approximately \$38,000,

We recommend, That the amount of this reduction be deducted at the Autumn Council of 1930, on a pro rata basis from the base appropriations to other divisions now on appropriations, unless the inflow of funds to the General Conference be sufficiently increased to take care of this amount.

We recommend, That the Northern and Southern European Divisions be given the spring on the tithe and mission offerings coming to the General Conference from year to year on the same basis as other division fields.

#### WAGE RATES AND MOVING EXPENSES:

The committee which was appointed to suggest salary rates and allowances on moving expenses of certain general workers, reported, and their recommendations were adopted as follows:

#### RUMANIAN SCHOOL:

A committee consisting of O.Montgomery, L.H. Christian, M.E.Kern, A.V.Olson, and G.W.Schubert, which had been appointed to study the situation of the school in Rumania, submitted a report which was adopted as follows:

Whereas, The location and holdings of the Rumanian school are entirely unsuitable for the conduct of our educational work and for their rapidly growing constituency,-

We recommend, That plans be made for removing the school to a more suitable location, and that a new property be purchased, with funds in hand, as soon as a suitable site can be found at a reasonable price.

We recommend, further, That the cuestion of supplying additional funds for this enterprise be referred to the coming Autumn Council.

#### CANADIAN JUNIOR COLLEGE:

The following report from the committee appointed to study the needs of the Canadian Junior College, was adopted:

\$20,000 We recommend, That an emergency appropriation of be made to the Western Canadian Union Conference in order to assist in replacing the buildings lost by fire, of the Canadian Junior College at Lacombe, Alberta, with the request that the brethren and sisters in the Western Canadian Union territory be urged not to allow such efforts as they may make to raise funds for the rebuilding of the school interfere with or weaken in any way the regular Harvest Ingathering campaign for missions, but that they throw themselves with their usual energy into this campaign, endeavoring to raise in the Harvest Ingathering campaign an amount equal to that raised in former years.

#### EDUCATIONAL DEPARTMENT:

VOTED, To appoint a committee of five to study the cuestion of the division of work in the Educational Department Named: C.H.Watson, J.L.Shaw, J.L.McElhany, C.W. Irwin, M.Lukens, J.E.Fulton, O.Montgomery.

#### ENLARGEMENT OF OAKWOOD BOARD:

VOTED, To refer to the Autumn Council the question of the enlargement of the Oakwood Junior College Board.

After thirty minutes' recess, the committee on the division of work in the Educational Department made a report which was adopted as follows:

#### EDUCATIONAL DEPARTMENT:

Inasmuch as Prof. H.G.Lucas has tendered his resignation in order to permit the Educational Department to organize its work on the basis of four men in the department instead of five, and along the lines that the field seems to demand.

Resolved, That we accept the resignation of H.G.Lucas as associate secretary of the General Conference Department of Education. This is done with the distinct understanding that there is no question at all in regard to his ability or his qualifications for the work he was called to do.

VOTED, That we ask C.A.Russell to continue with the Educational Department until the time of the Autumn Council.

#### DEPARTMENT COMMITTEES:

The appointment of all department committees was referred to the Minority Committee.

#### SONG BOOKS FOR PRIMARY AND JUNIOR YOUNG PEOPLE:
