The Commission on Negro work met again with the General Conference Committee at 1:30 P.M., September 16.

ACADEMY FOR COLORED YOUTH IN THE NORTH:

After full discussion, the report of the committee on a School for Colored Youth in the North was adopted as follows

"In view of the pressing need of making better provision for giving a Christian education to our colored children and youth, we recommend that the following program be entered upon immediately:

"1. That the Educational Department in conjunction with the Secretary of the Negro Department and our colored ministers and workers, institute a concerted and aggressive program of educating our colored believers on the supreme importance of giving their children a Christian education in schools of our own.

"2. That each union conference make a careful survey of the educational needs of the colored churches, and seek in every way to provide properly equipped elementary schools on the same general plan as our white schools.

"3. That in the larger churches where provision cannot be otherwise made the elementary school be gradually developed to a ten-grade school with the approval of the union educational board, and in case of need arising for still more advanced grades in the local school, provision be made for adding such grades only in counsel with and approval of the union and General Conference Committees.

"4. That we go forward with the plan voted at the Columbus Autumn Council to establish a secondary boarding school of academic grade in the country in such location, in the Columbia Union, as may be found best to serve the largest number of colored believers.

"5. That suitable location be purchased, to include good land and if possible buildings in which school work can be begun on a simple scale.

"6. That the Oakwood school serve as the junior college and training school for colored youth from all parts of the country; that Oakwood serve also as the academy especially for the Southeastern, Southern and Southwestern Unions, but not excluding academic students from any other union. That the management of Oakwood continue to solicit academic students from any union outside of the Atlantic and Columbia Unions, but the Eastern school may also receive academic students from any union except the Southeastern, Southern and Southwestern Unions

"7. That on this plan it be understood that the open door policy for admitting colored students to our white schools in the North be continued.

"8. That the financing of this Eastern school enterprise be on the following plan:

"a. That we raise an initial sum of \$50,000.00 for establishing the school.

"b. That we request our colored believers to raise dollar for dollar to match the \$20,000.00 already set aside by the General Conference for this school, it being understood that this plan of raising the \$20,000.00 is not to interfere with the payment of tithe, contributions to missions, or church debt.

"c. That the campaign for raising dollar for dollar be put on early in January, 1932, and that it be participated in by all our colored believers.

"d. That in addition to the funds provided for above, the entire proceeds of the colored offering for the year 1931 be devoted to this enterprise, and that we set \$15,000.00 as our goal.

"e. That no investment be made until 75% of the funds are in hand and that we only advance as far as the money in hand will permit.

"f. That the funds gathered come through the regular channels to the General Conference to be held in reserve for this enterprise.

"g. That we fix the operating subsidy according to the need but not to exceed \$6,000.00 a year, to be deducted from the comeback funds of the General Conference before any other division of that fund is made.

"h. That the Minority Committee and the academy board give study to the matter of the rates to be charged.

"i. That the board of management be made up as follows:

Presidents of Columbia and Atlantic Unions.
 Vice-president of North American Division.
 Secretary of the General Conference Educational Department.
 Principal of the school.
 Two colored representatives from the Columbia Union and one from the Atlantic Union.
 General Conference Negro Secretary.
 Presidents of New Jersey, East Pennsylvania, and Greater New York Conferences.
 Educational Secretary of the Columbia Union.

"9. That all our leaders and workers both white and colored, rally strongly to the support of Oakwood, the boarding academy, and church schools for our colored youth."

In connection with the adoption of clause g of section 8, it was--

VOTED, That we instruct the treasurer to place the amount of the suggested subsidy, \$6,000.00, in the regular budget to be passed on at the Autumn Council.
