MISSIONARY MAGAZINE CIRCULATION -- GOAL:

voted, That in harmony with the series of recommendations adopted at the Autumn Council launching a great soul-winning effort through the circulation of the Watchman magazine, we set a goal of 100,000 copies per month for the conferences in the United States, and ask each conference, by action of its committee to assume definite responsibility to circulate a certain portion of this total month by month.

DEPARTMENTAL COMMITTEES:

Revisions of the following departmental committees were presented and approved for publication in the 1933 Year Book: Sabbath School, Missionary Volunteer, Educational, Religious Liberty, Ministerial Association and Home Commission.

H.T.ELLIOTT--HARVEST INGATHERING COMMITTEE:

VOTED, That H.T. Elliott be asked to take the place of J.L. McElhany on the Harvest Ingathering Committee.

B. NIELSEN--NORTHERN EUROPE:

Brother and Sister B. Nielsen, of the Southern Asia Division, are at present on furlough in Denmark. Sister Nielsen's health is in such a precarious condition that it seems impossible for them to return to India. The Northern European and Southern Asia Divisions have agreed to an arrangement whereby it is hoped that Northern Europe can take Brother Nielsen onto their payroll by March, 1933.

VOTED, That we approve of the permanent return of Brother and Sister B. Nielsen from India to Denmark, it being understood that the Northern European Division will endeavor to assume the support of Brother Nielsen March 1, 1933.

T.R. HUXTABLE -- PERMANENT RETURN:

VOTED, That because of the cut in the appropriations to the Southern Africa Division for 1933, we do not return T.R. Huxtable to Africa at present; but that the way be kept open for his return to the African field as soon as financial conditions may make it possible; further, that the treasurer be authorized to continue salary to Brother Huxtable to the end of the year, if necessary.

MINISTERIAL INTERNESHIP LEAFLET:

VOTED, That the secretaries be authorized to print a leaflet containing the recommendations pertaining to the Ministerial Interneship Plan.

ITINERARIES AND APPOINTMENTS:

VOTED, That E. Kotz be appointed as our representative to attend the meeting of the Advisory Council of the American Bible Society in New York, November 30.

VOTED, That we approve of the following itinerary for E.E.Franklin: attend the Publishing convention at Mountain View, California, December 2-7; institute work in the Lake and Central Unions, December 27 to March 5.

VOTED, That in harmony with the request of the president of the West Virginia Conference, we authorize J.C. Thompson to spend three weeks in that conference in the interests of the Sabbath School work.

VOTED, That C.E. Weaks be authorized to attend colporteur institutes in the Columbia Union, December 27 to February 18, as may be arranged.

GENERAL CONFERENCE HELP FOR RUSSIA:

During the Autumn Council a committee was appointed by the officers, composed of W.H.Branson, L.H.Christian, H.F. Schuberth, A.V.Olson and O.Montgomery, to study the question as to what might be done to render help to our work in Russia. This committee submits the following:

"Your committee in studying the question of rendering help to our believers in the Russian Division feel that it would be a great advantage to have a permanent General Conference representative who can maintain contact with that field, said representative to be clothed with authority to render such help as may be deemed necessary for the good of the work in that large and important division.

"Therefore we recommend that L.H.Christian be appointed General Conference representative for Russia with the understanding that this responsibility be carried in connection with his present work.

"Further, we recommend that a delegation consisting of one of the General Conference officers from Washington, L.H.Christian, and L.F.Oswald or some other worker from Europe who speaks the Russian language, visit Russia as soon as possible."

VOTED, To adopt the foregoing report of the committee on General Conference help for Russia.

CENTURY OF PROGRESS EXPOSITION:

In September the Committee took action authorizing the rental of space for a denominational exhibit in the Century of Progress Exposition at Chicago, in 1933. Since then we have

been in Autumn Council, studying our possible income and dealing with budgets for 1933, and some question has been raised as to the wisdom of carrying out this action, in view of the condition of our finances. After some discussion it was--

VOTED, That we inform the Exposition officials that much to our regret we find ourselves unable to carry out our plan to take space for an exhibit in the Century of Progress Exposition, in view of the fact that we have had to make additional cuts in our regular budgets.

DR. E.G. MARCUS--FINANCIAL ARRANGEMENTS:

Correspondence between Dr. E.G. Marcus, of the Southern Africa Division and Elders J.L. Shaw and J.F. Wright, relative to the return transportation of Mrs. Marcus from America to Africa, has been reviewed by a small committee. While it is recognized that the Southern Africa Division has dealt fairly with the Doctor, and that he has no claim against the division for the return transportation of Mrs. Marcus to Africa, inasmuch as he finds himself heavily involved financially due to his postgraduate work in Europe and his wife's return expenses to Africa, it was-

VOTED, That we recommend to the Southern Africa Division that they make an emergency appropriation of \$750 to Dr. E.G.Marcus, to be credited to his account with the Southeast African Union Mission; and further, that the union arrange with Dr. Marcus to make regular monthly payment to apply on the balance of his overdraft until the account is liquidated.

BEASLEY PROPERTY IN CALIFORNIA:

Elders Shaw and Daniells spoke of the desire of Brother and Sister Beasley, of Pomona, California, to safeguard their large property to the denomination, and referred to a proposition which Brother and Sister Beasley have made. It was--

VOTED, That the following committee be appointed to give study to this proposition: C.H.Watson, J.L.Shaw, I.H. Evans, A.G.Daniells, J.L.McElhany, W.H.Branson, Dr. P.T.Magan, Dr. Benton Colver, G.A.Calkins.

FURTHER VOTED, That J.L.Shaw, Dr. P.T.Magan and G.A.Calkins be appointed to consult a capable attorney to gain preliminary information which will enable the larger committee to arrive at an understanding of a proper basis for handling this property.

JOHN KNOX--FINANCIAL HELP:

VOTED, That we join the Pacific Union and the Southern California Conference in assisting Elder John Knox to meet the freight and storage charges on his goods, our share to be one fourth of the amount, up to \$100 if necessary.

H. G. CHILDS--TRANSPORTATION AGENT:

VOTED, That we appoint H.G.Childs to take the place of C.H.Jones as our Western Transportation Agent, in view of the failing health of Brother Jones.

HAROLD PECKHAM--MEDICAL EXPENSE:

VOTED, That the treasurer be authorized to meet one half the medical expense of Mrs. Harold Peckham, returned from India.

H. H. MORSE--MEDICAL EXPENSE:

VOTED, That the treasurer be authorized to meet one half the medical expense of H.H.Morse, on furlough from China.

P.J. GAEDE--MEDICAL EXPENSE:

VOTED, That the treasurer be suthorized to meet one half the medical expense of P.J Gaede, returned from Rumania.

STATISTICAL AND FINANCIAL REPORTS:

Carrying out the recommendation of the General Conference Survey Commission, a small committee was appointed to give study to the Statistical and Financial reports with a view to suggesting possible reductions and economies in their publication. This committee reported, and their report was adopted as follows:

Whereas, The size of the Annual Statistical Report has been reduced from 35 pages in 1930 to 24 pages in 1931; and the Annual Financial Report from 90 pages of printed matter in 1930 to 48 pages in 1931; and,

Whereas, The cost of printing these two reports has been reduced from #1,108.12 in 1930, to #526.73 in 1931,--a net saving of #581.39; and,

Whereas, The foregoing reductions were made subsequent to the study of these reports by the Headquarters Survey Commission; and,

Whereas, Further reduction in size would seem to necessitate a recasting of the entire background or framework of these reports; therefore,

Resolved, That for the present at least the size of the Annual Statistical and Financial Reports be continued as in 1931.

YEAR BOOK:

The same committee having given study to effecting economies in the publication of the Year Book, made some suggestions which were adopted as follows:

That all church directories and the General Conference Constitution and By-Laws be omitted for this year.

That in listing the members of the Educational Department the names of senior and junior college presidents in North America be omitted, designating them simply "Presidents of colleges in North America;" and that in the educational section for all schools under junior college grade only the faculty members and officers of the Board be listed.

That in the listing of periodicals only the following information be given: the name of the paper, purpose, publishers, price, editors.

That the Year Book be printed on thinner paper.

TRANSLATION OF "DAY OF THE LORD":

A committee had been appointed to give study to the translation of the expression "Day of the Lord" in the New Testament, in the different Romance languages. This committee prepared and submitted a very thorough report on the question, also the following resolution, which was adopted:

Whereas, The translation of the Greek phrase kuriake/hemera in Revelation 1:10 is misleading as it appears in the text of most of the Spanish, Italian, and French Bibles distributed by the American Bible Society; and,

Whereas, The rendering of this phrase is misleading to the average reader because it employs an ancient word for Lord that is universally used to designate Sunday in the common secular calendar, and is understood by the ordinary reader to mean Sunday rather than Lord; and,

Whereas, The word Lord is rendered elsewhere in the New Testament by Senor in the Spanish, Signore in the Italian and Seigneur in the French, --terms universally understood in modern times to mean our Lord Jesus Christ; and,

Whereas, It is always and everywhere desirable to have the translation of the Holy Scriptures adhere as faithfully to the original as the common usages of languages allow, to the end that the common people as they read may obtain the very truth indited by the Holy Spirit; therefore,

the British and Foreign Bible South

Resolved, That we very respectfully request the American Bible Society to give attention to an improved translation of the Greek phrase kuriake hemera in Revelation 1:10 by a more modern and accurate rendering, at the earliest time consistent with the policies of the Society.

VOTED, That the foregoing resolution be embodied in a letter to the American and also to the British and Foreign Bible Society.

AMERICAN TEMPERANCE SOCIETY:

In view of the fact that O. Montgomery and M.E.Kern, who have been ærving as chairman and vice-chairman of the National Commission of the American Temperance Society, are to be away from America for a number of months, it was
