#### CHARLES A. GRAY--DETROIT:

VOTED, To pass on to the Southwestern Union and the Arkansas-Louisiana Conference the call from the Lake Union for Charles A. Gray to connect temporarily with the Michigan Conference for work in Detroit during the summer.

## R.L.BOOTHBY -- WEST PENNSYLVANIA:

VOTED, To pass on to the Pacific Union and the Central California Conference the call from the Columbia Union for R.L.Boothby to connect with the work in the West Pennsylvania Conference.

#### C. H. WATSON--AUSTRALASIA:

VOTED, That C.H. Watson as one of the general Field Secretaries of the General Conference, be assigned for the present to the Australasian Division.

#### CHINA DIVISION--MEDICAL SCHOOL:

Dr. H.W.Miller outlined the urgent need of provision being made for giving a medical training to our young people of the Orient, and placed before the Committee a request that the China Division be permitted to arrange for such training in connection with the Shanghai Sanitarium and Clinic, this work to be financed from the earnings of the Sanitarium.

In connection with this project, Dr. Miller desired approval of their plan to erect a laboratory building 40x60 feet, at an approximate cost of \$8,000, on land owned by the Samitarium.

VOTED, That the Chair be asked to appoint a committee of nine, with himself as chairman, and including the Secretary and the Treasurer, to give study to this question and report to the coming Autumn Council.

## SABBATH SCHOOL WORKER--EDITOR:

The resignation of Mrs. L.Flora Plummer as editor of the Sabbath School Worker was presented, and it was

VOTED, That the resignation of Mrs. L.Flora Plummer as editor of the Sabbath School Worker be accepted.

VOTED, That J.A. Stevens, Secretary of the Sabbath School Department, be appointed editor of the Sabbath School Worker.

## SUSTENTATION POLICIES REVISED:

The following revisions of the Sustentation Policy were presented and adopted:

WHEREAS, The regulation which requires a minimum service period of twenty years for permanent assistance from the Sustentation Fund has failed of its purpose since temporary assistance, which may be extended indefinitely, may be given to those who have a minimum of fifteen years' service, so that those with less than twenty years of service become in effect, in many cases, beneficiaries for the same assistance as those with twenty or more years of service; and,

WHEREAS, This has resulted in its being necessary to continue to carry on a so-called list of temporary beneficiaries scores who are permanently incapacitated and will always require assistance from the fund, but who cannot under present regulations be transferred to our list of permanent beneficiaries; and,

WHEREAS, The carrying as temporary beneficiaries those who are permanently incapacitated throws an unnecessary burden upon conference committees that are asked to give special study each year to the lists of temporary beneficiaries in their respective territories; therefore

We recommend, That the regulation (page 7 of the Sustentation Leaflet) governing the years of service required for admittance to the Sustentation Fund be amended to read as follows:

"Individuals who enter denominational service before reaching the age of thirty-five shall be required to render not less than fifteen years of service in order to become eligible to assistance from the Sustentation Fund; and those who enter denominational service after reaching the age of thirty-five shall be required to render not less than twenty years of service to become eligible for assistance. Widows of workers with dependent children, widows who have lost their husbands in foreign mission service, and workers who have lost their health in foreign mission service may be given assistance without regard to length of service, as provided by the regulations governing the granting of assistance to such applicants."

We also recommend, That the following amendments be made in our regulations to bring them into harmony with the above:

The regulation referring to continuity of service (page 8, paragraph b to read as follows:

"The years of his service to the cause both before and after withdrawing from the work shall amount to a minimum of twenty if he was under thirty-five years of age when first employed, or to a minimum of twenty-five if over thirty-five when first employed."

Regulation (page 11) referring to employment of workers over thirty-five years of age to read as follows:

"Special care should be used in bringing individuals into the service who have already reached the age of thirty-five years. However, when conditions seem to warrant employment of those who have passed this age, they shall not be regarded as eligible for assistance from the Sustentation Fund until after having served twenty continuous years."

Regulation (page 11) referring to admittance of colporteurs to the fund to read as follows:

"Regular colporteurs who have entered the work before reaching the age of thirty-five years and whose work has been continuous for fifteen or more years and whose service reaches up to the time of becoming incapacitated, shall be eligible to the benefits of the Sustentation Fund. Those beginning work after reaching the age of thirty-five shall not be recognized as eligible for assistance until after having served twenty continuous years."

## HINSDALE SANITARIUM -- SUSTENTATION BENEFITS:

The following recommendation with reference to extending the benefits of the Sustentation plan to the Hinsdale Sanitarium were adopted:

WHEREAS, The Hinsdale Sanitarium has requested that its employees be admitted to the benefits of the Sustentation Fund on the same basis as employees of our denominationally owned sanitariums, and has expressed a willingness to comply with the requirements of the Fund relating to its financial support; and,

WHEREAS, The Hinsdale Sanitarium is closely affiliated with our organized work in its management, and has connected with its staff those who have previously served our organized work for many years and whose present connection with the institution is upon the recommendation of the General Conference Committee; therefore,

We recommend, That employees of the Hinsdale Sanitarium be admitted to the benefits of the Sustentation Fund upon the same basis as other sanitarium workers, except that their time of service for sustentation credit while employed by the Hinsdale Sanitarium shall be reckoned as beginning from the time that the Sanitarium begins to make the prescribed payments to the Sustentation Fund, and such service shall be counted only so long as the institution continues to make these payments to the fund, and follows the denominational wage scale in setting the salaries of its employees.

## WORK OF GENERAL CONFERENCE RADIO COMMISSION:

In pursuance of the work already begun by the General Conference Radio Commission, and in harmony with the recommendations adopted at the General Conference session, the following further plans recommended for guidance in the work of the Commission were adopted:

- 1. That the purpose of the Radio Commission's work be to cooperate with all means and methods of soul winning already employed, and to encourage all union and local evangelists and workers to continue and strengthen their broadcasting, the aim of the Commission being to help speed up and rapidly extend this method of preaching the gospel message.
- 2. That in the work of promotion, the Commission work with and through the responsible leaders of the conferences in the interests of mutual understanding and good will.
- 3. That for the present the General Conference appropriate to the local or union conference employing the broadcaster an amount equal to fifty per cent of his salary, for the use of approximately half his time, it being understood that if and when the interests of the work would be served, a variety of talent be employed in the broadcasting.
- 4. That the personnel of the Standing Commission be made up as follows:
- M.N.Campbell, <u>chairman</u>. W.H.Williams, <u>vice-chair-man and treasurer</u>. W.E. Howell, <u>secretary</u>. John Ford, <u>broad-caster</u>. W.H. Branson, W.G. Turner, L.E. Froom.

## HOME STUDY INSTITUTE -- ORIENTAL BRANCH:

The report of the committee on the future work of the Oriental Branch of the Home Study Institute was presented and adopted as follows:

We recommend, That study be given to a plan to extend the services of the Oriental Branch of the Home Study Institute into the Southern Asia Division, and that a committee be appointed consisting of W.A. Scharffenberg and the Presidents and Educational Secretaries of the China, Far Eastern and Southern Asia Divisions, who shall cooperate with

with General Conference representatives who are to visit the Southern Asia field in the near future in studying the advisability of carrying through this plan, a report to be made to and final action taken by the General Conference Committee

## CREDENTIALS AND LICENSES:

VOTED, That ministerial credentials be granted to J.A. Stevens, whose name was inadvertently omitted from the report of the Committee on Credentials and Licenses; all other names being referred to the Minority Committee in Washington.

## SPECIAL APPROPRIATIONS:

The committee appointed to consider requests for special appropriations brought in the following recommendations, which were adopted:

## ADVANCED BIBLE SCHOOL:

A report from the committee on the Advanced Bible School, being amended, was adopted as follows:

Resolved, 1. That the Advanced Bible School be permanently organized as a separate corporation detached from any other school, to do the graduate work in Bible and Religious History for the Associated Senior Colleges of Seventh-day Adventists.

- 2. That the constituency of this corporation be the General Conference Committee.
- 3. That the school make provision for the granting of the M.A. degree in Bible and Religious History.
- 4. That the location be in or near Washington, D.C.
- 5. That the board of trustees be composed of the Home Officers of the General Conference, the Secretary and Associate Secretaries of the General Conference Department of Education, the Dean of the school, and the Presidents of Seventh-day Adventist senior colleges, and five other members to be chosen by the General Conference Committee.
- 6. That the officers for the coming General Conference term be: J.L.McElhany, <u>President</u>; H.A.Morrison, <u>Vice-President</u>; W.E.Nelson, <u>Treasurer</u>; M.E.Kern, <u>Secretary</u>.
- 7. That the 1937 summer session be held in Washington.
- 8. That the Minority Committee be authorized to make temporary provision for the Bible school, and that any provision requiring the erection of buildings be referred to the Autumn Council.

## PACIFIC UNION CONFERENCE HEALTH FOOD ORGANIZATION:

At the Autumn Council of 1934 a resolution was adopted that the General Conference join the Pacific Union Conference and the conferences and institutions within the confines of the Pacific Union territory in creating and establishing a separate organization for the manufacture and distribution of health foods. The Pacific Union Conference Committee has now taken action recommending that the proposed health food business be under the general supervision and control of the Pacific Union Conference, and that a suitable and adequate working capital be made available by securing the amount of money needed from our people at a reasonable rate of interest. The following recommendations from the Pacific Union Conference were submitted by the president, Glenn Calkins:

1. That the General Conference Committee be requested to secure the release of G.T.Chapman, of Australia, to connect with the proposed health food factory in the Pacific Union Conference as general manager of the organization.

- 2. That the Australasian Division be requested to provide a complete factory and equipment for the manufacture of Wheat-flake Biscuits, in harmony with assurances that they would make an effort to provide such a gift.
- 3. That the profits from this health food organization be distributed as follows:
- a. Twenty-five per cent to be made available for the promotion, development, and maintenance of church schools, primarily for the payment of church school teachers' salaries.
- b. Twenty-five per cent to be placed at the disposal of the General Conference for the promotion of the work of the College of Medical Evangelists.
- c. Fifty per cent to be retained within the organization for the expansion of the business, and the liquidation of note indebtedness.
- 4. That profits accruing from sales outside the Pacific Union Conference be divided as follows:
- a. Twenty-five per cent to be made available to the General Conference to be allocated to the unions in which the sales are made, to be used for the maintenance of church schools.
- b. Fifty per cent to be retained for expansion of the business and payment of note indebtedness.
- c. The remaining twenty-five per cent to be divided, fifteen per cent to be used in the promotion of the work of the College of Medical Evangelists, and ten per cent to the Pacific Union Conference, to be used in the promotion, maintenance, and development of their church schools.

Following a lengthy discussion, and full explanation by C.H. Watson and Glenn Calkins, it was

VOTED, That the recommendations be approved.

#### PUBLISHING HOUSE IN SHANGHAI:

VOTED, That permission be granted to the Signs of the Times Publishing House in Shanghai, to rebuild the old section of the plant, with the understanding that this will be done with funds accumulating from earnings of the Press.

#### SOUTHERN PUBLISHING ASSOCIATION:

VOTED, To recognize as a denominational institution the legal organization formed by the Southern Publishing Association, called the Southern Commercial Press, Incorporated.

#### TIME OF AUTUMN COUNCIL:

VOTED, That the date for the Autumn Council be set approximately for the latter part of October and early November.
