DECLARATION OF PRINCIPLES:

VOTED, That we approve of the following Declaration of Principles relating to civil duties in South America, as submitted by the South American Division Committee:

1. Seventh-day Adventists believe in the Holy Scriptures as their rule of faith and practice.

2. We recognize that earthly governments are instituted by God for the purpose of securing the peace, well-being, justice and tranquility of the peoples governed, and that in the exercise of these functions they should receive the loyal support of every individual. As the apostle Paul says in Romans 13:1: "Let every soul be subject unto the higher powers. For there is no power but of God; the powers that be are ordained of God."

3. We believe it is the duty of each individual to pay taxes to the constituted authorities and render to them due honor and respect, as is clearly taught in the New Testament: "Render unto Caesar the things that are Caesar's; and unto God the things that are God's." Matt. 22:21.

4. We consider ourselves to be not only citizens of our earthly fatherland, but also subjects of the kingdom of God; for this reason we reverence and observe the law of God as it is contained in the Decalogue, and set forth in the life and teachings of Jesus Christ.

5. We place special emphasis as Seventh-day Adventists upon the observance of the fourth command of the Decalogue according to the Holy Scriptures, which says: "Remember the Sabbath day, to keep it holy. Six days shalt thou labor and do all thy work; but the seventh day is the Sabbath of the Lord thy God; in it thou shalt not do any work, thou, nor thy son, nor thy daughter, thy manservant, nor thy maidservant, nor thy cattle, nor thy stranger that is within thy gates: for in six days the Lord made heaven and earth, the sea, and all that in them is, and rested the seventh day; wherefore the Lord blessed the Sabbath day, and hallowed it." Therefore we abstain on this day from doing any kind of work with the exception of acts of mercy and of the relief of physical suffering or the uplifting of mankind, just as was taught and exemplified by Jesus Christ.

6. We firmly believe in the benefits of peace, and labor for its conservation, believing that this is the spirit of Christian doctrine as taught by our Lord Jesus Christ. Therefore, neither in time of peace nor in time of war do we as followers of the Lord Jesus Christ think it right for us to participate in acts of violence or to take human life.

GEORGE NORRIS--SOUTH AMERICA:

VOTED, To pass on to the British Union Conference through the Northern European Division, the request of the South American Division that George Norris, of the British Realth Food Factory, be permitted to visit South America to give counsel in connection with the establishment of a health food factory by the Austral Union Conference in Buenos Aires; it being undergood that South America will meet the transportation expense, the British Union being asked to continue the salary.

GWYNNE DALRYMPLE--WALLA WALLA COLLEGE:

VOTED, To pass on to the Pacific Union Conference and the Pacific Press the call from the North Pacific Union Conference for Gwynne Dalrymple to connect with Walla Walla College as Bible teacher.

February 7, 1938

H.M. BLUNDEN--ANTILLIAN UNION:

VOTED, To request the Pacific Union and the Southern California Conference to release H.M.Blunden to connect with the Inter-American Division as superintendent of the Antillian Union Mission.

Mitchell, one of the Seventh-day Adventist members of the faculty of the Dental School, to visit Emmanuel Missionary College and Union College this spring, for the purpose of acquainting the students with the advantages offered by the Atlanta Southern Dental School, it being understood that the Doctor will encourage only those to look toward the profession of dentistry who may not have been planning on the ministry nor any other line of denominational work.

VCTED, That the Treasury be authorized to meet the transportation and entertainment expense of Dr. J.R.Mitchell in making the visit to Emmanuel Missionary College and Union College.

PUBLISHING HOUSE PAYMENTS TO SUSTENTATION FUND:

Whereas, All our publishing houses have not understood the intent of the action of the 1936 Autumn Council which provided for publishing houses to pay 11 percent of their current payrolls for the Sustentation Fund instead of 12 percent of the payrolls for the year previous to the year in which the Council was held, but have understood that the action merely changed the percentage on which payments should be made; and

Whereas, Those who had this misunderstanding built their 1937 budgets in harmony with their understanding of the action, and would now find it very embarrassing were they required to meet the provision intended by the action; and,

Whereas, It is recognized that the revision of our regulations relating to payments to the Sustentation Fund by our publishing houses was not as clearly stated as it might have been, thus opening the way for a misunderstanding, and in order that no hardship be worked upon any publishing house and that all be dealt with alike; therefore

VOTED, That for the year 1937 only 11 percent of their 1935 payrolls be required of our publishing houses as their contribution to the Sustentation Fund, and that any publishing house that has paid more than this to the fund be given a credit for such excess payment, the same to apply on their 1938 payments to the fund, it being understood that from January 1, 1938, onward, all publishing houses will pay 11 percent on their current payrolls.

ATLANTIC UNION COLLEGE:

W.H.Heckman and I.G.Ortner, of the Atlantic Union Conference, met with the Committee, presenting the emergency which has arisen in connection with Atlantic Union College due to the following:

1. The destruction of the barn by fire about a year ago, which has resulted in a heavy outlay for feed.

2. The unforeseen difficulty experienced because the prospective employment of from forty to sixty students did not materialize, which resulted in many students dropping out of the school, thus greatly reducing the College income.

Request was made for permission to borrow necessary funds to meet the present emergency. Inasmuch as the College has provided in its expansion program a substantial amount to meet its note obligations, it was

VOTED, That we grant permission to Atlantic Union College to borrow the necessary funds up to #17,000, to meet the present emergency, it being understood that the money will be used only to meet current unpaid bills, and will be repaid from the proceeds of the rebuilding campaign now being launched.
