AUTHORIZATION OF SIGNATURES:

The following resolutions were adopted:

Resolved, That the National City Bank of New York, in Havana, Cuba, be, and hereby is, authorized to recognize the signature of A.P.Christiansen, Treasurer, for the account of the Antillian Union Mission of Seventh-day Adventists, to sign or make all or any changes and orders for the payment of money, in the place of F.I.Mohr, Treasurer, heretofore authorized by this organization.

<u>Resolved</u>, That the National City Bank of New York be, and hereby is, authorized to recognize the signature of F.I. Mohr, Treasurer, for the account of the Central American Union Mission of Seventh-day Adventists, to sign or make all or any changes and orders for the payment of money, in the place of A.P. Christiansen, Treasurer, heretofore authorized.

EMERSON PROPERTY IN LOMA LINDA:

A request was presented from Otis Hudson, of the College of Medical Evangelists, for authorization for the purchase of a piece of property in Loma Linda. This property which is for sale by Brother Emerson, is adjacent to the College campus, and it is felt should be under the control of the College. They feel they can handle the matter through their investment department. It was

VOTED, That we approve of the purchase by the College of Medical Evangelists, of the Emerson property in Loma Linda.

DR. J. NUSSBAUM--SUPPORT:

Dr. Jean Nussbaum, who is Medical Secretary of the Southern European Division, and Religious Liberty Becretary for the Southern European Division and Section II of the Central European Division, having served these departments for a number of years in an honorary capacity, has in recent times given a good deal of attention to his work as Religious Liberty Secretary.

In view of the value of Dr. Nussbaum's service in this connection to our general work as well as to the divisions with which he is connected, and taking into consideration the fact that so much of his time has been taken from his medical practice of late because of this work, it was

VOTED, That we join with the Southern European Division and the Central European Division, Section II, on a one-third basis in supplying financial support for Dr. J.Nussbaum.

ALLOWANCES ON DENTAL EXPENSE -- COMMITTEE:

Inasmuch as the standing committee on dental allowances is having difficulty in administering the policy in strict accordance with some of its provisions, it was

VOTED, That the Chair appoint a committee of seven to give careful study to the whole policy of allowances on dental expense, with a view to its clarification, making recommendation as to any changes or adjustments that may be thought necessary.

W.E.HOWELL-TRAVEL ALLOWANCE AND TRANSPORTATION:

In June, W.E.Howell having been granted a leave of absence, accompanied Elder McElhany to California. Elder McElhany was detained in California for some time, and Brother Howell was asked to remain to help him with his work. After remaining longer than he had originally planned, and due to conditions beyond his control, Brother Howell found it necessary to return by train, using a pass.

VOTED, That during the time W.E.Howell was asked to remain in California beyond the time of the original plan, he be allowed the regular travel allowance, and further, that he be allowed the expense of his transportation in returning to Washington by train.

EMERGENCY APPROPRIATIONS:

VOTED, That the Treasurer be authorised to make an appropriation of \$1200 from the Emergency Fund to the Oklahoma Conference for the year 1938, to help in restoring the ten per cent cut that conference was compelled to make in workers' salaries.

VOTED, That the Treasurer be authorized to make an appropriation of \$750 from the Emergency Fund to the Maritime Conference, to apply on the budget of that conference for the year 1939.

VOTED, That the Treasurer be authorized to make an appropriation of \$750 from the Emergency Fund to the Wyoming Mise. sion.

EXPENSE OF SANDNESS TRIAL:

O.E.Sandness, a former worker in California, having been disfellowshipped by the Eureka church, brought suit against the Northern California Conference, the Pacific Union and the General Conference, in an effort to obtain sustentation benefits. A defense attorney was employed by the Pacific Union and the case was decided in our favor.

VOTED, That we share with the Northern California Conference and the Pacific Union on a one-third basis in meeting the attorney's fees in the Sandness trial.

SOUTHERN ASIA AUTHORIZED TO CALL FOR WORKERS:

The Southern Asia Division has sustained heavy losses in its working force during the past year and a half or two years, many of the leading workers having had to leave the field because of health conditions and for other reasons, and a number of these the division is still supporting, thus making it impossible to call for replacements. It was

VOTED, That we authorize the Southern Asia Division to place calls for four additional workers, to replace that number who have left the field, with the understanding that as these are placed under appointment and their salary is taken on by the division, the General Conference will assume the responsibility of caring for the workers who have been permanently returned, so that there will be no overlapping of salary as far as the Southern Asia Division is concerned.

DENTAL SCHOOL PROMOTION:

VOTED, That we invite Dr. J.R.Mitchell, one of the Seventh-day Adventist members of the faculty of the Atlanta Southern Dental College, to visit Washington Missionary College, Emmanuel Missionary College and Union College, in the interests of the work of the Dental College, the Treasurer being authorized to meet the transportation and entertainment expense of Dr. Mitchell in making this itinerary.

CANADIAN UNION:

W.B.Ochs, president of the Canadian Union Conference, requested counsel on a number of problems with which the union is confronted, among them the necessity of complying with the requirements of the authorities that electrical wiring which has been condemned at Oshawa Missionary College be replaced, and also the necessity of providing a working capital for the woodworking shop. The estimate for the re-wiring is approximately \$1800. It seems necessary that the woodworking shop should have a working capital of \$5000. It was

VOTED, That the Chair appoint a committee to give study to these problems and report.

MRS. L.V. CLEAVES AND DAUGHTER -- PERMANENT RETURN:

VOTED, That on recommendation of the Inter-American Division, we approve of the permanent return to the homeland of Mrs. L.V.Cleaves and her daughter.

A.B.RUSSELL--POTOMAC CONFERENCE:

VOTED, To pass on to the Southwestern Union and the Texas Conference the call from the Columbia Union for A.B. Russell to connect with the work in the Potomac Conference.

AUDITING HELP IN PACIFIC UNION :---

VOTED, That inasmuch as the Pacific Union has loaned James Howarth, their auditor, to the General Conference for some survey work in Europe, we agree to meet the expense involved if the Pacific Union finds it necessary to employ auditing help in Brother Howarth's place during his absence.

VOTED, To request the North Pacific Union and the Oregon Conference to release Mr. and Mrs. R.L.Badgley, to connect with the Inter-American Division and the Caribbean Union Conference as members of the faculty of the Caribbean Training College.

T.E. UNRUH RELEASED:

VOTED, That T.E.Unruh be released from the call to the North Pacific Union.

EDNA EDEBURN--PACIFIC UNION:

VOTED, To pass on to Miss Edna Edeburn, of the General Conference Educational Department, the call from the Pacific Union, for her to connect with the "Voice of Prophecy" office as stenographer, and as assistant to Brother Mattison in publicity work.

CANADIAN UNION:

The committee that was appointed to give study to certain financial problems in the Canadian Union, submitted the following recommendations, which were adopted:

We recommend, 1. That \$750 be appropriated to Oshawa Missionary College, from the Emergency Fund, to assist in making necessary electrical repairs.

We recommend, 2. That the returns from the sale of wood products at Oshawa Missionary College be safeguarded to the woodworking shop, to assist in building up an adequate working capital, and that a definite and regular percentage of the gross sales be set aside for this purpose; recognizing that while this capital is being accumulated it may be necessary for the Canadian Union Conference to make some temporary advances of funds.
