EDITORIAL COUNCIL -- DATE:

The 1938 Autumn Council in recommending that an Editorial Council be held in Washington next autumn, suggested September 1 to 12 as the date, at the same time recommending that organizations sending their editors to the Council, arrange for as many of them as possible to attend the summer quarter of the Theological Seminary.

The summer quarter of the Seminary runs from June 7 to August 22, leaving a lapse therefore of more than a week between the closing of the Seminary and the beginning of the Council. In view of this it was

CHICO CHURCH BUILDING:

Request was presented from the Pacific Union on behalf of the Northern California Conference, for approval of the erection of a church building at Chico, with the understanding that the only work to be done now is the roughing-in, which it is estimated will cost between \$6,000 and \$7,000. This amount is in hand, in cash, labor and materials. It was

VOTED, That we approve of the plans of the Chico church for the roughing-in of their church building, it being understood that they will proceed with further construction no faster than they have the funds in hand, so that no indebtedness will be incurred.

E.G. WHITE PUBLICATIONS -- PROMOTION:

The following report from the Committee on Promotion of the E.G.W hite publications was adopted:

Your committee appointed to give study to the special effort to stress the importance of the Spirit of prophecy writings and to widen their distribution in the North American Division recommend the following:

- effort be the creating in the heart of each Seventh-day Adventist an understanding appreciation of his need for and the value and timeliness of the instruction, encouragement, and information presented in the Spirit of prophecy writings; thus leading to the study of the volumes already in the homes of our people; and that we endeavor to place the most needed books in the homes that do not have them, giving special attention to the needs of our new believers.
- 2. That the time of the effect be May 15 to September 15.
- 3. That prior to and during this period, conference leaders, ministers, other workers and church officers, set before our church members the importance of having and studying the messages God has vouchsafed to this people through the Spirit of prophecy, for their enlightenment, guidance, and preservation.
- 4. That one Sabbath prior to the camp-meeting period in each local field, be devoted to the Spirit of prophecy, the time to be designated and the program to be arranged for in each local conference by the local committee.
- 5. That at the camp meetings special emphasis be placed upon the inestimable value of the Spirit of prophecy to each individual believer and the church as a whole, one or two services being devoted to this and to encouraging the widening of the distribution of the Spirit of prophecy books.
- 6. That a 20% discount be offered on all trade editions of the E.G.White books from May 15 to September 15, to be shared by the publishing houses granting an additional 5% and the Bible Houses an additional 5% added to the regular 10% camp-meeting discounts.
- 7. That we request the editors of the Review and Herald Ministry, Church Officers' Gazette, Journal of True Education, and Youth's Instructor to solicit and arrange for the publication of articles which will contribute to the dual objectives of the special effort, and that articles be furnished union and division papers.
- 8. That we call the attention of our foreign language reading believers in America to the Spirit of prophecy books available in the several respective languages.

- 9. That such advertising circulars as are deemed advisable be issued by the publishers, the expense to be shared proportionately by the three houses.
- 10. That a general 16-page informative leaflet, setting forth the value of the Spirit of prophecy to each Seventh-day Adventist, and appealing to our church members to avail themselves of this treasure of instruction and help, be issued by the General Conference for general distribution.
- 11. That Home Missionary Sabbath, December 2, be designated as Spirit of prophecy Sabbath, at which time the summer effort be followed up, the importance of a study of the books be reviewed, and the attention of our people be again called to the Spirit of prophecy books; and that the Home Missionary Department prepare the program for the day to appear in the Church Officers' Gazette.
- 12. That Elder M.N.Campbell be requested to write a letter to all church elders and workers preceding the summer effort, and that Elder J.L.McElhany be requested to address a letter to the same group preceding the December 2 Spirit of prophecy day.
- 13. That a representative standing committee be appointed to foster the effort called for by these resolutions.

CHILLAN SCHOOL--\$10,000:

Request was presented from the South American Division on behalf of the Chillan School, for an appropriation of \$15,000 to assist in the rebuilding of the Administration Building and Boys' Dormitory, destroyed by the recent earthquake in Chile. The Division is appropriating for razing the Administration Building and repairing other buildings that were only slightly damaged.

Attention was drawn to the fact that our Emergency Fund has already been heavily drawn upon, and with continued drafts there is danger of its being depleted before the end of the year leaving nothing with which to help in other serious emergencies that may arise. It was

VOTED, That the Treasurer be authorized to appropriate \$10,000 to assist in the reconstruction of buildings of the Chillan School destroyed by the earthquake; and that in view of the fact that our Emergency Fund has been so heavily drawn upon, we request the South American Division to give consideration to the possibility of rendering additional assistance from their funds, as may be needed in the rebuilding program.

DR. H.A. MOURER -- INDEBTEDNESS:

The Treasurer made a statement with reference to the indebtedness of Dr. H.A.Mourer, who was called from private practice in California to connect with the work in China about five years ago. Dr. Mourer owes \$181.64 to the Student Loan Fund of the College of Medical Evangelists, and tuition notes to the amount of \$302.50. In accepting the appointment to China he understood that this indebtedness would be cared for, not being

aware of the fact that he was not eligible for this consideration inasmuch as he did not enter mission work within the time limit after graduation set by the policy. It was

VOTED, That in view of the years of service Dr. Mourer has given to the China field, we ask the China Division to give favorable consideration to liquidating his \$181.00 indebtedness to the Student Loan Fund; and that we ask the College of Medical Evangelists to cancel the tuition notes, inasmuch as Dr. Mourer understood from the chairman of the College Board that these notes would be canceled.

VOTED, That the Secretary be asked to express to Sister Hoen, the widow, and to Prof. R.E. Hoen, the son, of Pacific Union College, our appreciation of this long life spent in the service of God, and our sympathy with them in their sorrow.
