REFUGEES TO BOLIVIA:

Word has been received that ----- and ----- and their families, who are believers in the message, are required to leave their homeland and arrangements have been made for them to enter Bolivia, South America, as a land of refuge. However, it is necessary that a deposit be made covering registration, transportation, and funds for entry into the country. These families are worthy of our assistance.

JEWISH FAMILY FROM GERMANY TO SOUTH AMERICA:

We had had a cable from J Wintzen of Holland asking us to advance \$1,100 to apply on the transfer of a Jewish family [Familie Amelung Greunzeng] from Germany to South America [Venezuela]. Information comes through Mrs. G.W. Schubert that a total of \$1,070 should be sent to Amsterdam to facilitate the handling of the case, though we had formerly taken action to appropriate \$1,300 from the Refugee Fund when the plans were that these refugees go to Bolivia. It appears now that they have a better opening in Venezuela and that a family by the name of Gruenzeng is prepared to sail for that country December 2.

Agreed that the Treasury go forward with this matter in behalf of the Gruenzeng family, with the request that the money be returned in due time if and when it is possible.

MOUNT VERNON ACADEMY--BOYS' DORMITORY:

Request was presented from the Columbia Union for permission to go forward with the erection of a boys' dormitory at Mount Vernon Academy, at an estimated cost of \$50,000. It is estimated that the building can be roofed and enclosed and windows placed, for \$25,000, which amount is in hand in cash. The request is for permission to proceed to this extent, assurance being given that further work on the building will go forward only as funds for this purpose are received.

VOTED, That we authorize the Columbia Union and the Ohio Conference to proceed with the erection of the boys' dormitory at Mount Vernon Academy, with the understanding that construction work will go forward only as funds are in hand, and that no indebtedness will be incurred.

WASHINGTON SANITARIUM--LISNER MEMORIAL ADDITION:

A bequest of \$100,000 came to the Washington Sanitarium from the estate of Mrs. Lisner, a former patient, with the stipulation that it must be used in the erection of a new building or an addition to the Sanitarium. Building plans for an addition, to be erected at the west of the main building toward the Sligo have been approved. The Sanitarium now submits plans for financing the project, including the construction of an automobile parking lot and improvement of roadways.

The estimate for the building is between \$75,000 and \$80,000, the balance of the \$100,000 to be used for equipment. The estimate for the parking lot and roadways is approximately \$16,000, to be met from Sanitarium reserve funds.

VOTED, That we approve of the plans for financing the Lisner Memorial Addition to the Washington Sanitarium, including the construction of parking lot and improvement of roadways.

J.L.SHULER--FIELD WORK:

A committee that had been appointed to give consideration to the arrangements that should obtain in connection with the field work to be done by J.L.Shuler, of the Theological Seminary, made the following recommendations, which were adopted:

1. That all arrangements for J.L.Shuler's field work be made by the General Conference Committee, on recommendation of the Theological Seminary Board.

2. That the salary and all chargeable expenses, when engaged in evangelistic efforts, shall be paid by the organization for which the efforts are held, including trips to the field to arrange for the efforts.

3. That inasmuch as Elder Shuler will have to maintain a home at headquarters, room or apartment rent where the efforts are held shall be considered a chargeable expense.

4. That when engaged in general field work the salary be paid by the Seminary and the expenses by the General Conference.

Building plans have been submitted and approved, with some suggestions from the General Conference Building Plans Committee.

Cable was received today from the Far Eastern Division, stating that more than seventy-five percent of the funds are in hand for building purposes, that there is opportunity for immediate sale of the old property with privilege of free occupancy if the new building is begun at once, and requesting authorization to proceed with building operations as funds permit.
