BROADVIEW COLLEGE AND
THEOLOGICAL SEMINARY INVENTORIES:

When the Broadview College and Theological Seminary was closed some years ago, the buildings, furnishings and equipment were leased to the Illinois Conference for the Broadview Academy. Part of the inventories still remain on the Broadview College books, with the exception of certain laboratory and library equipment, which at the time of the closing of the College was allocated to Union College, Emmanuel Missionary College, Sheyenne River Academy and Broadview Academy. HELP FOR WEST NORDIC UNION
CONFERENCE AND SKODSBORG SANITARIUM:

Cables were read from the West Nordic Union Conference and the Skodsborg Sanitarium, in Northern Europe, reporting their serious financial distress in the present situation in Scandinavia, and appealing for help. The Treasurers had sought counsel in the city with reference to the possibility of sending remittances to Norway and Denmark, but could not obtain any definite assurance of success, though those consulted were willing to assist in making the effort. It was

VOTED, That we authorize the sending of \$500 a month for four months to the West Nordic Union Conference, and a similar amount to the Skodsborg Sanitarium, on the best arrangement that can be made with the banks; and that at the same time we advise our leaders in Northern Europe to readjust their work on a self-supporting basis, in view of the present difficulty of sending money from here, and the likelihood of further restrictions that will make this still more difficult, if not entirely impossible.

## HAWAIIAN MISSION ACADEMY:

Request was presented from the Pacific Union on behalf of the Hawaiian Mission, for permission to proceed with the erection of an addition to the Hawaiian Mission Academy and Training School, at a total cost for the building and equipment of \$7,677.96. Blue prints having been approved by the Building Plans Committee, and the plan for financing being in harmony with the General Conference policy, it was

VOTED, That we authorize the Hawaiian Mission to proceed with the building of the proposed addition to the Hawaiian Mission Academy and Training School.

# TRANSPORTATION TO AUTUMN COUNCIL:

VOTED, That in view of the courtesies we receive each year from the railroad companies in the way of free transportation, those who go from the General Conference office to the Autumn Council at St. Paul be advised to use the train service; and that we earnestly request the conferences and institutions in the North American Division to do likewise in sending workers to the Council.

## INELIGIBLE SUSTENTATION BENEFICIARIES:

The Sustentation Committee made a request for counsel in the matter of suggesting that old age pensions be applied for in the case of certain persons who, though ineligible according to the policy, are receiving benefits from the Sustentation Fund having in most cases been admitted to the Fund years ago, and with less than fifteen years of service. It was

VOTED, That the Chair appoint a committee of five to give study to this question, and report.

## EXCHANGE POLICIES:

In view of the present world situation which is affecting exchange rates in many parts, the following recommendations presented by the Treasury were adopted as emergency measures, with the understanding that they will be reviewed at the time of the Autumn Council:

# Pertaining to Furloughs

Inasmuch as war conditions are making it difficult for workers who normally would take their leave of absence or furlough in their homelands in Europe, or other parts of the world affected by war,

We recommend, That the several division committees be counseled to defer, where possible, furloughs or leaves of absence to such workers, until the present emergency is past. That when it is deemed advisable for health or other urgent reasons to grant these privileges, then the necessary transfer of funds be authorized at the fixed rates of exchange.

## Pertaining to Educational Purposes

We recommend, 1. That when nationals of other divisions come to the North American Division for educational purposes and their support and school expense is met in whole or in part by denominational organizations, funds for such support and expense may be sent through the regular channels at the fixed rate of exchange, upon the approval of the division committee concerned.

- 2. When nationals of other divisions come to the North American Division for educational purposes and the funds for their support and school expense come from private sources, such funds may be sent through the regular channels at the fixed rate of exchange under the following conditions:
- a. When the student is a dependent of a denominational worker, and the transfer of funds in his behalf is approved by his division committee and the General Conference Committee.
- b. When the student is not a dependent of a denominational worker, but shows promise and has signified his intention of becoming a worker in his home division upon the completion of his school work, and the transfer of funds in his behalf is approved by his division committee (and the General Conference Committee.)
- 3. National workers or their dependents desiring to take courses of study in the Home Study Institute may upon the approval of their division committee transfer through the regular channels at fixed rates of exchange a sufficient amount of money to cover the cost of such courses, including necessary books.

## PUBLISHING DEPARTMENT -- MEETING OF UNION SECRETARIES:

VOTED, That the Publishing Department be authorized to call a meeting of union Field Missionary Secretaries, in the Chicago area, August 27-29.

## HELP FOR LATE CAMP MEETINGS:

VOTED, To adopt the following schedule of appointments for the late camp meetings, the officers being authorized to make any necessary changes or adjustments, including the appointment of any furlough workers who may be available to attend meetings:

#### LATE CAMP MEETINGS

#### 1940

Note: It is understood that the union conference president will arrange with the General Conference help assigned to the camp meetings of his union for their itinerary of attendance at the various camp meetings. It is recommended that as far as possible general workers who are asked to carry the burden of giving spiritual help to the people attend a camp meeting throughout its entire time. Thus the General Conference help assigned to the union may need to be divided and each man attend only part of the camp meetings listed. Where the interests of the work require that a worker attend many camp meetings to present a certain line or issue, the worker will explain the plans for him in making arrangements with the union president.
