WORK OF DR. E.N. DICK:

Recommendations relative to the work of Dr. E.N.Dick were submitted and adopted as follows:

We recommend, That Dr. Everett N.Dick work on the following program until September 1, 1941:

Between now and April 1, he proceed to College View, stopping in Indianapolis and Cicero, Indiana, and during this time he be authorized to respond to week-end calls in the Central, Northern and Lake Unions.

During the month of April, he enter the Army Officers' Training Course at Carlisle Barracks in Pennsylvania, provided army authorities make this possible. Failing this, that he proceed to Fort Robinson in Arkansas, for observation and such training as he may find possible to obtain there in up-to-date army methods; and that he be provided with the text books in use at Carlisle Barracks for his personal study.

That during the month of May he be authorized to respond to invitations for inspection and training work in connection with the Medical Cadet Corps in the Central corps area.

That in June he connect with a Medical Cadet officers' training camp for the Central corps area at Lake Taneycomo, Missouri, in connection with a Medical Cadet training camp for the Central Union Conference.

That in July he connect with a Medical Cadet officers' training camp for the Western corps area, somewhere in the North Pacific, in connection with a Cadet camp of the North Pacific Union Conference.

That in August he conduct a Medical Cadet officers' training camp for the Eastern corps area, at Reading, Pennsylvania, in connection with a Medical Cadet training camp of the Columbia Union Conference.

All of these Medical Cadet officers' training camps are planned for a three weeks' period.

We recommend, That the General Conference officers be requested to invite the cooperation of the union conferences in North America in following the foregoing program, urging them to select and send men of potential officer qualifications to these Medical Cadet officers' training camps.

SELECTION AND ADMISSION OF INDIVIDUALS FOR OFFICER TRAINING:

- Promising graduates of the Medical Cadet Corps training course or such individuals as have attended the Basic and Technical Training for three fourths the number of hours of the full course.

 - 3. Qualified physicians.
- 4. It is to be understood that all candidates for officer training shall be members of the Seventh-day Adventist church who by their lives and example exert a strong spiritual influence and leadership in their church.

- 3. There should be sufficient buses provided to adequately meet the needs of the residents of Takoma Park.
- 4. That endeavor be made to have the service from Flower and Erie Avenues continued to Laurel and Eastern Avenues (to connect with the General Conference and Review and Herald Buildings).

STATEMENT FOR THE DEPARTMENT OF JUSTICE:

VOTED, That the following statement be filed with the United States Department of Justice:

Statement in Behalf of the Seventh-day
Adventists in the United States in Regard to the Official
Teaching of their Denomination with Reference to Participation in War and Training for War

In harmony with their understanding of the principles taught by the Prince of Peace, Seventh-day Adventists make their contribution to the support of their government in time of war or preparation for war in the direction of saving life rather than taking life. They willingly serve in any capacity in war or in peace where they can make this contribution.

From the time of their organization Seventh-day Adventists have been noncombatants, serving only in those units of the army where they are not required to bear arms. They went on record with the United States Government in 1864 as noncombatants and their noncombatant position was then officially recognized and a noncombatant status accorded them. They reaffirmed this position in 1917 when again the United States Government accorded them a noncombatant status.

Seventh-day Adventists have from the beginning of their history been intensely loyal to government. This is part of their religious faith. Their conscientious objection is not to service for their country, but to the taking of human life. Their claim to exemption is from combatant not noncombatant service. They quite willingly salute the flag, wear the uniform, and do any and all service that contributes to the saving, welfare, and maintenance of human life. They hold that their supreme allegiance to God forbids their taking human life.

We are aware that our members serving their country are not as likely to encounter difficulties and misunderstanding regarding their noncombatant position as they are with reference to their conscientious convictions regarding the performance of their routine duties upon the day which they observe as the Sabbath, which is the seventh day of the week, from sunset Friday to sunset Saturday.

They will manifest no unwillingness to take care of the sick and wounded on that day, or meet emergency needs as they grow out of such lines of service. They will, however, request to be allowed to perform merely routine duties, those which do not involve works of necessity and relief, on other days than the Sabbath, and will seek to obtain mutually satisfactory arrangements so that their relief time may fall upon the Sabbath in order that this day may be used by them as far as possible for purposes of worship. It is here that we plead for due consideration to be shown our members whose conscientious convictions will be displayed in loyal devoted service to their country as well as in obedience to their God.

NORTHERN CALIFORNIA CONFERENCE -- OFFICE BUILDING:

Inasmuch as the Northern California Conference is in need of more office space than they have in their present quarters, request was presented from the Pacific Union on behalf of the conference, for authorization to proceed with the purchase of a suitable property they have found in a convenient location, the building in good repair, and which with an adjoining lot, can be secured for \$12,500. The cost of remodeling will be approximately \$1,000. Funds are in hand for financing the project.

VOTED, That we approve of the purchase by the Northern California Conference of the property suggested.

SAN BERNARDING CHURCH BUILDING:

Request was presented from the Pacific Union on behalf of the Southeastern California Conference, for authorization to begin work on the erection of a new church building in San Bernardino, the total cost of which it is estimated will be \$30,000.

The plan for financing includes cash in hand, reliable pledges, pledges of labor, building material on hand, the sale of the old church property and other lots, and appropriations from the conference and the union conference, amounting to a total of \$24,127. It is felt that this will cover the cost of

bringing the building near enough to completion so that it can be used while the remainder of the cost is being raised. Assurance is given that construction work will proceed only as the funds are in hand.

VOTED, That we give authorization to the Southeastern California Conference to begin the erection of the proposed church building in San Bernardino, with the definite understanding that work on the building will proceed only as the funds are in hand.

LODI CHURCH BUILDING:

When approval was given for the remodeling of the Lodi, California, church building, it was estimated that the work could be done for \$16,000. The Pacific Union for the Northern California Conference now reports that the cost will be \$19,000. Assurance is given that the conference and the church will meet this additional amount as the work progresses.

VOTED, That we reaffirm our approval of the remodeling of the Lodi church building.

SOUTHERN ASIA DIVISION-TRANSFER OF CHURCH EXTENSION APPROPRIATION:

VOTED, To accede to the request of the Southern Asia Division for permission to use in the completion of a village church in Bihar, Church Extension funds remaining from an appropriation that was made for the erection of a building for a native church at Oraon.

The following recommendations were submitted from the Medical Council held recently in Boulder, . Colorado:

TRAINING OF NURSE ATTENDANTS OR SUBSIDIARY WORKERS:

- We recommend, 1. That medical institutions needing the services of non-professional workers for non-professional duties employ such persons and train them for the specific need.
- 2. That the Medical Department of the General Conference work in conjunction with the Educational Department to plan an outline for a course of instruction for the preparang of trained attendants. It is understood that--
- a. The first part of this course shall be made up of some courses now given in the Home Economics Department of the college. These courses shall be so grouped that the students will be encouraged to take them in sequence as a basis of preparation for practical experience.

- b. The Medical Department shall work out plans with medical institutions not connected with schools of nursing, so that students who have completed the above mentioned courses may receive the prescribed practical experience.
- c. On completion of the prescribed theoretical and clinical work these individuals shall be entitled to a certificate indicating their accomplishment.
- d. That the Medical Department design the certificate of accomplishment.

VOTED, That we approve of the foregoing recommendations, and that the Medical Department be authorized to prepare the outline for the course of instruction, to be submitted to this Committee later.

A further recommendation from the Medical Council was submitted as follows:

MANUAL ON ORGANIZATION OF MEDICAL INSTITUTIONS:

We recommend, That a manual be prepared showing the organization of medical institutions with organic and functional relationships between the different departments.

VOTED, That we approve of the preparation of such a manual, and that in due course the manuscript be submitted to a committee to be appointed by the officers.

We recommend, 1. That the newly-merged organization formerly known as the Subcommittee on Training and Service of the Medical Cadet Corps Council, and the National Service Commission, be named the Commission on National Service and Medical Cadet Training.
