Suggestion was finally made that a letter be sent to the heads of the several military services that are offering the program, inquiring whether some provision cannot be included that would safeguard us in our noncombatant principles by providing that any student in a Seventh-day Adventist college having enlisted in the Reserve and not obtaining his officer's commission shall be guaranteed noncombatant assignment in the service, or be honorably discharged and placed back under Selective Service. It is understood that those who receive their commissions will obtain noncombatant assignments.

Accepting this suggestion, the Committee recessed, to give opportunity for the draft of a letter to be prepared.
