WAGE RATES OF WOMEN PHYSICIANS:

When the revised Wage Scale was adopted at the Spring Meeting, attention was called to the increasing difference between the wage rates

of men and women physicians after the first year, and it was recommended that a committee be appointed to give further study to the wage rate of women physicians, this committee to report to the Autumn Council.

MILITARY CHAPLAINCIES:

Discussion of the report from the committee on military chaplaincies was resumed, and the report after being amended was adopted as follows:

At the 1942 Spring Meeting of the General Conference Committee held in New York, an action relating to military chaplaincies was informally adopted. This question was again studied at the 1943 Spring Meeting of the General Conference Committee, and action was taken reaffirming the 1942 statement, which reads as follows:

"Requests having been received for counsel as to whether our ministers should accept chaplaincies in the army, and the Chief Chaplain of the Army having asked our denomination to appoint three chaplains to fill the places allotted to us in the army, some time was given to the discussion of our attitude on this important question.

"Voted, That in response to the request for counsel on the part of some of our ministers regarding applying for and accepting commissions as chaplains in the United States military services, and the request of the United States Army Chief of Chaplains for us to make immediate nomination of three of our men for such military commissions, we reaffirm our historical position on this matter, which is to the effect that we cannot as a religious body counsel or encourage our men to apply for or accept military commissions, but must leave such decisions to be made on the basis of individual convictions."

Since only limited publicity has been given to this attitude toward our ministers taking commissions as chaplains, the Spring Meeting of 1943 requested the Executive Committee to give study to the method of disseminating this information to the field. Therefore

We recommend, That the following statement be recorded as setting forth the reasons for our attitude on this question:

Military chaplains are ministers of religion to the men in the armed forces. They are employed by the government and are remunerated from public funds for the teaching of religion. This is a practice which is in clear violation of Biblical principles concerning the separation of church and states.

The teaching of religion is the duty and responsibility of the church, and it is wholly improper for the state to employ

individuals for this specific purpose. If it is permissible for the state to employ teachers of religion, then it is not difficult to conceive of the occasion arising when the employing state shall determine what kind of religion shall be taught, and when and where. If we grant the propriety of the state's employing individuals to teach religion, we must be prepared to face the inevitable consequences. The historial position of Seventh-day Adventists that church and state must be kept separate is well stated in the following quotation from a Memorial presented to the Congress of the United States of America by the General Conference Committee on January 29, 1908:

"While we feel constrained to yield to the claims of civil government and religion, as both being of divine origin, we believe their spheres to be quite distinct the one from the other, and that the stability of the Republic and the highest welfare of all citizens demand the complete separation of church and state."

Seventh-day Adventisteministers as military chaplains, commissioned, supervised and paid by the government, would have to consent to a limitation on the content of their preaching, which would prevent them from preaching the full gospel message for this prophetic hour. As clergy employed by the state, they could not preach the important Sabbath message, nor other doctrines recogn nized by the denomination as being vital, but looked upon by others as being controversial. Seventh-day Adventist soldiers, because of their Sabbath principles, are often considered a serious problem to military organizations. It is apparent, therefore, that chaplains could not consistently accept remuneration as military officers, and at the same time by their preaching and personal ministry aggravate the problems of military administration by encouraging men to observe the Sabbath "according to the command-ment."

Seventh-day Adventists are historically noncombatant. It is easy to imagine the embarrassment of Seventh-day Adventist chaplains, one of whose important functions is morale-building, if they should be asked by fellow-officers or soldiers to defend or explain the noncombatant position of the denomination.

Even if it were consistent for Seventh-day Adventist ministers to serve as chaplains in the armed forces, the number who could be accepted to function in that capacity at the present time is limited by government regulations to twenty-seven. We believe that the needs of Seventh-day Adventist boys in the army can best be cared for by the camp-pastor plan which is generally being followed throughout this and other countries. There are many more full-time and part-time Seventh-day Adventist camp pastors than there could possibly be of Seventh-day Adventist chaplains. These ministers are being maintained by the church and not the state. Though it is recognized that camp pastors may not be able to proceed overseas to be with our men in active service, it is also recognized that there is only the very remotest possibility that even Seventh-day Adventist chaplains would be placed in action where they could be of service to the widely scattered and comparatively few Seventh-day Adventist men at the fronts.

Therefore, because it involves a violation of the principles governing the separation of church and state, and for other reasons suggested, the General Conference Committee is seeking in these actions to guide Seventh-day Adventist ministers away from the acceptance of military commissions as chaplains.

We recommend, 1. That this statement concerning Seventhday Adventist ministers and their relation to military chaplaincies be printed and mailed direct to our ministers at the addresses on file in our office.

2. That W.H.Branson, chairman of the War Service Commission, be asked to prepare an article for the Review and Herald, setting forth the steps that have been taken to care for the interests of our men in the armed forces.
