DEATH OF W.E. HOWELL:

Professor Howell has been a member of our General Conference head-quarters staff for many years, carrying various responsibilities in educational lines, and later in other capacities as well. He always responded cheerfully to every responsibility laid won him, and his service in every line of duty was marked by earnest devotion and careful efficiency. Protected risk located within 500' of a public fire hydrant, connected with town or city system of water works and within 2 miles of an available regularly organized fire station. This group embraces towns classed 1 to 6, inclusive by the National Board grading system. Towns classed 7 and 8 should be graded unprotected or on a modified protected basis.

The above lines are also based on adequate insurance to value.

Where risks are sprinklered with a one-source limited volume such as a gravity tank, the board may authorize twice the above lines, and three times the above where the sprinkler system has full A.D.T. supervision. Where the sprinkler equipment is of one-source with unlimited volume, such as city connection, it may be advisable to increase the line to three times the above, and where supervised with full A.D.T. system, to four times the above.

It is understood that where liability covers on a general form of a hospital class or one of our other institutions, that the above mentioned net lines apply to each fire section of such a risk. In other words, calculations are made as to what percentage of the buildings and contents insured are subject to one fire; for example, if this amounts to 25%, four times the indicated net lines on the general form of that particular risk would be written.

1944 INGATHERING MAGAZINE:

The committee that was appointed on the question of the size of the 1944 Ingathering number, in order to conserve paper, submitted the following report, which was adopted:

We recommend, That the size of the Ingathering magazine for 1944 remain the same as last year.

That in order to conserve paper, we recommend the following:

- 1. That the printing order for the regular English edition of the Ingathering issue of the <u>Watchman Magazine</u> be limited to 2,000,000 copies.
- 2. That the Ingathering edition of the Message Magazine be limited to 200,000.
- 3. That the quantity of Singing Band Leaflets be 1,500,000, with the privilege of a re-print if necessary.
- 4. That the Home Missionary Department make very thorough investigation concerning the needed size of printing orders on all foreign language magazines for 1944.

TAX SITUATION IN TURKEY:

VOTED, That a cable be sent to F.F.Oster, of the Turkish Mission, authorizing him to care for the extraordinary expense incident to the new Turkish government law which is exacting exorbitant taxes that our one Swiss and three national workers are unable to pay, /which failure to pay carries severe penalties.

VOTED, further, that information be sought from the various religious societies operating in Turkey as to the manner in which they are meeting this unusual situation.

FILES TO BATTLE CREEK:

The attorneys who are caring for our interests in connection with the Battle Creek Sanitarium affair are desirous that when the case comes up they may have access to any of our denominational documents that have in them references to the origin of the Battle Creek Sanitarium and its operation in the early days of its history.

VOTED, That D.E.Robinson be authorized to take with him to Battle Creek certain files of the Review and Herald and of the General Conference Bulletin, and other similar documents that contain historical references to the Battle Creek Sanitarium.

FRENCH LITERATURE FOR NORTH AFRICA:

Some time ago a letter was received from one of our brethren who was with the military forces in North Africa, drawing attention to the need of French Sabbath School Lesson Quarterlies and other French literature for our own church membership, as well as for the military personnel and prisoners of war in North Africa, and the matter was referred to the War Service Commission for study as to what might be done.

The War Service Commission reports that it is not practicable under present conditions to supply French literature from this side to meet the need which apparently exists in North Africa In view of recent communications from A.V. Olson to the effect that the division office in Bern is still able to maintain contact with the work in North Africa, it was

VOTED, To refer this request for French literature for use in North Africa to the Southern European Division, with assurance to the division that we will gladly assist financially, if they desire assistance, in order to provide this literature, either by having it published in North Africa or in some other way.

SOUTHERN UNION CONFERENCE--PRESIDENT AND FIELD MISSIONARY SECRETARY:
