We recommend, i. The creation of a Council on Industrial Relations for the United States and Canada to consist of five persons appointed by the General Conference Committee, together with such other persons as necessity may require to be appointed by local or union conference organizations, the five persons appointed by the General Conference Committee to constitute the executive committee of the Council.

- · 2. The appointment of an executive secretary of this Council, who shall be one of the five members named by the General Conference Committee.
- 3. This Council shall work in cooperation with our organizations and institutions in the interests of our church members, where such interests are related to industrial organizations and labor unions. It shall carry out a program of education and enlightenment among our membership with reference to the principles which underlie our denominational position regarding our relationship to labor unions.

Recommendations and negotiation necessary in every case before coming. Emphasize our religious and character standards. Satisfactory finance and English Language ability necessary. Letter follows."

A list of our schools was submitted that might be negotiated with relative to taking a number of these students, and this list was also approved.

LANGUAGE STUDY PROJECT:

The plan for conducting special language classes in the Theological Seminary and in the colleges was instituted as a war emergency measure, the object being to have a number of workers prepared to enter certain language areas when the war should end. Now that the war has ended, it has been felt that this plan should be terminated. It was therefore

- VOTED, 1. That in general languages be studied in the fields where the missionary appointees are to labor, which is in harmony with the general practice before the war.
- Arabic or Russian classes, no more students be recruited, and that these classes be terminated with the work now starting; it being understood also that in case of any openings in Arabic or Russian speaking fields, the students in these classes may be sent forward without completing the class work.
- 3. That arrangements for the German class to be opened in December be canceled, and that the workers who were invited to connect with this class be so notified.
- 4. That arrangements be made to subsidize Emmanuel Missionary College and one other college (possibly Atlantic Union College), in order to foster and promote the study of the French language in those colleges, as a policy for preparing workers for French fields.
- 5. That the colleges now teaching languages under the special arrangements through the Missions Advance Committee be notified that this plan terminates with the 1945-46 school year.

PICTURES FOR PROMOTION PURPOSES:

In view of the continual need for pictures for promotion purposes, and inasmuch as the Home Missionary Department is our principal promotion agency, it was

VOTED, That the Home Missionary Department be authorized to gather together and be the custodian of a library of pictures for use by any of the General Conference Departments for promotion purposes.

VOTED, That the Committee on Missions and Evangelistic Films, composed of H.H.Cobban, S.A.Weilman, W.H.Teesdale, J.E. Weaver, A.W.Peterson, C.L.Bond, J.A.Stevens, Paul Wickman and E.D.Dick, with W.A.Butler added, be asked to give consideration to the whole question of pictures for General Conference use, including a general policy for handling the expense.
