CHINA DIVISION -- ACTING PRESIDENT:

At the time our action of October 29 was taken, with reference to leadership of the China Division, in connection with which G.J.Appel was appointed Vice-Chairman of the Division to serve in the field, it was thought that E.L.Longway would be absent from the field until after the General Conference session. Inasmuch as Elder Longway has consented to return to China, to be oresent for the Division Council in March,

VOTED, That E.L.Longway continue to be recognized as Acting President of the China Division in the field, with the understanding that G.J.Aooel will function as Vice-Chairman when Elder Longway leaves the field again.

MEETING OF COLLEGE DEANS AND SUPERVISORS OF NURSES' RESIDENCE:

VOTED, That we authorize the calling of a meeting of College Deans of Men and Deans of Women, and of Sanitarium Sucervisors of Nurses' Residence, for July 31 to August 13.

APPOINTMENTS AND ITINERARIES:

VOTED, That we approve of the following appointments and itineraries:

S. Kaolan, Takoma Park, December 27-30.

W.H.Williams, Mexico, January 8-16, in case it is not possible for W.E.Nelson to go.

H.A. Morrison, visit western colleges.

R.L.Benton, Chicago. Reoresentatives of the Religious Liberty Department, Southern Union.

AUSTRIA AND CZECHOSLOVAKIA--ADMINISTRATION OF:

VOTED, To request the Southern European Division to administer the work in Austria and Czechoslovakia until the time of the General Conference session.

CHARLES ALLAWAY -- PORTLAND BRANCH:

VOTED, To pass on to the North Pacific Union and the Oregon Conference the call from the Pacific Bress Board for Charles Allaway to connect with the Portland Branch of the Pacific Press.

DR. J. WAYNE McFARLAND:

VOTED, To join the Review and Herald Board in appointing Dr. J. Wayne McFarland editor of "Life and Health."

VOTED, That Dr. J. Wayne McFarland be appointed an assistant secretary of the Medical Department for Health Education.

F.D. NICHOL-MEMBER GENERAL CONFERENCE COMMITTEE:

VOTED, That F.D. Nichol be appointed one of the elective members of the General Conference Committee.

SPONSORSHIPS:

VOTED, That we authorize the sponsorship required by the United States government on behalf of each of the following:

For Mr. and Mrs. Max Fuss and three children, in connection with their application for visitors' visa to the United States. Brother and Sister Fuss are workers in Mexico.

For Dr. A.Anderson, of the Skodsborg Sanitarium, in connection with his application for visitors' visa to the United States.

For Charles Samuel Thomas, son of E.D. Thomas, of India, in connection with his application for immigration visa to the United States.

For Gunnar Vetne, of Norway, in connection with his application for immigration visa to the United States.

For Dr. Winston Williams, of Jamaica, in connection with his application for immigration visa to the United States.

NORWEGIAN STUDENTS IN ENGLAND:

VOTED, To authorize the Treasury to advance to the British Union the equivalent of 169 each for five Norwegian

students who are attending our college in England, to cover their school expenses for the current school year, the account to be adjusted when it is possible to exchange funds with the East Nordic Union.

BUILDING PROJECTS IN UPPER COLUMBIA CONFERENCE:

In response to a request from the North Pacific Union on behalf of the Upper Columbia Conference for approval of certain building projects, assurance being given in each case that they will be financed on a cash basis, it was

- VOTED, 1. That we approve of the erection of a building in Spokane to serve as the conference office for the Upper Columbia Conference, at a cost of \$15,000.
- 2. That we approve of the erection of a church building for the Toppenish church, at a cost of \$13,000.
- 3. That we approve of the erection of a church building for the Chewelah church, at a cost of \$7,000.

PUBLISHING HOUSE REHABILITATION:

VOTED, That the Publishing House Rehabilitation program, as adopted by our action of August 29, 1945, be amended to read as follows:

Whereas, In the providence of God, marked prosperity has attended the United States publishing houses, placing them in an unusually strong financial position; and

Whereas, The management of these houses have evinced a deep interest in the work of rehabilitating our foreign publishing plants which have been either destroyed or damaged by the ravages of war, and have requested that definite/projects be assigned to them; therefore

- Voted, I. That we invite the three publishing houses in the United States to undertake the financing of a program of rehabilitation of these destroyed or damaged institutions; and also the expansion of the equipment and facilities of our other mission printing plants which are inadequately prepared to meet the demands of a growing work.
- 2. That a permanent committee be appointed to care for the interests of this expansive program.
- 3. That the following named persons constitute this committee: H.M.Blunden, G.A.Huse, W.H.Williams, L.K.Dickson, W.P.Elliott, L.W.Graham, M.E.Dawson, H.G.Childs, J.L.Jones, E.W. Everest, H.C.Kephart, Nels Nelson,

the

- 4. That in/consideration of the rehabilitation of the Shanghai house and the Manila publishing house, H.L. Shull and J.A. Leland be added to the membership of this committee, and that V.T. Armstrong act in place of J.A. Leland during his absence.
- 5. The resources from which this program shall be effected shall be as follows:
- a. Such gifts as were made in 1944 by the United States publishing houses to the General Conference for rehabilitation.
- b. Such gifts as shall be made to the General Conference by these publishing houses for the purpose of rehabilitation during the time occupied in carrying out the program herein set forth.
- c. The one-tenth of the earnings now being paid by the publishing houses to the General Conference to be earmarked for this rehabilitation work.
- 6. All such publishing house gifts shall be held in reserve by the General Conference treasurer for the purposes named in this resolution and shall be appropriated by the General Conference Committee on recommendation of the Publishing House Rehabilitation Committee, which shall submit with its recommendation the estimated cost of each project, and the organization fostering the project shall not exceed the appropriation granted without further authorization being secured from the General Conference Committee. Withdrawals from the appropriated funds shall be only on the basis of actual expenditures.
- 7. In view of the business advantages and orestige that will accrue to a publishing house in placing orders for export, and paying bills directly, the publishing organization fostering a given project shall act as agent for the General Conference, receiving the funds from the General Conference treasurer for such project, and making settlement for the equipment with its own check.
- 8. The assignments recommended by the Publishing House Rehabilitation Committee shall be limited to the resources of the fund held in reserve for this purpose.
- 9. It is understood that the operation of this program will terminate by December 31, 1948.

PHILIPPINE PUBLISHING HOUSE:

VOTED, To allocate \$50,000 from the Publishing House Rehabilitation funds towards the erection of the buildings for the Philippine publishing house, understanding that detailed

estimates shall be submitted before funds for the completion of the buildings are authorized. The total cost of this project is guaranteed by the Pacific Press Publishing Association.

VOTED, To allocate \$70,000 from the Publishing House Rehabilitation funds for the equipment of the Philippine Publishing House in Manila.

CHINA DIVISION -- WAR SURPLUS SUPPLIES:

VOTED, To allocate \$100,000 from the Rehabilitation Fund to the China Division, for the purchase of war surplus materials, in Shanghai, including hospital supplies and preferably five 50-bed hospital units if these units contain X-ray machines, otherwise the purchase of one 250-bed hospital unit.
