BRITISH UNION--PURCHASE OF HOUSES:

A letter was read from the secretary-treasurer of the British Union Conference, telling of the great difficulty of securing rented quarters for their workers in any of the large cities where they may be called to labor, it being almost impossible to rent anything within working distance of the assignment. In some cases men are compelled to take houses eighteen and twenty miles from the place of their work. Counsel was desired as to the advisability of the Union purchasing houses in a number of cities, so as to have a house available for occupancy when an exchange of workers is made. The plan suggested

is to make a down payment of twenty to twenty-five percent on the cost price, and secure the balance from a Building Society, with payment of the interest and principal over a period of years.

VOTED, That we approve of the purchase of a limited number of houses, in a few strategic centers, by the British Union on the plan as suggested, if they find this to be the only solution of their housing problem, it being understood that the funds will be available without borrowing for the down payment in each case.

SANITARIUM PROJECT IN NORWAY:

We recommend, 1. That conference funds already appropriated and money for the same purpose collected from the public in Norway, be used in the establishment of such an institution.

- 2. That in connection with this sanitarium project, a clinic for Polio cases be established, with facilities for modern treatment, including hydrotherapy.
- 3. That in the development of these plans the brethren in Norway seek counsel from the West Nordic Union, the Northern European Division, and the General Conference, and that in the establishment of the institution the general policy of the denomination be adhered to, in that no commitments be made or buildings erected except as funds are in hand.

FOREST LAKE ACADEMY --- ADMINISTRATION BUILDING:

Request was presented from the Southern Union on behalf of the Florida Conference for approval of the erection of an administration building at Forest Lake Academy, at a cost

of \$50,000, including furnishings. Inasmuch as assurance is given that the Florida Conference has funds sufficient to cover the financing of the project without incurring any indebtedness, it was

VOTED, That we approve of the erection of the proposed administration building at Forest Lake Academy.

REQUEST OF SEMINARY BOARD FOR TAKOMA PARK CHURCH BUILDING:

As agreed upon in the meeting of the Committee on Monday, the early part of this meeting was devoted to a further consideration of the request of the Theological Seminary Board, that the present Takoma Park church building be made available to the Seminary for use of the Department of Practical Theology.

The situation as regards the need for a larger church building for what is known as the Takoma Park Church congregation was reviewed, as well as the need of the Seminary for a building for their use as suggested. Statement was made that a building large enough to accommodate the congregation can be built on the present church lot, and the general feeling was that with that in view it would be better to transfer the present building to the Seminary as requested, if it can be moved to another location, rather than to tear it down in order to make way for the new structure. After a full discussion of the question, it was

VOTED, That it is the consenus of this body that there should be provided enlarged church facilities for the Takoma Park Church by the erection of a new building on the present church site; and further, that the present building should be offered to the Theological Seminary, in harmony with their request.

HIGHLAND ACADEMY -- DORMITORY:

Request was presented from the Southern Union on behalf of the Alabama-Mississippi and Kentucky-Tennessee Conferences, for approval of the erection of a dormitory for the Highland Academy (formerly Fountain Head Academy), at an estimated cost of \$60,000. They have funds on hand to the amount of \$47,550, with which it is estimated they can complete the building to the point where it can be used for the opening of school in the fall, and they give assurance that they will go no farther until the balance is secured.

VOTED, That we approve of the erection of the proposed dormitory for the Highland Academy, with the understanding that the funds in hand are sufficient to make the building usable, and that further work will proceed only as the remaining funds necessary are in hand.

RIVERSIDE SANITARIUM -- OFFERING FOR EQUIPMENT:

VOTED, That Sabbath, October 5, be designaged as the day for an offering to be taken in all the colored churches in North America, ending the campaign among the colored constituency to raise \$60,000 for equipment for the Riverside Sanitarium.

FAMINE RELIEF:

A report from the Famine Relief Committee was presented, and adopted as follows:

We recommend, 1. That Rye Anderson, of Denmark, be asked to assist J.J. Strahle temporarily in relief work in Poland and elsewhere, operating from Denmark.

- 2. That David Rose and J.F.Knipschild, German language students, be assigned to help in relief work in Switzerland and nearby countries, under the general direction of J.J.Aitken; and that F.W.Bieber, German language student, be assigned for relief work in the British occupation zone of Germany, under the general direction of J.J.Strahle.
- 3. That request be made of the Columbia Union and the East Pennsylvania Conference for the temporary services of G.F Thiess, for general relief work in Czechoslovakia.

SALARY AND EXPENSES OF FAMINE RELIEF WORKERS:

VOTED, That the salaries of the German language students who have been assigned to famine relief work be met as heretofore from the Missions Advance Fund which was set up at the Autumn Council; and that their traveling and other expenses as well as the salary and expenses of other workers aside from the German language students, who are assigned to this relief work, be charged to the Famine Relief Fund.

SPONSORSHIPS FOR ALIEN STUDENTS:

VOTED, That H.A.Morrison, Roger Altman, the chairmen of the college boards, the college presidents, and the secretary and treasurer of the General Conference be a committee to give study at the time of the General Conference session to the question of sponsorships for alien young people who apply to our colleges in America for acceptance as students.

T.T. BABIENCO -- BALTIC STATES:

VOTED, That endeavor be made to secure permission for T.T.Babienco to enter the Baltic States in order to contact our work, workers and people in those fields, the Atlantic Union and the Greater New York Conference being requested to grant him a leave of absence for this purpose if such permission is obtained; and that in the meantime Brother Babienco be asked to come to Washington, for counsel especially with reference to our property interests in Poland.

REHABILITATION:

A committee that was appointed to give study to special rehabilitation requests, and to suggest a policy to be presented to the General Conference session for the handling of the rehabilitation funds, submitted a report, which was adopted as follows:

WHEREAS, The funds raised for rehabilitation are not provided for the enlargement of our institutions and staffs, but are for the purpose of repairing material damage and to aid in the transportation of evacuated workers so that we may resume our former operations,

We recommend, l. That the General Conference officers be asked to formulate a general policy for the administration of the Rehabilitation Fund, and to recommend it to the General Conference session.

- 2. That contact be made with all division presidents and treasurers, asking them to submit detailed figures covering rehabilitation needs.
- 3. That no further appropriations, except in cases of immediate emergency, be made from the Rehabilitation Fund until this policy is put into effect.
- 4. That the expenditure of funds already appropriated from the Rehabilitation Fund be suspended, except as provided in paragraph 3, until the policy has been implemented.

To meet the present emergency,

We recommend, That \$8,000 be appropriated to the West Nordic Union for a church building at Tromso, Norway. This sum, together with \$15,000 which has been raised in the field, will provide for the erection of a new church building.

The headquarters of the North Norway Conference is located in Tromso. The buildings formerly occupied by the officers of this conference have been destroyed by bombing and there is little possibility of renting any suitable place for these workers. We therefore

Recommend, That an appropriation of \$11,000 be made to the West Nordic Union for the erection of two housing units in Tromso.

We recommend, That the requests for the Vejlefjord school in Denmark, and for the West Nordic Union school at Unsuruh, be referred to the Autumn Council.

GENERAL CONFERENCE SESSION -- ARRANGEMENTS:

- 4. That H.H.Cobban be requested to arrange for the necessary envelopes.

Stenographic Staff:

VOTED, That Miss Leilafred Ballard be added to the stenographic staff for the session.

Moving Equipment:

VOTED, That H.R.Dixon be asked to oversee the moving of desks, typewriters and other equipment needed during the session, from the General Conference Building to the Sligo Church and College buildings where it will be needed, and its return to the General Conference Building.

Platform Committee for Overflow Meetings:

VOTED, That W.P.Bradley, L.L.Moffitt, R.A.Anderson, R.S.Watts and J.E.Weaver be a committee to serve in the nature of a platform committee for the overflow audiences in the Chapel below the main auditorium in the church, and in Columbia Hall.

SPIRIT OF PROPHECY -- BASIC LIBRARY:

Further recommendations with reference to the Basic Spirit of Prophecy Library were adopted as follows:

- 1. That in the European languages <u>Early Writings</u> be added to the Basic Library list as adopted at the Autumn Council of 1945.
 - 2. That the educational volume be the book Education.
- 3. That Christian Service be added to the Basic Spirit of Prophecy Library volumes.

That for the purposes of the session, the representatives from Holland be grouped with Northern Europe.

That the Northern European delegation be called together by E.D.Dick, and that he act as temporary Chairman.

SELECTION OF NOMINATING COMMITTEE:

The Chairman called attention to the fact that the large institutional interests in the United States are represented by men in the group of delegates at large, and that in the general plan for the selection of the Nominating Committee, there is no provision for representation from this group.

It was agreed that suggestion be made to the session that in the selection of the Nominating Committee, at least one member be chosen to represent the educational, medical and publishing interests respectively.

GENERAL CONFERENCE STAFF:

A recommendation from the Home and Foreign Officers, who have been in session the past few days, was submitted, and adopted as follows:

In view of the intensifying world conditions and the multiplying needs of a rapidly growing work in all lands,

We recommend, That the Nominating Committee of the General Conference session be asked to nominate a General Conference staff that will be adequate to provide for the world-wide needs of our work, it being understood that to make this possible the staff will need, in some instances at least, to be larger than it has been hitherto.

ADMINISTRATION OF THE WORK IN NORTH AMERICA:

A recommendation resulting from a meeting of the Home Officers and the North American Union Presidents was presented and adopted as follows:

We recommend, That the General Conference Committee appoint a small representative committee to study suggestions and plans whereby the methods of carrying forward our work in the North American Division may be strengthened.

VOTED, That the committee called for above be appointed by the Chair,

Appointed: L.K.Dickson, the Union Conference Presidents, H.T.Elliott, W.E.Nelson.

BUREAU OF HOME MISSIONS:

A further recommendation from the Home Officers and the Union Conference Presidents was adopted as follows:

We recommend, That a committee be appointed to give study to the question as to whether the Bureau or Home Missions should be continued as at present constituted, or whether some other plan for the administration of this department of our work should be instituted.

Committee appointed: L.K.Dickson, H.T.Elliott, W.H. Williams, L.Halswick, the Union Conference Presidents.

REHABILITATION ALLOWANCES:

VOTED, On recommendation of the Rehabilitation Committee, to make appropriations to workers who suffered losses through the war as follows:

GENERAL CONFERENCE OFFICE BUILDING:

A committee that was appointed to make a survey of the crowded condition of the General Conference Office Building, submitted the following statement:

Ten years ago the General Conference Office was comfortably filled, and our entire basement, except for the mailing and duplicating departments and vaults, was available for storage space. In the intervening time, the demands of the work have necessitated the addition of from one to three secretaries in several departments of the office, together with the stenographic help required to care for the correspondence of these secretaries. There have also been added to our office the following:

International Insurance Company, with a staff of five persons.

The White Publications with a staff of four persons.

Radio Commission with a staff of four persons.

War Service Commission with a staff of two persons.

Department of Purchase and Supply with a staff of five.

Ten years ago the Purchasing Department was being cared for by Elder L.A. Hansen along with his work as Secretary of the Medical Department; hence the present set-up constitutes an entire addition to the staff as it was constituted ten years ago.

Ten years ago the Bureau of Home Missions Miscellaneous Languages Department and also the German Department were located outside of Washington. Elder Halswick who, as head of the Bureau of Home Missions, carried the work of the Miscellaneous Languages Department, now has his office in the General Conference Building, as does also Elder Ruhling, of the German Department.

World War II has made necessary the carrying on of accounting work in the General Conference Office for overseas divisions which would not ordinarily be done here at all. This has required additions to our staff in order to care for this work. Some officers of overseas divisions have also been accommodated until the way opened for their return to their fields.

Due to an ever-expanding work and our inability to get our printing work done promptly outside of our own office, our printing staff and equipment have been more than doubled during the last ten years, but with no addition of floor space — a need which is keenly felt.

In an effort to accommodate added departments and staff members, rooms formerly used as storage space in the basement have been turned into offices and a number of our larger rooms on upper floors were partitioned off in order to make two small rooms out of one large one. This has been done as much as seemed practicable.

So crowded has our office become that we cannot take care of our present staff as now constituted. Some members of the staff have had only temporary tenure of the space allotted to them, since the room given to them was available only because the one occupying it was away on an extended trip. Upon the return of such person it has become necessary to find some other temporary location for such members of the staff, simply because there was no vacant room to which they could be assigned. Even the employment of an extra stenographer has presented a serious problem, because of the lack of office space. We have been under keen embarrassment because we have had no spare office room which we could offer to visiting members of the General Conference Committee where they could sit down and write and do their work.

The General Conference Committee recently authorized Dr. E.A. Sutherland to come to Washington to act as Coordinator of the Rural School Work in North America, but at present there is no room at the disposal of the General Conference which can be assigned to him and his stenographer.

What was formerly storage space in our basement has been turned into offices, and we are practically without any storage space for supplies or for baggage which frequently is shipped to us by appointees and others who may be passing through Washington This has necessitated filling our halls with materials which at times offer a hazard as well as inconveniencing the work of the office.

At the present time all large shipments of mail or express must be prepared for shipment in our Printing Department, which is already overcrowded, because there is no other place where it can be done. All incoming shipments of freight and express find a resting place in our basement hall until other disposition is made of them.

Altogether, we feel that we have reached a condition which is not only difficult and embarrassing, but it is hindering the efficiency of the work of the office. We believe that this condition can be cured only by the provision of additional office, storage, shipping and printing room space. We appeal for an early consideration of this urgent need.

VOTED, That the foregoing statement and appeal be referred to the Finance Committee of the session.
