FUND FOR EDUCATION OF SWEDISH WORKERS:

Reference was made to the action of June 28, 1945, having to do with fulfilling obligations to the Swedish constituency, in view of the money which was collected from them when the Broadview College and Theological Seminary was established. Part of this action reads as follows:

"\$10,000 to be set up as a fund to assist in the education of Swedish workers, including those in America for whom arrangements may be made to study in Sweden or vice versa; the fund to be administered by the Swedish Missionary School."

VOTED, That the last phrase of the foregoing paragraph be amended to read: "the fund to be administered by the General Conference Committee, through the Home-Foreign Bureau."

G.H.NELSON--SWEDEN:

VOTED, On recommendation of the Home-Foreign Bureau, that arrangements be made for G.H.Nelson, of the New York Conference, to go to Sweden for study, under the plan which provides assistance to be given workers in preparing definitely for work among the Swedish people.

COMMITTEE ON DISPLACED PERSONS:

VOTED, That there be hereafter one committee on Displaced Persons instead of two as heretofore, the personnel of this committee to be as follows: E.D.Dick, W.E.Nelson, M.C.Taft, H.H.Votaw, W.K.Ising, A.V.Olson, L.H.Christian, Roger Altman, H.W.Lowe, W.E.Read, J.J.Strahle, N.C.Wilson, W.H.Williams, H.T.Elliott, H.H.Cobban.

RYE ANDERSON--RELIEF PROMOTION:

VOTED, That in response to the request of the Northern European Division, we release Rye Anderson for one month from our general relief work in Europe, in order that he may assist in promoting the relief offering to be taken in Northern Europe.

CHANGE IN STATUS OF FORMER GERMAN MISSIONARIES:

A committee that had been appointed to counsel concerning the future of the former German missionaries who are now in America made a number of suggestions with reference to possible plans for these workers, which would involve in most cases a change in their residence status in the United States. It was

VOTED, That Roger Altman be authorized to go to Mexico, if necessary, C.L.Torrey or C.L.Bauer being asked to accompany him, to make contact with the proper officials with reference to changing the status of these German workers in the United States.

GRANTING OF SPONSORSHIPS:

The committee on the question of sponsorships submitted a recommendation, which was adopted as follows:

In view of a change in status of many of those sponsored, thus relieving the General Conference of its responsibility in connection with the sponsorship extended, and in view of the fact that it would be rather difficult to lay down a policy that would be workable in all cases.

We recommend, That no policy dealing with the sponsorship question be formulated at this time, but rather that the practice be followed of securing first the recommendation of the Division in which the alien resides before the General Conference enters into the responsibility of sponsorship.

DR. THEODOSI SHIVOTENKO AND FAMILY--SPONSORSHIP:

VOTED, To extend the sponsorship required by the Government on behalf of Dr. and Mrs. Theodosi Shivotenko and their two daughters, Adventina and Angelina, in connection with their application for visa to the United States. Dr. Shivotenko and his family are displaced persons from the Ukraine, now in Munich.

SPONSORSHIPS:

VOTED, On recommendation from the Southern European Division, to extend the sponsorship required by the Government on behalf of Miss Lucette Winandy, of Luzern, Switzerland, in connection with her application for visa to the United States.

VOTED, To extend the sponsorship required by the Government on behalf of C.H.Chen, M.D., of China, in connection with his application for immigration visa to the United States. Doctor Chen has a student visa, but this will not permit of his taking a hospital residency, which he desires.

COLORED ACADEMY IN NEW YORK:

Request was presented from the Atlantic Union on behalf of the Northeastern Conference, for approval of the purchase of a property in New York City, in which to conduct an academy for the colored young people who are coming out of the church school. The property is a two-story brick building in good condition, which can be secured for \$37,500, the funds for its purchase being provided by the union and local conference and the local church.

VOTED, That we approve of the purchase of the property as described for a colored academy in New York City, on the understanding that the purchase price is underwritten by the union and local conference.

LOMA LINDA ACADEMY BUILDING:

Request was presented from the Pacific Union for approval of the construction of a new building for the Loma Linda Academy, at a cost of \$75,000, the necessary funds being in hand.

VOTED, That we approve of the construction of the new building for the Loma Linda Academy, to replace the one destroyed by fire.
