They have \$6,782 cash in hand, and expect to receive the balance from the sale of the old church property, which the congregation has outgrown.

VOTED, That we approve of the purchase of the proposed building for the Savannah colored church, with the understanding that with the amount of cash on hand and the proceeds from the sale of the old property they will have the full amount necessary to cover the purchase price.

LITERATURE SALES RESTRICTIONS:

Word has come from the Southwestern Union that enforcement of an ordinance in New Mexico, somewhat similar to the Green River Ordinance, is causing our colporteurs considerable embarrassment, to such an extent that they have been compelled to cease work in the cities of Raton and Gallup. In view of this the Texico Conference is requesting that steps be taken to safeguard our constitutional rights in the matter.

SANITARIUM IN PUERTO RICO:

The completion of this unit, it is hoped, will make for the success of a special solicitation campaign which is being launched, through which they hope to raise \$40,000 toward the completion of the project.

VOTED, To make an appropriation of \$26,000 to the Inter-American Division, for the benefit of the Andrews Memorial Hospital and Clinic in Kingston, Jamaica.

MEXICAN UNION--\$5,000:

VOTED, That in order to meet some of the most pressing needs in the Mexican Union, due to the very great increase in the cost of living in that country, an emergency appropriation of \$5,000 be made to the Inter-American Division for the Mexican Union.

RATE OF EXCHANGE FOR THE LIRA:
