- 4. Foreign missionaries and their wives who may be in attendance and who may be appointed as delegates at the Session.
- 5. It is understood that the providing of entertainment for a worker's wife at the Session shall not obligate the General Conference for the wife's transportation unless the wife has been definitely included in the invitation to attend the Session.

Prayer by C.S.Longacre. Minutes of meetings held April 28 and May 1 were approved.

ELMSHAVEN:

VOTED, To appropriate \$375 to meet the expense of repairing the road to the parking lot on the Elmshaven property, and that help be provided in the way of guides at the time of the General Conference Session,—one guide for three weeks and an extra guide during the actual time of the Session; all of this expense to be charged to the Contingency Fund. Further, that the Pacific Union be asked to give consideration to the question of the future of the Elmshaven property.

M.V.JACOBSEN--ADJUSTMENT OF ACCOUNT:

VOTED, That there be charged to the Contingency Fund an item of \$287.50, in adjustment of M.V.Jacobsen's account, who suffered loss through improper handling of his personal effects when he went to Iran in 1945, and he having been unable to collect from the packing company.

CHARLES L.SMITH:

Due to lack of full information when the Canadian Union called Charles L.Smith to take the presidency of Oshawa Missionary College, and the fact that now after but a short period of service his condition of health makes it necessary for him to retire, the Canadian Union asks the General Conference to join them in making it possible for him to receive the equivalent of a full salary for one year from the time he gives up his work.

VOTED, That following the six months during which the Canadian Union will pay full salary to Charles L. Smith before he is placed on the Sustentation Fund, his sustentation allowance be supplemented to a full salary for a period of six months, the same to be charged to the Contingency Fund.

MURIEL HOWE--EXTENSION OF FURLOUGH:

VOTED, That the furlough of Miss Muriel Howe from China be extended to June 30, 1951, with the understanding that the responsibility of the China Division for her salary will terminate as of September 30, 1950, and that the General Conference will provide for her support from that date until her assignment to some other field.

OFFERING FOR MISSIONS--JULY 22:

VOTED, That in harmony with a recommendation from the union conference presidents, an offering for missions be taken in all our churches at the time the offering is taken at the General Conference Session, on Sabbath, July 22; and that the offering for Elementary Schools which is now listed for July 22, be taken on July 8 instead of the Second Sabbath Mission Offering.

VOTED, That the Committee on Promotion of Offerings be asked to take the responsibility of notifying the field relative to this arrangement for the mission offering and the offering for elementary schools.

VOTED, To refer to the meeting of the Home and Foreign Officers in San Francisco preceding the General Conference Session the suggestion that at every General Conference Session the offering for missions be taken on the second Sabbath of the Session, and that such an offering be taken in all the churches on the same date.

GENERAL CONFERENCE SESSION--INVITATIONS:

VOTED, That Mrs. W.H.Anderson and L.V.Finster, retired workers, be invited to attend the General Conference Session.

CENERAL CONFERENCE SESSION--DELEGATES AT LARGE:

The Secretary presented a list of names suggested for appointment as delegates at large to the General Conference Session, and it was

VOTED, That these names be referred to the meeting of the Executive Committee in San Francisco, preceding the Session.

CIVILIAN DEFENSE AND DISASTER RELIEF:

Recommendations from the War Service Commission relative to a nation-wide program in the United States for Seventh-day Adventist churches, conferences and institutions, on civilian defense and disaster relief, were presented, and adopted as follows:

We recommend, 1. That the War Service Commission be authorized to give leadership in the United States in the creation of a nation-wide program in our churches for civilian defense and disaster relief in cooperation with official defense agencies in states and cities.

- 2. That each union and local conference be requested to select and appoint to leadership in the relief program for their fields some person from among their present employed personnel.
- 3. That this leadership on the national level include the assembling and passing on of information of governmental planning and suggestions; counseling with those appointed to leadership in union and local fields about ways and means of organizing state and local programs of defense and relief in cooperation with state defense organizations; and the recommendation of government manuals and texts, together with the preparation of a manual of our own, for the training of our members in the various courses of relief activities.
- 4, That the Missionary Volunteer, Home Missionary, Medical and Educational Departments of the General Conference be requested to join forces with the War Service Commission in framing programs for cooperative efforts in planning and training civilian relief workers; and that these departments inform their respective workers in the various fields of the importance and necessity of these programs, in the endeavor to stimulate full cooperation on the part of churches, Missionary Volunteer Societies, Societies of Missionary Men, Dorcas Societies, doctors, dentists, and nurses, colleges, academies, church schools and teachers, in training and preparing our people, young and old, in the field of civilian defense and disaster relief activities.
- 5. We recommend authorization for establishing a course of instruction to prepare leaders to implement this program.
- 6. We recommend, That the boards of our colleges and academies make provision now for putting Medical Cadet training into their institutional program with the beginning of the next school year.

FRANCIS AVERY--ATLANTIC UNION:

VOTED, To pass on to the Southern Union and the Florida Conference the call from the Atlantic Union for Francis Avery, for the pastorate of the New England Sanitarium church.

W.L.GOFFAR--BUREAU OF VISUAL EDUCATION:

VOTED, To pass on to the North Pacific Union and the Upper Columbia Conference the call from the Pacific Union for W.L.Goffar to connect with the Bureau of Visual Education.

CARE OF JEWISH BELIEVERS IN ISRAEL:

B.Farnstrom, who has charge of our work in Israel, has asked for some help for a short time in caring for the number of believers who are in the Jewish refugee camps in that land. He reports that a Brother E.Landa, of the Southern European Division, who is in the country visiting some relatives, would be willing to remain a short time to engage in this work. The Middle East Union has also signified a willingness to meet the salary of G.C. Winslow for two months if he were to spend that amount of time in Israel before returning home. It was

VOTED, That request be placed with the Southern European Division for the services of E.Landa in Israel for a month or two. In case this cannot be arranged, that we accept the offer of the Middle East Union for G.C. Winslow to spend two months in Israel before returning home.

TIBET AND DR. R.H.DUNN AND WILLIAM HILLIARD:

When workers were being transferred from China to other divisions, Dr. R.H.Dunn and William Hilliard were assigned to the Southern Asia Division, to spend the time in studying the language until permits could be obtained for them to enter and open the work in Tibet. There now seems no possibility of such permits being granted, at least not for some time to come. It was therefore

VOTED, To counsel the Southern Asia Division to have Dr. R.H.Dunn connect temporarily with the Karachi Hospital, in West Pakistan, and to assign William A.Hilliard to evangelistic work in one of the unions of the Division.

VOTED, further, to refer the question of attempting to open the work in Tibet at the present time, to the Home and Foreign Officers when they meet in San Francisco.

JOINT COUNCIL ON RELIGIOUS LIBERTY
OF THE FOREIGN MISSIONS CONFERENCE--\$500:

VOTED, That an appropriation of \$500 be made as from the Religious Liberty Association to the Joint Council on Religious Liberty of the Foreign Missions Conference.

Prayer by T.E.Lucas. Minutes of the meeting of May 22 were approved.

PORTLAND SANITARIUM:

Approval was given some time ago for the erection of a much needed addition to the Portland Sanitarium. The work of construction has been going forward, but is costing more than was anticipated so that it will not be possible to finish and equip the addition with the funds in hand. A Federal grant in aid is available under the Hill-Burton Act to the amount of \$179,000, which will care for all the needs.

Inasmuch as the 1949 Autumn Council action relative to government grants for capital development of medical institutions states that such grants shall be accepted only after approval of the General Conference Committee, the North Pacific Union Committee and the Portland Sanitarium Board now place their request for such approval.

It was moved and seconded, that we approve of the request of the North Pacific Union relative to acceptance of a Federal grant in aid on behalf of the Portland Sanitarium as being within the provisions of the 1949 Autumn Council action.

The motion carried, a majority voting in the affirmative. The following members asked to have their names recorded as opposing the motion: H.H.Votaw, F.H.Yost, C.S.Longacre, M.C.Taft, F.D.Nichol, Paul Wickman, M.K.Eckenroth.

ORLANDO CHURCH SCHOOL:

Request was presented from the Southern Union on behalf of the Florida Conference for approval of the erection of an addition to the Orlando church school building, at a cost of \$12,500. The school is a union school serving three churches. They have \$8,500 cash in hand and pledges from the three churches for the balance. Assurance is given that construction will proceed only as the funds are available, so that no indebtedness will be incurred.

VOTED, That we approve of the erection of the proposed addition to the Orlando church school building.

SPENCERVILLE CHURCH BUILDING:

Request was presented from the Columbia Union on behalf of the Chesapeake Conference, for approval of the erection of a church building for the church at Spencerville, Maryland, with a seating capacity of 350. The church has a lot paid for and \$4,100 cash in hand. They have gift contracts for the plumbing, plastering, and electrical work, and pledges of other labor. They wish to use the cash in hand to purchase cement blocks and brick to begin the work of construction, giving assurance that they will proceed only as the funds become available and that no indebtedness will be incurred. The Chesapeake Conference states they will underwrite the project.

VOTED, That we approve of the erection of the church building for the church at Spencerville, Maryland, as proposed.

BAGHDAD HOSPITAL:

Letters were read from R.H.Hartwell and E.S.Cubley, of the Middle East Union, reporting the Iraq Government willing to donate 22,000 square meters of land in the city of Baghdad, on which to erect the Baghdad Hospital, a straight deed to be given for the land on the following conditions:

- 1. That the buildings erected shall be worth twice the value of the land, which is estimated at from \$40,000 to \$50,000.
- 2. That poor people as well as the rich shall be tared for.
- 3. That in case our work should be discontinued in Iraq, the Government be given the first opportunity to buy the buildings and to reclaim the land without charge.

VOTED, That we approve of the acceptance by the Middle East Union of the land offered by the Iraq Government on which to erect the Baghdad Hospital.



INGATHERING EMBLEM:

VOTED, That a permanent emblem be adopted, as suggested by the Home Missionary Department, for general use in connection with the Ingathering promotional work; the details relative to the design being referred to the Ingathering Committee.

B.PEREZ-TRANSPORTATION EXPENSE:

VOTED, That the Treasurer be authorized to meet the transportation expense of B.Perez from Guatemala City to Panama and Venezuela and return to Guatemala. Brother Perez is conducting evangelistic meetings in Guatemala, but is making the trip to Panama and Venezuela in the interests of the calendar question.

A.G.ZYTKOSKEE--EXTENSION OF FURLOUGH:

VOTED, That on recommendation of the Middle East Union Committee, the furlough of A.G.Zytkoskee be extended to the end of October.

SAMUEL ALBERRO--ARIZONA:

VOTED, To pass on to Samuel Alberro, of South America, now attending Emmanuel Missionary College, the call from the Pacific Union to connect temporarily with the Arizona Conference for Spanish work, it being understood that this does not change the status of Brother Alberro as a worker belonging to the South American Division.

MINNIE DAUPHINEE--ST. HELENA SANITARIUM:

VOTED, To pass on to the Washington Sanitarium the call from the Pacific Union for Miss Minnie E. Dauphinee to connect with the St. Helena Sanitarium as dean of nurses.

MR. AND MRS. J.C.TURNER--MADISON COLLEGE:

VOTED, To pass on to the Central Union Conference and Union College the call for Mr. and Mrs. J.C. Turner to connect with Madison College.

MR. AND MRS. J.M.ACKERMAN--MADISON COLLEGE:

VOTED, To pass on to the Central Union and the Nebraska Conference the call for Mr. and Mrs. J.M.Ackerman to connect with Madison College.

MR. AND MRS. KYELL ERICKSON-LAKE GENEVA SANITARIUM:

VOTED, To pass on to the Northern European Division the call from the Southern European Division for Mr. and Mrs. Kyell Erickson, nurses, to connect with the Lake Geneva Sanitarium, at Gland, Switzerland.

L.A.WHEELER--PERMANENT RETURN:

VOTED, That on his request and in harmony with the recommendation of the Inter-American Division Committee, we authorize the permanent return of L.A.Wheeler from Guatemala.

KENNETH FLECK--GUATEMALA:

VOTED, To request the North Pacific Union and the Upper Columbia Conference to release Kenneth Fleck, to connect with the Inter-American Division, to serve as president of the Guatemala Mission.

GOH ENGH WA-BURMA:

VOTED, To pass on to the Far Eastern Division the call from the Southern Asia Division for Goh Engh Wa, of Singapore, to connect with the work in Burma as a self-supporting colporteur.

PAULINE PJORLIE--RANCHI HOSPITAL:

VOTED, To invite Miss Pauline Pjorlie, of Oakland, California, to connect with the Southern Asia Division, in response to the call for a nurse for the Ranchi Hospital.

MARCELLA E.DUERKSEN---RANGOON HOSPITAL:

R.C.DINNING-MIDDLE EAST UNION:

VOTED, To invite R.C.Di ming, of Eugene, Oregon, to connect with the Middle East Union Mission, to serve as manager of the Middle East Union Press.

ASSISTANCE TO MISSIONARIES ON EDUCATION OF CHILDREN:

Question having arisen relative to the application of the policy pertaining to assistance for education of older children of missionaries [paragraph 2, page 99, of the Working Policy], where children attend one of our self-supporting schools, it was

VOTED, That it is our understanding that this policy was not designed to prevent the making of educational grants to students who attend our self-supporting schools, but rather to preclude the application of such grants to students who might attend non-Adventist schools. Therefore parents who choose to send their children to our self-supporting institutions should receive the regular educational assistance as provided in the policy.

MAGAZINE LEADERS SUBSIDY:

VOTED, That the following recommendations which have been accepted by the Publishing Department, and which have been in operation between the publishing houses and their respective fields, be adopted as the basic working plan for magazine leader subsidies, and that the plan adopted in the meeting of March 30, 1950, be regarded as a temporary experiment; and further, that this series of recommendations hereby recorded be submitted to the next Autumn Council for confirmation:

- l. That conferences which employ magazine assistants and desire financial assistance from publishing houses arrange for such assistance through the publishing house in whose territory they are located.
- 2. When arrangements are made with a publishing house for the appointment of a magazine leader in any conference, that publishing house shall immediately pass information to the other houses giving name of leader and any other necessary details.
- 3. That the total assistance rendered by publishing houses to conferences for a magazine leader be \$10.00 per week if a minimum of 4,000 magazines per month is sold, or \$15.00 per week if a minimum of 6,000 magazines per month is sold.
- 4. The division of the amount paid by the publishing houses shall be on the ratio of retail value of magazines purchased by Book and Bible Houses during the calendar month for single copy sale.

- 5. That each month the Book and Bible House shall send a complete report of all magazines purchased for single copy sale to each publishing house interested.
- 6. It is understood that after three months, if this support by publishing houses is to be continued to a conference, the total single copy sales in a field where a magazine leader is chosen on the above basis, must be not less than 4,000 copies per month. Where the magazine worker takes subscriptions, 12 single copies should be reckoned in this total for each yearly subscription.
- 7. The above plan does not admit any magazine subscription taken by book colporteurs on the combination plan or miscellaneous magazine business done by members of our churches. All such magazine business should be excluded.

FRANCIS COSSENTINE -- FOREST LAKE ACADEMY:

VOTED, To pass on to the Central Union and the Kansas Conférence the call from the Southern Union for Francis Cossentine, of Enterprise Academy, to connect with Forest Lake Academy as head of the Music Department.

B.J. SAVAGE--WYOMING:

VOTED, To pass on to the Pacific Union and the Southeastern California Conference the call from the Central Union for B.J.Savage to connect with the Wyoming Conference as Home Missionary and Publishing Department Secretary.

APPOINTMENTS AND ITINERARIES:

VOTED, That we approve of the following appointment for C.E.Meniger: meeting of American Association of Theological Seminaries, Columbus, Ohio, June 12-14.

VOTED, That we approve of the following appointment for Dr. E.A.Sutherland: Bethel Academy, June 10, en route to the General Conference Session.

SOUTH CHINA ISLAND UNION -- INGATHERING FUNDS:

VOTED, That we approve of the South China Island Union Mission using their 1950 Ingathering funds in establishing the work in the Portuguese island of Macao.

SPONSORSHIPS:

VOTED, On recommendation of the Northern European Division Committee, to extend the sponsorship required by the Government on behalf of Magne Yngvar Rosen, of Norway, in con-

nection with his application for visa to the United States. Elder Rosen is coming to America to take some work in the Theological Seminary.

VOTED, On recommendation of the Northern European Division Committee, to extend the sponsorship required by the Government on behalf of Helge Reinhold Lindberg, his wife and two children, of Sweden, in connection with their application for visas to the United States. Elder Lindberg is planning to spend some time in the Seminary.

YUBA CITY CHURCH SCHOOL BUILDING:

Request was presented from the Pacific Union for approval of the erection of a church school building for the Yuba City church, at a cost of \$8,500. This figure is fully covered by cash, lumber and other material in hand, and pledges of donated labor.

VOTED, That we approve of the erection of the proposed church school building in Yuba City, California.

VICTORVILLE CHURCH SCHOOL BUILDING:

Request was presented from the Pacific Union for approval of the erection of a class room at the Victorville church school, at a cost of \$8,000. They have \$3,675 cash in hand, the conference is appropriating \$2,667, and they have bona fide pledges for \$1,658.

VOTED, That we approve of the erection of the class room as proposed as an addition to the Victorville, California, church school building.

LA SIERRA COLLEGE---BOYS! DORMITORY:

Request was presented from the Pacific Union on behalf of La Sierra College, for approval of the erection of an addition to the boys' dormitory, at an estimated cost of \$50,000, to be financed from the union conference building fund during the present year, the union to advance the funds as soon as they are ready to proceed with the work.

VOTED, That we approve of the erection of the proposed addition to the boys' dormitory at La Sierra College.
