Harris and his wife, Mary Harris, now desire the General Conference to accept their stock at this time in preference to further delay, and inasmuch as the General Conference Committee was empowered by the agreement at the time of the 1951 Spring Council to make final decision in the matter,

VOTED, That the offer of Clyde H.Harris and Mary Harris to assign their stock in the Harris Pine Mills to the Seventh-day Adventist denomination be accepted as from this date, and that the General Conference Corporation be asked to take the necessary action in connection with the acceptance and transfer of said stock.

VOTED, That in accepting the gift of the stock in the Harris Pine Mills, it is understood that 75% of the profits from the business will accrue to the General Conference, 15% to the North Pacific Union, and 10% to the Upper Columbia Conference, all to be used in connection with their regular church work.
