EXCHANGE RATE ALTERATIONS:

VOTED, That as of January 1, 1954, denominational fixed rates of exchange be set as follows: Lebanese pound, US \$0.32; Turkish pound, \$0.25; Iranian Rial, \$0.015.

AARON LEVY AND WIFE -- APPROPRIATION TO:

VOTED, That while recognizing that that which Mr. and Mrs. Aaron Levy have done to assist in connection with the work of the Israel Mission has been done entirely on a voluntary basis, and that in consequence they have no claims on the denomination for any remuneration in respect to the service that they have rendered, we grant them the sum of 1,000 Israeli pounds, this sum to be made available to them through J.O.Wilson upon their having vacated Advent House, and having signed a statement to the effect that they recognize that neither the Israel Mission nor the General Conference is in any way obligated to them because of that which they have done in connection with the work in Israel.

- VOTED, 1. To approve plans for Dr. J. W.McFarland to connect with the London, England, evangelistic effort during March and April, 1954.
- 2. To request the Southern European Division to arrange for Dr. J. Nussbaum to visit Finland as requested by the Northern European Division, and Turkey and Syria as requested by the Middle East Division, the time of these visits to be determined by the Division.

LIQUOR ON MILITARY INSTALLATIONS-APPRECIATION OF NEW DIRECTIVE:

On September 4, 1953, Major General William E. Bergin, Adjutant General, issued an order authorizing the sale of alcoholic beverages on United States army posts. As a result of the vigorous protests that were made against this order to the President of the United States and the Secretary of Defense by this Committee, by other churches, and by temperance organizations, a directive has now been issued, by Roger M. Keyes, Deputy Secretary of Defense, not only repealing the Adjutant General's order, but prohibiting the sale of bottled and packaged liquor on all United States military installations—army, air force, and naval.

VOTED, That we express to the Government officials directly responsible for this directive our sincere appreciation for the valuable service that they have rendered in this matter to this country and particularly to the young men and women in the armed services.

AUDREY ASHBY -- TEXTBOOK COMMITTEE:

VOTED, To request the North Pacific Union and Oregon Conference to arrange for Miss Audrey Ashby to work with the Bible Eight Textbook Committee which is to convene in Takoma Park July 5 to August 27, 1954. Her salary, transportation and expenses will be met by the General Conference Textbook Fund.
