W. E. Murray, Chairman, read from Acts 20, portions of verses 18-24. Paul said to the elders of the church at Ephesus that he had been with them at all seasons, serving the Lord with all humility of mind, and with many tears, and temptations, which befell him by the lying in wait of the Jews, and that he had kept back nothing that was profitable unto them. These are very wonderful declarations of a man who had profound faith in God, who had served as a minister of the gospel for many years, had endured persecutions, and was coming near to the close of his ministry, and who was enabled to give the ones who had followed in the ministry some very good instruction and very good food for thought.

Elder Murray spoke of the sharing of experience the apostle Paul must have had with his brother ministers. He had visited from house to house. What a profitable ministry he must have had. He spread abroad this wonderful ministry that he had. He testified to the Jews and also to the Greeks repentance toward God and faith toward the Lord Jesus Christ. What a wonderful truth is bound up in these few words--"repentance toward God, and faith toward our Lord Jesus Christ." In those two expressions are bound up the history of the apostle Paul's teaching. He preached the gospel; and though bonds and afflictions awaited him, he still had a great spirit of courage, even down in the house of Caesar at Rome. We are in the same ministry, and should have the same courage, and preach the same gospel.

Then we shed glory, in our weak and humble way, on the great principles of the kingdom.
