God help us every day in our experiences to stand firm in His truth, recognizing the obstacles, but also confiding in His grace.

On June 13, 1963, the appointment was voted, with the understanding that the North American Division would be regarded as his home base. The Trans-Africa Division desires clarification regarding the Sustentation responsibility and rate.
