## DEVOTIONAL SERVICE:

M. S. Nigri, Chairman, stated it was his privilege to spend nine days in the Greater New York Conference, visiting eight of their thirteen Latin American Spanish churches, and one Brazilian church in Irvington, New Jersey. This was his first direct and official contact with these churches and their workers. New York City still impresses him as a giant that has not yet been conquered. No doubt New York City can be considered the most concentrated mission field we have here in America and the most cosmopolitan Adventist area in the world. It is like a city of refuge which lodges everyone. New York City is the Babel of the 20th Century, and there we have the most challenging and difficult field to evangelize in the world.

The Greater New York Conference has almost 6,000 SDA's, and the regional churches in New York City have about 8,000, or a total of 14,000 SDA's. In order to see the complexity of the problem there, you need to know that 46% of the Adventists of the Greater New York Conference are Latin-Spanish speaking members, the largest and perhaps the most progressive Adventist group in that conference; 36% of other foreign members and 18% of white Americans. The Spanish churches are open Sabbath, Wednesday night and also Sunday nights for evangelism.

Elder Nigri read quotations from <u>Life Sketches</u> and <u>Evangelism</u> concerning the work in New York City. The youth in these Latin churches of NYC with their pastors are going to the front, burning with zeal and fervor, working, preaching and winning souls. Were Jesus here, perhaps He would speak to us in this manner: "I tell you, lift up your eyes, and see how the fields in New York City are already white for the harvest" (John 4: 35). This is why Elder Nigri has

advised the Greater New York Conference that he has chosen New York City as the field where he wishes to spend some time in revival and evangelism as his contribution to the program of Mission '72.

In response to an inquiry by the Chairman as to prayer requests, J. J. Aitken, Radio-Television Department Secretary, referred to the special issue of the Review and Herald which came out recently, in which an article appeared on the front page in regard to Adventist world radio. He suggested the item of offerings for the Radio Trans-Europa broadcast be made a subject of prayer. It is not planned that a special offering be taken. The suggestion is that as God impresses hearts through prayer the offerings come in. Just recently \$7,500 was received.

#### DEVOTIONAL SERVICE:

F. L. Bland, Chairman, referred to the statement in the Bible (Luke 18: 1) that calls our attention to the fact that men ought always to pray and not to faint. Many times there are problems confronting individuals and the Church. If we can just take time to think and recognize that God hears and answers prayers, our problems would not be nearly so great in our estimation as we at times think they are, but we would recognize that our God is much greater than any problem that might confront us. Many times we pray to God for certain things and God hears and answers our prayers. Many times we go on our way forgetting to say "Thank you." We can look into our own experiences and see where we have prayed for certain necessary things, and God has heard and answered our prayers. Let our prayer also be a prayer of thanks. Each one knows for what he needs to thank God.

A number of prayer requests were made, and also an expression of thankfulness for answered prayers was given.

## REPORTS:

C. D. Watson, Temperance Department Associate Secretary: It is difficult to condense into two minutes a report of a visit to the Australasian Division which extended over two months. The overall impression was how very well established the Church has become in Australia, New Zealand and the island mission territories. It was a thrilling experience to visit Avondale College where the Lord's Messenger had guidance in the selection of the site, and some of the mission territories which have produced such thrilling chapters in denominational history.

The temperance work is on a very sound footing. We discovered everywhere that health authorities, school and church leaders appreciated the Seventh-day Adventist literature and the positive point of view in educational materials.

The news media gave us very considerable coverage, presenting our positive attitude towards health as the answer to the problems of dependency on alcohol, tobacco and narcotic drugs. On one occasion Pastor Ron Taylor was asked by the television interviewer, "How is it the Seventh-day Adventists have always taught that tobacco is injurious to health, whereas medical science has only come to recognize this during the last ten years?" A significant question which indicates that we have in this and other areas the advantage of information which should keep us at the head of all true reform. Alcoholism foundations, Roman Catholic bishops, university medical associations are finding the Australasian temperance magazine, Alert, not only useful for source material, but also for distribution amongst their organizations to help combat the inroads of dependency and addiction.

Pastor Ron Taylor, the Division Temperance Secretary, was recently appointed President of the New South Wales Temperance Alliance, and is the only clergyman on the New South Wales government committee on drug addiction. His leadership in this work is winning respect and confidence for the Church.

The ministry and members are recognizing how effective the temperance approach is in reaching the public today. Several evangelists are opening their evangelistic campaigns with meetings on the causes of drug addiction and alcoholism, advertising under such titles as "Don't Blame the Children," and using some of the drug films produced by the department.

Miss Mazie Herin, Health Department Associate Secretary: In the Far Eastern Division I traveled with Maxine Atteberry, the Nurse Consultant for that Division, and Maureen Maxwell, of Loma Linda University. This is the first time that I have been able to travel with two other nurses, who could share with me the work and the pleasures of such an itinerary.

This was my second visit to the Far Eastern Division and it was interesting to note the changes that have been made during the seven intervening years. Progress makes us happy and I saw much progress in some of the schools of nursing and in the hospital nursing services. In some places there were problems because of the large numbers of patients coming to our hospitals where we did not have the facilities and the nurses to care for them. This situation seemed to reverse in some other hospitals where we found so few patients that we wondered how long the institutions could operate.

The division has scheduled special meetings to discuss the medical work and the schools of nursing in that division.

Today I bring you greetings from the many workers in the Far Eastern Division, and ask that you remember them in your prayers.

### DEVOTIONAL SERVICE:

Following a welcome to those present and especially to a number who have returned from visits to overseas divisions, <u>W. J. Hackett</u>, Chairman, read from J. B. Phillips' translation of the Bible Galatians 5: 16-23. He stated we all have a battle between the higher and lower nature. He emphasized the necessity of being led by the Spirit, and particularly of our exercising patience, listed as one of the fruits of the Spirit. If we can follow the instruction given in these verses we will be men of God.

Opening prayer by W. P. Bradley.

## REPORTS:

E. W. Pedersen, General Conference Field Secretary, expressed his happiness in bringing Christian greetings from our 7,250 believers in Cuba. He had a wonderful and most interesting time while in that country, having entered on the basis of a tourist, and as a Danish citizen.

He outlined in detail helpful contacts which he was able to renew with certain government leaders, whom he had first met when he visited that country three years ago. They were both friendly and helpful.

He stated that though the Cuban concept of religious liberty is a little different from that of ours, the freedom of conscience is respected and the various churches enjoy full freedom to preach the Word of God in their registered places of worship. Our own Church has good relationship with the government.

A strong evangelistic program is being carried out throughout the country. All meetings are held in our churches and are not advertised. Even so 814 were

baptized last year (the highest ever), and the goal for 1971 is no less than 1,000 souls. Already during the first quarter 118 were baptized. While the membership of some other churches is going down, ours is not only holding its own, but is on a steady increase in spite of the fact that many of our members are still leaving the country--161 in 1970 alone.

Our ministers are registered as self-employed persons, and regular reports --financial, statistical, and personnel transfers--are submitted to the government

In 1968 a small seminary was re-opened at our Cuban headquarters in Havana under very primitive conditions and as an act of faith. Some students who lacked one and two years to graduate, when Santa Clara College was taken over, and were given work, returned to school. Fourteen of these have already graduated and joined the ranks of our regular working force.

In spite of some difficulties with Sabbath observance, our children and youth are loyal and true to the message. We have a very high percentage of young people in our churches. Finer young folk are not found anywhere. Indeed, all our brethren and sisters in Cuba are wonderful Christians that love their Lord and the message. Theirs is a spirit of devotion, of loyalty and sacrifice.

<u>V. W. Schoen</u>, Lay Activities Department Secretary, brought official greetings to the Committee from two Division fields—the great, booming South American Division and the Trans-Africa Division.

His was the privilege to visit three of the largest unions we have in the world field outside of the United States. The largest is the Pacific Union Conference in North America, the second largest is the South Brazil Union Conference, with 90,000 members; the next is the Central African Union, with 86,000 members; and the fourth largest is the Inca Union Mission, with 71,000 members.

The first great Laymen's Congress was held in the Inca Union Mission, in the Sports Palace in Lima, Peru. This was the largest meeting they had ever had--5,200 delegates came to that meeting. A layman, baptized two years ago, a little Inca Indian from the Northern Mission, a lay preacher today, had won 437 souls in two years. It is amazing to see what our laymen can do. The Inca Union is aiming for 15,000 baptisms this year.

Elder Schoen also referred to his visit to Chile. There were 1,500 in attendance at the meeting in Santiago. He told of a moving church which they operate—a bus, on wheels. It has a nice pulpit and chairs. They fill it with thirty—five to forty people, preach a sermon, have a Branch Sabbath School, and a Bible Speaks program. This is moved from village to village. They expect this year to baptize over 6,000 souls in Chile.

In Central Africa, with 86,000 members, they plan to baptize 18,000 people this year. They are praying and hoping that they will go beyond the 100,000 mark in Rwanda and Burundi this year.
