SEVENTH-DAY ADVENTIST WORLD SERVICE

1. PURPOSE AND NATURE - Seventh-day Adventist World Service (SAWS) was organized by the General Conference of Seventh-day Adventists at World Headquarters as a voluntary agency in 1956. As an humanitarian relief and development agency, its primary mission is to supply material aid on a world-wide basis to victims of disasters of all kinds and to aid people in the developing nations, fostering and operating developmental programs which aid these countries to improve the well being of their population.

SAWS is an international relief agency of the Seventh-day Adventist Church and is non-sectarian in its operational outreach. It is a further development of earlier efforts of the Church to help meet the needs of its own members following the two World Wars, which also included the relocation of refugees in cooperation with other volunteer agencies. While the organization has a particular responsibility to SDA members, its resources do not stop there for they are available, based on need, to all races, creeds, color, religion, sexes, and without regard to politics or national origin. SAWS strives to develop and operate programs directed to the needlest sector of the population in developing countries. The scope of service includes the areas of agriculture, community development, nutrition, literacy, adult education and some aspects of maternal-child health and public health.

SAWS also supports programs which benefit the general population that have priority in the development plan of the country.

2. ORGANIZATION AND SCOPE OF ACTIVITIES

a. SAWS At General Conference Level - SAWS is a Service Organization of the General Conference. As in all other branches of Church organization, SAWS has a controlling body which, in this case, is the Board of Directors. On the General Conference level, the President of SAWS is a Vice-President of the General Conference. There are four Vice-Presidents of SAWS: The General Conference Treasurer, the Under-Treasurer, the General Conference Secretary and the Director of Department of Lay Activities. The Executive Director

of SAWS is also Secretary of the Board. The Assistant Executive Director of SAWS is also Assistant Secretary of the Board. An Assistant Treasurer of the General Conference serves as Treasurer of SAWS. Most of the other members of the Board are chosen from the officer group of the General Conference, making a total of 17 Board members. All policy decisions and special appropriations of SAWS funds and resources are made by action of this Board. The constituency of the SAWS Board is the General Conference Committee.

Because several important activities of SAWS, such as disaster relief, clothing collection and distribution and promotion of the Worldwide Disaster and Famine Relief Offering, SAWS will maintain a close relationship with the General Conference Department of Lay Activities. The Executive Director of Saws also serves as a member of the Lay Activities World Advisory Council and the North American Division Advisory Council of the Lay Activities Department. He is also invited to attend the Staff Meetings of the General Conference Department of Lay Activities. The Associate Director of the Department of Lay Activities that is assigned to Community Service is also a member of the SAWS Board.

SAWS cooperates in joint planning with the Department of Health to avoid duplication of efforts and to design innovative programs through cooperation in development projects. In addition, SAWS makes available to Health Care facilities in developing countries Inter-Church Medical Assistance medicines; also commodities and funds through USAID. A representative of the Health Department is on the SAWS Board. Cooperation also extends to the World Food Service of the General Conference because of the mutual interest in the development of food technology. SAWS cooperates with Andrews University School of Agriculture and Loma Linda University's Schools of Agriculture and Health.

There are many international voluntary agencies, some Church related, like SAWS, and others, not Church related. It is necessary that SAWS maintain good relations with such agencies and in times of emergency or disaster, undertake joint efforts with other members of the voluntary agency community. This coordination will be done by SAWS at the General Conference and Division levels.

b. SAWS Organization Division Level - The Division SAWS organization should be patterned as nearly as possible after the General Conference organization. The Divisions of the General Conference whose territory include developing nations shall organize a SAWS Board and appoint a SAWS Director to oversee and coordinate SAWS activities within the Division. The Director will work with the Unions within the Division who operate SAWS programs. He will support these Union programs by seeking to obtain resources and will provide technical assistance and counsel from the Division level (in harmony with the guidelines mentioned elsewhere in the policy), to the

programs which may be carried out at Union level. He will serve as coordinator of information between the Union, the Division and SAWS at the General Conference.

c. SAWS Union Level - Unions desirous of establishing and operating SAWS programs shall do so by recommendation of the Union Committee and be approved by the Division and SAWS at the General Conference. A SAWS Representative should be appointed in harmony with the guidelines mentioned elsewhere in this policy. The Union SAWS organization should be patterned as nearly as possible after the General Conference and Division organizations.

3. FINANCIAL POLICIES

- a. Eligibility For Financial Aid Aid granted by SAWS is dedicated to helping individuals and families, but does not include employees of SDA Church organizations. The needs of such employees are considered the responsibility of their employing organizations and should be met with non-SAWS funds. SAWS funds are never available for the building, improvement or repair of institutions such as Denominationally owned offices, churches, church schools, hospitals or homes titled in the name of the Church organization or of their SAWS funds may be used to aid both Adventists and non-Adventists who suffer loss in disasters, including limited assistance in repair of damaged homes and household equipment; thus preventing the limited SAWS funds from being dissipated in other causes, deserving as these may be, and to keep faith with all donors who contribute to SAWS to meet specific needs. All SAWS aid, whether cash or material assistance which has been purchased by SAWS as mentioned hereinafter in the material resources section of this policy, is based on a matching of funds by either the Division, Union, or Conference organizations.
- b. Sources Of Funding The sources of funding are: International and national philanthrophic organizations; governmental agencies for international development; private industry; individuals; the General Conference Disaster and Famine Relief Offering; funds budgeted by the Divisions, Unions or Conferences.
- c. Accounting For Funds Funds received from any government-sources to purchase materials and commodities or to provide for the payment of salaries and expenses for the administration and operation of the program or any other purpose shall be kept in a SAWS bank account. Where funds for specific projects are advanced by Government, such funds must be kept in a separate bank account. These funds must not be co-mingled with other funds, but at all times the banking records and account books are to be subject to external audit whether conducted by General Conference auditors or government auditing services as stipulated when funds are received from government sources.

d. Solicitation Of Funds - Many Governments channel large sums of money for relief and development through voluntary agencies. In many cases, in order to qualify for receiving such funds, a voluntary agency must be officially recognized by the donor government. It is therefore necessary, at the General Conference and Division levels, that SAWS be registered with governments so that it may act as intermediary and receive grants and funding. Projects proposed within a Division that envision the use of assistance provided by sources outside of the Division will require endorsement by the Division SAWS Board and must then be forwarded to SAWS at the General Conference for approval.

4. MATERIAL RESOURCES PROGRAM

- a. Purpose of Material Resources Program -SAWS and its counterpart agencies around the world are engaged in development programs and projects, emergency relief and rehabilitation in which material resources are an essential component. In Europe, North America, Australia and other areas of the world, the Community Services section of the Department of Lay Activities carries forward an emergency relief operation to which SAWS also contributes. However, the primary purpose of the SAWS Material Resources Program is to provide functional support to developing countries.
- Providing material aid to the on-going SAWS programs and projects and counterpart agencies as effectively and efficiently as possible.
- 2) Responding to disasters and emergencies around the world within the mandate and capability of SAWS and in keeping with SAWS counterpart agencies and Community Service relationships.
- 3) Being a resource for appropriate technology information.
- 4) Assisting related agencies in the procurement and shipment of material resources to their particular programs and projects within the policies and regulations governing SAWS activities.
- 5) Assisting Division and Union SAWS Directors in formulating and developing material, programs and capabilities.
- 6) As is provided in the financial provisions above, it is also recognized that material resources such as food, clothing, medicines and other commodities have a monetary value and that SAWS and its counterpart agencies administering such material resources will do so at all times within the scope of program objectives and this policy. All material resources are subject to General Conference audit and when applicable, the donor government audit.

b. Food

- 1) Food will be made available by contributions in kind through SAWS and its counterpart agencies, purchased within the U. S. and other countries, from Food for Peace/USAID, World Food Program of the United Nations, or from other sources such as national or international agencies.
 - 2) Food is made available to programs on the basis of specific requests from the field and with due regard for the acceptability of the commodity, ability of proper storage facilities and distribution network.
 - 3) Food should be used to develop self-sufficiency with safeguards against a sense of continuing dependency among the recipients.
 - 4) Food should be used as far as possible to supplement development programs such as:
 - a) Food for Work Projects.
 - b) Maternal-Child Nutrition Programs.
 - c) Emergency Relief/Disaster and Refugees.
 - 5) The use of Food for Peace (Public Law 480 Title II) commodities is limited to those countries where SAWS and its counterpart agencies are able to administer responsibly their use under USAID regulations.
 - 6) To encourage Food Production programs by making available, when possible, seeds, fertilizers, agricultural equipment, etc., as appropriate.
 - 7) To purchase commodities within the country or region when practical and available, and when such purchases do not adversely affect the local market.
 - 8) To provide current nutrition information, studies and recipes, so that local foods can be appropriately used to the best nutritive advantage.
 - c. Clothing, Blankets, Yard Goods, etc.
 - 1) To maximize the use of clothing in Clothing for Work Projects.
 - 2) To provide materials and equipment for Self-help Clothing Projects.

- 3) To meet on-going development programs in Adult Education where sewing and clothing are the primary tools for operation.
- 4) To maintain adequate supplies strategically located to meet disaster/emergency situations.

d. Health And Medical Supplies

- To assist the General Conference Health Department and SAWS counterpart agencies in securing specialized pharmaceuticals, drugs and Hospital Grants from government sources.
- 2) To respond to disaster and emergency medical needs by contributions or purchases from other national or international agencies as practicable.
- e. Excess Property (U. S. Government) To provide a facility for SAWS and its counterpart agencies to secure health and medical supplies; equipment and reconstruction materials for programs and projects from U. S. Excess Property subject to country eligibility determined by SAWS and USAID.

f. Development

- 1) To assist in procuring appropriate agricultural materials and equipment (windmills, tractors, well drilling rigs, tools, etc.) that would be technically appropriate to meet particular needs in SAWS programs and projects.
- 2) To assist in procuring appropriate tools, equipment and materials for vocational training in SAWS programs and projects.
- 3) To provide general information on current developments in the field of appropriate intermediate technology so as to provide reference materials and suggestions to SAWS programs and projects.
- 4) To maintain a world-wide listing of appropriate technology agencies in developed and developing countries and to refer specific problems for recommended solutions.
 - g. Functional Guidelines For Relief And Material Assistance.
- 1) Annual Program Requests SAWS country and regional representatives and counterpart agencies are requested to submit an Annual Program Plan by July for the next fiscal year. Consideration should be directed to the following:
- a) The Annual Country Program Plan and how commodities, clothing, medicines, etc., would be supportive.

- b) The quantity requested, an estimate of the number of persons who would be recipients of these materials and items and their end-use.
- c) Attention should be given to the shipment schedule, warehousing, distribution and inventory control of all materials requested.
- d) Adjustments to the approved Annual Program Request allocation or shipment schedule as program needs vary or circumstances change.
- e) A report and evaluation on end-use of commodities (food, clothing, medicines, etc.) to SAWS at the General Conference as a report to its Board and which will be used in response to donor organizations and SAWS reports.
- f) To the extent of its ability, SAWS informs its counterpart agencies as far in advance as possible, of the types and quantities of material aid which has been procured and shipping details.
- g) To the extent possible, measures are taken to avoid duplication or over-supply.
- 2) Guidelines For Requesting Relief and Material Assistance SAWS programs proposed on Division, Union or local organizational level to utilize resources and materials provided from outside their fields, including SAWS General Conference, must be endorsed by the Division SAWS Board, and then forwarded to SAWS at the General Conference for approval.

Divisions, Unions or local organizations needing aid are not at liberty to request such aid directly from other Divisions or Unions outside their own Division. Such requests should come through the regular channels as stated above. In the event of major disasters, SAWS, at the General Conference, will pass on requests to other Divisions for additional help when advisable.

3) SAWS Clothing Program - The Department of Lay Activities is charged with the primary responsibility for gathering of clothing through Community Services. SAWS makes allocation, and prepares for shipping, and ships the clothing in emergency and disaster situations, and in support of program and project needs. SAWS, at the General Conference, maintains two warehouses for this purpose. Divisions are also encouraged, where possible, to maintain warehouses for this reason and also for storing other disaster supplies.

- 4) Other Contributed And Purchased Materials Other contributed materials are made available without charge as requested through SAWS at the General Conference and are made available to support programs, projects, emergency and disaster response insofar as type, quality and quantity meet specific needs. SAWS maintains inventories of tents, blankets, medicines, first aid supplies and food. SAWS is responsible for the purchasing and shipping of project, emergency and disaster support materials, as requested to countries in which SAWS or counterpart agencies are located. The cost of purchased materials are always shared by the recipient organization and SAWS at the General Conference.
- 5) Excess Property SAWS has been "determined" by AID/Washington as eligible to acquire U. S. Government Excess Property. Such property may be obtained only upon the approval of the sponsoring Division and SAWS at the General Conference.

6) Monitoring Role

- a) The SAWS in-country representative is charged with responsibility to supply SAWS at the General Conference upon arrival of all ocean freight shipments, a detailed report supported by outturn reports of the vessel, in-country dock receipts and in some cases a survey must be made by a licensed firm which is required within a specific time period after the discharge of the cargo.
- b) The SAWS in-country representative is also charged with the responsibility to monitor, file, process and collect loss and damage documentation subsequent to discharge while the goods are in port or in transport in the care or custody of steamship companies or common carriers, and to supply to SAWS at the General Conference this documentation.
- c) In the case of Food for Peace, USAID commodities controls shall be those in effect governing the administration of Public Law 480, Title II Programs.
- d) SAWS must have, for the purpose of eligibility for U. S. Government freight reimbursement or any other USAID financed program, a SAWS representative who will fulfill stewardship and legal responsibilities and requirements pertaining to the distribution or use of material resources. It is not the policy of SAWS at the General Conference to discriminate or require any person to represent SAWS because of his or her nationality. However, due to the fact that SAWS at the General Conference receives aid from the Agency for International Development, and from time to time, the Canadian International Development Agency, and other international governmental agencies, it is the legal requirement of the aforenamed agencies that the person in charge of receiving and administering such aid in development programs, be an American or Canadian citizen as the case may be. In matters con-

cerning the reception and distribution of supplies proceeding from USAID or transported by them, the SAWS Representative acts as Controller to the local SAWS Board in addition to his regular role as Secretary. He will keep the Board appraised of the rules and regulations of the U. S. Government that controls the reception and distribution of commodities. SAWS at the General Conference is legally responsible for the funds and/or commodities from the moment of reception in the U. S. or other countries until they reach the ultimate beneficiary. In like manner, the SAWS in-country representative is legally responsible for the administration of the SAWS programs in the country or countries where he is assigned.

- 7) Equipment Seventh-day Adventist World Service, Inc., is a registered voluntary agency in many different countries throughout the world. In its operation as a voluntary agency it has entered into legal agreements with such countries as an humanitarian relief agency which gives its help and benefit without charge and without regard to race, color, religion or national origin. As a working agreement with such host countries, said countries have allowed duty-free importation into their countries of equipment, commodities, etc., that are essential to the operation of these programs. The host government has also included duty-free shipping privileges and even(in some cases) diplomatic immunity for SAWS workers in the host country. Because of problems over the importation of cars and other equipment by SAWS when used by other workers in the local Mission or Union in the pursuit of their regular church and religious activities, and because some SAWS workers have imported excessive personal equipment resulting in personal profit, it is hereby agreed:
- a) That importation of commodities and equipment by SAWS or its affiliate agencies into host countries be limited to what will be used by SAWS or its affiliate agency for humanitarian relief and not for the general use of the Church.
- b) That SAWS workers be classified as are other denominational missionaries.
- c). That General Conference policies be applied to SAWS workers as they are applied to other overseas workers.
- d) That SAWS workers be allowed to use importation or exportation privileges only to the extent that such privileges are available to all denominational workers as set forth in General Conference policies for such workers.
