DEVOTIONAL MESSAGE

C E Bradford, Associate Secretary of the General Conference, gave the devotional message entitled "A Movement is Born" a summary of which follows:

"On that day the Lord will make His power more glorious by recovering the remnant of His people, those who are still left, from Assyria and Egypt, from Pathros, from Cush and Elam, from Shinar, Hamath and the islands of the sea."--Isaiah ll:ll (NEB)

We believe that God is active in human history. History is the arena of God's ongoing activity. History is divided, measured off, and apportioned out by Yahweh, the covenant-keeping God. Our text points to a greater exodus, a mightier liberation, a final movement. And this is what the pioneers of this church recognized as taking place in their daya new exodus--the hand of God outstretched the second time.

The early pioneers read the scenario of the rise of the Advent movement in the prophecies of Daniel and the Revelation. They were convinced that at the right time in history, at the end of the 2300-day period the right people arose with the right message. They came to a unique selfunderstanding, a sense of mission which compelled them to search the Scriptures to know the will of God more perfectly, and to share that knowledge with the entire world in global mission.

The final gathering of Israel is not to an earthly Canaan, but to the city built by God and the country that was promised to Abraham.

During 1977, 1,158 workers were sent overseas. Of these 312 were career missionaries returning for additional service. Sixty percent of the 350 regular workers sent out last year came from North America, the rest came from eight other world divisions.

There are now more volunteer workers than regular workers. The largest group is composed of student missionaries. Since 1959 when the first student missionary left Columbia Union College, 1,761 have carried varied responsibilities overseas. There are now 59 student missionaries who returned to complete their education who have returned to overseas service as regular missionaries.

TREASURER'S REPORT

K H Emmerson, Treasurer of the General Conference, briefly analyzed the financial milieu of the world today. The business world both in the United States and Europe faces a continuing period of uncertainty and lack of confidence.

The Treasurer summarized recent talks with economists and bankers in New York. The business cycle peak will most likely occur in late 1979 or early 1980, so the recession year will probably be 1980. Inflation probably will average seven to nine percent during the next six to eight quarters.

As of October 1, 1978, four overseas divisions have had exchange rate adjustments which made it necessary to provide additional US dollars in the amount of \$1,341,180, just to equal the original budget projections in local currencies for this year. In addition to this, various accounting adjustments have been made resulting from rate changes which have cost the General Conference an additional sum of \$2,067,550. Adding to this the cost of the share of exchange losses in the divisions, the real loss to the Church this year approaches five and a half million dollars.

The closing appeal was for the world leadership to evaluate again the real reason for the existence of the Church and then to take all necessary steps to set priorities for the use of the money that constituents generously return to God's treasury.

Because he stands in this special and constitutional relationship the General Conference has a major interest in the nomination of the division president.

In order to ensure proper representation of the interest of the General Conference in the nomination of such a vice-president as well as of that of the division to which he will be assigned, the following shall be the procedure: Under the chairmanship of the newly elected General Conference president or his designee, the members of the Session Nominating Committee from each division shall suggest a mutually agreed upon name to the Nominating Committee for nomination in plenary session.

3. The division presidents shall be among the first nominated after the President, Secretary and Treasurer of the General Conference.

4. Following the election of the division president by the General Conference Session, he shall meet with the division representatives in the Nominating Committee for counsel. As such he will also meet with the Nominating Committee for counsel when recommendations regarding his division are being considered.

5. The members of the Session Nominating Committee from each division shall choose their own chairman, who shall function as such after the division president has been elected. Thereafter, the General Conference president or his designee shall sit with the group for counsel as they consider and recommend personnel to the Session Nominating Committee for all elective positions on the division staff. The final decision regarding the nomination of such personnel rests with the Session Nominating Committee.

"c. Post-master's degree level scholarships/bursaries to be granted with the support of the divisions.

"4. Study is to be given to strengthening the policy entitled, 'Developing and Training Workers' (GC C 75) to provide financial assistance to national medical, dental, nursing and para medical personnel, under a plan similar to the North American Division medical deferred appointee plan.

"5. Divisions are encouraged to develop a post-employment financial aid policy for those who have completed their studies on a selfsupporting basis."

6. a. To request divisions to develop and put into operation a full range of continuing education courses and seminars including seminars in leadership and administration such as are conducted by the Christian Leadership Seminar, to provide for the leadership needs of the work. Coordination of such a Continuing Education Program may be

delegated to the Division Department of Education and/or to such other departments as may be directly concerned.

b. To request the General Conference Department of Education to develop and coordinate a plan whereby the Department along with Andrews University, Loma Linda University, Home Study Institute, the Christian Leadership Seminar, etc may serve as resource centers for providing course material, suggesting personnel for seminars, and giving guidance and leadership in Continuing Education Programs which could include credit and non-credit courses.

VOTED, To launch a worldwide thrust with both spiritual and financial objectives as follows:

 Name of worldwide spiritual thrust - "Adventure in Faith" Name of 1980 General Conference Session Offering - "Adventure in Faith Offering".

This is a concerted spiritual thrust for Christ. The major emphasis is to be on the spiritual. The offering associated with it is to underwrite the spiritual plans financially.

2. Motivation - Primary emphasis is to be placed on

a. What the offering will do (instead of on the amount of the offering).

b. Individual participation (instead of the goal).

c. A person's response to the spiritual needs of other persons, as an outgrowth of his/her own relationship to Christ.

3. Spiritual Objective - The basic objective of this worldwide spiritual thrust is to enter new territories, to begin work in new areas, to begin new work in territories already entered and to support other special projects approved by division committees.

(Adventure in Faith - contd)

Each conference/mission (worldwide) is to develop and individualize its own spiritual plans to meet this type of challenge in its own territory. These spiritual plans are to call the membership to go beyond the regular and ordinary in order to expand God's work and penetrate whole new frontiers. In some conferences this plan will embrace unentered sections of large cities or unentered counties, cities or towns. It may mean commencing work in another language, or developing new programs or new methods to reach a segment of the population not yet adequately reached. We are to make apparent impossibilities become possible.

"Our people are not to wait for more appeals, but are to lay right hold of the work, making those things which appear impossibilities, possibilities. Let each one ask himself, Has not the Lord entrusted me with means for the advancement of His cause?. .. "--ChS 44

"Courage, energy, and perseverance they must possess. Though apparent impossibilities obstruct the way, by His grace they are to go forward. Instead of deploring difficulties, they are called upon to surmount them."---DA 679

In short, each conference/mission is to specifically plan to meet an unusual spiritual challenge within its territory. This type of united action will serve to unite a conference and the world church. Individual participation is a key factor.

"Let none indulge the thought that we have attempted too much. No, no; we have attempted too little. The work which we are now doing ought to have been done years ago. Our plans must enlarge, our operations must be extended. What is needed now is a church whose individual members shall be awake and active to do all that is possible for them to accomplish."--Historical Sketches of SDA Foreign Missions 294

4. Dates for Offering - The "Adventure in Faith" offering is to be received in all churches on or before January 26 and April 19, 1980. This offering replaces the 1980 Spring Mission offering. The eleven o'clock offering received on both Sabbaths at the General Conference Session will become a part of this offering.

5. Suggested Guides for Individual Giving - A basic purpose of the suggested individual guides for giving is to encourage and develop individual response. "Individual responsibility, individual effort, personal sacrifice, is the requirement of the gospel." --MH 147

Suggested guides for giving which each member will be asked to seriously consider before making his/her decision are:

a. Basic objective - An offering equal to a total of one week's tithe, the offering to be taken two Sabbaths, not later than January 26 and April 19, 1980. 78-260 October 11, 1978

(Adventure in Faith - contd)

b. Faith objective - An offering equal to one week's income. This could be given at one time or given systematically between January 26 and April 19, 1980.

Note: It is understood these offerings will be in addition to a member's regular and systematic offerings for local and worldwide work.

6. Financial Objective - The following figures serve only as a guide to the potential which could be available if each conference/ mission would enthusiastically enter into the plan for opening new work in its territory and would adequately inform its members of the local and worldwide spiritual thrust of the church.

The total weekly tithe of our members in 1979 is projected to exceed \$4,400,000.

a. Basic objective - An amount equal to one week's tithe, of our members to be received in the offerings to be taken on the two Sabbaths January 26 and April 19, 1980:

January 26, 1980	\$2 ,2 00,000
April 19, 1980	\$2,200,000
Total	\$4,400,000

b. Faith objective - An amount equal to the weekly income of our members which in 1979 will be approximately \$44,000,000. It can be seen what the potential total would be if each member were to make a gift which would demonstrate self-denial. Participation will be strongly dependent on the type of emphasis given and the content of the information folders used in the educational approach.

7. Distribution of Funds

a. All funds shall be passed on to the General Conference for distribution.

b. Major responsibility for a completed work must rest upon the membership of each local conference and church. In order to encourage local participation for underwriting the spiritual program for new work, 70 percent of the money received from each world division conference/mission (unions in North America) shall be returned to it through regular channels, in 1980, with the understanding that the major portion is to be returned by vote of the division and union committees to the conference/mission where it was raised to finance their "Adventure in Faith" spiritual thrust.

c. Of the remaining 30 percent, \$160,000 which is the approximate equivalent of the Spring Mission Offering (which will not be

(Adventure in Faith - contd)

received during 1980) shall be set aside for the world budget. The total "Adventure in Faith" offering received at the General Conference Session (not including organizational or institutional gifts) shall be applied toward this \$160,000. The remainder of the 30 percent shall be divided equally in 1981 among the overseas divisions for use as special assistance in the "Adventure in Faith" spiritual thrust in local conferences/missions.

d. The following guidelines shall be followed by the overseas divisions in distributing their share of the special funds provided. In order to qualify for special assistance funds from this offering, the local conference/mission.

1) Shall present to its division through the union, detailed "Adventure in Faith" spiritual and financial plans for thrusts into new territories involving such expenditures as the following:

a) Public evangelism, particularly in areas where evangelism has not been featured in recent years.

b) Budgets for new workers to the extent that said budgets can be absorbed by regular operating income and/or appropriations after the first year.

c) Moving of workers into new territories.

d) Building of small clinics or small training centers in new territories.

e) Subsidizing the production and distribution of literature primarly aimed at new areas and territories.

f) Such other expenditures as might qualify under the broad terms of the above objectives and contribute to the finishing of the work.

2) Shall demonstrate that it is actively implementing the General Conference counsel to develop self-support in the local conference/mission.

3) Shall show that the particular conference/mission has an unusual need but a limited financial potential.

8. Conference/Mission Appropriations and Transfers - Local and union conferences or divisions shall not appropriate or transfer funds in order to increase the amount of the "Adventure in Faith" offering from their conference/mission. 78-262 October 11, 1978

9. Institutional and Business Gifts - Denominationally-owned institutions and businesses are encouraged to give on a voluntary basis and their gifts will flow through their parent organization. The parent organization is to take the initiative in arranging the time and method by which the offering is received from the institutions and businesses. Institutions under the care of the General Conference shall remit their gifts to the General Conference for distribution to the overseas fields.

10. Offering Report - The General Conference treasurers shall obtain the world total after the January 26 offering and again after the April 19 offering. The amount of the January 26 offering will be announced by the General Conference Treasurer if and when it seems to be most advantageous in presenting the appeal for the April 19 portion of the "Adventure in Faith" offering. The offering total will be announced by the General Conference Treasurer using the <u>Adventist Review</u> and division-wide papers.

11. Planning and Promotion - The General Conference Session Offering Committee shall implement the following:

a. Plan the flow of information to the membership, timing and type of communication to be used.

b. Prepare copy, layout and art work of the materials to be used.

c. Have the materials printed and shipped for the North American Division. Provide North America with material in other languages as needed.

d. Prepare and mail negatives of the materials to the overseas divisions. Send samples of the English material.

e. Plan the 1978/1979 Annual Council "Adventure in Faith" presentation.

f. Develop materials for youth which will inform them of the spiritual and financial objectives and will encourage them to participate in reaching both objectives.

g. Contact members who are not attending church and encourage them to renew their commitment to Christ, and extend to them the opportunity of participating in the "Adventure in Faith" offering. From Central Planning & Program/ADCOM/HOOUP/GC 78AC to GRT

Study Leave--1. Definition: A leave from regular denominational service granted exclusively for study purposes on a basis agreed to by the worker and the employing organization.

2. Criteria:

a. It is specifically for study purposes.

b. It is for a specific period of time.

c. The worker agrees to return for continued service with the granting organization upon completion of the study leave.

d. The granting organization agrees to accept the worker in full-time employment upon its completion.

3. Procedure:

a. The terms are approved by the executive committee of the granting organization.

b. The worker agrees in writing to the terms of the leave.

c. The granting organization continues to issue current credential/license to the worker.

(A 2682) LEAVE OF ABSENCE - POLICY AMENDMENT

VOTED, To amend section D 35 85, Leave of Absence, to read as follows:

Leave of Absence-An organization granting a leave of absence to a worker shall clearly define the conditions and terms of the leave of absence and communicate these to the worker in writing. These shall include the length of the leave of absence, financial assistance, if any, and the responsibility if any of the employing organization to reemploy the worker. Other denominational organizations shall not employ such a worker without clearance from the organization granting the leave. The worker's credential/license is not ordinarily withdrawn but is usually not renewed while he/she is on leave of absence.

(O 2683) UNSPONSORED STUDENTS - POLICY ADDITION

VOTED, To add a new division T 50, Unsponsored Students, as follows:

1. Educational institutions are advised that divisions will contribute financial assistance only for those students selected by the division committee and whose study and financial plans have been approved by that committee and outlined in a letter addressed to the institution by a division officer.

2. Students not approved by a division committee are understood to be undertaking their study program on their own financial responsibility. Educational institutions shall therefore assure themselves before accepting such students from overseas divisions, that they have a satisfactory financial plan for meeting school and living expenses.

(A 1449) SAFEGUARDING UNITY OF THE CHURCH - CHURCH MANUAL ADDITION

VOTED, To add the following to the SDA Church Manual, Chapter 13, page 244:

Christians should make every effort to avoid tendencies that would divide them and bring dishonor to their cause. "It is the purpose of God that His children shall blend in unity. Do they not expect to live together in the same heaven? . . . Those who refuse to work in harmony

(Safeguarding Unity of the Church - contd)

greatly dishonor God."--Testimonies, Vol. 8, p. 240. The church should discourage every action that would threaten harmony among its members, and should consistently encourage unity.

Reconciliation of differences within the church and its membership should, in most cases, be possible without recourse either to a conciliation process provided by the church or to civil litigation. "If matters of difficulty between brethren were not laid open before others, but frankly spoken of between themselves in the spirit of Christian love, how much evil might be prevented! How many roots of bitterness whereby many are defiled would be destroyed, and how closely and tenderly might the followers of Christ be united in His love!" Thoughts from the Mount of Blessing, p. 59. (See Matt. 18:15-18 and Church Manual, 1976 edition, pp. 237-240)

Settlement of Differences Among Members.--Every effort should be made to settle differences among church members and contain the controversy within the smallest possible sphere. "Contentions, strife, and lawsuits between brethren are a disgrace to the cause of truth. Those who take such a course expose the church to the ridicule of her enemies and cause the powers of darkness to triumph. They are piercing the wounds of Christ afresh and putting Him to an open shame. By ignoring the authority of the church they show contempt for God, who gave to the church its authority." Testimonies, Vol. 5, pp. 242, 243.

Civil litigation is often carried on in a spirit of contention that results from and reveals human selfishness. It is this kind of adversary proceedings that must be discouraged by a church that seeks to exhibit the spirit of Christ. Christian unselfishness will lead followers of Christ to "suffer . . . (themselves) to be defrauded" (1 Cor. 6:7) rather than to "go to law before the unjust, and not before the saints." (1 Cor. 6:1)

While there are, in the modern world, occasions for seeking decrees of civil courts, Christians should prefer settlement within the authority of the church, and should limit the seeking of such decrees to cases that are clearly within the jurisdiction of the civil courts and not within the authority of the church or for which the church agrees it has no adequate process for orderly settlement. Such suits before civil courts should never become revengeful adversary proceedings but should develop out of a desire to seek arbitration and to settle differences amicably. Examples of such cases may include, but are not limited to, the settlement of insurance claims, the issuance of decrees affecting the boundaries and ownership of real property, the deciding of some matters involving the administration of estates, and the awarding of custody of minor children. While the church should set up procedures within the constraints of legal practice to avoid the type of litigation referred to in 1 Cor. 6, it should constantly be on guard against turning from its gospel mission and taking up the duties of a civil magistrate. (See Luke 12:13, 14 and Testimonies, Vol. 9, pp. 216-218.)

God's ideal for members of His church is that they should, "If it be possible, as much as lieth in . . . (them), live peaceably with all men." (Rom. 12:18) The church should use its readily accessible and reasonably prompt process by which many differences among members can be settled. Should the church fail to respond to a member's request for help in reconciling a difference, or if the church acknowledges that the nature of the case is such that it is not within its authority, it should be recognized that the member has exhausted the possibilities of the Biblically outlined procedure for the settlement of differences and that what he or she should do beyond that point is a matter for his or her conscience. (See <u>SDA Bible Commentary</u>, Vol. 6, p. 698)

However, when the church, endeavoring to assist in timely and amicable settlement of differences among its members, recommends a solution, they should not summarily reject the recommendation the church has offered. It is no light matter for a church member, outside the orderly processes of the church, to litigate a grievance against another church member. "Now therefore there is utterly a fault among you, because you go to law one with another." (1 Cor. 6:7)

Church members who demonstrate impatience and selfishness by their unwillingness to wait for and accept recommendations of the church in the settlement of grievances against other church members may properly be subject to the discipline of the church (see p. 242) because of the disruptive effect on the church and their refusal to recognize properly constituted church authority.

Settlement of Grievances of Members Against the Church.--The same principles that influence resolution of differences among members apply to the settlement of grievances of members against church organizations and institutions.

A church member should not instigate litigation against any entity of the church except under circumstances where the church has not provided adequate process for orderly settlement of the grievance within the church, or where the nature of the case is such that it is clearly not within the authority of the church to settle.

Settlement of Grievances of the Church Against Members.--There may be times when church organizations or institutions will have grievances against church members. At such times, church administrators must, in Christian forbearance, keep in mind the Biblical counsel for settling disputes among Christians and apply that counsel to the settlement of grievances of the church against its members. The church should, in preference to litigating matters in a secular court, make every reasonable effort in cooperation with the member to provide a process by which orderly settlement of the problem can be accomplished.

(A-2037) PROCEDURE IN AUTHORIZING ORDINATION - POLICY AMENDMENT

VOTED, To amend division L 45, Procedure in Authorizing Ordination, to read as follows:

1. Ordination to the ministry is the setting apart of the worker to a sacred calling, not for one local field alone but for the world church, and therefore needs to be done with wide counsel. The following plan is the proper procedure, except in special cases where serious delay would result:

a. The administration concerned shall arrange for a preliminary examination of the prospective candidate and his ministry.

b. The matter of ordination is then taken under careful consideration by the local conference/mission committee for an employee of the conference/mission or one of its institutions, and by the union conference/mission committee for an employee of the union or one of its institutions.

c. In case of favorable consideration the local conference/ mission committee will submit the name of the candidate with its findings and convictions to the union committee for counsel and approval.

d. The division and its institutional boards will submit names recommended for ordination to the division committee. The General Conference and its institutional boards will submit names to the General Conference committee.

2. The time and place for the ordination ceremony, including the examination of the candidate, with his wife, shall be arranged by the approving organization in counsel with the union.

DEVOTIONAL MESSAGE

G J Christo, Secretary of the Southern Asia Division, spoke on the judgment. A summary of his message follows:

The attitude to the revealed Word of God is indicative of one's faith relationship to his Saviour. Jesus taught that the hearers of His word would be judged by His words. The study of the Word of God transforms one from a rebel into an obedient child of God. Character is developed as it comes in contact with the Word. The tendency to rationalize the intent of God's Word to suit one's own inclinations results in blindness to sin. Satan exults when men make excuses for their defects of character, for in doing so they fail to recognize and repent of their sins, and they remain unconfessed and unforgiven to condemn them in the day of judgment. The garment of Christ's righteousness does not cover unconfessed or unforsaken sin, nor does it cover the sin of selfrighteousness.

When one accepts in faith and by repentance the provisions of Christ's sacrifice, he is entitled to the benefits of Christ's atonement. His sins are blotted out and his name retained in the book of life. One's standing in the investigative judgment does not depend on the measure of one's achievement, but upon his relationship to Christ and His claims upon his life. This acceptance determines the verdict in the heavenly court.

STATISTICAL REPORT

F Donald Yost, Director of Archives and Statistics, first called attention to the reports of general departments and services as summarized in the Statistical Report. He then spoke concerning membership gains for the five-year period of 1973-1977, a period in which there was a net gain of 688,415. He then directed attention to rates of growth in overseas divisions and the North American Division. A portion of the comparative table follows:

(A 2196) AFFILIATION PROCEDURES--NAD AND OVERSEAS EDUCATION INSTITUTIONS - POLICY REVISION

VOTED, To revise section F 15 25, Procedures for Intercollege Relations Involving North America and Overseas Divisions, to read as follows:

Co-Directors: Robert Henderson, Verne Wehtje

When arranging for an affiliation of an overseas Seventh-day Adventist post-secondary school with a Seventh-day Adventist educational institution in the North American Division, the following procedure shall be implemented:

1. Upon authorization of its Board of Trustees, an overseas postsecondary school, or college, desiring affiliation for recognition of academic credits leading to a degree, an upgraded program, or quasiaccreditation for recognized certificates and diplomas, should request the division education advisory committee and/or commission concerned to study the need and proposal.

2. If the education advisory committee or commission concerned recommends such an affiliation, and the division committee approves it, then the division director of education shall correspond with the General Conference Department of Education for counsel.

3. The General Conference Department of Education shall:

a. Study the application for affiliation.

b. Study the substantiated needs of the overseas school.

(Affiliation Procedures - contd)

c. Survey possible opportunities for a parent or sponsoring school in the North American Division.

d. Initiate and coordinate the possible affiliation between the two institutions.

e. Recommend to the North American Division Board of Higher Education contractual arrangements involving organization, program, services, finance, and personnel.

4. The two institutions concerned shall work out all of the details and incorporate them into a contract to be signed by the chief administrators of the two institutions, the executive secretary of the Board of Higher Education and the director of the General Conference Department of Education. Among the items that should be taken into consideration in drawing up the affiliation contract are the following:

a. The organization of the program.

b. An outline of the program to be established.

c. Services to be rendered by both institutions.

d. Personnel to be involved.

1) The term of service should be indicated (possibly a period of one or two years). The service record shall remain in the files of the sending college, and credit for the overseas service shall be recorded.

2) Once an affiliation has been approved, travel plans for the personnel involved shall be submitted to the General Conference Overseas Travel Committee for recording.

3) The sending college to make adequate arrangements with the General Conference or division transportation offices to ensure that appropriate travel and accident insurance has been extended to cover the individuals concerned for the full term that they are abroad, this to be at the expense of the receiving institution.

 The receiving institution to pay salaries and allowances of the visiting professors.

5) The receiving division to be responsible for the visiting professor's social security payments.

6) Policies regarding allowances and other benefits for missionaries do not apply.

7) The policy with regard to the 25% homeland deposits does not apply to "exchange professors" in an affiliation program. However the division, where it deems it advisable, may pay the exchange professor his salary in accordance with its policy in dealing with regular missionaries. 78-274 October 13, 1978

5. The contractual instrument shall be submitted for approval to the boards of the respective institutions concerned, the division committee requesting the affiliation, and to the General Conference Committee. Copies of this affiliation contract shall be filed with the Board of Higher Education, the General Conference Department of Education, Secretariat, and Treasury office.

(A-2349) DIVISION COUNCILS - POLICY AMENDMENT

VOTED, To amend division C 15 Division Councils to read as follows:

The rapid growth of our work in the division fields makes it desirable that every means available should be used to unify the work in the individual fields, to coordinate the work of the lower organizations with that of the higher organizations, and to ensure that the work throughout the world is conducted as a harmonious whole.

There is need to develop in all classes of workers a proper sense of responsibility for the conduct of the work, and confidence in the policies governing the administration of the work in their fields, as well as confidence in the leaders chosen to direct the work. All division fields are therefore urged to follow the plan of holding regular division councils.

Division councils are not delegated sessions because divisions are not constituted bodies but sections of the General Conference. Division councils are enlarged meetings of the division committee, which, in addition to the usual members of the committee, are attended by other representatives. These should be persons who are able to benefit from, and contribute to, the success of the councils and should include representatives from union and local fields, various other classes of workers and selected laymen. They participate, with the right to vote, in the discussion and general work of the council, which includes the appointment of such officers and departmental directors/secretaries as are ordinarily appointed on such occasions, and the adoption of policies and plans governing the conduct of the work throughout the division.

The selection of additional representatives is by the executive committees of the union conferences approved by the division committee upon recommendation of the union committee in case of union missions. The full division committee will decide in advance the basis with regard to numbers and travel and other expense, on which representatives shall attend.

(Division Councils - contd)

Since these councils are not delegated sessions, technically the actions taken at such meetings have the same force as those taken by the division committee at its regular meetings. It will always be recognized, however, that such actions were taken when wide counsel from the division field was available to influence the decisions reached.

(A 2351) LOCAL CONFERENCE STATUS PROCEDURE - POLICY AMENDMENT

VOTED, To amend section C 35 10, Local Conference Status Procedure, to read as follows:

1. The local mission organization desiring local conference status should make its request to the union committee.

2. The union committee should give preliminary consideration to the request and if it finds the local mission request to have merit, should ask the division to appoint a survey commission with representation from the division, union and local mission.

3. The survey commission after careful investigation of the situation of the mission bearing in mind the factors referred to in paragraphs 1-4 of the foregoing section should report its findings to the union committee, and forward copies to the division.

4. The union committee with two or three special representatives from the mission appointed by the mission committee shall study the findings of the survey commission, and if the union wishes to proceed with the status change, the union committee shall record an action to this effect at the time of its annual meeting and forward this request to the division for consideration.

5. The division should then take action on the request and advise the union of its decision. If the mission desires, a representative, chosen by the mission committee and approved by the union committee, may sit with the division committee when the request for conference status is considered.

6. Upon approval by the division the union shall arrange at an early convenient time for a session of the mission in order to organize the conference and elect its officers, department directors/secretaries and executive committee.

(A-2454) WEEK OF PRAYER RECOMMENDATIONS

VOTED, To approve the following Week of Prayer recommendations:

In an earnest endeavor to revive and greatly increase the attendance and influence of the Annual Week of Prayer world-wide, we make the following proposals:

1. That the Week of Prayer name be expanded to include fellowship. Therefore the name suggested is, "Annual Week of Prayer and Church Fellowship."

2. That this week be annually designated as Church Homecoming Week, and that during this week we focus on the spiritual aspects and sanctity of home and family life, on the spiritual and social needs of our single membership including widows and widowers, and on the life style of the entire membership.

3. That in preparation for such a week, we launch an earnest reclamation project to bring back into our fellowship all former and inactive members, and that we work especially for those who while still members in name are not regular or faithful in their attendance and participation in the life of the church.

4. That we prepare a countdown program that will develop a schedule of events leading up to, and including, the Week of Prayer and Church Fellowship; and that carefully planned follow-up activities be initiated to solidify the blessings and experience of this week in the lives of our people.

5. That in preparation for this week, an intensive visitation program be launched well in advance in an earnest endeavor to reach every member in the church, to discover their present spiritual condition and to invite to the meetings all the church family including former members and the inactive. It is suggested that on the occasion of this visit in the homes that the Annual Week of Prayer readings be placed in their hands.

6. That special preparations be made to make this week one of the most interesting and inspiring weeks in the life of the church, and that special features be prepared that would focus on the value of church fellowship and the blessing of worship.

7. That we seek to prepare the church to welcome back all those who have strayed away and to show them the love and concern which all of God's people ought to feel one for another within the fellowship of the church. Let us really do what we can to close the back door and keep within our fellowship those that are in need of our love and interest.

8. We would suggest that the writers who prepare the message for

(Week of Prayer - contd)

the Week of Prayer be asked to prepare a short summary which could be presented from night to night in those churches where the pastor or a visiting speaker may choose to preach. Thus, the message of the Week of Prayer readings for that night could be presented in brief and the members of the family would be urged to read it for their family worship.

9. That in the countdown program we list a schedule of releases that would keep before our members and our ministers the importance and needs of this week. That we do this through our union papers, the <u>Adventist Review</u>, overseas division papers, <u>The Ministry</u> magazine and <u>Insight</u>; and that announcements be made from week to week in all church bulletins.

10. That for the Annual Week of Prayer and Church Fellowship of 1979, the book by Ellen G White, <u>Christ in His</u> <u>Sanctuary</u>, be promoted, and that we urge our Adventist Book Centers to make special prices available to all our members.

P 25 45 Travel Expense--on Assignment in North America--When missionaries furloughing in North America are asked to visit churches or camp meetings for the promotion of missions, the following plan shall apply in meeting the expense:

1. When a missionary is requested by a local conference president or a local pastor to accept speaking appointments in nearby churches within the local conference he may report the actual travel expense 78-278 October 13, 1978

incurred in meeting such appointments, up to a maximum of 500 miles per month. This expense shall be met by the General Conference, based on the type of transportation used.

2. When a missionary is authorized by the General Conference to attend camp meetings, the expense shall be cared for as follows:

a. Travel up to 2000 miles shall be paid by the General Conference.

b. Lodging and meals, while attending camp meeting, shall be paid by the local conference.

3. When camp meeting or other appointments requiring greater travel are arranged between a union conference and the General Conference, the expense shall be borne by the General Conference and union as mutually agreed on at the time the appointments are arranged.

Deadline for organizations with fiscal years ending December 31 is August 31. Deadline for organizations at the fiscal years ending January 1 to June 30 is October 31.

P 15 05 Initial Term (72 month modified cycle)--Families--The initial term of service for families shall be six years with a two-month midterm leave to the worker's base division after thirty-four months of service. The last two months of the initial six-year term shall be granted as furlough to families who have completed 34 months of service since their midterm leave and who are returning to the field for a subsequent term of service. 11. <u>Non-denominational Employment--If a permanently returned</u> worker is not denominationally employed, the General Conference will grant up to six months' support according to the following guideline (including salary, rent subsidy, medical assistance, automobile insurance, and scholarship grants for children attending church school, grades 1-8, and denominational academies and colleges) with the understanding that the financial support will cease when the permanently returned worker takes up employment or becomes self-employed.

The maximum period of such service that can be validated is ten years.

Inter-Division Calls--A beneficiary who was called to a division 2. other than his base division, and whose last service was in the division to which he was called, may elect to remain there and shall receive benefits according to the Retirement Plan policies of this division even though it is not his base division. The benefits are charged to the beneficiary's base division. If the benefits according to the policies of the division to which he was called are more than they would be in his base division, the division in which he retires shall be responsible for the difference. If such a beneficiary moves to another division other than the one to which he was called, or returns to his base division on the basis of an official permanent return at the time of his retirement or sometime later, he will not be eligible for this provision if he later returns to the division to which he was called. If he returns to his base division for a period of time at his own expense, he may have his retirement benefits sent to his bank account in the division to which he was called for up to six months. If he chooses to receive his benefits in his home country or stays longer than six months, his rate will be changed to the rate of his home division. He is eligible to be reinstated to the rate of the division to which he was called if he returns to that division within 18 months.

3. Independent Transfers--When a beneficiary who has effected independent transfer (s) during his denominational service returns to one of his base divisions, either home or adopted, he shall receive benefits for service performed in all divisions at the rate effective in the division to which he has returned. However, at no time shall his benefits be more than the respective rates being paid in the divisions in which he qualified.

4. <u>Sustentation Overseas Service Workers</u>-A beneficiary who has transferred to another division(s) on the basis of a call or an independent transfer and returns to his home division as an SOS worker will continue receiving benefits at the rate of the division to which he transferred during the period of SOS service if the following conditions are met:

a. The request of the retiree shall be approved by the calling division and shall be voted by the General Conference.

b. The request shall be for a specified period of time not exceeding two years with no provision for an extension.

c. The SOS worker's retirement benefits shall be paid to him

in the division to which he transferred during the time that he is serving in another division.

(A 2614) RETENTION AND SAFEGUARDING OF RECORDS -POLICY REVISION

VOTED, To revise division S 65, Retention and Safeguarding of Records, with the following, and transfer the new wording to "Administrative Policy" subsection "General Administrative Policies."

The normal operation of our organizations and institutions results in the production and the accumulation of a large volume of files and records of varying degrees of administrative and historical value. In order to preserve documents of permanent value and to avoid the unnecessary preservation of unneeded materials, each organization will find it advantageous to establish a records management program.

Administrators of all organizations should evaluate the legal, financial, and cultural worth of various types of files and records produced in all offices. The political vicissitudes through which the world is constantly passing seriously affect property rights, for example, and demand the proper preservation of denominational property records. Corporate papers and board minutes not only tell the history of an organization but may be called upon in cases of litigation. Many other documents and general files that seem to be of little value beyond their initial retention period grow rapidly in historical value as time passes and even serve future administrators in restudying issues and problems.

Records Retention

1. Each organization and institution shall establish a records center, that is, a storage place to protect documents from fire, deterioration and unauthorized access. This records center shall house those noncurrent documents or files designated for either short-term or permanent storage. The records center is not to be used for the storage of current files, that is, those that are consulted several times a year in the normal course of business.

2. A records retention schedule, available from the General Conference Archives, shall be considered by the respective denominational organizations and institutions and, with revisions that may be indicated by local need or varying legal requirements, be adopted by their governing boards or committees.

3. Documents and files stored in the records center awaiting later destruction shall be boxed in such a way as to make clear the date of their destruction, under the provision of a records retention schedule approved by the organization's executive committee or board. 78-288 October 13, 1978

4. Documents and files to be preserved permanently may be kept in hard copy or microform at the discretion of the appropriate governing body. Storage may be in the same storage facility with less permanent items but should be physically separated from them and clearly labeled.

Transmittal of Vital Records

1. All organizations and institutions shall give special attention to the preservation and security of their own vital records, such as articles of incorporation, constitutions and bylaws, minutes of boards or governing committees, property records and other legal documents.

2. The secretary of each division except North America shall forward to the General Conference Archives a true copy of the articles of incorporation of all legal bodies within the division, the division committee minutes and the board minutes of division institutions.

3. The treasurer (or other designated officer) of each division except North America shall forward to the General Conference Archives properly indexed and identified copies of property records as follows in microform or photocopy:

a. All deeds, mortgages, contracts, and other documents covering the acquisition and holding of real property by any Seventh-day Adventist organization or institution within the division's territory, excluding those of local churches, primary schools and residences (except those the division might desire to have included). The division treasurer will keep all property records on file including those of local churches and primary schools.

b. A list or index of such documents, with a brief description stating the location, name of legal body holding title, original cost, date acquired, and summary of major improvements or additions.

Property records are to be brought up to date annually by the transmittal of updated copies to the General Conference Archives as additional property is acquired, major improvements are effected, or property is disposed of.

4. A designated officer of the Treasury of the General Conference shall forward to the General Conference Archives copies and data relating to property holdings of the General Conference and of General Conference institutions as specified in paragraph 3 above. From Treasury/ADCOM/PRADCO/HOOUP/GC 78AC to COF

(A 2544) UNDERTREASURER-ASSISTANT TREASURERS

VOTED, To elect denominational undertreasurers in harmony with the following guidelines:

1. Authorize the use of the term "undertreasurer" on the division and union level in those cases where there would also be two or more assistant treasurers in addition to the undertreasurer. The term "associate treasurer" should not be used on any level of denominational organization.

2. Election of undertreasurers shall be by the General Conference/union session/executive committee.

3. Establish the following wage level maximums:

a. Increase the maximum loan amounts available to approved medical/dental students as follows:

N 20 20 Medical and Dental Appointee Indebtedness--In cases where a physician/dentist missionary appointee has educational indebtedness not exceeding \$42,000 the appointee may be permitted to proceed to the mission field with the understanding that the General Conference and the calling division shall share equally in granting indebtedness liquidation assistance at the rate of \$7,000 plus the current year's interest, for each year of mission service until the indebtedness, plus interest thereon from the date of proceeding to the mission field, has been liquidated.

Ordinarily no physician or dentist is allowed to go to the field if he has a net indebtedness in excess of \$600 after receiving the assistance provided above. Exceptions may be made only to meet special needs in the field or to secure workers with certain skills or qualifications; and provided that satisfactory arrangements can be worked out by the General Conference, the calling division, and the appointee.

When exceptions are authorized any amortization of such indebtedness shall not begin until after the indebtedness of up to \$42,000 has been amortized through service. In cases when the General Conference, division, and appointee agree on an exception, the division may assist by way of indebtedness reduction grants at the rate of \$7,000 for each year of service.

O 65 05 Counsel Required in All Cases--An interdivision worker/ family contemplating the adoption of a child should counsel closely with the controlling committees concerning financial aid and technical and legal aspects of their problem because the legal status of such adopted children will have a bearing on their gaining entrance to the country of the foster parents.

O 65 10 Single Workers--A single worker who adopts a child/children while in interdivision service thereby introduces a significant new factor into his/her work and personal life which will almost inevitably affect his/her employment, housing requirements and personal responsibilities. The employing organization shall therefore administer applicable privileges and allowances to such a worker as follows:

1. The employing organization shall not be required to alter employment responsibilities, financial benefits or living arrangements for such workers during the current term of service.

2. If furlough is authorized thereby confirming a return to interdivision service, child benefits shall be granted according to policy for the return from furlough and during subsequent service in the field.

(A 2592) NURSING LEADERSHIP PROPOSAL

VOTED, To recommend the following Leadership Training Program for nurses who serve in Adventist overseas institutions on a five-year pilot program:

Definition

Leadership Training is a program of planned, continuing education in administration/management, supervision, evaluation, and planning of nursing care. It is an upgrading program for nurses currently carrying leadership responsibility or being prepared for it. The training will include on-site consultation following coursework. 78-294 October 13, 1978

Where adequate nursing administrative training facilities are available, selected local nurses should be encouraged to qualify in areas of nursing leadership.

Where suitable nursing administrative training facilities are not available, we suggest the following plan:

Plan

1. Training through planned, short, intensive courses/seminars which accumulated over a 3-5 year period would meet certificate requirements, or apply toward degree requirements.

2. Preparation for training program: the division Director of Health or the Associate Director would collaborate with the division Educational Director and General Conference Department of Health Associate Director for World Nursing Affairs to select curriculum, set schools, etc.

3. Faculty: both national and expatriate qualified nurses and other instructional staff would provide instruction and consultation (on site following seminars for those requesting). The division nurse, where one has been appointed, will participate in the planning for the Leadership Training of the nurses in that division.

Academic Credit

The Loma Linda University School of Nursing has expressed interest in the project and is willing to cooperate in the off-campus program so that a certificate of attendance in Nursing Administration may be given, and so that continuing education units for nursing relicensure of American licensed nurses may be procured. They are giving study to the possibility of an off-campus graduate degree. Attendance at selected Seminars might carry credit toward a higher degree if such a program develops. There would be a tuition charge for such a course. There is a small fee charged for registration of continuing education credit.

Where there is a local educational institution which gives a baccalaureate program or courses in nursing, faculty would be requested to participate for specific specialized content with which they have competence.

Attendance

Nurses in positions of responsibility in SDA medical institutions such as supervisors, head nurses; directors and faculty of schools of nursing (SDA); North American nurses interested in obtaining continuing education units for renewal of professional license. (Nursing Leadership - contd)

Budget

1. Housing, travel, and food costs to be cared for on a basis worked out by the division.

2. Where credit is granted and tuition charged for the training, costs are to be cared for by the denomination on a basis worked out by the division.

3. Grant funds may be available from non-SDA sources to assist with the expenses of faculty travel and per diem.

Time Schedule

Attempt to begin the program in 1979 in four divisions; others may be added in 1980. The program will be on a pilot study basis for five years.

d. Have, when operating at night under Visual Flight Rules, 25 hours of nighttime cross-country flight as pilot in command and three takeoffs and landings at night within the previous 60 days. e. Have, when operating under Instrument Flight Rules,

Have, when operating under Instrument Flight Rules, an instrument rating and at least 75 hours of flight time as pilot in command in actual or simulated instrument conditions; six hours instrument flight, at least three of which are in actual flight; and six instrument approaches within the preceding six months.

f. Have at least 50 hours in class of aircraft (e.g. multi-engine land, single-engine sea), and 25 hours in make and model of aircraft to be flown (e.g. Cessna 172, Piper Twin Aztec).

g. Have airman's insurance as required by the denomination. (See section C 90 30 Insurance Requirements.)

Category II: A denominational worker who is employed professionally as a pilot or who pilots an aircraft on a regular basis, shall meet the following minimum requirements:

a. Hold a current commercial pilot certificate with instrument rating.

b. Hold a current airman's second-class medical certificate or its equivalent.

c. Have, when restricted to carrying passengers under Visual Flight Rules only, at least 500 hours of flight time as pilot in command, including 100 hours of cross-country flight time; 25 hours of night flight; and at least three hours in flight and three takeoffs and landings in the aircraft to be flown within the previous 60-day period.

d. Have, when approved to carry passengers under Instrument Flight Rules, at least 1,200 hours of flight time as pilot in command, with a minimum of 500 hours of cross-country flight time. Seventy-five hours of actual or simulated instrument flight time, 50 of which were in actual flight; and have six hours actual or simulated instrument flight time (three hours in actual flight) and six instrument approaches during the previous six-month period.

e. Have in addition to d. above, when night Instrument Flight Rules flying is required, at least 100 hours of night flying time.

g. Have a proficiency flight check which meets denominationally-approved standards every six months.

h. Have a periodic denominational professional pilot checkout.

i. Have airman's insurance as required by the denomination. (See section C 90 30 Insurance Requirements.)

Category III: A denominational worker who is employed as a mission pilot and/or who pilots an aircraft either part-time or fulltime in bush conditions, shall meet the following requirements:

a. Meet all the requirements of Category II above.

b. Have a denominational mission pilot checkout and

c. Have, if the assignment is to an area where maintenance facilities are unavailable, an airframe and power plant license or its equivalent.

Any denominational employee piloting aircraft for pleasure or business on his own responsibility (not denominationally authorized or requested) shall be covered with proper insurance (see insurance requirement below).

W 15 05 Regular Mission Offerings--The offerings received each Sabbath other than the thirteenth Sabbath of each quarter, and Investment constitute the regular Sabbath School Mission Offering.

W 15 15 Sabbath School Investment--In order to encourage further giving to the mission program and to raise mission funds through various individual or family projects, the plan known as Sabbath School Investment was developed. This plan is not particularly tied to a regular time period nor a weekly or quarterly appeal for the offering but is a continuing program to promote an increase of mission gifts beyond normal regular giving on the basis of financial returns from special projects decided on by the individual members. Such proceeds or offerings are received at any time, but generally a special promotional appeal is presented in the Sabbath School periodically.

All Sabbath School Investment funds are recognized as General Conference funds and designated as a portion of the World Mission fund. 25% of the Investment funds are appropriated as follows:

For frontier outreach and/or large city evangelism:

1. 22.5% to the overseas divisions in proportion to their regular annual base appropriations.

2. 2.5% to the North American Division.

Projects to be benefited by the Sabbath School Investment should be designated annually by each division committee. 78-300 October 13, 1978

b. That boards of large institutions, whose surroundings have changed to an urban environment and who are facing major rebuilding programs be sensitive to the counsels regarding the locations of these institutions as stated by Ellen G White as to the ideal locations for such institutions.

2. Evangelistic Outreach

a. That we give priority in our evangelistic planning to the massive challenge of the large cities, and that we plan for our work in these cities in harmony with the inspired counsels of Ellen G White.

1) "The cities are to be worked from the outposts. Said the messenger of God, 'Shall not the cities be warned? Yes; not by God's people living in them, but by their visiting them, to warn them of what is coming upon the earth.'"--Ev 77.

2) ". . All that Lot and his family did in Sodom could have been done by them, even if they had lived in a place some distance away from the city. Enoch walked with God, and yet he did not live in the midst of any city, polluted with every kind of violence and wickedness, as did Lot in Sodom."--Ev 78.

3) "It is God's design that our people should locate outside the cities, and from these outposts warn the cities. . . "--Ev 76.

3. Counsels to Church Members

a. That church members be urged to study the counsels to move out of the large and heavily populated cities to areas that are more rural or to smaller towns, keeping in mind the following principles:

1) That city to country living does not necessarily mean city to farm situations miles removed from city areas, but it means relocation to more rural or small town areas conducive to the spiritual and physical welfare of the family, where land for a garden is available.

2) That country living does not necessitate purchasing a farm but might entail the operation of a small business or industry.

3) That a good piece of land where a good water supply and garden space are available would be desirable.

(Country Living - contd)

4) That individuals should find employment or seek selfemployment sufficient to sustain their families before moving from the cities to rural areas, thus avoiding discouragement and a subsequent move back to the city.

5) That some members could well move from large cities to smaller, unentered towns or counties and begin work to raise up a memorial to the Lord as self-supporting workers.

b. That arrangements be made to republish the pamphlet "From City to Country Living," so that church members contemplating a change in home location may have opportunity to secure and study this pamphlet, along with the counsel given in the pamphlet "Country Living" by Ellen G White.

c. That church leaders, Spirit of Prophecy directors, or other persons appointed for this purpose in the union and local conferences make themselves acquainted with the counsels regarding these matters and seek to guide our church members who may be contemplating a move to a more rural area.

d. That while these counsels are kept before the members as ideals towards which they should prayerfully strive, it should be recognized that there are many new converts whose economic situation makes it practically impossible to immediately follow this counsel. Therefore, efforts should be made to suggest alternative measures for such persons so they can raise and train their families as nearly as possible in harmony with the guidelines for country living.

APPENDIX

Spirit of Prophecy Statements Relating to Country Living

Small Sanitariums Are to be Established in Many Places

For a long time the Battle Creek Sanitarium was the only medical institution conducted by our people. But for many years light has been given that sanitariums should be established near every large city. Sanitariums should be established near such cities as Melbourne and Adelaide. . .Small sanitariums are to be established in many places.--MM 326, 327; K-233 (1905); 8T 89

I have been given light that in many cities it is advisable for a restaurant to be connected with treatment rooms. The two can cooperate in upholding right principles. In connection with these it is sometimes advisable to have rooms that will serve as lodgings for the sick. These establishments will serve as feeders to the sanitariums located in the country and would better be conducted in rented buildings. because God has plainly indicated that the sick can be better cared for outside the cities. In many places it will be necessary to begin sanitarium work in the cities, but, as much as possible, this work should be transferred to the country as soon as suitable locations can be secured. 7T 59, 60

Stormy Times are Upon Us

This disaster (the burning of the Review and Herald building) may make a decided change in affairs. I hope that our brethren will heed the lesson that God is trying to teach them, and that they will not rebuild the publishing house in Battle Creek. God means that we shall not locate in the cities; for there are very stormy times before us. --Letter 2, 1903

Where the Youth May Be Taught Most Effectively

God has sent warning after warning that our schools and publishing houses and sanitariums are to be established out of the city, in places where the youth may be taught most effectively what is truth. Let no one attempt to use the Testimonies to vindicate the establishment of large business interests in the cities. Do not make of no effect the light that has been given upon this subject. . .

Conditions are arising in the cities that will make it very hard for those of our faith to remain in them. It would therefore be a great mistake to invest money in the establishment of business interests in the cities.--Manuscript 76 (1905)

Working the Cities from Outposts

As far as possible, our institutions should be located away from the cities. We must have workers for these institutions, and if they are located in the city, that means that families of our people must settle near them. But it is not God's will that His people shall settle

in the cities, where there is constant turmoil and confusion. Their children should be spared this; for the whole system is demoralized by the hurry and rush and noise. The Lord desires His people to move into the country where they can settle on the land, and raise their own fruit and vegetables, and where their children can be brought in direct contact with the works of God in nature. Take your families away from the cities is my message. . .

The cities are to be worked from the outposts. Said the messenger of God, "Shall not the cities be warned? Yes; not by God's people living in them but by their visiting them, to warn them of what is coming upon the earth."--Letter 182 (1902)

A Place "the Lord Selected"

The instruction given regarding the removal of the publishing work from Battle Creek to some rural place near Washington, DC, was clear and distinct, and I earnestly hope that this work may be hastened.

Instruction has also been given that the Pacific Press should be moved from Oakland. As the years have passed by, the city has grown and it is now necessary to establish the printing plant in some more rural place, where land can be secured for the homes of the employees. Those who are connected with our offices of publication should not be obliged to live in the crowded cities. They should have opportunity to obtain homes where they will be able to live without requiring high wages.--FCE 492 (1904)

The Lord has opened this matter to me decidedly. The publishing work that has been carried on in Battle Creek should for the present be carried on near Washington. If after a time the Lord says, Move away from Washington, we are to move. We are pilgrims and strangers in this earth, seeking a better country, even a heavenly. When the Lord tells us to move, we are to move, however inconvenient and inconsistent such a command may seem to us to be. RH, August 11, 1903

Within Easy Access of the City

I was surprised when, in speaking of the work they wished to do in the South, they (Brethren Sutherland and Magan) spoke of establishing a school in some place a long way from Nashville. From the light given me, I knew that this would not be the right thing to do, and I told them so. The work that these brethren can do, because of the experience gained at Berrien Springs, is to be carried on within easy access of Nashville; for Nashville has not yet been worked as it should be. And it will be a great blessing to the workers in the school to be near enough to Nashville to be able to counsel with the workere there.

In searching for a place for the school, the brethren found a farm of four hundred acres for sale, about nine miles from Nashville. The size of the farm, its situation, the distance that it is from Nashville, and the moderate sum for which it could be purchased, seem to point it out as the very place for the school work. We advised that this place be purchased. I knew that all the land would ultimately be needed.--Special Testimonies, Series B, No. 11, 8

Lessons from Enoch and Lot

As God's commandment-keeping people, we must leave the cities. As did Enoch, we must work in the cities but not dwell in them.--Ev 78, 79 (1899)

. .All that Lot and his family did in Sodom could have been done by them, even if they had lived in a place some distance away from the city. Enoch walked with God, and yet he did not live in the midst of any city, polluted with every kind of violence and wickedness, as did Lot in Sodom.--Ev 79 (1903)

Churches, but Not Institutions in the Cities

Repeatedly the Lord has instructed us that we are to work the cities from outpost centers. In these cities we are to have houses of worship, as memorials for God, but institutions for the publication of our literature, for the healing of the sick, and for the training of workers, are to be established outside the cities. Especially is it important that our youth be shielded from the temptations of city life.

It is in harmony with this instruction, that meetinghouses have been purchased and rededicated in Washington and in Nashville, while the publishing houses and the sanitariums at these centers have been established away from the congested heart of the cities, as outpost centers. This is the plan that has been followed in the removal of other publishing houses and sanitariums into the country, and that is now being followed in Great Britain with regard to the London publishing house and also the training school there. We are now given opportunity to advance in the opening providences of God by helping our brethren in these and

many other important centers to establish the work on a firm basis, in order that it may be carried forward solidly.--Special Testimonies, Series B, No 8, 7, 8 (1907)

We are to be wise as serpents and harmless as doves in our efforts to secure country properties at a low figure, and from these outpost centers we are to work the cities.--Special Testimonies, Series B, No. 14, 7 (1902)

Church Schools in the Cities

It is of the greatest importance that church schools shall be established, to which the children may be sent and still be under the watch care of their mothers and have opportunity to practice the lessons of helpfulness that it is God's design they shall learn in the home. . .

Much more can be done to save and educate the children of those who at present cannot get away from the cities. This is a matter worthy of our best efforts. Church schools are to be established for the children in the cities, and in connection with these schools provision is to be made for the teaching of higher studies, where these are called for. --Child Guidance 306

VOTED, To amend subsection Z 25 35-2, Physicians (Retirement Plan), as follows:

5. Financing. a. Divisions will be responsible for the cost of conducting the workshops.

b. The General Conference will be responsible for the travel expense of non-denominational resource personnel requested from outside the respective division territory provided the request is approved by the General Conference Publishing Department and travel is authorized by the General Conference Committee.

6. Format and Materials. a. Each division will determine the format of the workshop(s) in its territory and will select materials for its workshop(s) in counsel with the General Conference Publishing Department.

b. The General Conference Publishing Department will develop a model program for workshops for translators and will recommend materials for use in the workshops in counsel with the following individuals: Fernando Chaij, Gottfried Oosterwal, Werner Vyhmeister, Donald Neufeld, Thomas Davis, P A Gordon. G Ralph Thompson called to order the eleventh session of the 1978 Annual Council.

From Special Nominating Comm/GC 78AC to COF

WILSON, NEAL C--GENERAL CONFERENCE PRESIDENT

Cree Sandefur, Chairman of the Special Nominating Committee, spoke about the unity that prevailed in the meeting. Nine names were submitted as candidates for the presidency of the General Conference, three of which were deleted on request of the candidates. The candidate proposed was nominated practically unanimously on the first ballot. C B Rock, Secretary of the Committee, then read the report.

VOTED, To elect Neal C Wilson to serve as President of the General Conference.

As soon as the report of the Special Nominating Committee had been voted, Robert H Pierson ushered in Neal C Wilson and his wife Elinor Wilson. They were warmly received and given a standing ovation.

(A 2645) USE OF PICTURES - NEW POLICY

VOTED, To adopt a new policy, section I 45 30, Use of Pictures, to read as follows:

Publishers wishing to obtain pictures from other publishers shall do so in harmony with the following provisions:

1. Original pictures shall not be sent away for making reproductions. Instead a print or a negative shall be supplied, and the expense charged in addition to the fee for use of the picture.

2. The picture, when published, shall carry a copyright notice and artist's credit line.

3. The use of a picture shall be limited to a specific publication. The owner of the print or negative used in printing shall not use reproductions in any way other than that for which permission has been granted, nor lend reproductions or photos to others, nor grant permission for others to use them.

4. Permission shall not be given for use of pictures for handbills, posters, circulars, or other general advertising matter, with the possible exception that permission may be granted for use in advertising the particular book or periodical in which the picture appears.

5. Charges for the use of pictures shall be as follows:

a. For publishers in North America 25 percent of the original cost of the picture (amount paid artist plus cost of prints and copyright) when used as an editorial illustration only. For cover use refer to illustration committee to recommend a fee above the 25 percent.

b. For publishers outside North America:

1) Ten percent of the original cost of the picture to publishers in Argentina, Australia, Brazil, Denmark, France, Germany, India, Norway, Philippines, South Africa.

(Use of Pictures - contd)

'2) Five percent of original cost of the picture, but not less than \$5.00 for any one picture to publishers in Indonesia, Italy, Kenya, Korea, Madagascar, Singapore and other smaller mission plants.

6. A committee shall be appointed in each publishing house with authority to grant permission for use.

7. If and when approval is given for the reproduction of pictures in slides for promotion or evangelistic use, control of the reproduction, distribution, and sale for these uses shall be through the audiovisual service of the Seventh-day Adventist Radio, TV and Film Center. All rights for reproduction shall remain with the original publishing house.

8. Information with respect to the use of pictures and related costs shall be sent to each publishing house and overseas field that might be interested.

9. When selecting illustrations for subscription books, publishing houses shall counsel with sister houses and with their division/ union publishing department directors.

From Treasury/ADCOM/Finance 78AC/GC 78AC to WLM

(A 2633) RETIREMENT PLAN CONTRIBUTIONS RESPONSIBILITY (NAD)

VOTED, To care for NAD Retirement Plan contributions as follows:

1. The next higher organization shall be responsible for and shall underwrite the payment of the contributions of their subsidiary organizations to the North American Division Retirement Plan.

a. Local Conference--ABC, Academy, Hospitals, Retirement Homes and other local conference institutions.

b. Union Conference--HHES, College, Hospitals that are participating in the Union Health Corporations, and other union institutions.

c. General Conference--GC institutions.

2. The next higher organizations shall be responsible for the payment, by December 31, 1983, of the Retirement Plan contributions that are due from their subsidiary organizations for fiscal periods previous to January 1, 1979. A minimum of 20% of such contributions will be expected each year. Interest shall be charged at 8% on amounts that are not paid according to the above schedule. 78-334 October 17, 1978

3. Starting January 1, 1979, interest shall be charged at 8% on all Retirement Plan contributions that are more than 60 days late for current periods.

4. If Retirement Plan contributions are not paid in harmony with the above plan, the General Conference undertreasurer is authorized to deduct such contributions from annual General Conference appropriations to the unions and General Conference institutions.

5. Starting January 1, 1979, the contributions of each participating institution (excluding conferences) will be charged to their account in the Retirement Office on an estimated basis each month. An adjustment will be made at the end of the institution's fiscal year.

October 18, 1978, 8:00 a.m.

DEVOTIONAL MESSAGE

W O Coe, President of the Columbia Union, spoke on the subject, "The Loud Cry." Following is a summary of his message:

The angel of Revelation 18 joins the work of the third angel of Revelation 14, causing the message to swell into a "loud cry." This angel will cry "mightily with a loud voice" thus implying great power that will attend the giving of God's last message of warning to the world.

One quotation used by the speaker from the <u>Review and Herald</u> of 1885 states, "God will soon do great things for us, if we lie humble and believing at His feet."

Reasons for the delay of the Lord's coming were dealt with. He emphasized that the primary reason for the Lord's delay is the good reason that the Lord is not willing that any should perish, and that it is within our power to hasten or hurry along the coming of our Lord.

The Pentecostal experience was referred to as primarily a unifying experience. Then the disciples became of one accord and all differences were put aside; then the Holy Spirit was poured out and thousands were converted in a day.

"This one thing I do" characterized the spirit of the disciples. One interest prevailed. The advancement of God's kingdom was their primary interest and when we respond to God's work in this way, unusual things will begin to happen.

Harvest time is here. Three hundred eighty-one were baptized or received on profession of faith every 24 hours during 1977. Surely the third angel's message is swelling into a "loud cry." The work is soon to close and Jesus will come.

Richard Hammill gave a brief outline of the work of Ethel Young who for the last eight years has served as an associate director of the General Conference Department of Education. Her outstanding contribution is the development of textbooks suitable for Adventist elementary schools. Inasmuch as she could not be present, appreciation will be conveyed to her.

Robert H Pierson expressed thanks for the tribute paid to him, and stated that any major success was due to God and the inspiration and encouragement of his wife. He also expressed appreciation to his secretary, Margaret Fuller and those who have worked with her, and to his assistant, F C Webster.

(A 2607) SEVERANCE SETTLEMENT - POLICY ADDITION

VOTED, To add a new subsection to section Z 25 05, Severance Settlement (Retirement Plan), to read as follows:

4. <u>Severance Settlement--Service credit shall not be granted for</u> the period of time covered by a financial settlement that is granted to an employee at the time of termination of employment.

(A 2502) CORPORATION/ASSOCIATION INVESTMENTS - POLICY DIRECTIVE

VOTED, To direct the editors of the <u>Working Policy</u> to revise sections S 40 70, S 40 75, S 40 80, and S 40 85, Annuities/Trust Agreements Involving Cash, Loans to Churches and Institutions, Borrowing from Trusts, and Mortgages, by rewording and rearranging these items into a single item as follows:

S 40 70 Association/Corporation Investments--Conference legal associations/corporations shall invest their funds in the following manner:

Owned-Funds (Current, Plant, and Pooled Investment):

Short-Term:

Items 1 through 7 listed in S 40 40 and Union Revolving Fund Notes.

Long-Term:

1. General Conference or union unitized funds.

2. Purchase of building sites for conference and church projects, Current Fund only.

3. Denominationally-owned employee housing, Plant Fund only.

4. Loans to churches, schools and institutions where borrowing has been authorized (for Pooled Investment Fund only, limited to 35% of demand noteliability).

5. Loans to denominational employees for homes under the following provisions from Current and Plant Funds only:

a. Recorded first trust deeds/mortgages up to 75% of appraised values of properties with 90-day demand replacemnt provision after one year, and/or

b. Recorded second trust deeds/mortgages under NAD provisions contained in X 20 10.

6. Automobile loans to denominational employees per NAD provisions contained in X 20 10 from Current and Plant Fund only.

7. Government and corporate bonds (Grade A or better).

8. Government, government-backed, and corporate notes (Grade A or better).

9. Trust deeds/mortgages of the following types:

a. Recorded first trust deeds/mortgages other than to employees up to 75% of appraised values of properties.

b. Recorded second trust deeds/mortgages which when combined with existing balance of first trust deeds/mortgages does not exceed 75% of the appraised values of the property.

c. Pass-Through mortgages guaranteed by a federal agency or involving large financial institutions as listed in the American Bank listings of the 200 largest banks in the United States, and 75 largest mutual savings banks in the United States, and the 100 largest savings and loan associations in the United States as relates to savings capital dollar totals.

d. Other investments in facilities as provided under stipulated conditions by NADCA.

The following guidelines will govern minimum and maximum percentages for each owned-fund:

Current Fund	15%	85%
Plant Fund	10%	90%
Pooled Investment Fund	25%	75%

Non-Owned Funds (Pre-1969 Irrevocable, Charitable Gift Annuity, Unitrust, Annuity Trust and Agency/Demand)

1. Pre-1969 Irrevocable--Governed by trust law and the investment objectives of the donor, utilizing any of the above investment vehicles except unitized funds, Union Revolving Funds and items 2, 3, 5 and 6 of the long-term items. Funds may be pooled.

2. Charitable Gift Annuity--Any of the above investment vehicles for owned-funds except items 2, 5 and 6 of the long-term items. Funds may be pooled.

3. Unitrust -- Same as Pre-1969 Irrevocable, but no pooling of funds permitted.

4. Annuity Trust -- Same as Pre-1969 Irrevocable, but no pooling of funds permitted.
