BLOCKED CURRENCIES - INTER-AMERICAN DIVISION

VOTED, To counsel the Inter-American Division to use the following guidelines in the handling of funds in blocked currency areas:

In some areas of the Inter-American Division, church funds cannot be transferred between organizations because of restrictive currency regulations. This prevents the flow of funds, particularly to higher organizations. The Caribbean and West Indies Unions are affected. Study was given to this problem by a survey commission with representation from the General Conference, division and unions concerned:

1. The accounting records of the Caribbean and West Indies Unions shall be reorganized as of January 1, 1979, keeping records for tithe and offering income by currency areas. Remittances of tithe and offerings received will be recorded and reported monthly in a local currency in harmony with denominational procedure and policy.

2. There should not be any financial transactions, particularly no money transfers, between soft and hard currency areas on the union and local level. All fixed rates of exchange are set by the General Conference Committee and no cross-exchange rates should be established and applied by the unions and local organizations.

3. The Inter-American Division is to set up bank accounts in each currency area to which General Conference and division funds, such as tithe percentages, mission funds and contributions to the Retirement Fund, will be deposited regularly and not less frequently than monthly.

4. These funds, which belong to the General Conference and Inter-American Division and which cannot be passed on through regular channels, shall be distributed once a year by the General Conference and the division as part of the annual budget.

5. Retirees in these two unions shall be paid by their employing organizations as of January 1, 1979. Rates will be supplied by the Inter-American Division before January of each year and monthly reimbursements will be made from the Inter-American Division Retirement Fund. The names and payments to the retirees are to be listed in the operating budget and accounting records of the organizations concerned as an expense, and the monthly reimbursements received from the division Retirement Fund as an income. For the purpose of computing operating capital requirements, these expenses are not to be included as regular operating expense.

Christian replies: "Yes; when I think what I saw at the cross, that will do it; and when I look upon my brodered coat, that will do it; also when I look into the roll that I carry in my bosom, that will do it; and when my thoughts wax warm about whither I am going, that will do it."

The thought of our blessed destination should constantly inspire us.
