DEVOTIONAL MESSAGE

C E Bradford read portions of the article, "Total Evangelism Needed for the Eighties" by the late J L Shuler, veteran Adventist evangelist, which appeared in the Africa-Indian Ocean Division Ministry magazine, third quarter of 1985.

Public evangelism is the sickle which will reap Harvest 90. He called attention to the haste and urgency of evangelism in the final moments of this world. Following are pertinent excerpts from the article by J L Shuler:

"Every pastor and layman should, in his sphere, focus on total evangelism in the Eighties.

"My fellow pastors, what do you expect to be engaged in when Revelation 18:1,2 is being fulfilled? Will it be hovering over a group of church members? Will it be promoting some good church items that are now keeping you from preaching the truth in season and out of season? In the final moments, every pastor who is called of God will focus on one item--preaching the third angel's message with power from on high.

"In the closing days thousands will be converted to the truth with a rapidity that will surprise the church" (see 2SM, p 16).
