DEVOTIONAL MESSAGE

C E Bradford spoke on the subject of the Church in the last days. He read Revelation 12:11, 17: "They overcame him by the blood of the Lamb and by the word of their testimony; they did not love their lives so much as to shrink from death. . . . Then the dragon was enraged at the woman and went off to make war against the rest of her offspring—those who obey God's commandments and hold to the testimony of Jesus." (NIV)

The remnant church is under great attack during the last days. The woman looks so fragile and helpless while the dragon appears strong and fierce. The devil has at times written an obituary for the church but has never been able to print it. Ultimately Satan is overcome by the blood of the Lamb. The Spirit of Prophecy states that those who cling to the atonement cannot be overthrown. They will stand as firm as a rock.

Special prayer was requested for the Fourth Triennial Conference on Philanthropy currently being held in Lincoln, Nebraska. Prayer was also requested for the families of May Belle Figuhr, widow of R R Figuhr and mother of Mrs Alva Appel, who passed away on June 2, and James R Hardin, president of the Nevada-Utah Conference, who passed away on May 26. Prayer requests were made for Mrs Robert H Wood of Texas and Elwood Staff, secretary of the Southeastern California Conference, who are both ill.

C E Bracebridge offered prayer.

REPORTS

<u>C D Martin</u> gave an account of his itinerary with C E Bracebridge in the Euro-Africa Division where they attended the Berchtesgaden Retreat, the Servicemen's Center in Frankfurt, Germany, and the army chaplains' headquarters in Heidelberg, Germany. The retreat is held annually and is in effect a yearly campmeeting. There were 213 individuals in attendance this year including children. Herald and Donna Habenicht from Andrews University conducted workshops. A military policeman who is married to a Seventh-day Adventist attended all the meetings and at the end of the retreat made a decision to join the Church.

The Glen Bowens are currently directing the Servicemen's Center in Frankfurt and are doing an outstanding job. They have held a weekend program to train the lay leaders who are working with the 11 groups of SDA military personnel stationed in Germany. Recently the Bowens invited 17 teenagers, dependents of military personnel, to spend a weekend with them at the Center where a 12-member Pathfinder club also meets. A few weeks ago a group of company commanders held weekend meetings at the Center and were much impressed with the facilities and the work the Bowens are doing.

Martin and Bracebridge also spent some time at the army chaplains' headquarters visiting with the four army chaplains the church has stationed in Europe. Before leaving Europe Martin visited Elder and Mrs Alf Lohne in Oslo, Norway who send their greetings to the General Conference.

<u>Leo Ranzolin</u> reported that Daniel Martinez, president of Montemorelos University, has resigned in order to continue his education. Ismael Castillo, vice president for student affairs, has been elected to succeed him.

This past Sunday the groundbreaking for the new Central Brazil Union headquarters was held in the interior of the state of Sao Paulo, Brazil. Many church institutions in the Sao Paulo city area, including Brazil College, are moving farther into the country.

J Lynn Martell reported on his recent itinerary through the Nevada-Utah Conference where he conducted Sabbath School workshops. He also attended a meeting of the Church Ministries directors for the North American Division at the Southwestern Union Conference office. All the unions now have Church Ministries directors. He also mentioned the assistance which the Church has been giving in connection with the tornado which struck a Texas town two weeks ago. In the Quebec, Canada area, two new churches have been established in areas where we previously did not have any church members.

MA Tyner stated that although in the last few years it has become more difficult to resolve Sabbath-keeping problems in the work place, in some recent cases there have been positive results. He then mentioned several individual cases where solutions have been found which benefitted the Sabbath-keepers. Recently in the process of settling a case with an extremely large company, the Department of Public Affairs and Religious Liberty participated in writing some new guidelines for the company which will help to accommodate employees with Sabbath problems.

AMENDMENT # 11

I hereby certify that, on _______,

1987, the Executive Committee of the General Conference
of Seventh-day Adventists adopted the following
resolution:

"WHEREAS, on September 25, 1980, the General Conference of Seventh-day Adventists, on its own behalf and on behalf of certain Employers, adopted the Seventh-day Adventist Hospital Retirement Plan ("Plan"), and on February 26, 1981; August 6, 1981; May 13, 1982; May 27, 1982; February 17, 1983; December 29, 1983; December 27, 1984; and April 11, 1985, adopted Amendments #1, #2, #3, #4, #5, #6, #7, #8, #9, and #10 to that Plan; and

WHEREAS, on October 24, 1985, the General Conference of Seventh-day Adventists adopted the attached Resolution adopting Amendment #11 to the Plan; and

WHEREAS, the General Conference of Seventh-day
Adventists desires to make certain changes in Amendment
#11 and the Resolution adopting it, it is hereby:

"RESOLVED, that the General Conference of Seventh-day Adventists, pursuant to Section 8.1 of the Plan, on its own behalf and on behalf of the Employers set forth in Exhibit A hereto, hereby revokes the attached Resolution adopting Amendment #11 to the Plan in its entirety, and adopts in its place the following amendment to the Seventh-day Adventist Hospital Retirement Plan:

1. Effective January 1, 1981, section 2.1 of the Plan is amended by adding at the end thereof the following flush sentence:

"'Notwithstanding the above, a member of the scholastic administration or teaching staff of an educational institution operated by a Participating Employer shall not be a Participant in this Plan.'"

- 2. Effective January 1, 1981, to clarify the definition of "Hour of Service" under the Plan, section 1.14 of the Plan is amended by adding at the end thereof the following subsection:
- "'(e) Hours an employee is on call. Notwithstanding the preceding subsections, or any other provision of this Plan, hours during which an employee is paid or entitled to be paid to be on call during periods during which he is not actually working shall not be counted as "Hours of Service" for purposes of this Section 1.14 or for any purpose under this Plan.'"

- 3. Effective January 1, 1987, a new subsection
 (k) is added to section 3.14 as follows:
- "'(k) Further Limitation. In addition to other limitations set forth in this Plan, and notwithstanding any other provisions of this Plan, the accrued benefit, including the right to any optional benefit provided in this Plan (and all other defined benefit plans required to be aggregated with this Plan under the provisions of section 415 of the Internal Revenue Code), shall not increase to an amount in excess of the amount permitted under section 415 of the Internal Revenue Code as amended by the Tax Reform Act of 1986.*"
- 4. "Effective January 1, 1987 a new paragraph (4) is added at the end of subsection (c) of Plan section 14.2 as follows:
- "'(4) Solely for the purpose of determining if the Plan, or any other plan included in a required aggregation group of which this Plan is a part, is topheavy (within the meaning of Section 416(g) of the Code), the accrued benefit of an Employee other than a key employee (within the meaning of Section 416(i)(l) of the Code) shall be determined under (a) the method, if any, that uniformly applies for accrual purposes under

all plans maintained by the Employer (including any affiliated employers), or (b) if there is no such method, as if such benefit accrued not more rapidly than the slowest accrual rate permitted under the fractional accrual rule of section 411(b)(1)(C) of the Code.'"

- "5. Effective January 1, 1984, Plan section 14.2(c)(3) is amended by striking the words 'received compensation from' and inserting in their place the words 'performed services for'."
- "6. Effective January 1, 1981, Plan section
 1.31(a) is amended by striking the words 'as in effect
 as of the Effective Date' and inserting in their place
 the words 'as in effect on the date a written
 application for benefits is filed with the Committee.'"
