Ellen G White wrote in a letter to O A Olsen and D H Kress, "I have been referred by the Lord to the first epistle of Peter. I must impress upon the churches in every place the importance of reading this scripture, and of practicing, with watchfulness and prayer, the instruction given. 'Here,' said my Instructor, 'is a most precious representation of what Christians may be, if they will only hear and obey.""-(MR 1459, Letter 188, 1906) R W Olson then read I Peter 1:1-5.

Ellen White always urged people to read the Bible. "Several times each day precious, golden moments should be consecrated to prayer and the study of the Scriptures, if it is only to commit a text to memory, that spiritual life may exist in the soul."-(4T 459)

A pocket-sized portion of the Bible or a xerox copy of a favorite chapter in a pocket can help us to feed our souls in spare moments instead of picking up something else to read.

We need to give greater emphasis each day as well as on the Sabbath to the study of the Bible-those special moments. We must be people of the book!

DEVOTIONAL MESSAGE

R J Kloosterhuis read Deuteronomy 6:4-9 and then spoke on the problems of literalism and verbal inspiration in the past and in the present. The Pharisees had problems in these areas and this may be one of the reasons why they rejected Christ. The Pharisees felt that if there was only one God, how could Jesus claim to be God? The Pharisees also took the ten commandments to heart, but before long Sabbathkeeping became more important to them than the individual.

If we study the ministry of Christ on this earth, we see that He preached and lived a "whole" gospel. He had proper balance in all He did. This is what the Church needs today. Our presuppositions greatly color the problems we face. Truth does not change, but does enlarge. It does not reject, but fortifies. If we will allow God to expand our minds, we will grow with understanding as truth unfolds before us and God's will can then be accomplished in our lives.

Prayer was offered by Gary M Ross who remembered Mabel Joiner who is suffering from cancer.

REPORTS

E H J Steed reported on his recent attendance at the Muslim Conference on Prevention of Alcoholism and Drugs held in Pakistan. More than 200 top Muslims from 15 countries met together. When it became known that Steed is a Seventh-day Adventist, people crowded around him asking for the Church's help in combating the effects of alcohol and drugs. The Church has a unique opportunity today to lead out in the health message in Muslim countries.

T R Neslund recently returned from Egypt where he had the opportunity to meet with top officials to discuss temperance concerns. Egypt would like to see Seventh-day Adventists leading out more in

temperance topics. The comment was made to him that Muslims and Seventh-day Adventists are alike in their regard for the human body.

M T Bascom reported on his recent itinerary in the South American Division. He showed one of the new Sabbath School picture rolls being printed in Portuguese by the Brazil Publishing House. It is hoped that picture rolls can soon be published in other divisions.

Thousands of Revelation Seminars are being held throughout the South American Division. Bascom showed one of the Revelation Seminar packets which has been produced and is being used in many churches. There is a willingness on the division's part to share this packet with the world field.

Last Sabbath M T Bascom was in Peru. A bomb exploded in a bus outside the residence of the president of Peru and several people were killed. Terrorists are operating throughout the country. A number of missionaries in the interior have been forced to flee. Terrorists are ordering Peruvians in some areas of the interior to leave their homes and lands and they are crowding around the city of Lima by the thousands and even millions. ADRA and other aide agencies are doing what they can to provide food and water. In the midst of all this turmoil, the Inca Union has already reached its Harvest 90 goal.

DEVOTIONAL MESSAGE

Enoch Oliveira stated that Old Testament priests waited at the temple for the people to come to them. The priest offered all the sacrifices for the people. New Testament ministers were called to go out to the people not to offer sacrifices but to sacrifice themselves in proclaiming the mission of God's Son. We also are called to go forth with an obligation to proclaim Jesus with a consuming power. "Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost:"--(Matt 28:19)

Uriah Smith understood that since this nation is a melting pot with representatives from many nations, the ministers of that time were preaching to the entire world. For two decades the Church remained within the boundaries of this country. But God was looking for a man to take the message to mission lands and found J N Andrews, a most qualified man who opened a new chapter in the history of the Church. He made a remarkable thrust in conquering the world for Christ.

John Mott, a leading evangelical who was a great promoter of the mission program, completed three trips around the world. When he returned from the first trip he said, "We need more missionaries." After the second trip he commented, "We need more qualified national workers" but after the third trip he said, "We need more of the Holy Spirit." Oh how we need the power of the Holy Spirit to overcome the obstacles and fulfill the task before us in countries with only limited freedom to work.

"For the daily baptism of the Spirit every worker would offer his petition to God. Companies of Christian workers should gather to ask for special help, for heavenly wisdom, that they may know how to plan and execute wisely. Especially should they pray that God will baptize His chosen ambassadors in mission fields with a rich measure of His Spirit. The presence of the Spirit with God's workers will give the 89-230 June 15, 1989 - GCC

proclamation of truth a power that not all the honor or glory of the world could give."--(AA 50, 50)

"During the loud cry . . . light will be communicated to every city and town. The earth will be filled with the knowledge of salvation. . . .the light of present truth will be seen flashing everywhere.--(Ev 694)

The Chairman noted that this was the last General Conference Committee meeting to be held at this historical site where it has operated for approximately 85 years. It is hoped that the move to the new building will be the last move before Jesus comes.

Opening prayer was offered by Israel Leito. He especially mentioned the General Conference move, Milton Murray's recovery from surgery, C E Bracebridge's encouraging outlook for the future, the jury selection on the Cottam trial in Pennsylvania, and the situation in China.

INTRODUCTIONS

Shirley Burton introduced Herbert Ford from Pacific Union College who is retiring but who will now work for Adventist World Radio. Herbert Ford and D A Roth were two men who encouraged her when she started her career in Communication and Public Relations.

Shirley also introduced Keith Potts who is applying for an internship in the General Conference Communication Department this summer. Keith Potts served as photographer for the final General Conference Committee meeting.

REPORTS

<u>DeWitt Williams</u> reported that on his last trip to Africa, he found national chapters of the International Commission for the Prevention of Alcoholism and Drug Dependence (ICPA) springing up everywhere. The temperance work opens doors in Muslim countries where some of the strongest ICPA chapters are located. Williams read part of a letter from a Muslim which said that Christians and Muslims make good neighbors as they hold the same principles.

Developing countries are becoming the target of tobacco and alcohol industries. While usage of these drugs is decreasing in the United States, these industries are replacing this loss by marketing these drugs in developing countries, mostly without the warning labels required in this country. Elementary students are receiving free packages of cigarettes and nine-year-old boys and girls are seen smoking. Fathers in developing countries who acquire the habit of smoking reduce the family income by 80 percent to cover the cost of their habit. Williams urged governments to require warning labels on cigarette packets.

The temperance work helps the Church to get into high offices in countries which would otherwise be inaccessible. For this reason, it is hoped that an ICPA congress can be held in Africa. The congress held in Australia was not financially accessible to Africans.

Gaspar Colon, Africa-Indian Ocean Division Temperance Director, speaks good French and is making a tremendous impact. There is a drugdependency ministry in the Cote d'Ivoire Government located in a lovely well-maintained building.

The Breath-Free clinics in the African-Indian Ocean Division are very successful and all expenses are being paid for by the governments.

Leo <u>Ranzolin</u> reported on his trip to Brazil. He held a Week of Prayer in Chile. He preached 27 sermons during which time forty decisions were made for Christ. The main purpose of his trip was to hold an evangelistic effort in the city of Belo Horizonte, Brazil. The workers were surprised that a General Conference officer would come there to hold a meeting. One worker is reported to have said that this meeting would be a waste of time because the work is so difficult in this area. However, the team enrolled 600 people in the Voice of Prophecy lessons. Young people stopped the traffic and distributed fliers.

The fourth largest network in the world televised Ranzolin on the first Sabbath without being requested to do so. The local church really prepared for the meetings. Ranzolin preached three to four times each Sabbath and every evening on the book of Revelation. One hundred people were baptized and two more baptisms are to follow in June and July.

The mayor of the city of Belo Horizonte reported that there are one million people living in the slums. They were invited to the meetings even though the church members were slow to accept this idea at first. A convert from the slums who is now a successful businessman donated 50 percent of the cost to build a Seventh-day Adventist Church in the slums. These new members are now clean and well-dressed, a difference made by the gospel.

New members are often baptized during an evangelistic series held in a public hall or in a tent. They hear of the world-wide influence of the Church but when they start attending their area churches they are shocked and cannot believe the conditions under which they must worship.

In spite of the difficulties and challenges there are many encouraging evidences of God's leading in New York City.

<u>D</u> <u>F</u> <u>Gilbert</u> reported on the organizational meeting of the Chan Shun International Foundation. Dr Chan Shun plans to use this organization as a vehicle for making substantial donations to the Church.

ROZEMA, EUNICE--TRIBUTE

F G Thomas paid tribute to Eunice Rozema who was spending her last day of work at the General Conference. She has served the Church for 49 years. Thomas thanked Eunice for her contribution to the work.

Neal C Wilson mentioned that he first met Eunice 45 years ago. R W Olson said he met her at Emmanuel Missionary College, now Andrews University. W L Murrill found her most helpful when he enrolled at Washington Missionary College, now Columbia Union College.

Prayer was offered by W G Johnsson in which he remembered the bereaved, Eunice Rozema in her retirement and the proposed sale of La Loma Foods, Incorporated.

LA LOMA FOODS, INC - POSSIBLE SALE

Neal C Wilson introduced the subject of the possible sale of La Loma Foods which is wholly owned by the General Conference Corporation. The General Conference Officers considered the possibility at a recent meeting. A majority favored the sale but expressed the need for counsel from the General Conference Committee. Wilson stated that a decision needs to be made quickly.

Wilson noted that the forthcoming Global Strategy meeting will consider the Church's mission statement. There is a growing feeling that in the fulfillment of its mission the Church will need to utilize certain of its assets in more productive ways.

Loma Linda Foods was established in the Pacific Union Conference but it later became a General Conference institution. A group of dedicated Adventist laypersons also established a similar company called Worthington Foods. The hope was that the non-Adventist public would accept soya bean products as a meat substitute but such has not proved to be the case in any great measure.

Loma Linda Foods experienced some serious financial problems through the years although recently under the able-management of Alejo Pizarro it became a profitable enterprise. Recently the infant formula production line was sold to Nutricia, a Dutch firm.

One fact impacting this situation today is that the emphasis of healthful eating is to eat more foods in their natural state rather than eating meat analogs or processed foods. Worthington Foods was established by a devoted group of laypersons in Ohio. At one time strong consideration was given to merging Loma Linda Foods and Worthington Foods. Through the years many Adventists thought that Worthington Foods was indeed owned by the Church. Later on it was sold to Miles Laboratories who in turn sold it to a West German Company. A few years ago a group composed primarily of Adventist laypersons once again obtained ownership of Worthington Foods which has now made an offer to purchase La Loma Foods, Incorporated.

It is this offer that has prompted earnest consideration of the future of La Loma Foods, Incorporated which at the present is saleable because it is making a profit.

Several other factors are also involved such as,

1. The need for a separate retirement fund.

2. The growing risk of labor union involvement.

3. The possible relocation of La Loma Foods, Incorporated with the resultant loss of key personnel who do not wish to move.

4. The difficulty of training or finding qualified management personnel in the future.

5. The problem of marketing products. La Loma Foods, Incorporated caters mostly to the Adventist market.

Objections to the sale of La Loma Foods, Incorporated include the following:

1. A monopoly would be set up in the meat analog business if La Loma Foods, Incorporated were sold to Worthington Foods which would doubtless drive up prices to consumers.

2. Formulas would be lost to the Church.

3. Some faithful and talented employees would be displaced or even lost to the service of the Church. Some also feel that promises which were made to employees will appear to be broken.

4. The Church should operate a health food enterprise in the North American Division. Not to do so is contrary to the counsel of Ellen G White.

The pros and cons of the proposed sale were elaborated on at length. Wilson finally stated, however, that a consensus is developing among both the Officers and prominent Adventist businessmen that the time has come for the Church to utilize the asset it has in 89-256 June 30, 1989 - GCC

La Loma Foods, Incorporated in other ways. After caring for its obligations to employees of the company the proceeds of the sale (including the money already realized from the sale of Loma Linda Foods) could be invested and the income used to fund certain pressing needs in the Church.

Information was also presented on the purchase offer by Worthington Foods. Some expressed the need to obtain proposals from other interested parties before arriving at a decision.

The Chairman suggested a straw vote by members be conducted to ascertain the mind of the group. A secret ballot revealed 28 in favor of selling La Loma Foods, Incorporated and 19 against.

The way was then opened for a formal motion.

VOTED, 1. To recommend the sale of La Loma Foods, Incorporated, giving health food organizations in overseas divisions and interested lay persons in the North American Division the opportunity to submit proposals.

2. To authorize the Chairman to appoint a small group of five individuals to expedite the evaluation of offers within a 30 day period if possible. The group is authorized to extend the time if needed but emphasis was placed on the need to expedite the sale.
