

TERMS OF REFERENCE AND HISTORICAL BACKGROUND San Juan, Puerto Rico May 5 and 6, 1991

TERMS OF REFERENCE

On December 7, 1990 the Executive Committee of the Inter-American Division took an action requesting the General Conference to appoint an Antillian Union Conference Survey Commission to study the possibility of dividing the Antillian Union into two unions.

On January 24, 1991 the General Conference Committee took the following action:

VOTED, To appoint an Antillian Union Conference Survey Commission (GCC-A) as follows:

On April 18, 1991 the General Conference Committee made a membership adjustment to the survey commission and the name of Karl H Bahr was deleted and Robert E Osborn was added.

HISTORICAL BACKGROUND

1. <u>Dominican Republic</u>

When Charles Boulton, a Jamaican, went to the Dominican Republic from Puerto Rico in 1907 as a colporteur, he found seven Sabbathkeepers already there. In 1908 a Sabbath School was organized at Central Consuelo, and the first Dominican converts, Maria Williams, her six sons, and a daughter, were baptized. The first Seventh-day Adventist Church was organized in the city of Santo Domingo in 1917, when H D Casebeer arrived to take charge of the work. The second church was organized at Jababa in 1921.

The early Seventh-day Adventist Church work in the Dominican Republic was administered from Puerto Rico. In 1924 the Dominican Mission was organized with William Steele as its first superintendent. By 1936 church membership had reached 743 in 10 organized churches. The year 1962 saw a remarkable advance of the SDA church in the Dominican Republic, when at the end of the year the membership of the mission reached 5,248. On August 1, 1963 the Dominican Mission achieved conference status and became the Dominican Conference. In 1972 at a special biennial session, the Dominican Conference was reorganized as the Central Dominican Conference and the North Dominican Mission. As the church continued to grow, further changes took place with the South Dominican Mission being organized in 1986 and the East Dominican Mission in 1990.

2. <u>Puerto Rico</u>

Seventh-day Adventist work was opened in Puerto Rico in 1901 when A M Fischer and his wife went from Lincoln, Nebraska, to the city of Mayaguez to take care of an interest that had developed among a group of English-speaking Jamaicans who lived there. In 1903 B E Connerly arrived from the United States and began to publish a monthly evangelistic magazine in Spanish called "El Centinela de la Verdad". the first Protestant religious paper to be published on the island. The January 26, 1905 "Review and Herald" reported the first baptisms and indicated there were 19 Sabbathkeepers in Puerto Rico.

In 1909 the Puerto Rico Mission was organized with William Steel as the first president. Until 1924 the territory of the mission included also the Dominican Republic, and until 1926 the Virgin Islands. The oldest Puerto Rican SDA church still in existence was organized at Moca about 1913 or 1914. In 1919 the first Puerto Rican. Francisco Megrant, was ordained to the ministry.

At the biennial session in June 1948 the Puerto Rico Mission was reorganized as the Puerto Rico Conference with 35 churches and 2,627 members. At a special biennial session held in December 1968, the Puerto Rico Conference was reorganized as the East Puerto Rico Conference and the West Puerto Rico Conference. The East Puerto Rico Conference was established with 67 churches and 5,883 members. The West Puerto Rico Conference was established with 51 churches and 4,514 members.

3. Organization of the Union

In 1923, the Antillian Union was organized with 101 organized churches and 3,863 members. J A Leland served as its first president. The union initially included the Bahama Islands, the Cayman Islands. Cuba, the Dominican Republic, Haiti, Jamaica, Puerto Rico, and the Virgin Islands. The headquarters was located in Havana, Cuba. Over the next 45 years some of these countries joined other unions until only the Dominican Republic and Puerto Rico formed the Antillian Union. As of December 31, 1990 the Antillian Union Conference had 503 organized churches and a membership of 100,398. The headquarters office is located in Rio Piedras, Puerto Rico. The union is comprised of six local fields made up of four conferences and two missions:

Conferences:

Central Dominican Conference with headquarters in Santo Domingo East Puerto Rico Conference with headquarters in Rio Piedras North Dominican Conference with headquarters in Santiago West Puerto Rico Conference with headquarters in Mayaguez

Missions:

East Dominican Mission with headquarters in San Pedro de Macoris South Dominican Mission with headquarters in Azua

ANTILLIAN UNION CONFERENCE SURVEY COMMISSION REPORT San Juan, Puerto Rico May 5 and 6, 1991

OPENING

George W Brown introduced the members of the committee, and mentioned that Julio Cesar Rivera, secretary of the Antillian Union. was absent due to illness.

Leo Ranzolin, chairman of the survey commission, commented on the past history of the Inter-American Division and its tremendous growth. The growth of the Church is a direct result of the outpouring of the Holy Spirit. When Christ left this earth the disciples felt alone, but then the Holy Spirit came to give the power they needed to carry forth the work given to them to do. God is presenting His message to the world through the Holy Spirit.

We are now in the dispensation of the Holy Spirit. We see baptisms led by the Spirit in every division, and in particular in the Inter-American Division, which has the largest Seventh-day Adventist membership in the world. In the days ahead there will be even more people coming into the Church because the Holy Spirit is empowering every member to be entirely dedicated to the mission given by Christ to His Church. May the Holy Spirit continue to guide in the mission of the Church, and in the matters considered by this survey commission.

PRAYER

Prayer was offered by George W Brown and Dionisio Christian.

DIVISION PRESIDENT'S REPORT

George W Brown gave a historical sketch of the Antillian Union Conference and commented that the major growth of the union has been in the Dominican Republic. At present it surpasses Puerto Rico in membership by more than two to one. The union session which met prior to the last one was tense as one group was very strong in its representation. But there was also understanding of the problems facing the union. During the last union session there was a consensus that something needed to be done to address these problems. The main reasons for studying the possibility of separating into two unions are as follows:

1. It is very difficult to obtain visas for workers from the Dominican Republic being called to serve at the union office in Puerto Rico due to restrictions by the Immigration and Naturalization Service. This results in a shortage of representation in the union office of workers from the Dominican Republic.

2. Delegates from the Dominican Republic face difficulties with the Immigration and Naturalization Service in obtaining visas to attend meetings being held by the union in Puerto Rico.

3. Due to government restrictions, it is becoming more difficult to channel tithes and offerings out of the Dominican Republic to the union office in Puerto Rico.

4. The large membership in the Dominican Republic of 70,000 seems to warrant a union separate from the 30,000 members in Puerto Rico.

5. Past experience has shown that the growth of the Church in the Dominican Republic and Puerto Rico could be much improved if the present union is divided.

George W Brown then stated that the purpose of the survey commission was to see whether there was merit at this time in forming two separate unions.

UNION PRESIDENT'S REPORT

Felix Rios, president of the Antillian Union Conference, presented the three volumes of materials which were prepared by the union giving details about the local fields, institutions, and union office.

The union hopes that the rapid growth of the Church in the Dominican Republic will be considered as an acceptable reason for forming two unions.

COMMENDATIONS AND RECOMMENDATIONS

The Antillian Union Conference Survey Commission, after extensive study and evaluation of the available data relative to the Antillian Union Conference and its subsidiary organizations and institutions, made the following commendations and recommendations: CENTRAL DOMINICAN CONFERENCE - RECOMMENDATIONS

VOTED, 1. To give immediate study to reducing the workers in the conference office (34) and to increasing the number of pastors in the field (27).

2. To prepare a feasible plan for providing church buildings for the many new churches in the conference.

3. To urge the conference to organize some of its 268 companies into churches in order to increase the current number of 106 churches.

4. To increase the mission offerings to a minimum equivalent of 8 percent of the tithe. In the past the minimum has been 5.7 percent and the maximum 6.8 percent.

5. To study the possibility of increasing the level of education of its ministers by encouraging more workers to obtain the Master of Arts degree in Religion being offered by the Andrews University extension program.

NORTH DOMINICAN MISSION - RECOMMENDATIONS

VOTED, 1. To encourage the mission to organize as many of its companies into churches as soon as possible.

2. To insist that the financial operation of the mission be improved as the financial statements of the mission and the Adventist Book Center and the auditor's reports show that these organizations are in a critical situation with expenses higher than income.

EAST PUERTO RICO CONFERENCE - COMMENDATIONS

VOTED, 1. To commend the East Puerto Rico Conference for the good proportion of churches in relationship to companies--131 organized churches and 10 companies.

2. To commend the East Puerto Rico Conference for the large number of church buildings owned by the conference and the small number of rented facilities. Presently there are 138 church buildings, 10 buildings in construction, and only three rented buildings.

EAST PUERTO RICO CONFERENCE - RECOMMENDATIONS

VOTED, 1. To require the union to give study to the finances of the East Puerto Rico Conference since its expenses in 1990 increased by 5.4 percent while tithe increased by only 3 percent. Some of the elements to be considered are the excessive number of workers, the heavy capital investment which resulted in a decline in the financial condition of the conference, and the radio operation.

2. To increase the mission offerings to a minimum equivalent of 9 percent of the tithe.

3. To study the financial condition of the Adventist Book Center with a view to reducing the number of personnel. At present there are nine full-time budgets. Considering the size and volume of operation, the Adventist Book Center can adequately operate with less personnel. There is also an imbalance between income and expenses that must be corrected.

WEST PUERTO RICO CONFERENCE - COMMENDATIONS

VOTED, 1. To command the West Puerto Rico Conference on the good ratio between churches and companies--120 organized churches and 19 companies.

2. To commend the West Puerto Rico Conference for the large number of church buildings owned by the conference as compared to rented churches. At present 107 churches have their own buildings, 12 churches have buildings under construction, and only 20 churches/companies do not have buildings.

3. To commend the Adventist Book Center for its healthy financial condition.

WEST PUERTO RICO CONFERENCE - RECOMMENDATIONS

VOTED, 1. To give study to reducing the number of workers in the conference office (36) and increasing the number of pastors and Bible workers in the field (60).

2. To give study to reducing the number of workers in all areas of the conference since 57 percent of the net income of the conference is currently dedicated to workers' salaries. This percentage is excessive.

3. To increase the mission offerings to a minimum equivalent of 8 percent of the tithe. Currently it is 6.02 percent.

4. To develop an effective program of stewardship giving particular attention to the overall trend of reduction of tithe increase that has been observed in the last few years.

5. To require the union to assist the conference in developing ways to increase the ratio of members to the population. The ratio now is one member for every 79 inhabitants.

6. To insist that the academies be made responsible for the loans they obtain and that proper payments be made to the conference. In light of the 1990 auditor's report, study should be given to ascertain why the conference has lent 50 percent of its savings to the academies when according to policy the limit should be 33.35 percent. This has legal implications and affects the financial health of the conference.

7. To require the conference to cease making loans until it reaches 100 percent liquidity.

8. To require the Adventist Book Center to study the cost of goods sold.

EAST DOMINICAN MISSION - COMMENDATIONS

VOTED, 1. To commend the East Dominican Mission for the 45 organized churches within its territory while urging that as many as possible of its 34 companies be organized into churches.

2. To commend the East Dominican Mission and its Adventist Book Centers for its sound financial situation.

EAST DOMINICAN MISSION - RECOMMENDATIONS

VOTED, 1. To encourage the mission to increase the mission offerings to a minimum equivalent of 9 percent of the tithe. Currently it is 8.01 percent.

2. To encourage the mission to upgrade where necessary teachers' qualifications thus making it possible to certify all teachers according to division policy.

SOUTH DOMINICAN MISSION - RECOMMENDATIONS

VOTED, 1. To require the mission to give study to reducing the number of mission office workers (17) and increasing the number of district pastors (11).

2. To urge the mission to organize as many of its 83 companies into churches thus adding to the 26 currently organized churches.

3. To require the mission to give study to establishing educational facilities for the families of workers and church members in the vicinity of the mission headquarters. 4. To urge the mission to upgrade where necessary teachers' qualifications thus making it possible to certify all those teaching within the mission according to division policy.

5. To require the union to give study to assisting the mission and the Adventist Book Center to operate in harmony with division policies regarding working capital and liquidity since it has dropped 50 percent in one year.

6. To encourage the mission to increase the mission offerings to a minimum equivalent of 8 percent of the tithe from the current 5.6 percent.

7. To urge the mission to send its monthly fund remittances to the next higher organization according to division policy.

DOMINICAN ADVENTIST UNIVERSITY - RECOMMENDATION

VOTED, To urge the implementation of the recommendations made to the Dominican Adventist University by the evaluation committee that met March 18-21, 1991 and recorded in a document prepared by the Inter-American Division Department of Education.

BELLA VISTA HEALTH CARE SYSTEM - RECOMMENDATION

VOTED, To urge the Bella Vista Health Care System to comply with generally accepted accounting principles as noted in the auditor's report.

BELLA VISTA ADVENTIST SCHOOL - RECOMMENDATION

VOTED, To urge the Bella Vista Adventist School to comply with generally accepted accounting principles as noted in the auditor's report.

ANTILLIAN UNION CONFERENCE - COMMENDATIONS

. .

VOTED, 1. To commend the Antillian Union Conference organization for running a strong, sound financial operation.

2. To commend the Antillian Union Conference for the two colleges operating successfully within its territory. The preparation of future workers will not be a problem since each of the two new unions will have a fine school within its own territory. ANTILLIAN UNION CONFERENCE - RECOMMENDATIONS

VOTED, 1. To require the Antillian Union Conference to have necessary information ready for any future studies which may be done. The work of the survey commission was delayed due to the lack of needed materials.

2. To require the union to conduct a study of all its fields to determine how many teachers need to be upgraded in harmony with division policy and to establish a plan by which the upgrading can be done. Particular attention should be given to the East Dominican and South Dominican Missions.

3. To urge that study be given to hiring only teachers who have been properly certified by the union.

4. To require the union to comply with division policy concerning the ratio of 75 percent of SDA students to 25 percent of non-SDA students in the schools.

5. To require that teachers with either Bachelor's Degrees or Licenciatura be allowed to teach equally in schools located in rich or poor communities.

6. To urge that teachers' salaries be on the denominational remuneration scale established by policy regardless of the type of school in which they serve or whether the school is located in rich or poor communities.

PROPOSED FINANCING FOR THE NEW UNIONS - RECOMMENDATIONS

VOTED, 1. To require the Antillian Union Conference to preserve in liquid assets a minimum of US\$ 850,000 in order to provide for:

The remaining portion of existing current assets at the time of separation will be distributed equally after assigning the trust funds and/or allocated funds to each of the new unions, as well as receivables and payables.

2. To require that before the time of separation any balance in commercial accounts should be fully paid off by the Antillian Union Conference.

3. To require the Antillian Union Conference to immediately freeze all capital asset acquisitions for the time being and use its assets only for the upkeep of present union capital assets.

4. To require that at the time of the separation of the union, a special committee review and adjust these guidelines of the final figures for the two new unions. This special committee will be formed by two treasurers selected by the Dominican fields and two treasurers selected by the Puerto Rican fields and chaired by the Inter-American Division treasurer.

SEPARATION OF ASSETS

VOTED, 1. To require that the fixed assets of the Antillian Union Conference be assigned to the new union of each country.

2. To divide the liquid assets of the current Antillian Union Conference between the two new unions on a 50/50 basis less the liabilities.

OPERATING CAPITAL AND LIQUIDITY

VOTED, To require that the operating capital and liquidity of the Antillian Union Conference and all its subsidiary organizations and institutions be brought into full compliance with the working policies of the Inter-American Division as a prerequisite for the reorganization of this field.

ANTILLIAN UNION CONFERENCE REORGANIZATION - APPROVAL

Contingent on the full implementation of the above recommendations.

VOTED, To reorganize the Antillian Union Conference into two separate unions as follows:

1. Dominican Union Mission - comprised of the Central Dominican and North Dominican Conferences, and the East Dominican and South Dominican Missions. 2. Puerto Rican Union Conference - comprised of the East Puerto Rico and West Puerto Rico Conferences.

ADMINISTRATIVE, DEPARTMENTAL AND SUPPORT STAFF

VOTED, To require the following positions for the administrative, departmental, and support staff for the two new unions:

1. Dominican Union Mission

President Secretary-Treasurer Department Directors - 4 Secretaries - up to 4 Cashier-Accountant Janitor-Custodian

2. Puerto Rican Union Conference

President Secretary-Treasurer Department Directors - 4 Secretaries - up to 4 Cashier-Accountant Janitor-Custodian

HEADQUARTERS' LOCATIONS

RECOMMENDED, 1. To establish the headquarters of the Dominican Union Mission in the city of Santo Domingo, Dominican Republic.

2. To utilize the present Antillian Union office located in Rio Piedras, Puerto Rico as the headquarters for the Puerto Rican Union Conference.

TIMING FOR IMPLEMENTATION

RECOMMENDED, To implement the timing for the reorganization of the Antillian Union Conference into two new unions as follows:

1. The report of the survey commission will be approved by the General Conference, the Inter-American Division and the Antillian Union Conference in June 1991.

2. By June 30, 1992 a report by the Antillian Union Conference will be due at the Inter-American Division on the successful implementation of the recommendations of the survey commission. Antillian Union Conference Survey Commission - Report

3. When the Inter-American Division is satisfied that the Antillian Union Conference and its organizational entities are in full compliance with the recommendations of the survey commission a date will be established for a union session when the reorganization of the two unions will be effected.

FREEZE IN MOVEMENT OF WORKERS

1

VOTED, To freeze all transfers and calls of workers between the territories of the present Antillian Union Conference until such time as the new unions are organized.

CLOSING

Felix Rios, president of the Antillian Union Conference, expressed appreciation for the work of the survey commission and accepted the commitment on the part of the union leadership to implement the actions and recommendations given.

George W Brown, president of the Inter-American Division, reiterated that although some of the recommendations given by the survey commission could be compromised on, the main recommendation concerning the need to bring the working capital of all of the union's entities into harmony with division policies, is non-negotiable. With God's guidance, these two new unions will help to finish the work in the Dominican Republic and Puerto Rico.



TERMS OF REFERENCE

On December 7, 1990 the Executive Committee of the Inter-American Division took an action requesting the General Conference to appoint a Colombian Union Mission Survey Commission to study changing the status of the union mission to a union conference.

On January 24, 1991 the General Conference Committee took the following action:

VOTED, To appoint a Colombian Union Mission Survey Commission (GCC-A) as follows:

OPENING

Luis Florez, president of the Colombian Union Mission, welcomed the survey commission members and mentioned the preparations which were necessary to have the printed materials ready for the meeting. He expressed regret that the location for the survey commission had to be changed from Medellin to Bogota.

George W Brown, president of Inter-American Division, introduced the members of the survey commission. All the members, as named by the General Conference, were in attendance. He referred to the growth of the church in the Colombian Union Mission, and expressed pleasure that the time had come to review the status of the union with the objective of upgrading it to a union conference. The philosophy of the Inter-American Division is to encourage every union mission to become a union conference as soon as possible.

Mario Veloso, associate secretary of the General Conference, offered a devotional message on the organization of the apostolic church. Many people believe there was no organizational structure in the early church and that everything related only to the local church. The New Testament is not a complete record of all activities of the church; however, it has a few passages in which some of the early church's organization can be seen. As seen in Acts 1:15-26, the election process was very sophisticated. Acting upon principles as outlined in the Scriptures, the disciples who met together defined the qualifications needed for a particular position, made a list of candidates, prayed to God for guidance in selecting the correct individual, and then voted one man into the group of leaders. God was in control of the entire process, and the church acted following His orientation with a willingness to accept His will. All business matters of the Church should be conducted in a similar way.

PRAYER

Luis Florez and George W Brown offered prayer, asking the Lord's guidance in the work of the survey commission.

Colombian Union Mission Survey Commission - Report

PRESIDENT'S REPORT

Luis Florez gave the historical background on the growth of the Seventh-day Adventist Church in Colombia. Frank C Kelley and his wife lived in Bogota as self-supporting missionaries from 1915-1918 where they taught English and worked in photography while sharing the message. However, 1921 is the year when the message officially came to Colombia with the visit of E Max Trummer. At that time Trummer was president of the West Caribbean Conference and Colombia was part of this conference. He came to Bogota for the first public meetings which cultivated the interest created by the colporteurs Gilberto Schewerin. Harold C Brown, George A Kneeland, and L V Cleaves. Early in 1923 the first converts, Francisco Hernandez and Eugenio and Carlos Plata were baptized. Later that year Pastor Trummer organized the first church in Bogota. There was also interest in Cartagena as a result of a box filled with books sent to the harbor which later resulted in the baptism of Antonio Redondo, a Presbyterian pastor. The second church was organized in 1924 in the city of Barranquilla.

In 1925 as the work grew, Colombia was divided into four missions:

Atlantic with headquarters in Barranquilla Antioquia with headquarters in Medellin Central with headquarters in Bogota Pacific with headquarters in Cali

It took several years to provide leadership for each mission. This territorial arrangement lasted until January 17, 1942 when the Colombian territory was organized into three fields: Upper Magdalena, Pacific, and Atlantic.

In 1927, by action of the Inter-American Division Committee meeting in the city of Balboa, Panama Canal Zone, the Colombia-Venezuela Union Mission was organized. The first meeting of the Colombia-Venezuela Union Mission Committee took place on August 15, 1929 in Cali, Colombia where the headquarters of the union mission was located until February 23, 1930. It was then moved to Medellin, Colombia. Henry E Baasch was the president and J B Ross served as secretary-treasurer.

On March 9, 1989 the Colombia-Venezuela Union Mission was divided into two separate union missions and the Colombian Union Mission began functioning as a new entity.

At the General Conference Session in Indianapolis, Indiana on July 5, 1990 an action was taken to recognize and record the new Colombia Union Mission, effective March 9, 1989, and to accept it into the world sisterhood of unions of the Seventh-day Adventist Church. In 1991 by general concensus between the union, the division, and the General Conference, the name of the union mission was adjusted slightly and became known as the Colombian Union Mission. Within the present Colombian Union Mission there are five missions/conferences:

Atlantic Colombia Mission with headquarters in Barranquilla Colombian Islands Mission with headquarters in San Andres Isle East Colombia Mission with headquarters in Bucaramanga Pacific Colombia Conference with headquarters in Cali Upper Magdalena Conference with headquarters in Bogota

UNION SECRETARY'S REPORT

Bernardo Rodriquez, secretary of the union, presented the secretary's report.

VOTED, To accept the secretary's report and express appreciation for Bernardo Rodriquez's work within the union.

CHURCH GROWTH RATE

As indicated below, the growth of the church in the Colombian Union Mission has remained steady over the last five years in spite of the difficulties and challenges faced within the country of Colombia.

UNION TREASURER'S REPORT

Cristobal Torres, treasurer of the Colombian Union Mission, presented the treasurer's report. See attached copy in Appendix B.

VOTED, To accept the treasurer's report and express appreciation for Cristobal Torres' contribution to the union.

EDUCATION DEPARTMENT - COMMENDATION

VOTED, 1. To commend the Colombian Union Mission Education Department for the evolving process that it has gone through during the last few years.

2. To commend the Colombian Union Mission for the excellent plan of education to upgrade its teachers at all levels, and for the clear way this plan was presented in the union's study document.

EDUCATION DEPARTMENT - SDA STUDENT PERCENTAGES

In the schools operated by the Seventh-day Adventist Church in Colombia, 31.2 percent of the students at the elementary level are Seventh-day Adventists, 51 percent of the secondary level students are Seventh-day Adventists, and 98 percent of the college level students are Seventh-day Adventists.

RECOMMENDED, To request the union mission to increase the number of Seventh-day Adventist students in the church-operated schools as much as possible to comply with the division policy that requires at least 70% of the students at all levels of education should be Seventh-day Adventists.

CHURCH MINISTRIES DEPARTMENT - COMMENDATION

VOTED, To commend the Church Ministries Department for the excellent development in all its activities, most notably in the stewardship area, which has contributed greatly to the growth of the church in this union.

COMMUNICATION DEPARTMENT

The Communication Department is active in several areas in bringing the name of the Seventh-day Adventist Church before the people of Colombia. Currently the Voz de la Esperanza is carried by a number of radio stations throughout the country, in particular in the cities of Medellin, Bucaramanga, and Buenaventura. Colombian Union Mission Survey Commission - Report

In the last four years, 40 articles have been published in newspapers, 20 photographs have been published, 4,448 column centimeters have been printed, 240 news items have been broadcast by radio and television, 212 contacts have been made as a result of the broadcasts, 1,272 programs have been transmitted, and a total of 1,840 hours of the Voz de la Esperanza have been broadcast.

PUBLISHING DEPARTMENT

According to the statistics of the Publishing Department, in 1990 a total of 576 colporteurs worked within the territory of the Colombian Union Mission. As a result of their endeavors, there were 702 baptisms in the union in 1990. Total sales of literature in 1990 amounted to US\$ 1,144,116.

ABC SALES - FINANCIAL REPORT

The survey commission was not able to review the financial report of the Adventist Book Centers as the whole system is under the process of reorganization with the participation of the Inter-American Division. The objectives are to make the system more operative, and to comply with the labor laws of the country.

COLOMBIAN UNION MISSION - COMMENDATIONS

Following the review of the materials presented to the Colombian Union Survey Commission, the following commendations were recorded:

VOTED, 1. To commend the Colombian Union Mission for the excellent 292-page document prepared for study by the survey commission.

2. To commend the Colombian Union Mission for calling to the ministry all those who finish studies in theology.

3. To commend the Colombian Union Mission for the balanced distribution of office workers and church pastors.

4. To commend the Colombian Union Mission for its very low number of payable and receivable accounts which means that the union operates on what it has and pays its debts, and for the good quality of its working capital which shows a solid solvency.

5. To commend the Colombian Union Mission for the plan that exists at all levels of the union to assist churches in providing church buildings and schools which makes possible the housing of so many new members without incurring additional indebtedness. Colombian Union Mission Survey Commission - Report

6. To commend the Colombian Union Mission for the excellent program of physical development at Colombia Adventist University, and for the outstanding financial condition of the institution.

COLOMBIAN UNION MISSION - RECOMMENDATIONS

As a result of the study of the materials presented by the Colombian Union Mission to the survey commission, the following recommendations were made by the survey commission:

RECOMMENDED, 1. To include lay members on the board of the union institutions as is done on conference and union committees.

2. To organize into churches as soon as possible as many of the 588 companies to join the current 396 organized churches in the Colombian Union Mission.

3. To request a study be done and then implemented to assist the Upper Magdalena Mission, Colombian Islands Mission and Pacific Mission in raising their mission offering from 6.7 percent, 6.2 percent, and 5.8 percent respectively to 8 percent in relation to their tithe during 1991, remembering that the general goal for the whole division is 12 percent.

4. To encourage the Upper Magdalena Mission to continue working to improve its working capital to reach the levels required by Inter-American Division policy.

CONFERENCE STATUS APPROVAL AND IMPLEMENTATION

After the members of the survey commission reviewed the items discussed during the meeting, it was

VOTED, To approve conference status for the Colombian Union Mission which will be named Colombian Union Conference. The procedure as outlined in General Conference <u>Working Policy</u> B 09 10-3, 4. 5 will be followed. Implementation will take place at the end of a specially called session of the union to meet January 8 to 11, 1992.
