DEVOTIONAL MESSAGE

The devotional message entitled "Patching Old Clothes" was presented by C Lee Huff, President of the Euro-Asia Division. Scripture texts are quoted from the New International Version.

"No one sews a patch of unshrunk cloth on an old garment, for the patch will pull away from the garment, making the tear worse" (Matt 9:16).

This text explains a task we all understand. But why did Jesus use this illustration? Let us look at verse 14 for some background. "Then John's disciples came and asked him, 'How is it that we and the Pharisees fast, but your disciples do not fast?""

The followers of John wondered why Jesus—a respected religious man—would not follow the traditions of their fathers. Jesus was telling the people that His mission to earth had been misunderstood. They were applying their preconceived ideas (patches) to His mission. His mission was not to patch up the world, but rather to make a new world. "Behold, I will create new heavens and a new earth. The former things will not be remembered, nor will they come to mind" (Isa 65:17).

Jesus is also trying to get us to understand that we cannot patch up our lives, but rather, He wants to give us a totally new life. "Therefore, if anyone is in Christ, he is a new creation; the old has gone, the new has come!" (2 Cor 5:17).

The question we must ask today is, How do we achieve this new creation experience? In society we find three answers to this question. Let us examine them briefly.

- 1. Many people say there is nothing man can do in this process. Some are predestined to become new creatures in Christ, others are predestined to be lost. In this group there is not unity of thought. Some think the world is getting better and finally everyone left will experience this new creature experience. Others feel the world is getting worse and will finally destroy itself.
- 2. Another group wants to change society and, by cutting out certain social orders, and through their own efforts, patch up the world and society and solve their own problems. But can we by our own efforts change man, change society, and patch up world problems?

I once purchased a suit that needed to have major tailoring to make it fit me. The outcome was not what we had hoped for, and I only wore the suit once.

3. Jesus says the remedy is to forget about patching and instead let Him make new people out of us. He illustrated this by saying we must be born again and we must yield our lives to Him. How can we become new creatures?

I was once lost in a forest at night while riding a horse. I guided the horse up and down every road and trail I could find in the forest. But for two hours I could not find my way out. Finally, in desperation, I dropped the reins and said to the horse, "Go home." Five minutes later we were home.

What Jesus is saying to us is, "Quit trying to patch up your life. Drop the reins. Let Me have control, and I will bring you home."

The response was that the Net meetings have inspired more lay involvement and that more evangelistic meetings are occurring in the North American Division now than previous to the Net meetings.

DEVOTIONAL MESSAGE

The devotional message entitled "It Is Written" was presented by Luka T Daniel, President of the Africa-Indian Ocean Division. All texts are quoted from the New King James version of the Bible unless indicated otherwise.

Humankind is an endangered species. The danger comes not from the dreaded weapons of mass destruction, from a threat of World War III, from an impending invasion from outer space, from the menace of global warming, or from moral decay in society. All these are the byproducts of a war which has been raging since the beginning of human history. James says, "Where do wars and fights come from among you? Do they not come from your desires for pleasure that war in your members? You lust and do not have. You murder and covet and cannot obtain. . . . Adulterers and adulteresses! Do you not know that friendship with the world is enmity with God?"—James 4:1, 2, 4

It is important to note that the word desire is translated from the Greek Epithumia, which can also be translated as craving, or appetite, or passion, or lust. The Apostle John breaks down this warfare into three battlegrounds: "For all that is in the world—the lust of the flesh, the lust of the eyes, and the pride of life—is not of the Father but is of the world."—I John 2:16

The devil used one attack to defeat our first human parents on all three battlegrounds. "So when the woman saw that the tree was good for food, that it was pleasant to the eyes, and a tree desirable to make one wise, she took its fruit and ate. She also gave to her husband with her, and he ate."—Genesis 3:6

The lust of the flesh clearly has to do with appetite, because we have just read that Eve ate the forbidden fruit because she "saw that the tree was good for food." The second major aspect of the lust of the flesh is sexual immorality. Sexual immorality kills prematurely (Prov 5:3-6). It may lead to deadly diseases like AIDS, and eventually "your flesh and your body are consumed" (vs 11).

The lust of the eyes deals with the inordinate desire for popularity. The pride of life is rendered as "the boasting of what he has or does" (1 John 2:16, NIV). In other words, what we need to fight on this battleground is the passion for possession and position.

The first Adam and his offspring have been defeated on all three battlegrounds of this warfare. However, we read that Jesus "was in all points tempted as we are, yet without sin" (Heb 4:15). There is a weapon that can be used in this warfare which is not "against flesh and blood, but against . . . spiritual hosts of wickedness in the heavenly places" (Eph 6:12). The weapon is none other than "the sword of the Spirit, which is the Word of God" (vs 17).

Jesus Christ was starving for food after He had fasted forty days. So the devil took advantage of Christ's hunger and suggested to Him, "Command that these stones become bread" (Matt 4:3). That was an appeal to the lust of the flesh—the first battleground. Jesus replied to the tempter, saying, "It is written, 'Man shall not live by bread alone, but by every word that proceeds from the mouth of God'" (vs 4).

The devil then led Jesus to the pinnacle of the temple (vs 5) and told Him to throw Himself down (vs 6). There were always many people on the temple premises, so a miracle here would result in popularity for Jesus, thus satisfying the lust of the eyes. In response, the Saviour quoted from Deuteronomy 6:16, saying, "It is written again, 'You shall not tempt the Lord your God'" (Matt 4:7).

Satan finally took Jesus to "an exceedingly high mountain and showed Him all the kingdoms of the world and their glory" (Matt 4:8). He said to Christ, "All these things I will give You if You will fall down and worship me" (vs 9). The Creator silenced the grand usurper with a rebuke, "Away with you, Satan!" (vs 10). Then He quoted from Deuteronomy 6:3 again, "For it is written, "You shall worship the Lord God, and Him only you shall serve."" The story came to a happy ending, because "Then the devil left Him!" (vs 11).

That was how Christ, the second Adam, won the war against the devil on all three battlegrounds where the first Adam lost it. "Resist the devil and he will flee from you!" (James 4:7). The secret of how to win this war is found in Psalms 119:11, "Your word I have hidden in my heart, that I might not sin against you."

MINISTRY PROFESSIONAL GROWTH SEMINAR - REPORT

James A Cress and Nikolaus Satelmajer reported on the professional growth seminar that was held for 4.5 hours on March 31, 1998. The satellite program was downlinked to 525 sites across North America, with additional sites in Europe. According to an initial survey, it is estimated that approximately 6,000 clergy of many denominations viewed the seminar. The number one request of callers following the seminar was that such seminars be held more frequently. It is felt that one secret of success was the participation by speakers of other denominations.

Also mentioned was the Robert Spangler Memorial Scholarship to be offered at Andrews University. This scholarship will provide one quarter of education at Andrews University, with all expenses paid, to two pastors of other denominations.

GENERAL CONFERENCE SESSION - 2000—OFFERING FOR 10/40 WINDOW

Approximately six billion people live on earth, and 60 percent of those live in what missiologists call the 10/40 window. Only ten percent of the Seventh-day Adventist total world membership lives in this area which lies between 10 degrees north latitude and 40 degrees north latitude, bordered on the east by the Pacific Ocean and on the west by the Atlantic Ocean. It was

VOTED, 1. To adopt the concept of establishing 1,040 new congregations in the 10/40 window before the end of the next quinquennium.

- 2. To assign to the Global Mission office the responsibility for preparing promotional material for the 10/40 Window General Conference Session 2000 Offering, in consultation with the Communication Departments of the General Conference and the North American Division and the *Adventist Review* office.
- 3. To request the General Conference Administrative Committee to set offering goals for each division.
- 4. To schedule two dates for the 10/40 Window General Conference Session 2000 Offering—the first on December 11, 1999 and the last on July 6, 2000. Divisions who opt for three offerings will select a date during the first or second quarter of 2000. Any sum raised in excess of the General Conference established division goals will be retained by the divisions for use in their own Global Mission programs.

153-98G GENERAL CONFERENCE SESSION DELEGATIONS— CLARIFICATION/INTERPRETATION

Because of ambiguities in the General Conference Constitution and Bylaws concerning delegations to General Conference Sessions, it was

VOTED, To approve the clarification/interpretation of the General Conference Constitution and Bylaws provisions relating to General Conference Session delegations, with the understanding that the General Conference Constitution and Bylaws Committee (ADCOM-S) will recommend new wording to the appropriate committees. The issues are as follows:

1. Organizational nomenclature

For purposes of delegate quota assignments for the 2000 General Conference Session, the local organizations within divisions and unions which use the following nomenclature shall be deemed equivalent to local missions: associations*, attached districts, attached fields, delegations, fields, regions, and sections. (The Trans-Mediterranean territories shall be considered collectively as one field.)

^{*}In this clause, the term "association" is used instead of local mission and does not refer to a legal association.

2. Allocation of regular delegates, Article IV, Sec. 6-a. and 6-h., to unions

The General Conference Constitution Article IV, Sec. 6-i. shall be interpreted as follows for the 2000 General Conference Session:

Delegates from each division, provided for under Article IV, Sec. 6-a. and 6-h., shall be allocated first to union conferences and union missions that are affiliated with that division, based on each union's proportion of the division membership. Any delegates not allocated to unions under this process shall be allocated at the discretion of the division committee.

3. Method of calculation in Article IV, Sec. 8.

The General Conference Constitution Article IV, Sec. 8., for purposes of the 2000 General Conference Session delegate quota allocations, shall be interpreted as having no reference to delegates at large specified under sections 7-a., 7-b., and 7-c.

4. Allocation of delegates provided under Article IV, Sec. 7-d.

The following procedure shall be approved for the distribution of 2000 General Conference Session delegate quotas under Article IV, Sec. 7-d.:

- a. One third of the Article IV, Sec. 7-d. delegate pool will be released to divisions by April 1, 1999. Each division shall receive an allocation of such delegates based on the proportion of division membership to world membership.
- b. The General Conference Committee shall retain the balance of the Article IV, Sec. 7-d. delegate pool. Divisions may request, prior to June 30, 1999, additional delegate quotas from the General Conference Executive Committee.
