# 68/12 EGYPT SECTION--REQUEST FOR RELIEF CLOTHING

On January 7, 1968, a minority committee consisting of F. C. Webster, R. E. Anderson, Salim Japas, R. C. Mills, Chafic Srour, R. W. Wilmot, and R. L. Jacobs met in the Beirut airport and took the following action:

# 68/13 EGYPT SUMMER SCHOOL--REQUEST

WHEREAS, The Egypt Academy does not offer the official course leading to a valid certificate that can be accepted by Middle East College, and

WHEREAS, There are at least twelve students who have finished the academy course offered and whose value as workers could be increased if they could receive further preparation, it was

VOTED, To pass on to Middle East College the request of the Egypt Section that plans be made for conducting an extension school in Egypt every summer, with the understanding that Middle East College provide the teachers with their salaries and that all other expenses including housing and daily allowance will be paid by the Egypt Section.

VOTED, To grant M. T. Oliverio, M.D., an extended furlough of fifteen months beginning in the summer of 1968 for study in Loma Linda University for a degree in Public Health and special work in Radiology and Cardiology. It is understood that one stop is authorized in the Philippines en route either way, and authorization is also granted for Mrs. Oliverio to take studies leading to a Medical Records degree. The provisions of the Advanced Study Policy will apply. This supersedes our action 66/264. RLJ

## 68/17 SABRY AZER--CALL CANCELED

VOTED, To rescind Middle East Division action 67/332 passing on a call for Sabry Azer to serve as pastor-evangelist in the Iraq Section. RLJ

#### 68/18 JERUSALEM EVANGELIST--CALL CANCELED

Due to the present political situation making it impossible for us to carry on work in Jerusalem, it was

VOTED, To cancel our call (MED 65/336) for an evangelistic worker to be located in Jerusalem. RLJ

#### 68/19 IRAN SECTION--CALL FOR PASTOR-EVANGELIST

VOTED, To pass on to the General Conference the call of the Iran Section for a Pastor-Evangelist, suggesting the name of R. R. Nickell, presently employed in the Idaho Conference, and further,

To Recommend to the General Conference that this appointee be authorized to pursue an intensive study course in the Farsi language for up to three months in a specialized language school in the United States before coming to his new field.

# 68/20 BENGHAZI HOSPITAL--CALL FOR ELEMENTARY TEACHER

## 68/21 RUTH CHUNG--CALL

Ruth Chung is a Chinese nurse graduated from our Chung King Sanitarium and was employed for approximately ten years as staff nurse, head nurse, supervisor, and finally as assistant director of nursing service in the Taiwan Sanitarium and Hospital. She is now employed by the Libyan Government in the Derna Government Hospital and has expressed her desire to work in Benghazi Adventist Hospital (See MED 67/62). A work permit is being secured to enable her to work in the Benghazi Hospital, but difficulty has been encountered in securing permission for her to remain in Libya without first returning to Taiwan, as stated in her contract with the Libyan Government. Since it would also appear to be advantageous to her to be called from her homeland on the basis of a regular worker called from the Far Eastern Division, it was

VOTED, To pass on to the General Conference and the Far Eastern Division the call of the Benghazi Hospital Board for Ruth Chung of Taiwan to serve as staff nurse, on the basis of present arrangements for Filipino workers in Benghazi.

# 68/22 HANNA MALAKA--CALL TO JORDAN

VOTED, To pass on to the Egypt Section the call of the Jordan Section for Hanna Malaka to serve as principal of the Amman school. RLJ

### 68/23 HANNA ABDEL-MALEK--CALL

VOTED, To pass on to the Egypt Section the call of the Benghazi Hospital for Hanna Abdel-Malek to serve as assistant in the maintenance department.

### 68/24 R. D. HYDE--FURLOUGH

In harmony with the recommendation of the Iran Section, it was

VOTED, To grant R. D. Hyde a three-month furlough beginning June 1, 1968.

## 68/25 AARON DENNIS--FURLOUGH AND STUDY PLANS

In harmony with his request and on the recommendation of the Benghazi Hospital Board, it was

VOTED, To approve an extended furlough of fifteen months for Aaron Dennis, beginning May 15, 1968, and further

To authorize Brother Dennis to study in Andrews University in the field of education. RLJ

# 68/26 FUAD ASHKAR--WORKER IN-SERVICE TRAINING

In harmony with the recommendation of the Iraq Section, it was

VOTED, That Fuad Ashkar be approved for study in Middle East College under the provisions of the Worker In-Service Training Policy (MED WP 112-115) for the 1967-68 school year. Further, that in application of the policy the 75 per cent salary be applied to his own salary rate rather than the ordained minister's maximum rate.

## 68/27 MOTORCYCLE--DEPRECIATION AND MILEAGE RATE

VOTED, That where workers are authorized to use motor scooters or motorcycles, the depreciation and kilometer rates be set by the Section committee at approximately one-fifth the automobile rates in the country concerned, it being understood that liability insurance be carried and paid for by the employing organization in harmony with the policy for automobiles.

## 68/28 JORDAN SECTION--INCOME TAX POLICY

VOTED, To authorize the application of the provisions of the Income Tax Policy (MED WP 97) in the Jordan Section. RCM

# 68/29 SOCIAL SECURITY ALLOWANCES -- LEBANESE WORKERS

November 14, 1967, the committee to study the Social Security regulations in Lebanon as related to wage scale and allowances granted to employees, was reactivated. (MED 67/268) It was

VOTED, To adopt the report of the subcommittee on Lebanese Social Security, as follows:

Policies concerning Social Security service termination, family allowances and denominational sustentation as they pertain to workers employed by SDA organizations and institutions in Lebanon:

- 1. That where family allowances are paid according to the Social Security Law, child allowances according to the present policy be canceled.
- 2. That workers who are not eligible to collect family allowances under the Social Security Law, receive an amount equal to what they would receive from the Social Security Fund if eligible.
- 3. That workers registered under the Social Security Law be assured sustentation eligibility as any other regular worker under the provision of the sustentation policy and, if found eligible for sustentation, amounts received from the Social Security Fund will be considered pre-payments of sustentation benefits.
- 4. That a worker eligible for sustentation and receiving Social Security benefits who chooses to:

- a. receive his Social Security benefits in a lump sum, will be eligible for full sustentation as soon as his monthly credits from the sustentation fund exceed the lump sum payment received from Social Security.
- b. receive his Social Security benefits in a lump sum and in turn pays it to the Middle East Division, if he is eligible for sustentation benefits, may receive sustentation payments according to the sustentation policy. In case the worker passes away before he receives from sustentation an amount equal to that paid in from Social Security benefits, the unused balance will be paid to a beneficiary pre-named by the worker.
- c. receive his Social Security benefits on a monthly basis will receive from the sustentation fund an amount that when added to the Social Security benefits equals the amount of full sustentation for which he is eligible.
- 5. That a worker who chooses to receive full benefits from both the Social Security fund and the sustentation fund, may deposit with his employing organization a sum equal to the amount the employing organization is required to pay to the Social Security Fund. It is understood that at retirement or termination of service the worker may elect to collect the amount thus deposited by him and, if eligible, receive only the benefits of the sustentation policy.

# 68/30 HOUSING SUBSIDY EVALUATION COMMITTEE -- REPORT
