VOTED, To amend the action taken by NADCA on June 28, 1979 (NADCA 79-82), the revised report now to read as follows:

VOTED, To approve the following cooperative program between Narcotics Education, Inc and the General Conference Publishing Department as the plan of operation for the Community Crusade Against Drugs in schools according to the following, commencing July 1, 1979:

1. The division of funds or monies contributed or provided the CCAD shall be allocated on the following basis:

\*This percentage of 6.25 for NEI materials is to be set up in the HHES office as a reserve for each Literature Evangelist to supply schools in his territory. This reserve is to be used only for the schools in the community in which the funds were given, unless otherwise specified by the donor. NEI is to stock the supplies needed by LISTEN LE's, as listed in the HHES - Narcotics Catalog and distributed through the HHES.

2. Respective unions shall provide to the General Conference publishing Department a semi-annual financial report from their HHES/FHES of such plans by January 15 (for July 1 to December 30) and July 15 (for January 1 to June 30) of each year.

3. Each union HHES/FHES Committee shall supervise this operation in cooperation with the Temperance Department director as a member of the committee.

- a. To maintain the financial plan
- b. To maintain the objective for community benefit
- c. To maintain the church's image and involvement

4. Fulfillment of services to schools shall be the responsibility of the LISTEN literature evangelist as outlined in a specified report form, as provided. In the event the LISTEN representative is unable to provide the lecture services, the union HHES/FHES Committee, with the temperance director as a member, will recommend the service be provided by:

- a. The Temperance Department, or
- b. A qualified and interested local pastor or lay person.

5. No organization shall be established to implement this plan except the Publishing Department working cooperatively with Narcotis Education, Inc through the Publishing Department's established agencies as the only organizational approach in achieving these goals.

6. The CCAD representative shall be limited to securing of funds from the non-Seventh-day Adventist public for school programming.

7. This plan is concerned exclusively with supplying LISTEN and NEI aids and materials to schools, with NEI continuing to introduce LISTEN and its educational aids and material to other agencies and contacts, such as churches and temperance organizations.

8. A review of this plan shall be made by March 31, 1980, and at this date, consideration will be finalized as to the possibility of increasing NEI materials to 10 percent, effective January 1981.
