DEPARTMENTS

Neal C Wilson, President, addressed the members of the General Conference Committee in regard to organizational structure and management of the church, expressing his conviction that there is a need for a change in the conventional approach in operating our work. The following specific suggestions were made:

1. That the General Conference operate with a maximum of six vice-presidents in addition to the vice-president for North America, these vice-presidents to assist departments in the carrying forward of practical programs for the world church.
2. That certain departments be grouped for maximum coordination.

3. That certain departments be merged, for example, the Temperance and Health Departments and the Ministerial Association with the Stewardship and Development Department.
